Monarch Server is the smart business intelligence software that gives you the power to keep the data and lose the paper. That's because Monarch Server's powerful report mining technology can unlock data buried in reports and documents and turn it into data that you can use now.

Monarch Server comprises three modules, namely, Automator, Report Warehouse, and Report Mining Server. This guide provides a comprehensive look at the following:

- **Automator**

Automator is designed to be used in conjunction with Altair Monarch Complete, a data extraction and analysis tool that lets you view, analyze, extract, and print data from existing computer reports. Any structured report that is used in your organization can be utilized by Monarch Complete. When Monarch Complete "reads" a report file, instead of producing a hard copy printout with words and numbers frozen on the page, Monarch Complete creates a soft copy of the report on screen, with live data you can work with.

- **Report Warehouse**

Report Warehouse is a reliable platform for report and document content management. In Report Warehouse, reports and documents are "read-in" to a storage system and then indexed. These stored reports and documents can be easily retrieved using Report Warehouse's powerful query system and subsequently transformed into data views and Excel spreadsheets. The filing, storage, and retrieval of reports and documents are made easy in Report Warehouse.

- **Report Mining Server**

Report Mining Server is a powerful tool that allows you to extract data from structured documents or reports. Altair has further developed Monarch Server Report Mining Edition with the ability to provide the extracted data in various analytical and presentation formats for delivery over the Web. Monarch Server Report Mining Edition employs innovative technology that allows any PC or laptop connected to the Internet, or to a corporate intranet, to access reports stored in other systems. All of these capabilities make Monarch Server Report Mining Edition truly unique.

About Monarch Server Automation Edition

Monarch Server Automation Edition is a data conversion solution that uses existing ASCII or ANSI reports, PDF files, XPS files, ISAM files (for example, XLS, MDB, ACCDB, DBF) Open XML Spreadsheets (XLSX/XLSM), HTML files, and OLEDB/ODBC sources as a source for data. You can input report files (for example, TXT, DAT, PRN, LOG) into Monarch Server Automation Edition and then export their data to a variety of formats (for example, PDF, XLS, XLSX/XLSM, MDB, ACCDB, HTML, DBF) or to an OLE DB or ODBC destination. Monarch Server Automation Edition also allows you to export files to a Microsoft Office SharePoint Server, FTP site, email destination, or distribution list. In short, Monarch Server Automation Edition lets you extract, transform, move and load data faster and more easily than previously possible.

Monarch Server Automation Edition offers far more than an easy way to automate Monarch: it is an information delivery system, capable of distributing files over the network and to SharePoint locations, emailing users the files they need, or alerting them that new files are available and where to get them, either over the network or via the Internet. RSS feeds can be created, integrating with newsreaders or corporate information portals, so users are kept up-to-date on the latest information and can click to download or view the information via their browser.

Monarch Server Automation Edition is a perfect solution for extracting data from periodic reports on a regular basis. For example, you might instruct Monarch Server Automation Edition to process files delivered to a specified location on your network at 3:00AM, delivering Excel files to all sales reps so that they have the latest figures in their Inbox first thing in the morning.

Alternatively, you can use Monarch Server Automation Edition to monitor specified folders, so that as soon as a file arrives, the conversion process begins.

Monarch Server Automation Edition is also great for automating complex conversion projects that call for extracting data from multiple reports, generating output for multiple recipients, or for taking multiple passes through a complex report in order to assemble the data you need.

Features and Functions

Monarch Server Automation Edition has the following capabilities:

- Automated conversion of data from TXT, PDF, ISAM, XPS, and OLE DB/ODBC sources to an ISAM, or OLE DB/ODBC (for example, SQL Server, Oracle) target by scheduled or event-driven execution via monitored folders.
- Email distribution of PDF, ISAM, and Open XML Spreadsheets
- File system and SharePoint distribution of input and export files
- RSS publication
- Creating logs and alerts resulting from operations
- Allowing user creation of pre-processes and post-processes using VB.NET Scripting
- Scheduled administration of job logs and database entries

Monarch Server Automation Edition Workflow

When using Monarch Server Automation Edition a typical sequence of events might be as follows:

NOTE: This sequence of events does not have to be followed exactly. Depending on your needs, you may perform fewer or more steps than those listed below, and the order in which you perform them may differ.

1. [Create a Process](#): Once you have created or identified the project file(s) you want to work with, you can create a process. Creating a process includes multiple steps, such as the following:
 - Specify general settings: General settings include a name and description of the process, a How many projects per job setting (i.e., one per job or multiple ones per job), the project(s) to be assigned to the process, etc.
 - Specify advanced settings: Advanced settings include a priority setting, and whether to allow parallel jobs and process retries.
 - Specify job log disposition settings: These settings determine what will be done with the job log after the job has run, and when (i.e., under what circumstances) the specified action will be carried out.
 - Specify input file monitoring settings: These settings enable you to tell Monarch Server Automation Edition to monitor a particular location, then trigger the running of a process when a specific input file (or any file of the specified file type) appears in that location.
 - Specify script settings: Script settings enable you to specify pre-process and post-process operations that execute before or after any operations in the process itself do.

NOTE : Depending on your needs, not all of these steps will have to be performed, for example, you may not need to specify input file monitoring settings.

2. [Run the Process](#): Once you have completed the process configuration, you can either run the process manually, schedule the process to run, or configure an input file specification which will trigger the process to run when a particular input file arrives in the specified location.

About Report Warehouse

Report Warehouse is a reliable platform for report and document content management. In Report Warehouse, reports and documents are "read-in" to a storage system and then indexed. These stored reports and documents can be easily retrieved using Report Warehouse's powerful query system and subsequently transformed into data views and Excel spreadsheets. The filing, storage, and retrieval of reports and documents are made easy in Report Warehouse.

At the heart of Monarch Server is Report Warehouse's subsystem for efficiently storing and managing large volumes of corporate reports. Reports produced in any host environment can be brought into Report Warehouse. These reports are automatically identified, indexed, compressed, and stored in the warehouse system. Monarch Server uses an industry-standard SQL database to manage storage and provide fast, efficient access to report data.

Report Warehouse allows end users to retrieve information from reports, search for data in several reports simultaneously, and manipulate data for further analysis. This online system makes report data available more quickly, economically, and effectively than is possible with traditional hardcopy reports.

Report Warehouse Components

The MSAdmin is a part of the Report Warehouse system, which consists of these major components:

- **SQL database**. Report Warehouse works with industry-standard SQL databases. It supports Microsoft SQL Server 2016/2017/2018. A database server can be chosen from a list of supported devices based on your report volume and existing network architecture. This database supplies the underlying mechanisms for managing the internal data structures.
- **Monarch Server Administrator (MSAdmin)**. It is used by the system administrator to define the parameters of the system. MSAdmin identifies where reports are to be found, how they are to be processed into electronic documents, and where the results (that is, documents) will be physically stored. It calls Monarch to set up models for indexing and extracting data from documents. MSAdmin provides capabilities for enforcing system security, establishing user rights and privileges, and handling maintenance issues.
- **Monarch Server Client (MSClient)**. It contains the functionality necessary for retrieving documents. It allows users to query the report warehouse in a number of ways to find the documents that they are looking for. Once found, these documents are launched into Monarch with the appropriate model file for viewing and analysis. MSClient is also used

to process reports into documents. Using the parameters established in MSAdmin, new reports are recognized, indexed, broken into documents, and stored away, creating a warehouse of documents and indexes.

Overview of MSAdmin Tasks

MSAdmin is the administration interface for Report Warehouse. Report Warehouse provides automatic indexing, instant retrieval of selected pages, and comprehensive security features.

In order to understand how Report Warehouse works, you need to understand its terminology. Although the terms are familiar, they have specific meanings in the context of Report Warehouse.

In Report Warehouse, [reports](#) are the electronic versions of the reports generated by your company's reporting systems. They have a consistent and structured layout, and they are generally stored as one file. For instance, an Employee Insurance Report is a report that might be stored in a single file called EMPINSUR.TXT.

A [document](#) is a section of a Report Warehouse report that can be logically independent from other sections of the report. The Employee Insurance Report might be sorted by office, with a subtotal for each department. Each section of the report that represents a regional department is logically independent of the others. Breaking the report into smaller logical documents allows users to retrieve only those pages of the report that they want.

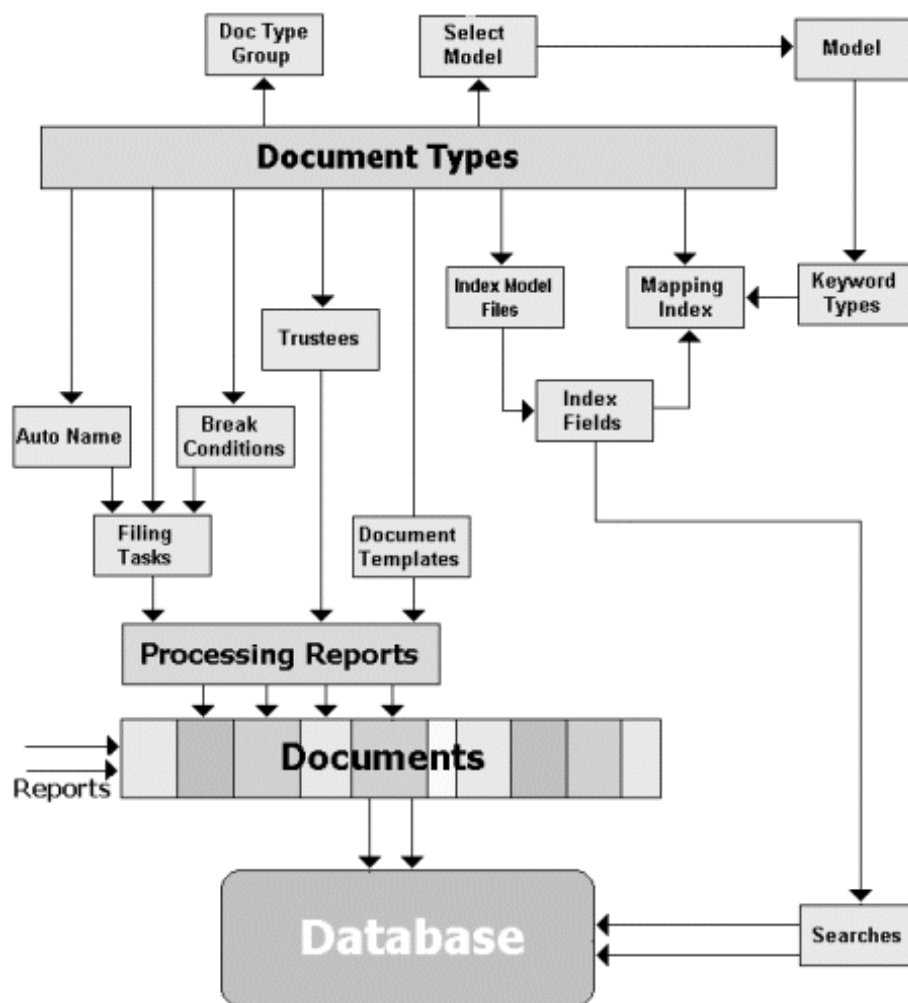
A [keyword type](#) is defined when you create a Monarch model, specified by a Monarch model file. In other words, when creating a model, one or several keyword types are defined. A keyword type is a field within a model that identifies the document. Document retrievals are based upon these fields of information.

A [document type](#) may have several keyword types associated with it. These keyword types are set up by a system administrator and are made available to users automatically. While a keyword type is a general category, a [keyword](#) is the specific value of a keyword type. For example, 'Q197-4112' would be a keyword for the keyword type of Purchase Order Number. The keyword type of Social Security Number would contain the keywords '011-39-0778' and '287-33-1111'.

An [index field](#) is actually a keyword type but is kept in the database. When Monarch begins processing reports (filing), the system matches index fields with corresponding keyword types. All values of keywords for a document are saved in the database and are associated with index fields. A user can then begin searching for documents and setting appropriate values of index fields.

An index field points to the start of the document, with which the given keyword is to be associated. Report Warehouse uses index fields to locate and retrieve documents according to keywords. For example, when you type in the keyword '011-39-0778' for Social Security Number, the index is used to locate documents for the individual with that social security number.

The following scheme represents the main relationships between the parts of the system at the conceptual level.



Here, the [Document Type](#) is a base concept, which defines how the system functions as a whole. You may acquaint yourself with it further by reading the section titled [Document Types](#). Document types comprise a [Document Type Group](#), as described in the section titled [Document Groups](#).

When you create or edit a document type, the system allows you:

- To select a model from the list of available models. Before you can select a model, you need to define it with the help of the **Model** page, described in the section titled [Adding a Model](#). Each model described by [mod- or xmod-type files](#) defines the [keyword types](#).
- To define the auto-name scheme using the AutoName page, which automatically assigns document names based on any combination of indexes and document identifiers. For more information, see [Auto-naming documents](#).
- To define [filing tasks](#), which begin to process the reports. For information on how to manage filing tasks, see [Filing Tasks](#).
- To set trustees ([users](#)) for documents in the system defined by their [roles](#) and the [user group](#) they belong to. For details, refer to [Rights and Privileges](#).
- To define [document templates](#) for documents extracted from the reports. On how to define document templates, see [Templates](#).

- To select the [index model files](#) with the help of the Model page described in the section titled [Adding a Model](#). These files define the [index fields](#) used to search for documents in the database.
- To bring [index fields](#) in accordance with [keyword types](#) with the help of the **Document Type** page. For more information, see [Adding a Document Type](#).

About Monarch Server Report Mining Edition

The RMSAdmin is a part of the Monarch Server Report Mining Edition system, which consists of these major components:

- **SQL database**
Monarch Server Report Mining Edition works with industry-standard SQL databases. It supports Microsoft SQL Server 2008+. A database server can be chosen from a list of supported devices based on your report volume and existing network architecture. This database supplies the underlying mechanisms for managing the internal data structures.
- **RMS Administrator (RMSAdmin)**
It is used by the system administrator to define the parameters of the system. RMSAdmin provides capabilities for adding models, enforcing system security, establishing user rights and privileges.
- **RMS Client (RMSClient)**
It contains the functionality necessary for viewing and analysis of the data from reports.

Launching Monarch Server Web Administrator

MSAdmin is the administration interface of Monarch Server that operates in an Intranet/Internet environment. Hence, users should be familiar with the standard techniques used to work in the Internet environment.

NOTE: Only users with administrator privileges have access to the system.

To initiate MSAdmin

1. Launch Microsoft Internet Explorer or any other browser by clicking its shortcut.
2. Type the MSAdmin address in the **Address** bar, which may look like this: `http://servername/MSAdmin`.

NOTE: In Monarch Server upgraded from previous versions (e.g., v13.2), the virtual folders could still be labeled as "DSAdmin" (or "DSClient"). In this case, use "DSAdmin" (or "DSClient") instead of "MSAdmin" (or "MSClient") to open the Admin (or Client) page.

3. Press **Enter**. Your browser will load the Login page.

4. Select a locale in the upper right corner of the page. The list includes locales that were selected during the installation.
5. Type in your name as an administrator, the password and click **Sign In**. If you enter your password correctly, the main page of Monarch Server Administrator is displayed on your screen.

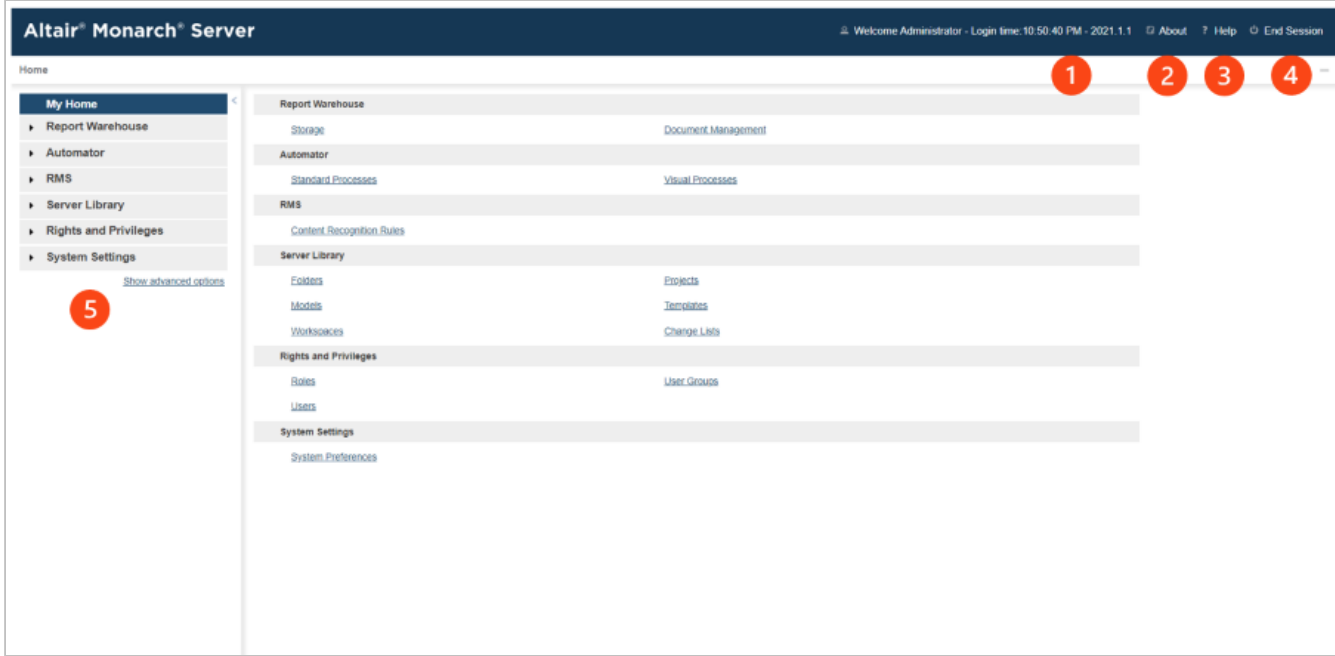
NOTES:

If your password has expired, the system displays the expired password page. You have to change your password. Type in your old password, a new password, confirm the new password and then click **Save**. If the new password you entered does not correspond to the requirements (for example, the length of a new password is less than the value defined by the administrator), the system displays a corresponding message.

If you try to log in to the application again while running it, a message will appear on the Login page, informing you that you have already logged in to the application. To clear the current session and log in to a new one, select the check box below the message, and click **Sign In**. This option is available only for the **Named** license type.

When you click a second-level option in the left pane, the right pane of the window displays the corresponding tab(s) with a list of items.

Functional Buttons

The following functional buttons are present throughout the application in the right pane:


 Allows you to add a new item to the list displayed in the right pane.

 Allows you to edit items (documents, document types, maintenance tasks and so on) from the list displayed in the right pane. Select the item to be edited, by clicking anywhere on a row, and click .

Note: Instead of clicking this button you may click the name of an item in a list.

 Allows you to remove items from the list displayed in the right pane.

To remove an item

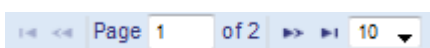
1. Click  at the end of the row with the item you want to delete.
2. Click **Delete to remove the corresponding item.**

NOTE: If an item does not contain any data, it will be removed from the list. If there are dependent items, you will not be allowed to delete it (for example, you cannot delete an index field if it is used for defining report types).

Page Navigation

In MSAdmin, whenever an item list exceeds the [Count of Items Per Page](#) setting, items are listed on subsequent pages. You can access these additional pages via page navigation icons.

For example, let's say the specified **Count of Items Per Page** setting is 10. If there are 20 Monarch Server users and you attempt to view them on the Users page, only the first 10 users will be visible. At the bottom of the users page, the page navigation icons would appear like this:







To see the remaining 10 users, you would have to click one of the page navigation icons.

The two left icons are dimmed, because there are no preceding pages.


You can also change the number of items to be displayed on one page, by selecting an option (10, 20, 50, 100, or 500) from the Items per Page drop-down list.

To navigate between pages, type a page number in the **Page** box, at the bottom of the table, or use the page navigation buttons:

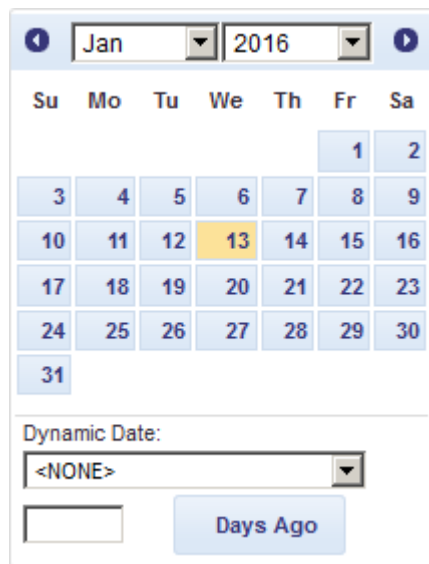
- To navigate to the next page, click .
- To navigate to the last page, click .
- To navigate to the previous page, click .
- To navigate to the first page,click .

If there are no additional pages to view all page navigation icons are disabled. The current page is the only page available.

Using the Calendar

When completing input information requirements of some pages you are required to define the date. To access the **Calendar** window, click the  icon next to a date field, or click the date field itself.




The **Calendar** window appears on your screen:



The left arrow navigates to the previous month, and the right arrow navigates to the next month.

To set a date

- Select a month on the **Calendar** using arrows and then select the date.
- Select one of the following predefined relative date values from the **Dynamic Date** list: Yesterday, End of Last Week, Start of This Quarter and so on.
- Set a date as a number of days ago. Enter the corresponding value in the box and click **Days Ago**.

- You can also use the following buttons, placed next to a date field:
 - To decrease the date by one day, click .
 - To enter the current date, click .
 - To increase the date by one day, click .

Relational Operators

Relational operators let you specify the relationship between an [index field](#) and an [index value](#) in your search criteria.

The relational operators are located in the **Operator** drop-down list, on the [Search page](#).

NOTE: This list is not visible, until you select a [document group](#) and [document type](#), and click the **Add condition** button under the **Search Criteria** heading.

The following relational operators are available:

- [Equal to](#) (=)
- [Not equal to](#) (<>)
- [Less than](#) (<)
- [Greater than](#) (>)
- [Less than or equal to](#) (<=)
- [Greater than or equal to](#) (>=)

When using relational operators in conjunction with [Boolean operators](#), make sure that your search criteria make sense. For example, if your search criterion is **Employee Name = John Smith** and you add the search phrase **Employee Name = Jane Doe** to it, you cannot link the two phrases with the **AND** operator, because none of the **Employee Name** index fields would contain both **John Smith** and **Jane Doe** index values. (The **AND** operator specifies that *all* search phrases linked by it must be true.) To use these two search phrases in your search criteria, you would have to link them with the **OR** operator.

Equal to (=) Operator

When [configuring a search](#), the equal to (=) operator is one of the [relational operators](#) you can use to specify the relationship between an [index field](#) and an [index value](#) in your search criteria.

Though the **equal to** (=) operator is the default relational operator used, you can select any of five other relational operators from the **Operator** drop-down list, on the [Search page](#).

NOTE: This list is not visible, until you select a [document group](#) and [document type](#), and click the **Add condition** button, under the **Search Criteria** heading.

Use the **equal to (=)** operator to retrieve only those documents that contain, in the specified index field, the index value contained in the search phrase.

Examples:

Customer Name = Bob's Records retrieves all documents with an index value of **Bob's Records** in the **Customer Name** index field.

Ship Date = 01/31/2001 retrieves all the documents with an index value of **01/31/2001** in the **Ship Date** index field.

Not Equal to (<>) Operator

When [configuring a search](#), the **not equal to (<>)** operator is one of the [relational operators](#) that lets you specify the relationship between an [index field](#) and an [index value](#) in your search criteria.

The **not equal to (<>)** operator is located in the **Operator** drop-down list, on the [Search page](#).

NOTE: This list is not visible, until you select a [document group](#) and [document type](#), and click the **Add condition** button, under the **Search Criteria** heading.

Use the **not equal to (<>)** operator to retrieve only those documents that do not contain, in the specified index field, the same index value as the one in the search phrase.

Examples:

Customer Name <> Betty's Music Store retrieves all documents with index values other than **Betty's Music Store** in the **Customer Name** index field.

Ship Date <> 01/31/2001 retrieves all documents with index values other than **01/31/2001** in the **Ship Date** index field.

Less Than (<) Operator

When [configuring a search](#), the **less than (<)** operator is one of the [relational operators](#) you can use to specify the relationship between an [index field](#) and an [index value](#) in your search criteria.

The **less than (<)** operator is located in the **Operator** drop-down list, on the [Search page](#).

NOTE: This list is not visible, until you select a [document group](#) and [document type](#), and click the **Add condition** button, under the **Search Criteria** heading.

Use the **less than** (<) operator in a search to retrieve only those documents that contain, in the specified index field, an index value that is less than the one in the search phrase.

Examples:

Ship Date < 06/01/2001 retrieves all documents with an index value of **05/31/2001** or earlier in the **Ship Date** index field.

Invoice Amount < 20000 retrieves all documents with an index value of **19,999.99** or less in the **Invoice Amount** index field.

Greater Than (>) Operator

When [configuring a search](#), the **greater than** (>) operator is one of the [relational operators](#) you can use to specify the relationship between an [index field](#) and an [index value](#) in your search criteria.

The **greater than** (>) operator is located in the **Operator** drop-down list, on the [Search page](#).

NOTE: This list is not visible, until you select a [document group](#) and [document type](#), and click the **Add condition** button, under the **Search Criteria** heading.

Use the **greater than** (>) operator to retrieve only those documents that contain, in the specified index field, an index value that is greater than the one in the search phrase.

Examples:

Ship Date > 06/01/2001 retrieves all documents with an index value of **06/02/2001** or later in the **Ship Date** index field.

Invoice Amount > 20000 retrieves all documents with an index value of **20,000.01** or more in the **Invoice Amount** index field.

Less Than or Equal to (<=) Operator

When [configuring a search](#), the **less than or equal to** (<=) operator is one of the [relational operators](#) you can use to specify the relationship between an [index field](#) and an [index value](#) in your search criteria.

The **less than or equal to** (<=) operator is located in the **Operator** drop-down list, on the [Search page](#).

NOTE: This list is not visible, until you select a [document group](#) and [document type](#), and click the **Add condition** button, under the **Search Criteria** heading.

Use the **less than or equal to** (<=) operator to retrieve only those documents that contain, in the specified index field, an index value that is less than or equal to the one in the search phrase.

Examples:

Ship Date <= 07/01/2001 retrieves all documents with an index value of **07/01/2001** or earlier in the **Ship Date** index field.

Invoice Amount <= 15000 retrieves all documents with an index value of **15,000** or less in the **Invoice Amount** index field.

Greater Than or Equal to (>=) Operator

When [configuring a search](#), the **greater than or equal to (>=)** operator is one of the [relational operators](#) you can use to specify the relationship between an [index field](#) and an [index value](#) in your search criteria.

The **greater than or equal to (>=)** operator is located in the **Operator** drop-down list, on the [Search page](#).

NOTE: This list is not visible, until you select a [document group](#) and [document type](#), and click the **Add condition** button, under the **Search Criteria** heading.

Use the **greater than or equal to (>=)** operator to retrieve only those documents that contain, in the specified index field, an index value that is greater than or equal to the one in the search phrase.

Examples:

Ship Date >= 07/01/2001 retrieves all documents with an index value of **07/01/2001** or later in the **Ship Date** index field.

Invoice Amount >= 15000 retrieves all documents with an index value of **15,000** or more in the **Invoice Amount** index field.

Boolean Operators

Boolean operators enable you to define searches that include more than one search phrase. Searches made up of two or more search phrases can include multiple [index fields](#) and [index values](#).

The Boolean operators are located on the [Search page](#).

NOTE: This list is not visible, until you select a [document group](#) and [document type](#), and click the **Add condition** button under the **Search Criteria** heading.

Click the drop-down arrow to select a Boolean operator from the list.

NOTE: While the **AND** operator can be used to link search criteria containing different index fields, the **OR** operator can only be used to link search criteria containing the same index field.

The following Boolean operators are available:

- **AND Operator:** The **AND** operator specifies that, in order for a document to be retrieved, all search phrases linked by it must be true. The search phrases linked with the **AND** operator can contain different index fields.

Examples:

Ship Date > 01/31/2001 AND Ship Date < 03/02/2001 — This retrieves all documents with ship dates from February 1, 2001 through March 1, 2001.

Customer name = Betty's Music Store AND Ship Date = 01/31/2001 — This returns only documents for Betty's Music Store that have a ship date of January 31, 2001.

- **OR Operator:** Use the **OR** operator to configure a search, in which only one of the search phrases linked by it must be true for a document to be retrieved. The **OR** operator will also retrieve any documents that meet both or all of the search phrases. **Note:** The **OR** operator can only be used to link search criteria containing the same index field. For example, the search phrase **Employee Name = John Smith OR Department = Accounting** would not work because **Employee Name** and **Department** are two different index fields. (This search phrase would work if you linked the search criteria with the **AND** operator, however.)

Examples:

Customer Name = Bluegrass Records OR Customer Name = The Glass Harmonica — This search returns documents for either **Bluegrass Records** or **The Glass Harmonica** (or both, if the document type selected contains documents for both stores).

Invoice Number = 11187 OR Invoice Number = 11189 — This search will return documents for either invoice **11187** or invoice **11189** or both.

Report Warehouse

Report Warehouse allows end users to retrieve information from reports, search for data in several reports simultaneously, and manipulate data for further analysis. This online system makes report data available more quickly, economically, and effectively than is possible with traditional hardcopy reports.

Storage Management

MSAdmin provides a system administrator with tools to define how and where Monarch Server compresses and stores [reports](#). How and where those reports are stored has a direct impact on the overall speed and flexibility of the system.

Reports put into the Monarch Server system are stored in logical storage bins referred to as [storage groups](#). All data in a storage group is stored together, so keep this in mind when establishing these groups. You may want to store all accounting reports in one storage group and all personnel reports in another. All reports having the same retrieval requirements might be stored together. Or, you may want to store all reports in a single storage group. Each organization will have different requirements based on its specific company policies and procedures.

Each storage group may be composed of several [storage volumes](#), each volume having a specific, user-defined size. You may create several copies of each volume, each copy with its own physical location. A single storage group is actually a volume set, and each volume set includes multiple [sub-volumes](#).

Volumes are used as a means of segmenting the increasing number of stored reports in a storage group. Segmenting the number of stored documents into smaller, more manageable pieces facilitates the migration of older data to nearline or offline storage media.

Each volume contains at least one copy. This copy is where the compressed report files that have been processed by Monarch Server are recorded initially. Additional copies may be recorded to other storage locations for data redundancy and long-term archival purposes.

Each storage group contains a set of volumes of the **First Copy** or **Second Copy**. When creating a storage group, the sub-volume size is defined. All the files for the current storage group will be grouped by sub-volumes, each of which will have the fixed maximum size defined by a storage group.

A storage group is also defined by such term as current sub-volume. This is the sub-volume all the new files are created on. If the current sub-volume is completed (or reaches the maximum size), it is closed and a new sub-volume is created. It becomes the current sub-volume. A new sub-volume may be created on any volume with the same type (**First Copy** or **Second Copy**), which is contained in the storage group. The system chooses the first volume, which has enough space for creating another full sub-volume.

For more information about storage groups, see [Storage Groups](#).

For more information about storage volumes, see [Storage Volumes](#).

Storage Volumes

A storage volume is a physical location on a server, to which reports can be archived, and from which documents can be retrieved. You can use storage volumes to segment the continually growing amount of data in a [storage group](#). Segmenting stored data into smaller, more manageable pieces facilitates the migration of older data to nearline or offline storage media.

NOTE: Volumes are subdivided into [sub-volumes](#).

Each storage volume in the Monarch Server system is either a **First Copy** or a **Second Copy** volume. When you [assign a storage volume to a storage group](#), you must specify the copy number of the volume (either **1** or **2**).

The first volume you add to the Monarch Server system should be designated a **First Copy** volume. This **First Copy** volume is where the compressed report files that are archived in the system are initially written to. **First Copy** volumes usually reside on fast devices. They should provide quick access because they use the most often retrieved documents. **Second Copy** volumes may reside on slower devices (such as magneto-optical) and can be used for data redundancy and long-term archival purposes.

Each document may reside on the volumes of the **First Copy** or **Second Copy**, or on both. When performing document retrievals, the system attempts to extract data from the volumes of the **First Copy** initially. If the data on the **First Copy** was either moved ([Maintenance Task — Move](#)) or copied ([Maintenance Task — Copy](#)) into **Second Copy** AND was purged ([Maintenance Task — Purge](#)), it will attempt retrieval from the volumes of the **Second Copy**.

NOTE: See [About Copies](#) for additional information.

You can move a document from one copy to another using [maintenance tasks](#).

All storage volumes used in the system are listed on the Volumes page. To display this page, click **Report Warehouse** on the Navigation Tree, then click **Storage** and select **Storage Volumes**. Use this page to [add](#), [edit](#), or [remove](#) a storage volume.

To add data to a storage volume

1. [Configure](#) a [filing task](#).
2. [Run](#) it via a [filing process](#).

To remove data from a storage volume

1. [Configure](#) a [maintenance task](#).
2. [Run](#) it via a [maintenance process](#).

The volume can be [closed](#) to prevent further writing and copying operations to this volume, or can be set as [Read Only](#) to restrict access to deletion of this volume.

About Copies

A copy is a [storage volume](#) that receives data (reports or documents) when it is archived in the system. Each volume in the Monarch Server system is either a **First Copy** or a **Second Copy** volume. When you [assign a storage volume to a storage group](#), you must specify the copy number of the volume (either **1** or **2**).

The first volume you add to the Monarch Server system should be designated a **First Copy** volume. This **First Copy** volume, which should reside on a mass storage device, is where the compressed report files that are archived in the system are initially written to. Subsequent volumes (that is, **Second Copy** volumes) may reside on any kind of storage medium, and can be used for data redundancy and long-term archival purposes. When performing document retrievals, the data on a **First Copy** volume will be accessed before the data on a **Second Copy** volume.

First Copy Volume

If the data is to be accessed frequently, you may choose to continue to retain the **First Copy** volume until data retrieval requirements subside. As reports are filed to this location, they are maintained in sub-volumes according to the specified sub-volume size. You may specify more than one **First Copy** volume. The first **First Copy** volume in the list will be used until it is full. Then the second **First Copy** volume will be used, etc.

NOTE: Data should not be moved or copied to a **Second Copy** volume until you are sure it is "error-free", as data in a **Second Copy** volume cannot be removed from the system.

Second Copy Volume

A **Second Copy** volume is a storage location where reports are archived for long-term storage. Typically, this is an optical storage device (for example, CD-ROMs, CD-ROM drive, etc.). If you don't specify a **Second Copy** volume, data remains in a **First Copy** volume indefinitely.

In practice, the way it works is this: A report is filed into a **First Copy** volume for temporary storage. If there was an error in a report or the archive process, the data can be deleted from the **First Copy** volume. Once the data has been determined to be correct (and/or once the retrieval demand for it decreases enough), it can be copied or moved to a **Second Copy** volume.

NOTE: Once data has been moved or copied to a **Second Copy** volume, it cannot be deleted from the system.

There are two ways, via [maintenance tasks](#), to permanently archive data in a **Second Copy** volume:

1. **Copy 1 to 2** maintenance task: Copies the data to a **Second Copy** volume, but retains it in a **First Copy** volume.
2. **Move** maintenance task: Moves the data from a **First Copy** volume to a **Second Copy** volume. After that it is possible to delete the **First Copy** volume (**First Copy** volumes can only be deleted if they are empty, that is, if they contain no data). The **Second Copy** volume will be used for all subsequent retrievals.


NOTE: If data that has been moved to a **Second Copy** volume needs to be accessed frequently again, the data could be copied back to mass storage for faster retrievals.

Adding a Storage Volume

When you add a [storage volume](#) to the system, you designate a physical location on a server for archiving [reports](#). Every time you add a volume, you must assign the volume to a [storage group](#) and specify whether it is a **First Copy** or a **Second Copy** volume.

NOTE: The first volume you add should be designated as a **First Copy** volume. (See [About Copies](#) for more information.)

To add a storage volume

1. On the Navigation Tree, click **Report Warehouse**, then click **Storage** and select **Storage Volumes**.
2. Click  on the **Volumes** page. The **Storage Volume** page appears.

NOTE: Field value defaults for some of these fields can be preset in MSAdmin. To do this, click **System Settings** on the Navigation Tree, select **System Preferences** and click the **System Defaults** tab. Setting these defaults can save time and errors in definition of storage volumes.

- Enter a unique name of a new storage volume into the **Storage Volume Name** field.
- Enter the text defining the storage volume into **Description field**. This step is optional.
- Select the name of a server from **Location** list. Select the **Any Location** option, if you will specify a UNC path in the **Path** field.
- Select the name of a server from a list. You can select the **Any Location** option, if you specified a UNC path in the **Path** field.

NOTE: If the required server is not on the list, refer to [Locations Management](#) topic to add a new location.

3. **Path:** Enter a path to the volume or use the **Browse** button. This path must be unique. In some cases such as defining a path using UNC paths, it may be required to manually create the path on the server. Typically, Monarch Server will create the storage path if needed.
4. Enter the maximum size of the volume into the **Maximum Volume Size field**. **Volume size** is measured in megabytes or gigabytes depending on the value you select from the list. **Current Size in bytes:** Displays the current volume size when editing only. This value will not be displayed for a new volume.

NOTE: The **Location**, **Maximum Volume Size**, and **Path** boxes are available only when adding a new volume.

5. Select **Read only** check box if you want to prevent deletion of a volume.
6. Select **Closed** check box to prevent further writing and copying operations to this volume.


NOTE: Storage Volume is Assigned To|Copy # : This list contains a storage group with an associated copy number. This is an information box only. The contents of this box cannot be edited.

7. To save a new storage volume, click **Save**.
If the operation is completed successfully, the system saves the new storage volume to the database and displays the updated **Volumes** page.
8. To clear the recent changes, click **Clear**.
9. To cancel the operation and return to the **Volumes** list without saving data, click **Cancel**. Keep in mind that no changes will be saved.

Assigning Storage Volumes to Storage Groups

After [adding a storage volume](#) you can assign it to a [storage group](#). If no storage groups exist, you will need to [create one](#) and then add the storage volume to it.


To assign a storage volume to a storage group

1. On the Navigation Tree, click **Report Warehouse**, then click **Storage** and select **Storage Groups**.
2. Click the name of a storage group you want to add a volume to or click anywhere on its row and then click .
3. Drag a storage volume from the **Available Storage Volumes** pane to the **Assigned Storage Volumes|Copy#** pane.
4. Under the **Assigned Storage Volumes | Copy #**, select either **#1** or **#2** to specify a [copy](#) number for the volume.
5. To assign the volume to the group, click **Save**.

Editing a Storage Volume

To edit a storage volume


1. On the Navigation Tree, click **Report Warehouse**, then click **Storage** and select **Storage Volumes**.

2. On the Volumes page, click the name of the storage volume you want to edit or click anywhere on its row, and then click .
The **Storage Volume** page appears. For details about how to change its items refer to [Adding a Storage Volume](#).
3. Make the necessary changes and click **Save**.
The system saves the modified storage volume to the database and displays the updated **Volumes** page.

Deleting a Storage Volume

If you no longer need a storage volume, you can delete it. Before you can delete a volume, however, you must remove all data from it. Volumes that contain any data cannot be deleted. In addition, if the volume you want to delete is the only volume assigned to a storage group, you will not be able to delete it because a storage group cannot exist unless a storage volume is assigned to it.

To delete a storage volume

1. On the Navigation Tree, click **Report Warehouse**, then click **Storage** and select **Storage Volumes**.
2. Click  at the end of the row with the storage volume you want to delete. A dialog box will appear.
3. Click **Delete** to delete the storage volume from the list.

NOTE: You cannot delete a storage volume, if it contains data files.

Storage Groups

A [storage group](#) is a logical storage location for reports filed into the Monarch Server system. Each storage group may include several [storage volumes](#).

All the storage groups used in the system are listed on the Storage Groups page. To display this page, click **Report Warehouse** on the Navigation Tree, then click **Storage** and select **Storage Groups**.

Use **Storage Groups** page to [add](#), [edit](#), or [remove](#) a storage group.

The page displays a storage group name, the maximum sub-volume size and the count of existing sub-volumes for each storage group on the list.


Adding a Storage Group

When adding a storage group, you need to specify the maximum size (in megabytes or gigabytes) for any sub-volumes that are subsequently assigned to it. You also need to [assign at least one storage volume](#) to the storage group (a storage group must contain at least one volume). If no storage volumes exist, you need to [create](#) one before you can add a storage group to the system.

You also need to specify a [copy](#) number for the volume. Before specifying this information, you should determine what device type will be used for archiving documents. The media size must be accounted for when defining the sub-volume size.

You should also take into account when the media is to be recorded, and whether it is to be recorded over multiple sessions (requiring a dedicated device) or all at once (for backup).

To add a storage group

1. On the Navigation Tree, click **Report Warehouse**, then click **Storage** and select **Storage Groups**.
2. Click  on the **Storage Groups** page.
3. **Storage Group Name:** Enter a unique name of a new storage group.
4. **Description:** Enter any text defining the storage group. This step is optional.
5. **Maximum Sub-Volume Size:** Enter the maximum size of any sub-volumes measured in megabytes or gigabytes.
 - The size should be no greater than 80% of the media or device size that will serve as the smallest archive storage for the reports contained in this storage group. For example, if your selected archive media is CD-ROM, which has a storage capacity of 650 Megabytes, you would enter 520 Megabytes in this box.
 - E-mail notifications can be configured to alert administrators when a storage volume is running out of space. The notification will be sent when the available free space of a volume is less than 2 x Storage Group size. See [System Notifications](#) for additional instructions.

NOTE: You cannot change the maximum sub-volume size for an existing storage group.


6. **Force sub-volume promotion:** Select this check box to force sub-volume promotion after a specified number of files. When the number of files in the current (active) sub-volume reaches the specified value, this sub-volume will be forced to close and a new active sub-volume will be created automatically. The number of files can be configured in the Monarch Server properties configuration file. The default value is 10000. It is recommended to select this option to ensure proper performance.
7. **Number of Sub-Volumes:** Displays the number of existing sub-volumes for a storage group. This field is empty for a new storage group.
8. **Available Storage Volumes:** Displays the available storage volumes, created earlier by an administrator. To assign a storage volume to a storage group, drag it from the **Available Storage Volumes** pane to the **Assigned Storage Volumes | Copy#** pane.
9. **Assigned Storage Volumes | Copy#:** Displays the assigned storage volumes with the associated copy number. These storage volumes will be included in the current storage group. Include at least one storage volume of the **First Copy**. You can assign only volumes, whose size is greater or equal to the **Maximum Sub-Volume Size** value. To remove a storage volume from the storage group, drag it to the left pane. To change a copy number for a volume, select either **#1** or **#2**.
10. To save a new storage group, click **Save**.
If the operation is completed successfully, the system saves the new storage group to the database and displays the updated **Storage Groups** page.
11. To clear the recent changes, click **Clear**.

12. To cancel the operation and return to the **Storage Groups** page without saving data, click **Cancel**. Keep in mind that no changes will be saved.

Assigning Storage Volumes to Storage Groups


After [adding a storage volume](#) you can assign it to a [storage group](#). If no storage groups exist, you will need to [create one](#) and then add the storage volume to it.

To assign a storage volume to a storage group

1. On the Navigation Tree, click **Report Warehouse**, then click **Storage** and select **Storage Groups**.
2. Click the name of a storage group you want to add a volume to or click anywhere on its row and then click .
3. Drag a storage volume from the **Available Storage Volumes** pane to the **Assigned Storage Volumes|Copy#** pane.
4. Under the **Assigned Storage Volumes | Copy #**, select either **#1** or **#2** to specify a [copy](#) number for the volume.
5. To assign the volume to the group, click **Save**.

Editing a Storage Group

To edit a storage group


1. On the Navigation Tree, click **Report Warehouse**, then click **Storage** and select **Storage Groups**.
2. On the Storage Groups page, click the name of the storage group you want to edit or click anywhere on its row, and then click .
The Storage Group page appears. For details about how to change its items, refer to [Adding a Storage Group](#).
3. You can [promote a sub-volume](#) for the current storage group. To do this, select the **Sub-Volume Information** tab, and click **Promote**.

NOTE: This tab displays information about the storage group's sub-volumes and is available only for existing storage groups. (For details, see [Viewing Information On a Sub-Volume](#).)

4. Make the necessary changes and click **Save**. The system saves the modified storage group to the database and displays the updated Storage Groups page.

Deleting a Storage Group

To delete a storage group

1. On the Navigation Tree, click **Report Warehouse**, then click **Storage** and select **Storage Groups**.
2. Click  at the end of the row with the storage group you want to delete. A dialog box will appear.

3. Click **Delete** to remove the storage group from the list.

Sub-Volumes

A sub-volume, like a [storage volume](#), is a physical location on a server, to which reports can be archived and from which documents can be retrieved. A sub-volume is a subdivision (that is, a subdirectory) of a storage volume.

When you first [archive reports](#) into a volume, the reports are automatically stored in the first sub-volume. (Initially, volumes contain only one sub-volume.) If you [promote the sub-volume](#), or if the sub-volume is automatically promoted — for example, when the maximum sub-volume size (specified on the [Storage Group page](#)) is reached — the first sub-volume is closed and a second sub-volume is opened. Reports will be archived to this second sub-volume until it is promoted too.

A new sub-volume may be created on any volume of the same type (**First Copy** or **Second Copy**), which is contained in the storage group. The system selects the first volume, which has enough space for creating another full sub-volume.

Volumes can contain an unlimited number of sub-volumes. The only limiting parameter is the volume size (specified on the [Storage Volume page](#) when adding a volume). Once the specified maximum volume size is reached, no additional sub-volumes can be opened on that volume.

A storage volume may be [closed](#) by an administrator to prevent further writing.


You can [view detailed information](#) about the storage group's sub-volumes on the **Sub-Volumes Information** tab.

Promoting a Sub-Volume

A sub-volume is automatically promoted (that is, closed) when it reaches its maximum allowed size. (This maximum size is specified on the Storage Group page, when the [storage group](#) is [created](#).) Once a sub-volume is closed, you can no longer archive reports into it. Sub-volumes are numbered sequentially, so each time a sub-volume is promoted, the next sub-volume in the sequence begins. A sub-volume cannot be backed up or removed from the system until it has been promoted.


There may be situations where you would like to force MSAdmin to begin a new sub-volume even though the current one is not completely full. For example, you may want to keep all reports for a particular month on a single sub-volume. Or you may not want to start a new fiscal year on a sub-volume that contains information from the previous year. In such cases, you can manually promote a sub-volume and begin a new one.

To manually promote a sub-volume

1. On the Navigation Tree, click **Report Warehouse**, then click **Storage** and select **Storage Groups**.
2. On the Storage Groups page, click the name of the storage group that contains the sub-volume to be promoted or click anywhere on its row, and then click .
3. Select the **Sub-Volumes Information** tab at the top of the page. This tab lists all sub-volumes of a storage group and provides information about their status (i.e., active or closed), number of files, etc.
4. Click **Promote**. A dialog box appears, asking you to confirm that you want to promote the sub-volume.
5. Click **OK** to promote the sub-volume (or click **Cancel** to cancel the promotion).

Viewing Information On a Sub-Volume

To view detailed information about the sub-volume(s) of the selected storage group

1. On the Navigation Tree, click **Report Warehouse**, then click **Storage** and select **Storage Groups**.
2. Click the name of the storage group that contains the sub-volume or click anywhere on its row, and then click .
3. Select the **Sub-Volumes Information** tab at the top of the page.

The Volume Information window provides the following information:

- **State:** Displays the current status of the sub-volume, e.g., whether it is active or closed.

NOTE: It is not possible to archive data to closed sub-volumes.

- **Number of files:** Displays the number of files in a sub-volume.
- **First Copy volume:** Displays the name(s) of a **First Copy** volume(s).
- **Size on first copy:** Displays the size (in bytes) of data stored in a **First Copy** volume.
- **Second copy volume:** Displays the name(s) of a **Second Copy** volume(s).
- **Size on second copy:** Displays the size (in bytes) of the data stored in a **Second Copy** volume.
- **Promote:** Click to promote the sub-volume. A dialog box appears. Click **OK** to promote the sub-volume. **Note:** When you promote a sub-volume, you close it. Data cannot be added to closed sub-volumes.
- **Cancel:** Click to cancel the promotion.

Maintenance Tasks

A maintenance task is the operation of copying, moving, and deleting files to maintain document storage. You need to assign maintenance tasks to a [maintenance process](#) in order to execute them.

A maintenance task operates on the document files basis (not document object basis).

All maintenance tasks used in the system are listed on the Maintenance Tasks page. To display this page, click **Report Warehouse** on the Navigation Tree, then click **Maintenance** and select **Maintenance Tasks**.

Use this page to [add](#), [edit](#), or [remove](#) a maintenance task from the list.

The following types of maintenance tasks are available on the [Maintenance Task page](#):



- **Block:** Blocks certain reports to deny user access. You can also block reports of a document type by clicking on the Report Instances tab.
- **Change DTA_indices:** Changes indexes for pre-mining models.
- **Copy 1 to 2:** Copies data from First Copy volumes to Second Copy volumes.
- **Copy 2 to 1:** Copies data from Second Copy volumes to First Copy volumes.
- **Delete:** Deletes files from the database and from First Copy volumes. However, the files remain on a Second Copy volume, if any.
- **Drop DTA table(s):** Removes pre-mined data from the MS database including tables for the reports matching the task criteria.
- **Drop Empty Index Values Tables:** Removes tables with empty index values, to speed up the partition creation. This task is recommended if you update a database created in the previous version of the application.
- **Drop Pre-Mined Data:** Removes pre-mined data from the DTA tables in the MS database for the reports matching the task criteria.
- **Full Text Search:** Searches for reports containing the specified text.
- **Move:** Moves data from First Copy volumes to Second Copy volumes. The reverse moving task (from Second Copy to First Copy) is not supported.
- **Pre-Mined Data:** Pre-extracts table data from reports during a filing process (as part of archiving report data), and puts it into the MS database.
- **Purge:** Files are removed from First Copy volumes only if they exist on Second Copy volumes. The system does not remove files from the database and they are available for viewing and searching as usual.
- **Re-index:** Recreates indexes for documents and is used when one of the Monarch models is changed.
- **Rename:** Renames reports and documents. The name model is set in the Auto-Name and Report Name options of the appropriate Document Type.
- **Restore from Archive:** Restores archived-only reports back into working storage where users can view and mine them.

After configuring a maintenance task, in order to run it, you need to configure a maintenance process and [assign the task to it](#). Then you may either specify the execution frequency for the maintenance process, or execute it manually. When the maintenance process runs, the assigned maintenance task is executed.

Adding a Maintenance Task


With maintenance tasks you can copy, move, delete, purge and re-index data. To run a maintenance task, you [create a maintenance process](#) and [assign the task to it](#) (or you can assign the task to an already existing process). When the maintenance process is executed, it will run the task(s) assigned to it.

To add a maintenance task

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page.
3. **Maintenance Task Name:** Enter the name of a new maintenance task.
4. **Description:** Optionally, enter any text defining the maintenance task.
5. **Task Priority:** If there are several tasks in queue, the system will first handle those with higher priority. Select priority from the following options: **Lowest, Below Normal, Normal, Above Normal, Highest**.
6. **Task Type:** Specify the type of a task. This list contains the following types:
 - **Block** — Blocks certain reports to deny user access. You can also block reports of a document type by clicking  on the [Report Instances](#) tab.
 - [Change DTA indices](#): Changes indexes for premining models.
 - [Copy 1 to 2](#): Copies data from First Copy volumes to Second Copy volumes.
 - [Copy 2 to 1](#): Copies data from Second Copy volumes to First Copy volumes.
 - [Delete](#): Deletes files from the database and from First Copy volumes. However, the files remain on a Second Copy volume, if any.
 - [Drop DTA table\(s\)](#): Removes pre-mined data from the MS database including tables for the reports matching the task criteria.
 - [Drop Empty Index Values Tables](#): Removes tables with empty index values, to speed up the partition creation. This task is recommended if you update a database created in the previous version of the application.
 - [Drop Pre-Mined Data](#): Removes pre-mined data from the DTA tables in the MS database for the reports matching the task criteria.
 - [Full Text Search](#): Searches for reports containing the specified text.
 - [Move](#): Moves data from First Copy volumes to Second Copy volumes. The reverse moving task (from Second Copy to First Copy) is not supported.
 - [Pre-Mine Data](#): Pre-extracts table data from reports during a filing process (as part of archiving report data), and puts it into the MS database.

- **Purge:** Files are removed from First Copy volumes only if they exist on Second Copy volumes. The system does not remove files from the database and they are available for viewing and searching as usual.
 - **Re-index:** Recreates indexes for documents and is used when one of the Monarch models is changed.
 - **Rename:** Renames reports and documents. The name model is set in the Auto-Name and Report Name options of the appropriate Document Type.
 - **Restore from Archive:** Restores archived-only reports back into working storage where users can view and mine them.
 - **Search Text:** The following option becomes available if you select the Full Text Search task type. Type here the text you want to find in the report.
7. **Max Result Count** (0: unlimited): The following option becomes available if you select the Full Text Search task type. Limit the number of displayed reports. If you enter 0, all reports are displayed.
 8. **Whole words only** check box: The following option becomes available if you select the Full Text Search task type. Select this check box to search for the whole words only.
 9. **Case sensitive** check box: The following option becomes available if you select the Full Text Search task type. Select this check box to distinguish between upper and lowercase letters while searching.

Criteria section


1. **Based on:** Select one of the following options:
 - **Report/Document Dates:** If you select this option, the current task will process reports/documents with creation dates specified in the Date Range field.
 - **Filing Dates:** If you select this option, the current task will process reports/documents with filing dates specified in the Date Range field.
2. **Date Range:** If you select this option, the current task will process reports with dates specified in the From ... To boxes. Click  to [use the Calendar](#).
3. **Document Age in days:** If you select this option, the current task will process reports with creation dates specified in the Younger than ... Older than boxes.
4. **Except:** If you select this option, the current task will process all reports in the Document Types pane with the exception of several latest reports number of which is specified in the latest box in conformity with the defined Based on parameters, namely Report/Document Dates or Filing Dates.
5. **Count of Reports/Files:** Specifies that the current task will process reports defined by the first/last count of reports you set in the **First** or **Last** boxes. The reports will be sorted by a document date.
 - **For all selected document types:** applies values from Count of Reports/Files fields to all selected document types.
 - **For each document type selected:** applies values from Count of Reports/Files fields to a selected document type only.

6. **Containing Index Value:** This option becomes available after you select a document group in the section below, and assign document types to the task (provided that index fields of the document type are mapped with the corresponding keyword types). Select this option, if you want to specify an index value as one of the maintenance criteria. When you select it, the Maintenance Criteria box to the right becomes available. Click **Maintenance Criteria** to expand a hidden section. Select an index field from the list, select an operator from the list, and type a keyword value. You can lookup available keywords by clicking the **Keyword Lookup** button. Click Save and the new maintenance criteria will be displayed in a dimmed box.

Document Types section

Click this header to expand a section with the following items:

1. **Document Groups:** Allows you to select a document group from the list. After selection, the system displays all document types for this group, used by the current task, in the Document Types pane.
2. **Document Types:** Displays all document types for the document group, selected from the Document Groups list. These are used by the current task.
3. **Filter by:** Enter part of the name of a document type you want to find, and click **Apply**.
4. **Assigned Document Types:** In the Document Types pane, select the document types that you wish to assign to the task, and drag them to the Assigned Document Types pane.

NOTE: The  icon allows you to remove assigned document types from the list.

Re-index options

NOTE: These options become available if you select the Re-index task type.

1. **Perform re-pagination:** Allows to re-paginate the volume data. Becomes available on Re-index task selection.
2. **Remove Deleted Documents:** Allows to remove deleted documents during Re-index task.
3. **Remove Deleted Documents Only:** Re-Index is not performed, only deleted documents are removed.
4. **Use Index Defaults:** Allows use of default document indexes, including original file name element indexing. This option is only visible when using the Re-index Maintenance Task type.
5. **Indexed Fields:** This button appears on Change DTA_indices task selection. It calls the Choose Indexed Fields dialog box.

Redaction options

NOTE: These options become available only if a redaction license is enabled in MS.

1. **Store reports redacted:** Select this option to allow storage reports to be stored with redaction. In this case reports are stored in the redacted format in storage volume. (**NOTE:** This option becomes available only if you select the Restore from Archive task type.)
2. **Store mining data redacted:** Select this option to allow pre-mined data to be stored with redaction. (**NOTE:** This option becomes available only if you select the [Pre-Mine Data](#) task type.)

Delete options

NOTE: These options become available if you select the Delete task type.



1. **Delete Working Reports:** Select this option to delete only working reports.
2. **Delete Report Archives:** Select this option to delete report archives.
3. **Delete All:** Select this option to delete all reports.
4. To save a new maintenance task, click **Save**. If the operation is completed successfully, the system saves the a new maintenance task to the database and displays the updated Maintenance Tasks page.
5. To clear the recent changes, click **Clear**.
6. To cancel the operation and return to the Maintenance Tasks page without saving data, click **Cancel**. Keep in mind that no changes will be saved.

Copying Data from a First Copy Volume to a Second Copy Volume

Once the demand for documents in a **First Copy** volume decreases sufficiently, you may want to copy or move the data to a **Second Copy** volume.

NOTE: Before copying data from a **First Copy** volume to a **Second Copy** volume, make sure that it is error-free, because once it is archived in a **Second Copy** volume, it cannot be deleted from the system.

To copy data from a First Copy volume to a Second Copy volume



1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page. The **Maintenance Task** page appears.
3. [Configure a maintenance task](#), making sure to select the **Copy 1 to 2** option from the **Task Type** drop-down list.
4. Click **Save**.
5. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
6. Click  on the **Maintenance Processes** page.
7. [Configure a maintenance process](#), making sure to assign the maintenance task you just created to it.

8. [Schedule the process to run](#), or run it manually by clicking **Run Now** on the **Maintenance Process** page. When the process is executed, the maintenance task runs and the data is copied from the **First Copy** volume to the **Second Copy** volume.

Copying Data from a Second Copy Volume to a First Copy Volume

Sometimes you need to copy data from a **Second Copy** volume to a **First Copy** volume. You can configure a maintenance task to perform this operation in MSAdmin.

To copy data from Second Copy to First Copy volume



1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page. The Maintenance Task page appears.
3. [Configure a maintenance task](#), making sure to select the **Copy 2 to 1** option from the **Task Type** drop-down list.
4. Click **Save**.
5. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
6. Click  on the Maintenance Processes page. The Maintenance Process page appears.
7. [Configure a maintenance process](#), making sure to assign the maintenance task you just created to it.
8. [Schedule the process to run](#), or run it manually by clicking **Run Now** on the Maintenance Process page.

When the process is executed, the maintenance task runs and the data is copied from the **Second Copy** volume to the **First Copy** volume.

Moving Data from a First Copy Volume to a Second Copy Volume

You can move data from a **First Copy** volume to a **Second Copy** volume. Before doing so, however, make sure that it is error-free, because once it is archived in a **Second Copy** volume, it cannot be deleted from the system.

To move data from a First Copy volume to a Second Copy volume

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page. The Maintenance Task page appears.
3. [Configure a maintenance task](#), making sure to select the **Move** option from the **Task Type** drop-down list.
4. Click **Save**.
5. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
6. Click  on the Maintenance Processes page. The Maintenance Process page appears.
7. [Configure a maintenance process](#), making sure to assign the maintenance task you just created to it.



8. [Schedule the process to run](#), or run it manually by clicking **Run Now** on the Maintenance Process page.

When the process is executed, the maintenance task runs and the data is moved from the **First Copy** volume to the **Second Copy** volume.

Deleting Data from a First Copy Volume

You can delete data from a **First Copy** volume, if the data it contains already resides on a **Second Copy** volume. (A **First Copy** volume cannot be deleted unless the data it contains also resides on a **Second Copy** volume.) If the data doesn't yet reside on a **Second Copy** volume, you must first [move](#) or [copy](#) it to the **Second Copy** volume.

To delete data from a First Copy volume

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page. The Maintenance Task page appears.
3. [Configure a maintenance task](#), making sure to select the **Delete** option from the **Task Type** drop-down list.
4. Click **Save**.
5. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
6. Click  on the Maintenance Processes page. The Maintenance Process page appears.
7. [Configure a maintenance process](#), making sure to assign the maintenance task you just created to it.
8. [Schedule the process to run](#), or run it manually by clicking **Run Now** on the Maintenance Process page.


When the process is executed, the maintenance task runs and the data deleted from the **First Copy** volume.


Purging a First Copy Volume

When you purge a **First Copy** volume, the data it contains is removed. Only **First Copy** volumes can be purged (**Second Copy** volumes cannot be purged), and you can only purge a **First Copy** volume if the data it contains also resides on a **Second Copy** volume. (See [Copying Data from a First Copy Volume to a Second Copy Volume](#) for related information.)

NOTE: Purging a **First Copy** volume does not remove its files from the database. They are available for viewing and searching as usual.

To purge a First Copy volume

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page. The Maintenance Task page appears.
3. [Configure a maintenance task](#), making sure to select the **Purge** option from the **Task Type** drop-down list.



4. Click **Save**.
5. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
6. Click  on the Maintenance Processes page. The Maintenance Process page appears.
7. [Configure a maintenance process](#), making sure to assign the maintenance task you just created to it.
8. [Schedule the process to run](#), or run it manually by clicking **Run Now** on the Maintenance Process page.

When the process is executed, the maintenance task runs and the data purged from the **First Copy** volume.

Re-indexing Archived Documents

Sometimes you need to re-index documents stored in the system (for example, when you change the [model](#) or [autoname string](#) of a [document type](#)). To re-index archived documents, you need to configure and run a re-index [maintenance task](#).

To re-index archived documents


1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page. The Maintenance Task page appears.
3. [Configure a maintenance task](#), making sure to select the **Re-index** option from the **Task Type** drop-down list.
4. Click **Save**.
5. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
6. Click  on the Maintenance Processes page. The Maintenance Process page appears.
7. [Configure a maintenance process](#), making sure to assign the maintenance task you just created to it.
8. [Schedule the process to run](#), or run it manually by clicking **Run Now** on the Maintenance Process page.


When the process is executed, the maintenance task runs and the documents are re-indexed.

Pre-Mined Data Maintenance Task

The **Pre-Mined Data** maintenance task allows you to pre-extract table data from reports during a filing process (as part of archiving report data), and put it into the MS database, if the document type has a premining model assigned to it.

To pre-mine data

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page. The Maintenance Task page appears.
3. [Configure a maintenance task](#), making sure to select the **Pre-Mined Data** option from the **Task Type** drop-down list.
4. Click **Save**.



5. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
6. Click  on the Maintenance Processes page. The Maintenance Process page appears.
7. [Configure a maintenance process](#), making sure to assign the maintenance task you just created to it.
8. [Schedule the process to run](#), or run it manually by clicking **Run Now** on the Maintenance Process page.

When the process is executed, the maintenance task runs and the data is pre-mined.

Dropping Pre-Mined Data

The **Drop Pre-Mined Data** maintenance task allows to remove pre-mined data from the MS database. The archived documents become non pre-mined after running the task.

To drop pre-mined data


1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page. The Maintenance Task page appears.
3. [Configure a maintenance task](#), making sure to select the **Drop Pre-Mined Data** option from the **Task Type** drop-down list.
4. Click **Save**.
5. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
6. Click  on the Maintenance Processes page. The Maintenance Process page appears.
7. [Configure a maintenance process](#), making sure to assign the maintenance task you just created to it.
8. [Schedule the process to run](#), or run it manually by clicking **Run Now** on the Maintenance Process page.


When the process is executed, the maintenance task runs and the pre-mined data is removed.

Dropping DTA Tables

The **Drop DTA table(s)** maintenance task allows to remove pre-mined data from the MS database including tables for the reports matching the task criteria.

To drop DTA tables

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page. The Maintenance Task page appears.
3. [Configure a maintenance task](#), making sure to select the **Drop DTA table(s)** option from the **Task Type** drop-down list.



4. Click **Save**.
5. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
6. Click  on the Maintenance Processes page. The Maintenance Process page appears.
7. [Configure a maintenance process](#), making sure to assign the maintenance task you just created to it.
8. [Schedule the process to run](#), or run it manually by clicking **Run Now** on the Maintenance Process page.

When the process is executed, the maintenance task runs and all premined data including tables is removed from the database.

Drop Empty Index Values Tables

The **Drop Empty Index Values Tables** maintenance task allows to remove tables with empty index values, to speed up the partition creation. This task is recommended if you update a database created in the previous version of the application.

To drop tables with empty index values


1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page. The Maintenance Task page appears.
3. [Configure a maintenance task](#), making sure to select the **Drop Empty Index Values Tables** option from the **Task Type** drop-down list.
4. Click **Save**.
5. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
6. Click  on the Maintenance Processes page. The Maintenance Process page appears.
7. [Configure a maintenance process](#), making sure to assign the maintenance task you just created to it.
8. [Schedule the process to run](#), or run it manually by clicking **Run Now** on the Maintenance Process page.


When the process is executed, the maintenance task runs and all tables with empty index values are removed from the database.

Changing DTA Indices

The **Change DTA_indices** maintenance task allows to change indexes for a premining model.

To change indices

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page. The Maintenance Task page appears.



3. [Configure a maintenance task](#), making sure to select the **Change DTA_indices** option from the **Task Type** drop-down list.
4. Click **Save**.
5. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
6. Click  on the Maintenance Processes page. The Maintenance Process page appears.
7. [Configure a maintenance process](#), making sure to assign the maintenance task you just created to it.
8. [Schedule the process to run](#), or run it manually by clicking **Run Now** on the Maintenance Process page.

When the process is executed, the maintenance task runs and the indexes for the pre-mining model are changed.

Full Text Search Task

The **Full Text Search** maintenance task allows to search for reports containing the specified text.

To perform Full Text Search

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click  on the Maintenance Tasks page. The Maintenance Task page appears.
3. [Configure a maintenance task](#), making sure to select the **Full Text Search** option from the **Task Type** drop-down list.
4. Click **Save**.
5. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
6. Click  on the Maintenance Processes page. The Maintenance Process page appears.
7. [Configure a maintenance process](#), making sure to assign the maintenance task you just created to it.
8. [Schedule the process to run](#), or run it manually by clicking **Run Now** on the Maintenance Process page.


When the process is executed, the maintenance task runs and a link to the reports containing the specified text is displayed in the Full Text Search list.

Assigning Maintenance Tasks to Maintenance Processes

To execute a [maintenance task](#), you need to assign it to a [maintenance process](#). The process runs and executes the task at a certain time, according to the scheduled execution frequency.

Note: You can [configure a new maintenance process](#) and add the maintenance task to it, or you can add the task to an existing process.

To assign a maintenance task to a maintenance process

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**. The Maintenance Processes page appears.
2. On the **Maintenance Processes** page, click the name of the maintenance process you want to add a maintenance task to or click anywhere on its row, and then click .
3. From the **Available Tasks** pane, drag the appropriate task to the **Assigned Tasks** pane.
4. Set the process [execution frequency](#).
5. Click **Save**.

The process will execute the maintenance task according to the scheduled execution frequency.

NOTE: If you prefer, you can execute the process right away by clicking the **Run Now** button.

Running a Maintenance Task

When you finish [configuring](#) a [maintenance task](#), you can run it to perform the specified maintenance action.

To run a maintenance task

1. [Configure](#) a [maintenance process](#).


NOTE: If the desired maintenance process already exists, skip down to step 2.

2. [Assign the maintenance task](#) to it.
3. [Run the maintenance process](#). When the process is executed, the tasks assigned to it will be run as well.

Editing a Maintenance Task

[Maintenance Tasks](#) can be edited via the Maintenance Task page.

To edit a maintenance task

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**. The Maintenance Tasks page appears.
2. Click the name of the maintenance task you want to edit or click anywhere on its row, and then click . The **Maintenance Task** page appears. For details about how to change its items refer to [Adding a Maintenance Task](#).
3. Make the necessary changes and click **Save**. The system saves the modified maintenance task to the database and displays the updated **Maintenance Tasks** page, if the operation is completed successfully.

Deleting a Maintenance Task

You can delete a [maintenance task](#) if you no longer need it.

Note: If the maintenance task you want to delete is the only task assigned to a process, that process will be deleted as well, since an empty process (that is, a process that contains no tasks) cannot be saved.

To delete a maintenance task

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Tasks**.
2. Click **X** at the end of the row with the maintenance task you want to delete.
3. Click **Delete** to delete the maintenance task from the list.

Log Clearance Tasks

A log clearance task deletes records of a specified type from the Logs, and Schedule Jobs, Pump Job Logs, and Visual Process Logs tables of the Monarch Server database. Use these tasks to delete old (or unnecessary) events from the database. They help to use database space economically.

To display the **Log Clearance Tasks** page, click **Report Warehouse** on the Navigation Tree, then click **Maintenance** and select **Log Clearance Tasks**. Use this page to [add](#), [edit](#), or [delete](#) log clearance tasks.

The following Event Source types of Logs table of log clearance tasks are available:

- **Audit:** Select this option to delete audit events.
- **Custodian:** Select this option to delete custodian events.
- **Entity Audit:** Select this option to delete entity audit events.
- **Filing:** Select this option to delete filing events.
- **Maintenance:** Select this option to delete maintenance events.
- **Pumping:** Select this option to delete pumping events.
- **Pumping Job Log:** Select this option to delete pumping job log events.
- **Security:** Select this option to delete security events.
- **System:** Select this option to delete system events.

The following log statuses of the Pump Job Logs table of log clearance tasks are available:

- **Cancelled:** Select this option to delete cancelled job log.
- **Completed:** Select this option to delete completed job log.
- **Failed:** Select this option to delete failed job log.



The following job/log statuses of Schedules Jobs and Visual Process (for Automator) Logs table of log clearance tasks are available:

- **Completed:** Select this option to delete completed job log.
- **Failed:** Select this option to delete failed job log.

NOTE: Instead of deleting pump job log data, the log clearance task for pump jobs will mark pump jobs as deleted. [Custodian Schedule](#) should be used to completely delete pump jobs from the database.

Adding a Log Clearance Task


To add a log clearance task

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Log Clearance Tasks**.
2. Click  on the **Log Clearance Tasks** page.
3. **Maintenance Task Name:** Enter the name of a new log clearance task.
4. **Description:** Optionally, enter any text defining the clearance task.
5. **Date:** Specify the dates of events to be deleted by the current task in the **From ... To** boxes. Click  to [use the Calendar](#).
6. **Please, select Tables for clearing:** Specify the table to delete records from.
7. Select the event types or the job log statuses to delete from the specified table.
8. **Select All:** Click this button to select all options.
9. **Select None:** Click this button to clear the selection.
10. To save a new log clearance task, click **Save**.
If the operation is completed successfully, the system saves the a new task to the database and displays the updated **Log Clearance Tasks** page.
11. To clear the recent changes, click **Clear**.
12. To cancel the operation and return to the **Log Clearance Tasks** page without saving data, click **Cancel**. Keep in mind that no changes will be saved.

Editing a Log Clearance Task


To edit a log clearance task

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Log Clearance Tasks**. The Log Clearance Tasks page appears.

2. Click the name of the log clearance task you want to edit or click anywhere on its row, and then click . The Log Clearance Task page appears. For details about how to change its items refer to [Adding a Log Clearance Task](#).
3. Make the necessary changes and click **Save**. The system saves the modified log clearance task to the database and displays the updated **Log Clearance Tasks** page, if the operation is completed successfully.

Deleting a Log Clearance Task

To delete a log clearance task

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Log Clearance Tasks**.
2. Click  at the end of the row with the log clearance task you want to delete. A dialog box will appear.
3. Click **Delete** to delete the log clearance task from the list.

Running a Log Clearance Task

When you finish [configuring](#) a [log clearance task](#), you can run it to perform the specified action, in the same way as you assign a maintenance task.

To run a log clearance task

1. [Configure](#) a [maintenance process](#).

NOTE: If the desired maintenance process already exists, skip down to step 2.


2. Assign the log clearance task to the maintenance process, in the same way as you [assign a maintenance task](#).
3. [Run the maintenance process](#). When the process is executed, the tasks assigned to it will be run as well.

Maintenance Processes

A maintenance process defines the schedule of executing maintenance tasks and log clearance tasks. All maintenance processes used in the system are listed on the Maintenance Processes page.

To display the Maintenance Processes page, click **Report Warehouse** on the Navigation Tree, then click **Maintenance**, and select **Maintenance Processes**.



The list shows:

- Process name
- Run Now (click  to run the process immediately)

- Suspend status
- Last started date and time
- Last finished date and time
- Next execution date and time of the current process

Use the **Maintenance Processes** page to [add](#), [edit](#), or [delete](#) a maintenance process.

You can also:


- Suspend all processes, by clicking the **Suspend** button below the list.
- Resume all processes, by clicking the **Resume** button below the list.
- Run a process immediately, by clicking the  icon next to its name.
- Update the status of maintenance processes by clicking the  icon, below the list.

With maintenance processes, you can schedule the execution of [maintenance tasks](#) to copy, move, delete, purge or re-index data. When a maintenance process runs, it executes all maintenance tasks and log clearance tasks that are assigned to it. Maintenance processes can be [run](#) on a scheduled or manual basis.

Adding a Maintenance Process

[Maintenance processes](#) are used to schedule and run [maintenance tasks](#) and [log clearance tasks](#). When a maintenance process runs, it executes all maintenance tasks that are assigned to it.

To add a maintenance process

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
2. Click  on the **Maintenance Processes** page. The Maintenance Process page appears.
3. **Name:** Enter the name of a new process.
4. **Number of concurrent tasks:** Enter the number of concurrent tasks. Enter **1**, if you want several tasks to be executed sequentially. Enter the actual number of tasks, if you want them to be executed simultaneously.
5. **Suspended:** Select this option to suspend the current process.
6. **Available Tasks:** Displays all available tasks, from which you can select tasks to assign to the current process. To do this, drag a task from the left pane to the right pane. The tasks are carried out in the order they appear on the list. You can change the order by dragging items up or down.
7. **Filter by:** The filter for the **Available Tasks** list. Type (part of) a task name, and click **Apply** to filter the list.
8. **Assigned Tasks:** The tasks in this pane will be assigned to the current process. To remove a task from this pane, drag it back to the left pane.
9. **Execution Frequency:** These options allow you to set the periodicity of launching the current process. For more information, see [Execution Frequency](#).

10. To save a new process, click **Save**.
The system saves the new process to the database and displays the updated Maintenance Processes page, if the operation is completed successfully.
11. To allow an administrator to launch the process immediately (subject to internal processing queues) and save the schedule in the database with the **Run Once** scheduling type and the current date as a date to run, click **Run Now**.
12. To clear the recent changes, click **Clear**.
13. To cancel the operation and return to the **Maintenance Processes** page without saving data, click **Cancel**. Keep in mind that no changes will be saved.

Execution Frequency

Execution frequency (or run time) specifies both how often a process will run (for example, once, hourly, daily, etc.) and at what time it will run. You specify execution frequency when configuring a [filing](#) or [maintenance process](#).

The options in the Execution Frequency pane allow you to set periodicity of launching the current process. An administrator can set the following options:

- **One Time**: Select this option if you want to launch the current process only once.
 - **At**: Set the time when the current process will be launched following the **HH:MM** format.
 - **on (mm/dd/yyyy)**: Set the date when the current process will be launched. Upon clicking the field, the [calendar](#) appears.
- **Hourly**: Select this option if you want to launch the current process at the specified hour or hours.
 - **At... minute(s) of Every hour**: Set the time when the current process will be launched following the **MM** format.
- **Daily**: Select this option if you want to launch the current process in a specified number of days.
 - **Every ... day(s)**: Set the number of days after which the current process will recur.
 - **At**: Set the time when the current process will be launched following the **HH:MM** format.
- **Weekly**: Select this option if you want to launch the current process weekly.
 - **Recur every**: Set the number of weeks after which the current process will recur.
 - Select corresponding days of the week.
 - **At**: Set the time when the current process will be launched following the **HH:MM** format.
- **Monthly**: Select this option if you want to launch the current process monthly.
 - Select the day when to perform the process.
 - If you select **Day**, set the number of days in the box.
 - If you select **Business Day**, set the business day(s) on which the current process will be launched. Business days are weekdays (i.e., Monday-Friday), unless an exception date is defined. The definition of [Exception Dates](#) can be used for holidays. When an exception day is found, the count skips to the next working day.

The process will be executed immediately after exception date/time is over. Otherwise, the process will only run on the set schedule, with the exception of the Business Day schedule, wherein an "All day" Exception Date will be excluded in the day count.

Examples:

To run the process on the 6th business day of the month, enter "6" in the field.

To run the process on the 1st business day of the month, then again on the 16th to the 20th business day of the month, enter "1, 16-20" in the field.

NOTE: It is possible to schedule the process on a range of working days at a given time, e.g., "5"; "1,2,22,23"; "1-3, 21-23"; "-1"; "-3--1"; and "-2-3, 5, 10." A negative number denotes the number of days prior to the month selected, e.g., "business day -1" of October 2019 would be September 30, 2019 (provided it is a working day). Exception Dates must skip count to the next previous working day.


- If you select **The...**, select First, Second, Third, Fourth or Last from the first drop-down list and the day of the week from the second drop-down list.
- Select the month on which to perform the action.
 - If you select the **of every n Month** option, set the number of month in the box.
 - If you select the **of selected months** option, select the appropriate check box referring to the desired month.
- In the **At** check box set the time when the current process will be launched following the **HH:MM** format.

Assigning Maintenance Tasks to Maintenance Processes

To execute a [maintenance task](#), you need to assign it to a [maintenance process](#). The process runs and executes the task at a certain time, according to the scheduled execution frequency.

NOTE: You can [configure a new maintenance process](#) and add the maintenance task to it, or you can add the task to an existing process.

To assign a maintenance task to a maintenance process

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance**, then select **Maintenance Processes**.
2. Click the name of the maintenance process you want to add the maintenance task to or clicking anywhere on its row, and then click .
3. From the **Available Tasks** pane, drag the necessary task to the **Assigned Tasks** pane.
4. Set the process [execution frequency](#).
5. Click **Save**.


The process will execute the maintenance task according to the scheduled execution frequency.

NOTE: If you prefer, you can execute the process right away by clicking the **Run Now** button.

Running a Maintenance Process

When a [maintenance process](#) runs, it executes all [maintenance tasks](#) assigned to it. When a [maintenance process](#) runs, it executes all [log clearance tasks](#) assigned to it. A maintenance process can be run in two ways:

Manually: To run a maintenance process manually

1. Click the  icon next to its name on the [Maintenance Processes page](#) or click the **Run Now** button at the bottom of the [Maintenance Process page](#). You can do this immediately after configuring a new process, or you can manually run a previously configured process:
 - a. click **Report Warehouse**, then click **Maintenance Management** on the Navigation Tree and select **Maintenance Processes**.
 - b. Click the name of the process you want to run.
 - c. Click the **Run Now** button at the bottom of the Maintenance Process page.

NOTE: When you click the **Run Now** button, there may be a brief delay before the process actually runs. This is likely due to a time discrepancy between the server's clock and the clock on a local machine. Processes are run according to the time of the server's clock.


Scheduled: To execute a maintenance process via a scheduled runtime

1. [Specify the execution frequency](#) for it on the **Maintenance Process** page, then click **Save**. The process will be executed according to the scheduled execution frequency.

Editing a Maintenance Process

[Maintenance Processes](#) can be edited via the Maintenance Process page.


To edit a maintenance process

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
2. Click the name of the maintenance process you want to edit or click anywhere on the row, and then click . The Maintenance Process page appears. For details about how to change its items refer to [Adding a Maintenance Process](#).
3. Make the necessary changes and click **Save**. The system saves the modified process to the database and displays the updated Maintenance Processes page.

Deleting a Maintenance Process

If you no longer need a [maintenance process](#), you can delete it.

To delete a maintenance process

1. On the Navigation Tree, click **Report Warehouse**, then click **Maintenance** and select **Maintenance Processes**.
2. Click  at the end of the row with the maintenance process you want to delete.
3. Click **Delete** to delete the maintenance process from the list.

Full Text Search



All results of the maintenance full text search type tasks in the system are listed on the Full Text Search page.

To display the Full Text Search page, click **Report Warehouse** on the Navigation Tree, then click **Maintenance** and select **Full Text Search**.

The list shows:

- **Search Text:** The text you entered while [configuring a maintenance task](#).
- **Search Date:** The date when the search was fulfilled.
- **Task Name:** The name of the maintenance task.
- **Count:** A number of the results found.
- **Whole Words Only:** This field is marked if you selected the **Whole Words Only** check box while [configuring a maintenance task](#).
- **Case Sensitive:** This field is marked if you selected the **Case Sensitive** check box while [configuring a maintenance task](#).

You can also:

- Select the users to send notification to, by clicking the  icon.
- Delete the result, by clicking the  icon.

Document Management

When reports are archived in Monarch Server, they are compressed and stored in their entirety. Users retrieving information from the report warehouse, however, may choose to retrieve portions of a report. These portions of reports are called documents. For example, a February music invoice report may contain invoices for dozens of different music stores. A user

looking for the February invoice for only Betty's Music Store, however, needs to retrieve just that portion of the file. The invoice for Betty's Music Store can be represented as a single document in the stored February invoice report.

To configure stored information so that users can access it in this way, you need to define how you want to [break out documents](#) from the input reports. What makes up a document? In some cases, such as with a file of numerous invoices, the answer is easy: each invoice in the file is a separate document. For other reports, however, you may need input from users to determine how to define documents.

You categorize the documents you define as [document types](#) and then assign them to previously defined [document groups](#). For each document type (e.g., Music Orders), you specify [index fields](#) (e.g., Customer Name) and then [map](#) them to the corresponding indexes in the assigned Monarch [model file](#). You then configure a [filing task](#) and execute it via a [filing process](#) to archive the documents into the system. (A filing task uses the document type information to parse individual reports and index, compress and store them for later retrieval.) Lastly, you grant users access rights to the document types and [security keywords](#), so that they can specify search criteria to retrieve documents.

The archiving process comprises eight steps, all performed within MSAdmin:

- [Define a document group](#)
- [Define a document type](#)
- [Create index fields](#)
- [Map index fields to Monarch indexes](#)
- [Specify an auto-name string for the documents](#)
- [Define a filing task for the document type](#)
- [Schedule a filing process to run the filing task](#)
- [Assign user rights to view the document type](#)

NOTE: Though the sequence of these tasks represents a logical progression, you do not have to follow their exact order.

About Models

A model file, created within Monarch, is a file with a .dmod or .xmod extension that may contain field, filter, summary and chart definitions as well as other settings. Typically, all Monarch models are created by a system administrator.

Creating a model file is one of the first steps you need to perform, as you cannot define a document type or archive documents into the system without specifying a model file. (Refer to the Altair documentation for detailed information on the model creation process.)

There are three types of model files that can be utilized in Monarch Server:

- **Report Models:** A report model is a model file that contains field, filter, summary and chart definitions (as well as other settings), and which is automatically opened when associated documents are viewed. The primary purpose of the report model is to generate the **Data View** in MSCClient.

NOTE: Though you can use a report model for your index model, a report model may contain a number of fields that are irrelevant for searching. These unnecessary fields will only slow down the document retrieval process. So, it would be better to create an index model that contains only the fields that will be used for document retrieval.

- **Index Models:** An index model is a special form of model file that, ideally, should only contain those fields that are to be used as index fields for a given document type. It defines the fields on which you want to index a document, and is used only during the archive process. Index models typically contain fewer fields than report models, thus speeding up the document retrieval process.

NOTE: When [configuring](#) a [document type](#), you may utilize the same model file for your index and report models. It is not necessary to use a different model file for each of them.


- **Premining Models:** A premining model defines a premining scheme for the filing process (as part of archiving report data), and putting it into the MS database. The primary purpose of a premining model is to generate the **Dynamic View** in MSClient.

Removing a Model from a Document Type

When removing a model from a document type — whether it be a report, index or premining model — you need to specify a replacement model. (A document type cannot be saved without an assigned model.)

NOTE: You will also need to run a **Re-index** [maintenance task](#) to update the changes to a document type.

To remove a model from a document type

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types** to display the Document Types page.
2. Click the name of the document type you want to remove a model from or clicking anywhere on its row, and then click .
3. Click the **Index Models** button or the **Premining Models** button to display the **Select Model** page.
4. Select a new model.
5. To add a report model to the document type, drag its name from the **Available Report Models** pane to the **Assigned Report Models** pane.
6. To remove a report model from the document type, drag its name from the **Assigned Report Models** pane to the **Available Report Models** pane.
7. Click **Save** to save the changes.

Index Fields

An index field is a field within a [document type](#) that is used as an identifier. Document retrievals are based on these fields of information. For example, an index field for a purchase order could be **Purchase Order Number**, while index fields for employee records might be **Social Security Number** and **Employee Name**.

While an index field is a particular field within a document type, an index value (also called a *keyword value*) is a specific value of an index field. For example, **Q197-4112** could be an index value for a **Purchase Order Number** index field, and **123-45-6789** could be an index value for a **Social Security Number** index field.

Monarch Server uses index fields to locate and retrieve documents according to index values. For example, if a user entered an index value of **123-45-6789** for a **Social Security Number** index field, the index value is used to locate documents for the individual with this social security number.

The first step in creating index fields is to open a report in Monarch and create traps to extract the desired fields of information (for example, invoice numbers, customer names, ship dates, and so on). Then you save the index fields in a [model file](#). (For detailed information on this process, consult the Altair documentation.) When [adding](#) a document type to the Monarch Server system, you assign Monarch Server index fields to it and specify which model file you want to associate with it. Then you [map](#) the Monarch Server index fields with the ones in the associated model file. Monarch Server users will then be able to use the index fields and values to retrieve documents from the report warehouse.

All [indexes](#) used in the system are listed on the Indexes page. To display this page, click **Report Warehouse** on the Navigation Tree, then click **Document Management** and select **Index Fields**.

Use this page to [add](#), [edit](#), [remove](#) indexes from the list, or [import](#) index fields from existing models.

It is possible to save the index fields' values (index values) in encrypted format using the [Encipher](#) option.

Also the [Enable index selection](#) option is available for index fields to enable or disable access to the index values in MSClient application.

Identifying Index Fields

The indexing process begins with the creation of an index [model](#) within Monarch, via the same field definition process that you would use to extract fields of data from a report (refer to the Altair documentation for detailed instructions on this process). When creating an index model to be used in Monarch Server Web, however, only those fields that are to be used as index fields need to be identified. When you [configure](#) a [document type](#) within Monarch Server, you will map these Monarch indexes to the document type's [index fields](#).

Monarch Index Definition Considerations

When creating an index model within Monarch, consider doing the following:

- **Include only the fields you want to index:** The index model file should contain all the fields that you plan to map to index fields for the given document type in Monarch Server. It is not necessary to include other fields in the model — in fact, it is preferable that you do not include them. All fields contained in the model will be extracted from the report as part of the archive process, so unused fields would be extracted unnecessarily. Keeping the number of fields to a minimum will speed up the archiving process.

- **Index fields should be natural fields:** Calculated fields should not be used as index fields unless they are derived from a natural field (that is, a field extracted from your reports).
- **Avoid page header templates:** Index fields cannot be derived from page header templates.
- **Use a detail-level template to access the Data View:** During the archive process, all fields in the index model will be used as index fields, regardless of their template level. You don't need or even necessarily want a detail-level template.

However, if you do not create a detail template, you will not be able to go to the Data View. You may want to go to the Data View in order to gain access to the field properties for the index fields you have defined.

You can get around this problem in two ways. The first way is to create your lowest-level index field as a detail template, regardless of whether it is truly at the detail level in the report. The second way is to define a detail template temporarily, providing access to the Data View. You can then delete the detail-level model before saving the index model.

- **Match data type and check data length:** As part of the document type configuration process in Monarch Server, index fields are mapped to their corresponding Monarch indexes. In order to ensure proper operation, the data type (and field length, when applicable) of the Monarch Server Web index fields and Monarch indexes must coincide. For example, if in Monarch Server you create a string index field, and then you attempt to map it with a Monarch date index, the mapping will fail due to the incompatibility of their data types.

In addition, you should check that the defined length of the Monarch indexes is less than or equal to that of the corresponding index fields in Monarch Server Web. If they are longer, Monarch Server Web will truncate the index field's data when it is stored. This may cause errors during the archive process if, for example, an index field is no longer unique due to truncation.

- **Set the Ignore Leading Control Characters setting to zero:** Depending on the source of your report data, your report files may contain one or more extra characters at the beginning of each line. These characters are typically printer control codes that have no meaning to Monarch. Monarch provides a setting that allows you to strip a specific number of characters from your reports when they are viewed so that these characters do not interfere with report data.

If you supply a number greater than 0 for this setting in your Monarch index model, that number of characters will be stripped from the input report as it is compressed and archived in the warehouse. The characters are permanently removed. If the number is set to 0, no leading control characters are removed from your report. However, you may still choose to ignore those characters when viewing, by setting an appropriate value in the Monarch model file that is launched for viewing.

NOTE: In order to ensure that characters are not stripped from your report files inadvertently, it is recommended that the value be set to 0 for all Monarch index models.

To review or change the Ignore Leading Control Characters setting

1. In Monarch, open the desired report (**File, Open Report**) and model files (**File, Open Model**), then select **Options, Input** (ALT,O,I) from the main menu to display the **Input Options** dialog box.
2. Enter the appropriate number of leading control characters to ignore in the **Ignore n Leading Control Characters** field.

NOTE: It is recommended that you set this number to 0 for the index model.

3. Click **OK** to close the **Input Options** dialog box, then save the change to the model by selecting **File, Save Model**.
 - **Turn off the Ignore Form Feed Characters setting:** Many report files use a form feed character to indicate the top of a new page. This is especially useful when breaking reports into documents if the **Top of Page** option is chosen. Monarch provides a setting that allows you to ignore form feed characters that are embedded in the report. **Note:** For most reports, it is recommended that the setting be unselected in the Monarch index model.

To review or change the Ignore Form Feed Characters setting

1. In Monarch, open the desired report (File, Open Report) and model files (File, Open Model), then select **Options, Input** (ALT,O,I) from the main menu to display the **Input Options** dialog.
2. If the **Ignore Form Feed Characters** check box is selected, clear it.
3. Click **OK** to close the **Input Options** dialog, then save the change to the model by selecting **File, Save Model**.

Monarch Server Web Index Field Considerations

A few things to consider before [adding index fields](#) in Monarch Server:

- **Survey your user's requirements:** The point of an index is to help users find documents in the report warehouse as quickly as possible, so you should be sure to index the fields that users are likely to use when looking up a particular type of document. In many cases, the selection of index fields is obvious. However, that is not always the case. The best way to ensure that you are meeting your user's requirements is to ask them. Take a copy of a representative document and ask users which fields they would want to use to find that document in a database.
- **Choose unique identifiers:** When selecting index fields, it is best to select the most unique identifiers in the document, such as Customer name, Social Security Number, Invoice Number, etc. You should not, in general, select fields that would return a large number of instances, like State, for example. You should also avoid using fields that may not have consistent input. For example, Bill or William in the **First Name** field could both refer to the same customer, making it difficult to locate all documents for that individual. The more unique the identifier, the more precise the lookup will be. These identifiers are often found as column heads, titles, or page headers. In Monarch terms, they are typically found at an Append level.
- **Index only necessary search fields:** In general, you should avoid indexing line item data. In Monarch terms, this means you should generally not index items that are at the Detail level. These index entries would significantly increase the size of the index and increase the length of time required for the system to search the index tables. In addition, having a lot of index entries means that the initial processing of the report will take longer.

Adding an Index Field

When [configuring a document type](#), one of the steps is to [map Monarch Server index fields with Monarch indexes](#). Before that, you need to configure index fields.

NOTE: When configuring an index field in Monarch Server, keep in mind that its data type (and, when applicable, its data length) must be compatible with the data type (and length, if applicable) of the Monarch index you plan to map it to. For more information, see [Identifying Index Fields](#).

To add an index field

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Index Fields**.
2. Click **+** on the **Index Fields** page. The **Index Field** page appears.
3. Enter a unique name of a new index field in the **Name** field. As the name is only reference identification, an index name may be changed without effect to indexed data.
4. Enter any text defining the index in the **Description** field. This step is optional.
5. Select index field data type:
 - **String**: If you select this option, the **String** data type is defined. In this case type the number of characters in the **Length** box to set the maximum length of string fields. It is important to make the field length for string data long enough to accommodate the largest possible value.
 - **Date**: If you select this option, the **Date** data type is defined.
 - **Number**: If you select this option, the **Number** data type is defined. In this case type the number of digits after the decimal point in the **Decimals** box to set the maximum number of digits after the decimal point.
6. Select **Enable index selection** to enable selection of index values in **Select Index Value** dialog boxes in the MSClient and MSAdmin applications.
7. Select **Enable cross-references table** to be able to use a cross-reference table when index searching for documents.
8. Select **Apply wildcards index field search values on search to replace embedded space(s)** to add the ability to automatically add wildcard(s) to Document Search index search criteria. For example, the client's accounts will show both "XX XXXXX" or "XXXXXXXX". The the index field is stored with the spaces but some users enter the spaces and some do not so the system needs to replace the space with * to make it an automatic wildcard.
9. Select **Enciphered** to enable storing index values as an encrypted data. By default, they will not be displayed in **Select Index Value** dialog boxes.


NOTE: Extended Security option only.
10. Select **Enable dynamic search** to enable the auto-suggest feature for this index field in MSClient.
11. To save the index field, click the **Save button**.

The system saves the new index to the database and displays the updated **Index Fields** page, if the operation is completed successfully.
12. To reset the values, click the **Clear** button.
13. To close the **Index Field** page without saving, click **Cancel**. Keep in mind that no changes will be saved.

Editing an Index Field

[Index Fields](#) can be edited via the **Index Field** page.


To edit an index in the list

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Index Fields**.
2. On the Index Fields page click the name of the index you want to edit or click anywhere on its row, and then click . The **Index Field** page appears. For more information on how to change index options, see [Adding an Index Field](#).
3. To save the changes, click the **Save** button.
The system saves the modified index to the database and displays the updated **Index Fields** page, if the operation is completed successfully.

Deleting an Index Field

You can delete an [index field](#) via the Index Fields page.

To delete an index from the list

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Index Fields**.
2. Click  at the end of the row with the index you want to delete. A dialog box appears.
3. Click **Delete** to delete the index from the list.

Importing an Index Field

To import an index field

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Index Fields**.
2. Click the **Import Fields** button on the Index Fields page. The **Select Model** box appears.
3. Select a model you want to use for importing, by clicking its name.
4. The **Import From Model** dialog box appears, displaying the following items:
 - **Import**: Select an index, if you want to add it to the index fields.
 - **Name**: Names of index fields from the selected model.
 - **Type**: The type of each index field (for example, string, date or number).
 - **Size**: The length of each string and number index field.
 - **Encipher**: This option allows to keep index values in encrypted format and hide field values in **Select Index Value** dialog boxes.
 - **Enable index selection**: The option enables selection of index values in **Select Index Value** dialog boxes.
 - **Save**: Imports and saves indexes to database.
 - **Cancel**: Closes the window.
 - **Select All**: Selects all indexes.


- **Select None:** Clears all indexes.
5. Select model fields to import as index fields and click **Save**. If an index field name already exists in the database, the row will appear shaded. The system imports and saves indexes in the database and displays the updated **Index Fields** page with them, if the operation is completed successfully.


Mapping Index Fields to Monarch Indexes

When [adding a document type](#), one of the steps you must perform is to map the assigned [index fields](#) to the indexes in the Monarch [model](#). Mapping Monarch Server index fields to indexes in the Monarch model enables you to use the index fields (and their associated index values) to retrieve data from a report.

Note: Before you can map index fields to Monarch indexes, you need to specify an index model in the **Index Model Name** box on the [Document Type page](#).

To map index fields to Monarch model indexes

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Either click  to create a new document type, or click the name of a document type that you want to do mapping for.
3. Click the **Mapping** header to expand a hidden section with the following items:
 - **Available Index Fields:** Select an index to assign to the current document type from the list.
 - **Modeler Indexes:** Select a corresponding Monarch index (keyword type) for the current document type.
 - **Add To Map:** Click this button to add a selected index field and a corresponding keyword type to the map list. It allows mapping an index field with a corresponding Monarch index (keyword type).
 - **Add To Map Hidden:** The same as **Add To Map**, except that the hidden index field will not be available to users in **Simple** and **Advanced Searches**. This feature can be used to add indexes to document types that are used to define security keywords, but are not visible to users.
 - **Auto Map:** Click this button to automatically map all available indexes to Monarch indexes (keyword types).
 - **Map List:** Displays the list of index fields and corresponding Monarch indexes (keyword types).

Note: To remove a mapped entry (a pair — an index field with a Monarch index) from the map list, click .

4. Map as many index fields to Monarch indexes as you want to, then click **Save**.

Default Index Values

You can have a default [index value](#) automatically assigned to each document in a report file. A default index value is a value you specify for an [index field](#) that does not occur within a given report. A default index value, therefore, will not change from document to document in a given report file. Typically, you would use a default index value as a document indicator, much in

the same way as a "stamp" for a document. A default index value is automatically assigned to each document during the archive process.

NOTE: The use of default index values is optional.

For example, let's say you have 10 report files coming in every month, each one containing the sales information of one of 10 different sales regions. The region number does not appear in the report, but you would like that information to be associated with each document. You could create an index field called **Region Number** and assign it to the document type. As reports for each region are processed, the appropriate value for region number would be assigned to each of the report files as a default index value. All documents generated from this report file will have the default index value assigned to them. You can use default index values as search criteria, as if they were ordinary index values. Thus if you searched for information about Region 3, all the documents in the report file could be part of the search results.

To specify a default index value

1. [Create a new index field](#) (for which you'll subsequently specify the default value, see step 3 below).
2. [Assign the index field to the appropriate document type](#)
3. [Configure a filing task](#) to archive the document type into the report warehouse. When scheduling the filing task, on the **Filing Task** page, click the **Index Defaults** tab at the top of the page to display the **Edit Index Defaults** page, then fill in the boxes.
4. [Run the filing task](#).

Document Groups

A document type group (or simply a [document group](#)) is a classification of [document types](#) according to some common characteristic or subject. You could, for example, decide to group different kinds of financial reports into a single document group. Each document group, then, contains one or more document types. A document type is defined by its layout or structure. An invoice, for example, is a document type.

Documents are classified in document groups as a means of organizing information hierarchically and thus speeding up the search process. In other words, when users perform a search, they typically select a document group first, and then select a document type or types from that group to search.


In addition, all document types are assigned to [storage groups](#). The storage group you select during configuration is a default storage group. You can assign document types in the same document group to different storage groups. You would take this approach, for example, if you do not want to treat all the document types in the same way.

Adding a Document Group

When [configuring a document type](#), you must assign it to a [document group](#). So before configuring the first document type, you need to configure a document group.

NOTE: Adding a document group is one step in the process of [archiving reports](#).

To add a document group to the list

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Groups**.
2. Click  on the Document Groups page. The Document Group page containing the following items appears:
 - **Document Group Name:** Enter a unique name of a new document group.
 - **Description:** Optionally, enter any text to describe the document group.
 - **Available Document Types:** Contains the list of the document types, from which an administrator selects those to be assigned to the current document group. To add a document type, drag it from the left pane to the right pane.
 - **Assigned Document Types:** Displays the document types selected by an administrator for the current document group. To remove a document type, drag it from the right pane to the left pane.
 - **Filter by:** The filters for the **Available Document Types** list and **Assigned Document Types** list. Type a document type name (or a part of it), and click **Apply** to filter the list.
 - **Save:** Saves a new or existing document group.
 - **Clear:** Clears all the boxes.
 - **Cancel:** Cancels the operation.


NOTE: If you assign a document type to the current document group, the system automatically excludes it from the document group, which contained it before. If you exclude a document type from the document group, it will not be shown in MSClient.

3. Fill in the boxes of the page and click **Save**. The system saves the new document group to the database.

Editing a Document Group

[Document Groups](#) can be edited via the Document Group page.

To edit a Document Group

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Groups**.
2. On the Document Groups page do one of the following:
 - Click the name of the document group you want to change.
 - Select the document group, by clicking anywhere on the row, and then click .

The Document Group page appears. For details about how to change its items refer to [Adding a Document Group](#).

3. Make the necessary changes and click **Save**. The system saves the modified document group to the database and displays the updated Document Groups page, if the operation is completed successfully.


Deleting a Document Group





You can delete a document group via the Document Groups page.

NOTE: Before you can delete a document group, you must remove any document types that are assigned to it.

To delete a document group

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Groups**.
2. Do one of the following:

- Select the document group you want to delete, by clicking anywhere on the row, and then click .

 ... Click  at the end of the row with the document group you want to delete. ...  

A dialog box appears.

3. Click **Delete** to delete the document group from the list.

Document Types

A [document type](#) is defined by its layout or structure. An invoice is an example of a document type. All instances of a document type display the same types of information using the same format, though the actual data can vary. For example, Mary's invoice may contain 3 line items, while John's invoice — 11. Both invoices, however, contain [index fields](#) for an invoice number, invoice date, and customer name, located in the same relative positions.

All document types used in the system are listed on the Document Types page. To display this page, click **Report Warehouse** on the Navigation Tree, then click **Document Management** and select **Document Types**.


Use this page to [add](#), [edit](#), [duplicate](#), or [remove](#) a document type from the list.

Adding a Document Type

Adding a [document type](#) is one step in the process of [archiving reports](#).

To add a document type

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.

2. Click  on the **Document Types** page. The **Document Type** page appears.

3. Modify the following settings:

- **Document Type Name:** Enter a unique name of for the new document type.
- **Description:** Optionally, enter a description of the new document type.
- **Character encoding:** Select the character set encoding for the current document type (for example, ASCII). If you select the **Default** value then character encoding specified for the index model will be used.

NOTE: Changing this value after reports have been filed will not change their input encoding. In order to correctly file reports with an incorrect encoding, you need to delete the existing incorrect reports by a maintenance task, and re-file the original reports into Monarch Server.

- **Exclude this Document Type from searches:** Select this box to make the document type unavailable for client viewing. Typically, this is used in conjunction with a separate pre-mined document type. The hidden document type will only be used as a data-join source in **Dynamic View**. This is a user-search setting and may be changed without effect to stored documents.
- **Allow searches by document dates:** In some cases, document dates for user searching may be defined by an index field (e.g. **Report Date** or **Run Date**). In this case the document date fields are redundant and may be hidden. Document dates are still stored and are valid for maintenance operations. This is a user-search setting and may be changed without effect to stored documents.
- **Request filter before initial Table/Summary view:** In case of reports with a large number of data rows, it may be more efficient to request the user to set view options before the data is displayed. The default action is to display the data before allowing the user to set view parameters. This is a user-search setting and may be changed without effect to stored documents.
- **Assign preceding values to documents not containing append/page values:** When defining a document type to break the report into logical sections (documents), it is expected that each document will contain at least one case of each defined index field. However, there may be cases where an index value occurs only in the beginning of a report or at certain points that are prior to the document breaking point. In this case, a document can be assigned the preceding value, if it does not contain the value.

NOTE: Changing this value will not change indexes for previously filed reports. A **Re-index** maintenance task is required to update indexes for previously stored documents.

- **Document Group:** Select one document group for the document type to be a member of. Changing this value will associate all reports of this document type to the current document groups assignment.
- **Storage Group:** Select from the list a storage group for the document type. If you change it, filed reports will remain in the previously defined storage group, while new filings will be stored in the newly defined storage group. Changing a storage group assignment does not affect the ability to search for, or retrieve reports in multiple storage groups.

NOTE: Storage groups with no associated storage volumes are not included in the list.

- **Document State Group:** Select one document state group for the document type. Changing this value will associate all reports of this document type to the current document state group assignment.
- **Index Model Name:** Specify the name for an index model. Click the **Index Models** button on the right to display the list of existing index models. Specifying an index model is necessary for defining document break conditions.
- **Premining Model Name:** Specify the name of a premining model. Click the **Premining Models** button on the right to display the list of existing models. Defining a premining model is necessary, if you want to use a premining scheme for the filing process.

NOTE: For the model, the field names Def_DocId, Def_FileId, Def_PageNo, and Def_LineNo are reserved for Monarch Server use. If these field names exist in the model already, they will be renamed with the addition of an underscore as a suffix. Alternatively, the field names can be changed by editing the model.

- **Choose Indexed Fields:** This button allows you to select indexes for a premining model. This is an advanced function included for potential performance reasons only. It is recommended that no pre-mine column indexes be selected initially. This button is enabled only when you add a document type. Changing pre-mine indexes after document type definition is accomplished via Maintenance Tasks/Processes.
- **Available Report Models:** Contains available report models you can select from.
- **Assigned Report Models:** Contains report models you select from the available ones. To assign a report model to the document type, drag it from the left pane to the right pane. To de-assign a report model from the document type, drag it to the left pane.


NOTE: To break a report into smaller documents, you need to [identify a break field for it](#). The system uses the break field to divide the report into documents. The division is logical only, because the report remains stored as one file. For example, you may choose the **Customer** field as the break field for an invoice report. Therefore, every time the system encounters a change in the **Customer** field (which you may have mapped to a **Customer Name** keyword type), a new document begins. Use the following fields to specify document break fields.

- **Break Pages at (based on either # lines or the model's Page Header):** Specify document break fields. You may select one of the following options from the list:
 - **Top of current page:** If you select this value, the system breaks the report at the top of the page, on which the break value occurs.
 - **Break On Line and Line # (Line # being an offset value):** If you select this option, Monarch Server breaks the report on the line where the field break value occurs. The **Line #** field allows you to specify where you want the document breaks to occur in relation to the break field. For example, if your report is a list of sales by state, you might want to break out a new document whenever a new state is encountered. To do so, you would choose the **Break On Line** option, enter a value of **0** in the **Line #** field (a value of 0 means that there is no offset), select **Value Change** from the **Break files/reports into Documents sections when** list, then select **State** from the list of fields. Whenever a change in the state is encountered in the report, a new document is broken out and a new state becomes the first line of that document.

NOTE: Negative values are not permitted in the Line # field.

- **Break files/reports into Documents sections when:** Select one of the following options from the list:
 - **Always:** Select this option if you want a new document to begin whenever the break field is encountered regardless of whether there has been a change in its value. For example, if you specify the **Customer** break field and the report contains three invoices for the same customer, then the report will be broken into three documents, even though the customer on each invoice is the same.
 - **Never:** Select this option if you don't want the report to be broken into separate documents. You might select this option if the report contains a small amount of information that doesn't need to be broken into documents (for example, an invoice report that contains only one invoice).
 - **Value Change:** Select this option if you want a new document to begin whenever the break field value changes. For example, if you specify the **Customer** break field, and the report contains one invoice for three different customers, then the report will be broken into three documents, one for each customer.
- **Page header rows:** Optionally, specify in this field the number of page header lines that will be inserted in **Document Search** views, when the Document Break does not occur at the beginning of a printed page. The field is enabled only when **Break On Line** is selected. This setting does not alter the source report and may be changed without effect to filed reports. The display effect is in **Document Search** views only. Set this value to **0**, if the header is not required.
- **Mapping: Click this header to expand a hidden section with the following items:**
 - **Available Index Fields:** Select an index to assign to the current document type from the list.
 - **Monarch Indexes:** Select a corresponding Monarch index (keyword type) for the current document type.
 - **Add To Map:** Click this button to add a selected index field and a corresponding keyword type to the map list. It allows mapping an index field with a corresponding Monarch index (keyword type).
 - **Add To Map Hidden:** The same as **Add To Map**, except that the hidden index field will not be available to users in **Simple** and **Advanced Searches**. This feature can be used to add indexes to document types that are used to define security keywords, but are not visible to users.
 - **Auto Map:** Click this button to automatically map all available indexes to Monarch indexes (keyword types).

NOTE: Before mapping indexes you should select the Index Model and add indexes to the **Assigned Indexes** box on the Document Type page.

- **Map List:** Displays the list of index fields and corresponding Monarch indexes (keyword types). To remove a mapped entry (a pair — an index field with a Monarch index) from the map list, click .
- **Auto Name:** Allows you to set document names based on any combination of indexes and document identifiers. Click the **AutoName** button to open the [Auto-Name](#) dialog box that automatically creates an auto-name format.
- **Report Name:** Allows you to set report names based on any combination of indexes and document identifiers. Click the **ReportName** button to open the **Report-Name** dialog box that automatically creates a report-name format (in the same way as [Auto Name](#)).
- **Document Date:** Set the document date to display:

- **Last write time:** Select to use the Last Modified date of file properties as a Document Date.
- **Index value:** Select to map a date type field to Document Date. From the enabled list of the date type index fields available in the defined index model, select the field you want to use the date from.

NOTE: If the selected date type index field doesn't exist in report, **Last write time** is used as a Document Date. If the selected date type index field contains more than one value, the first field value is used as a Document Date.

- **Save:** Saves a document type.
 - **Clear:** Clears all the boxes.
 - **Cancel:** Cancels the operation.
 - **Duplicate:** Opens the **Copy Document Type** dialog box, where you can select a document type. All boxes will be filled with values of the selected document type. You can make the necessary changes.
4. Fill in the boxes of the page and click **Save**. The system saves the new document type to the database and displays the updated Document Types page, if the operation is completed successfully.


NOTE: You can specify other settings for a document type, including access rights to users, templates, report instances, report security rules, views available in the document search results page, PDF print settings and digital signature for a document type. The corresponding tabs appear on the Document Type page after you save a new document type and [open it for editing](#).

Assigning Document Types to Roles, User Groups and Users

After you [configure and save](#) a [document type](#), you can assign it to [roles](#), [user groups](#) and [users](#). When you do so, you enable the role members, group members and users to retrieve documents of that type.

When assigning a document type, keep in mind that rights in Monarch Server are cumulative. If, for example, you assign a document type to a role, any user assigned to that role will be able to retrieve documents of that type.

To assign a document type to roles, user groups and users

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**. The **Document Types** page is displayed.
2. Click the name of a document type or click anywhere on its row, and then click .
3. Select the **Rights** tab.
4. **Important:** To make a document type to be available to all users, select **Global** check box and click the **Save** button. Otherwise proceed to the next steps.
5. Click **User Groups** to expand a hidden section. Select user groups that you want to have access to the document type. To select a user group, drag it from the left pane to the right pane.

6. Click **Roles** to expand a hidden section.
Select roles that you want to have access to the document type. To select a role, drag it from the left pane to the right pane.
7. In the **Users** section you can select users that you want to have access to the document type.
To select a user, drag their name from the left pane to the right pane.



NOTE: If you don't want a user to retrieve any documents of a particular document type, drag a role, user group, or user from the right pane to the left pane.

8. To save the changes, click the **Save** button.
9. To clear the changes, click the **Clear** button.
10. To close the **Rights** tab without saving, click **Cancel**. Keep in mind that no changes will be saved.

Assigning Document Types to Maintenance Tasks


When [adding](#) or [editing](#) a [maintenance task](#), you need to specify, which [document types](#) you want the task to affect.

To assign a document type to a maintenance task

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Maintenance Tasks** to display the **Maintenance Tasks** page.
2. Create a new maintenance task (by clicking ), or select an existing maintenance task (by clicking its name, or by clicking anywhere on the row and then clicking ).
3. Click the **Document Types** header to expand a hidden section.
4. In the **Document Groups** list, select a document group that contains the desired document type. All document types assigned to the selected document group appear in the **Document Types** pane.
5. In the **Document Types** pane, choose the document types that you want to assign to the task. To add a document type, drag it to the **Assigned Document Types** pane.
6. Click **Save** to save the changes.

Editing a Document Type

To edit a document type


1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Click the name of the document type you want to change or click anywhere on the row, and then click . The **Document Type** page appears. For details about how to change its items see [Adding a Document Type](#). When you open a saved document type for editing, the following additional tabs become available on the Document type page:
 - **Rights** tab is used to [assign the document type to appropriate roles, user groups and users](#).

- **Templates** tab is used to [manage templates](#) for document types.
 - **Report Instances** tab is used to [manage report instances](#) for document types.
 - **Report Security** tab is used to [manage report security rules](#) for document types.
 - **Available Views** tab is used to [manage views](#) that will be available to a user working with a document type.
 - **PDF Print Settings** tab is used to manage [user's print settings](#) for a document type. If not defined, the default system settings will be applied.
 - **Excel Digital Signature** tab is used to [add a digital signature](#) to Excel exports. This guarantees that the data provided to a user is not modified.
3. Make the necessary changes and click **Save**. The system saves the modified document type to the database and displays the updated Document Types page, if the operation is completed successfully.

Duplicating a Document Type


When creating a new document type, you can save time by duplicating an existing document type with similar parameters.

To duplicate a document type

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. On the **Document Types** page click .
3. Click the **Duplicate** button at the bottom of the page. The **Copy Document Type** dialog box appears.
4. Click the document type that you want to duplicate. All boxes will be filled with values of the selected document type, except for the **Document Type Name** and **Description**.
5. Enter the name and description (optional) of a new document type, make the necessary changes to other boxes and click **Save**. For details about how to fill in the page items refer to [Adding a Document Type](#).

Deleting a Document Type

To delete a document type

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Click  at the end of the row with the document type you want to delete.
3. Click **Delete** to delete the document type from the list.

Identifying Document Break Fields

Document break fields are [index fields](#) that are used to logically divide reports into documents. As a result, even though entire reports are stored in the warehouse, users are able to retrieve individual documents from within them when performing a search.

Typically, the creator of the original report has set up the document in a way that can help you identify break fields. Reports are generally organized according to some type of sorting criteria. For instance, you might have an employee listing broken out by department within each regional office. Each department could be treated as a separate document. Document breaks do not have to appear on page boundaries. They may occur anywhere within a report file.

You need to identify the criteria used to organize a report and then determine a suitable break field for the report. Here are some specific tips regarding break fields:

- **Imagine the report being cut apart with scissors.** This is the effect of a break field. If a header appears only once on a page and you break that page into more than one document, only the first document from that page will have the header included. You cannot duplicate header information from the report across multiple documents.
- **Look for lines that provide numerical subtotals.** You should be sure to include in a single document all the previous lines that contribute to that subtotal, along with the subtotal line itself.
- **Consider how page boundaries affect your document breaks.** You do not need to be limited by them, but many reports will issue a top-of-page command before beginning a new sort field.
- **Break the report into subsections that stand alone and "make sense".**
- **Consider how users will be working with the documents.** If users always want to look at an office location in its entirety, then it makes no sense to break out documents by department.
- **Decide how duplicate consecutive break field values should be handled.** If you have a report that contains invoices, for example, you might have 3 or 4 invoices in a row for the same customer. How should that situation be handled? Do your users want to see all invoices for the customer as one single document, or do they want each invoice as a separate document? Either option is available. The user's needs will dictate the appropriate solution.

Once you have identified which field in a report you want to break on, you're ready to break the report into separate documents by specifying a document break field. A document break field creates only virtual breaks in a report. The report is still stored in its entirety, but the document break allows the users to retrieve only portions of the report (documents).

NOTE: [Specifying a document break field](#) is part of the [document type configuration process](#).

Auto-naming documents

With Monarch Server's auto name feature you can automatically assign names, based on any combination of index fields and document identifiers, to documents filed into the system. It is important to provide meaningful names for documents (that is, names that identify the kind of data the documents contain).

NOTE: Before assigning an auto-naming scheme, you need to select an index model and add indexes to the map in the **Mapping** section on the [Document Type page](#).

To auto-name a document

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Click **+** to add a new document type, or open an existing document type by clicking its name.
3. Click the **AutoName** button at the bottom of a page to display the Auto Name window.
The **Auto-Name String** field will display auto name macros after you select them by clicking corresponding buttons at the bottom of the page.
4. Build the auto-name string by clicking any combination of the following buttons:
 - **Space:** Adds a space, a hyphen, and another space (-) between two values in the auto-name string.
 - **Document Type:** Adds the document type macro ([DOCTYPE]) to the auto-name string.
 - **Document Dates:** Adds the document date macro ([DOCDATE]) to the auto-name string.
 - **Document Time:** Adds the document time macro ([DOCTIME]) to the auto-name string.
 - **Date of Filing:** Adds the filing date macro ([FILINGDATE]) to the auto-name string.
 - **Time of Filing:** Adds the filing time macro ([FILINGTIME]) to the auto-name string.
 - **File Name:** Adds the file name macro ([FNE <element number>/<delimiter>]) to the auto-name string. For example, if you specify the element number as **1** and the delimiter as a period (.), then the first element of the file name before the period will be included in the auto-name string.
 - **Index:** Adds an index macro (for example, [INDEX 108.2]) to the auto-name string for the index selected in the **Index** list.

NOTE: Before you click this button, select an index field from the Index drop-down list, then enter the number of repeat indexes to add to the auto-name string in the **Repeat** field. To include all values of this index field, enter **A** in the **Repeat** field. In the index macro, the first number is the ID number that was automatically assigned to the index field when it was created. The number (or letter, for example, **A**) following the colon is the number you entered in the **Repeat** field.

5. Enter any static text that you would like to appear in the auto-name string.
6. Click **Save** to save the auto-name string settings and close the Auto Name window.
7. To save the change to the document type, click the **Save** button on the Document Types page.

NOTE: A dialog may appear, asking whether you want to rename any documents that have already been stored using this new name. Select Yes to rename existing documents, or No to just use this name for new documents as they are added.

Example of using the auto name feature

To auto name documents of a Checking Statement document type in the following format:

Checking Statement - Thomas T. Edwards, 12/11/97

Perform the following steps in the **Auto Name** window:

1. Click the Document **Type** button. [DOCTYPE] appears in the **Auto-Name String** field.
2. Click the **Space** button. A space, hyphen, space (-) appears in the **Auto-Name String** field after [DOCTYPE].
3. Select **Customer Name** from the **Index** drop-down list, enter **1** in the **Repeat** field, then click the **Index** button. [INDEX 100.1] appears in the **Auto-Name String** field after the space, hyphen, space (-).
4. Type a comma (,) in the **Auto-Name String** field after [INDEX 100.1].
5. Using the spacebar on your keyboard, enter a space in the **Auto-Name String** field after the comma.
6. Click the **Document Date** button. [DOCDATE] appears in the **Auto-Name String** field after the space.

The completed string in the **Auto-Name String** field reads: [DOCTYPE] - [INDEX 100.1], [DOCDATE]

Managing Document Type Templates

Monarch Server users can apply templates to documents when exporting them. All [document templates](#) used in the system are listed on the [Templates](#) page.

NOTE: Each template type is available only under the appropriate license.

User can manage document type templates ([add](#), [edit](#), or [remove](#)) on the Document Type Templates page.

To display the Templates page



1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Open a document type for editing by clicking its name.
3. Click the **Templates** tab.

Adding a Template to a Document Type

After you assign template to a [document type](#) you can assign this document type and template to a Monarch Server user. The user will be able to retrieve documents of this type and apply the specified template to documents when exporting them.

To add a template

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.

2. On the Document Types page, do one of the following:
 - Click the name of the document type you want to add a template to.
 - Select the document type, by clicking anywhere on the row, and then click 
3. On the displayed page, select the **Templates**.
4. Click the **Add** icon (). The Template page containing the following items is displayed:
 - **Name:** The name of a new document template is assigned automatically depending on the selected Template file.
 - **Type:** Allows you to select the type of a document template. The type is defined by an application, which will be used for document export.
 - **Model:** This field becomes available, if you select **ES Style** from the **Type** list. You can select the model type, which is used for extracting data for ES Style. At the customer site, the report model for XSL presentation is optimized for extraction and cannot be used for analysis.
 - **Template file:** Select Template file, which will be used for document export.



If you select **ES Style** or **ES Report Style** in the **Type** list, the following options become available:

- **PDF page type:** Select the print size of PDF page from the list.
 - **Orientation:** Select PDF page orientation (**Portrait** or **Landscape**).
 - **PDF page width (inches):** Specify PDF page width.
 - **PDF page height (inches):** Specify PDF page height.
 - **Left margin (inches):** Specify PDF page left margin.
 - **Right margin (inches):** Specify PDF page right margin.
 - **Top margin (inches):** Specify PDF page top margin.
 - **Bottom margin (inches):** Specify PDF page bottom margin.
 - **Server XML/XSL conversion:** Select this checkbox to use server XML/XSL conversion.
 - **Enable formatting:** Select this checkbox to enable formatting for templates from user preferences.
5. Fill in the boxes of the page and click **Save**. The system saves the new document template to the database and displays the updated Templates page, if the operation is completed successfully.

NOTE: You can assign document type templates to user groups, roles or users via the **Template Rights** tab that is available only for existing templates. For more details see [Editing a Template](#).

Editing a Template of a Document Type

To edit a document template



2. On the Document Types page, do one of the following:
 - Click the name of the document type you want to edit a template for.
 - Select the document type, by clicking anywhere on the row, and then click .
3. On the displayed page, select the **Templates** tab at the top of the page.
4. Do one of the following:
 - Click the name of the template you want to edit.
 - Select the template, by clicking anywhere on the row, and then click .

The Template page appears. For details about how to change its items see [Adding a Template](#).



5. Make the necessary changes.
6. Click **Save**. The system saves the modified document template to the database and displays the updated Templates page, if the operation is completed successfully.

Deleting a Template from a Document Type

To delete a document template

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. On the Document Types page, do one of the following:
 - Click the name of the document type you want to delete a template from.
 - Select the document type, by clicking anywhere on the row, and then click .

The Document Type page appears.

3. Select the **Templates** tab at the top of the page.
4. Do one of the following:
 - Select the template you want to delete, by clicking anywhere on the row, and then click .
 - Click  at the end of the row with the template you want to delete.

A dialog box appears.

5. Click **Delete** to delete the template from the list.

Report Instances

All [reports](#) of the current document type are listed on the Report Instances page.

To display the Report Instances page

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Open a document type for editing by clicking its name.
3. Click the **Report Instances** tab.


The Report Instances page displays the list of reports in the system, including the following information:

- **Premined** (check marks indicate premined reports)
- **Blocked** (check marks indicate blocked reports)
- **Report file name**
- **Report Date**
- **Filing Date**
- **Working** (check marks indicate working reports)
- **Original** (check marks indicate original reports)


Use this page to [edit](#) a description of existing report, [remove](#) it from the list, or [block](#) all reports.

Editing a Report Instance

To edit a report description

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. On the Document Types page, do one of the following:
 - Click the name of the document type you want to edit a report for.
 - Select the document type, by clicking anywhere on the row, and then click .

The Document Type page appears.

3. Select the **Report Instances** tab at the top of the page.
4. Do one of the following:
 - Click the name of the report file you want to edit.
 - Select the report file, by clicking anywhere on the row, and then click .


The Report Instance page appears.

5. Make the necessary changes (change the date, or select the **Blocked** check box), and click **Save**.

The system saves the modified report description to the database and displays the updated Report Instances page, if the operation is completed successfully.


Deleting a Report Instance


To delete a report

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. On the Document Types page, do one of the following:
 - Click the name of the document type you want to delete a report for.
 - Select the document type by clicking anywhere on the row, and then click .

The Document Type page appears.

3. Select the **Report Instances** tab at the top of the page.
4. Select the report file by clicking anywhere on the row and then click:

 — To remove only a working report and unique dependent objects such as index values, annotations, discussion threads, etc.

 — To remove a working report, an archived original report, and unique dependent objects such as index values, annotations, discussion threads, etc.

NOTE: The associated filing result records are not removed in any case.


A dialog box appears.

5. Click **Delete** to delete the report from the list.


Blocking Report Instances


You can block all report instances via the **Report Instances** tab, so that reports cannot be searched for or viewed by non-admin users in MSCClient.

To block all reports

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. On the Document Types page, do one of the following:
 - Click the name of the document type you want to block reports for.
 - Select the document type by clicking anywhere on the row, and then click .

The Document Type page appears.

3. Select the **Report Instances** tab at the top of the page.
4. Click  to block all reports. Check marks will appear in the **Blocked** column of the table.

Note: To unblock all reports, click . Users in MSClient will be able to search for and view the reports.

Report Security Rules

MS administrators can apply report security rules to reports when users view them in MSClient. The whole report is divided into two parts: "secure" areas of report which can only be seen by users with explicitly granted access rights (branch level) and "non-secure" areas which can be seen by all users who have access to the document type. Report-level security works in parallel with document-level security ([security keywords](#)).

Report Security rules allow sections of reports and report data to be hidden from user's view unless access is allowed. By default, users will not have access to hidden sections of reports unless specifically allowed to access the rule (see [Rule Rights](#)).

Rules must be defined before reports are filed. If a rule is defined or redefined after reports are filed, a **Re-index** maintenance task must be performed on all affected reports.

All report security rules used in the system are listed on the Report Security page.



To display the Report Security page

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Open a document type for editing by clicking its name.
3. Click the **Report Security** tab.

The **Report Security** tab displays the list of report security rules assigned to a document type. Use this page to [add](#), [edit](#), or [remove](#) a rule from the list.

Adding a Report Security Rule

To add a report security rule

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Select the name of the document type you want to add a rule to by clicking the name of the document type or click anywhere on the row, and then click .
3. Select the **Report Security** tab at the top of the page.
4. Click  to display the **Security Rule** page.
5. Modify the settings accordingly.

Report Security Rule:

- **Model name:** Shows the current index model.
- **Depends on field:** Select a model field from the list.

Starting Rule: This allows you to define the starting point of the rule being added.

- **Start At:** This refers to the portion of the report on which the security rule is first applied. The following options are available:

- **Top of Current Page:** The rule is first applied at the beginning of the current page.

Example:

A report contains 50 lines of text. The rule begins on the first line of the report, i.e., the top portion of the page.

- **On Line:** The rule is first applied on the line specified by the user.

- **Line #:** This field is enabled only when the **On Line** option is selected in the **Start At** list.
- **On field change:** Specify a field for triggering the rule.

Example:

A report contains 50 lines of text with the following fields available: Customer, Account Number, Contact, Quantity, Description, etc.

If you wish to hide the Account Number information specifically, set the **On field change** to "Account Number," and then set **line #** field to 0. The rule is first applied to the field labeled as "Account Number."

If you wish to hide, for example, the third line from the field "Contact," then set the **On field change** to "Contact," and then set **line #** to 3. The rule is first applied to the third line from the "Contact" field.

Note that all fields available in the report are listed in the drop-down menu of **On field change**.

Ending Rule: This allows you to define the end point of the rule being added. The following options are available.

- **End At:** This refers to the portion of the report on which the security rule is last applied. The following options are available:

- **End of Current Page:** The rule is last applied at the end of the current page.

Example:

In the previous example, you applied the rule to the Account Number field.

If you wish to hide all succeeding information, set the **On field change** to **End of Current Page**. The report will no longer show information following the Account Number field.

- **On Line:** The rule is last applied on the line specified by the user.

- **Line #:** Specify a line offset for the **On Line** options. This field is enabled only when **On Line** option is selected in the **End At** list.
- **On field change:** Specify a Monarch field for triggering the rule.

Example:

If you wish to hide all information provided before a certain field, for example, the Contact field, then set the **On field change** to “Contact,” and then set **line #** field to 0. The rule is last applied to the field labeled as “Contact.”

If you wish to hide, for example, the third line after the “Contact” field, then set the **On field change** to “Contact,” and then set **line #** to 3. The rule is last applied to the third line from the “Contact” field.

Section Limit: Describe the section limits.

- **Limit section to:** Specify how to limit the section.

The options are: **No limit**, **Amount of lines** and **End of Current Page**.

- **Amount of lines:** Specify the amount of lines for the **Amount of lines** option.

This field is enabled only when the **Amount of lines** option is selected in the **Limit section to** list.

6. To save the new report security rule, click the **Save button**.



The system saves the new report security rule to the database and displays the updated **Report Security** page, if the operation is completed successfully.

7. To reset the values, click the **Clear** button.

8. To close the **Security Rule** page without saving, click **Cancel**. Keep in mind that no changes will be saved.

Editing a Report Security Rule

To edit a report security rule

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Do one of the following:
 - Click the name of a document type, to which the rule is assigned.
 - Select the document type, by clicking anywhere on the row, and then click .
3. Select the **Report Security** tab at the top of the page.
4. Do one of the following:
 - Click the name of a rule that you want to change.
 - Select the rule, by clicking anywhere on the row, and then click .

The Security Rule page appears.

5. Make the necessary changes.


6. To set trustees for the report security rule, click the **Rule Rights** tab.
7. Click the **User Groups** or **Roles** heading to expand hidden sections. To assign a report security rule to a user group, role, or user, drag the appropriate trustees from the left pane to the right pane.

NOTE: The Security Rule page has the **Rule Rights** tab only for existing rules.



8. Click **Save**. The Security Rule page appears.
9. Click **Save**. The system saves the modified rule to the database and displays the updated Report Security page, if the operation is completed successfully.

Deleting a Report Security Rule

To delete a rule

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. On the Document Types page do one of the following:
 - Click the name of the document type you want to delete a report for.
 - Select the document type by clicking anywhere on the row, and then click .

The Document Type page appears.

3. Select the **Report Security** tab at the top of the page.
4. Do one of the following:
 - Select the rule you want to delete, by clicking anywhere on the row, and then click .
 - Click  at the end of the row with the rule you want to delete.

A dialog box appears.

5. Click **Delete** to delete the rule from the list.

Hyperlinks

Values in all character and numeric detail cells in selected Dynamic View columns can have defined hyperlinks to query MES and other systems to display additional information in a new window.

All hyperlinks of the current document type are listed on the Hyperlinks page.

NOTE: The **Hyperlink** tab is displayed only if a premining model name is defined for the current document type.



To display the Hyperlink page

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Open a document type for editing by clicking its name.
3. Click the **Hyperlink** tab.

The **Hyperlink** tab displays the list of hyperlinks assigned to a document type. Use this page to [add](#), [edit](#), or [remove](#) a hyperlink from the list.

Adding a Hyperlink



To add a hyperlink

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Click the name of the document type you want to add a hyperlink to or click anywhere on the row, and then click .
3. Select the **Hyperlink** tab at the top of the page.
4. Click  to display the Hyperlink page.
5. Make changes to the following items:
 - a. **Model name**: Shows the current index model.
 - b. **Field Name**: Select a field name from the list.
 - c. **Hyperlink Type**: Select the hyperlink type:
 - i. **Inner Document**: Select to link to the most recent single Document of the specified Document Type where the Index Value is equal to the cell value from the hyperlink.
 - ii. **External Link**: Select a model field from the list.
 - d. **Connected Document Type**: The option becomes available if you select the **Inner Document** hyperlink type. Select a connected document type to search.
 - e. **Connected Index Field**: The option becomes available if you select the **Inner Document** hyperlink type. Select a connected index field to use.
 - f. **Url Template**: The option becomes available if you select the **External Link** hyperlink type. Define a URL template for the link.
 - g. **Test Value**: The option becomes available if you select the **External Link** hyperlink type. Enter a value you want to test. The field is not required.
 - h. **Preview**: The option becomes available if you select the **External Link** hyperlink type. Click, to preview the result in a new window.
6. **Save**: Saves the hyperlink. If the operation is finished successfully, the system displays the Document Type page.
7. **Clear**: Clears all the fields.

8. **Cancel**: Cancels the operation.

Editing a Hyperlink

To edit a hyperlink

The Hyperlink page appears.

5. Click **Save**. The system saves the modified hyperlink to the database and displays the updated Document Type page, if the operation is completed successfully.

Deleting a Hyperlink

2. On the Document Types page do one of the following:
 - Click the name of the document type you want to delete a hyperlink for.
 - Select the document type by clicking anywhere on the row, and then click .

The Document Type page appears.

3. Select the **Hyperlink** tab at the top of the page.
4. Do one of the following:
 - Select the hyperlink you want to delete, by clicking anywhere on the row, and then click .
 - Click  at the end of the row with the hyperlink you want to delete.

A dialog box appears.

5. Click **Delete**, to delete the hyperlink from the list.

Available Views

You can select views that will be available to users in the document (report) search results page.

To display the Available Views page

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Open a document type for editing by clicking its name.
3. Click the **Available Views** tab.

To define data views that are to be available for the current document type, select appropriate check boxes and click **Save**.

PDF Print Settings

You can define PDF export settings for printing from **Report** and **Table/Summary** views. These settings do not affect PDF printing from ES Style views (see [Adding a Template](#)).

To display the PDF Print Settings page

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Open a document type for editing by clicking its name.
3. Click the **PDF Print Settings** tab.
4. Define the appropriate settings and click **Save**.

Digital Signature Settings

You can set the requirement to provide a digital signature on Excel workbook exports.

Digital signatures can be applied to Excel exports using XSLX format and Monarch XMOD model format only.

A digital signature guarantees that data has not been manipulated after the spreadsheet was created by the Monarch Server.

To display the Digital Signature Settings page

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Document Types**.
2. Open a document type for editing by clicking its name.
3. Click the **Digital Signature Settings** tab.

The Digital Signature Settings page contains the following items:

- **Enable Digital Signature on this Document Type:** Select the check box, if you want to enable digital signatures on Excel workbook exports.
- **Certificate Name:** A digital signature may be acquired from a Certificate Authority (CA) or generated by Office 2007 Tools. Monarch Server only supports Digital Signatures based on User Stores (no support for file-based digital signatures). Therefore, the certificate name must always include the container reference ('CN=').
- **Friendly Name:** Optional and will be included with the certificate for the user's information.
- **Require Signature:** Select this check box to force a signature on all exports including those made by users without a user preference of XLSX format.
- **Save:** Click to save the settings.
- **Copy to All Document Types and Save:** Click to copy the settings to all document types and save.
- **Cancel:** Click to cancel the operation.

Filing Tasks

A filing task is used to [archive reports](#) into a [storage volume](#). After you have [configured a filing task](#), you can run it via a [filing process](#).


All filing tasks used in the system are listed on the Filing Tasks page. To display this page, click **Report Warehouse** on the Navigation Tree, then click **Document Management** and select **Filing Tasks**.

Use this page to [add](#), [edit](#), or [remove](#) a filing task.

Adding a Filing Task

Adding a [filing task](#) is one of the steps of archiving reports into the Monarch Server system. (See [Archiving Reports](#) for a list of steps you need to perform before you add a filing task.)

To add a filing task

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Filing Tasks**.
2. Click  to display the **Filing Task** page.
3. Fill in the boxes of the page and click **Save**.

The system saves the new filing task to the database and displays the updated **Filing Tasks** page, if the operation is completed successfully.

The **Filing Task** page contains the following items:

General Options

- **Filing Task Name:** Enter a unique name of a new filing task.
- **Description:** Enter any text defining the filing task. This step is optional.
- **Task Priority:** If there are several tasks in queue, the system will first handle those with higher priority. Select priority from the following options: **Lowest, Below Normal, Normal, Above Normal, Highest.**

Location

Select the location type from the following options: **Physical Location, Virtual Location.**

If you select the **Physical Location** type provide the following information:

- **Location:** Specify the CORBA name of the server, which you can select from the list. Select the **Any Location** option, if you specified a UNC path in the **File Path** field.

NOTE: If the required server is not on the list, refer to [Locations Management](#) topic to add a new location.

- **File Path :** Specify the path to a folder containing files to be processed or click the **Browse** button to locate it.
- **File Name Mask:** Specify an input file mask. You can use wildcard characters * (to substitute for any zero or more characters) and ? (to substitute for a single character).
- **Pin filing task to run only on the specified location:** Enable the check box to specify forcefully a particular machine for filing task implementation. The check box is used if you use distributed MS installation with **Datawatch.RemoteServices.FilingDispatcherServiceHost** module run on different locations. Enabling the check box displays the **Location to run** drop-down list.
- **Location to run:** Select a machine from the list for pinning the filing task. If no machine is selected for pinning the filing task, the Monarch Server system will select the most relevant machine for running the filing task. If the machine with stopped **Datawatch.RemoteServices.FilingDispatcherServiceHost** module is selected, the filing task will not be implemented.

If you select the **Virtual Location** type provide the following information:

- **Virtual Path:** Specify the virtual path to a folder containing files to be processed.
- **File Name Mask:** Specify an input file mask. You can use wildcard characters * (to substitute for any zero or more characters) and ? (to substitute for a single character).

NOTES:

- When editing the page, an administrator may add only one location.
- Location Names are case-sensitive. Use only names created during Monarch Server installation.

Document Groups

- **Document Group:** Select a document group from the list to narrow the selection list of document types.
- **Document Type:** Click the **Select Document Type** button to open a dialog box, where you can select the document type that you want to assign to a task.

Processing Type

- **Read and process internal indexes.** This option is selected by default. It is used for reading text and PDF reports where index values will be extracted and reports will be mined by users.
- **Process as native document.** This option is used for processing any file or document that does not require index values extraction, and mining from its content. Native documents can be indexed on fixed values ([Index defaults](#)), document date, and filename element values. This option requires licensing. To display native documents, appropriate software should be installed on the client's computer (for example, XLS documents will require MS Excel application or viewer).

File processing during filing


- **Pre-mine all processed reports for interactive data analysis:** Select this option, if you want table data to be extracted from the reports during the filing process and put into the Monarch Server database. Then the data can be used to build **Dynamic View** data views. This option requires licensing.

File processing after filing

Select one of the options listed below, which describe actions for processing files after filing. Files may be saved, deleted or moved to other directory.

- **Leave input files where they are**
- **Delete input files**
- **Move input files to the location** (specify folder)
- **Move files causing errors to folder** (specify folder)


NOTES:

- When specifying folder, you may use the naming macros to name the destination folder. To do this, click the **Insert Macro** icon  and select the [naming macros](#) from the drop-down list.
- The **File Path**, **Move input files to the location** and **Move files causing errors to folder** boxes define the path related to the server specified in the **Location** list.

Ok files processing before filing

Select one of the options listed below, which describe actions for processing input files with zero size before filing. Files may be deleted or moved to other directory.

- **Delete 0k input files**
- **Move 0k input files to the location** (specify folder)

NOTE: When specifying folder, you may use the naming macros to name the destination folder. To do this, click the **Insert Macro** icon  and select the [naming macros](#) from the drop-down list.

File Storage Options

- **Use separate PDF storage in addition to plain text storage:** For filing of PDF reports only. When PDF reports are filed, the text is stripped and stored in Monarch Server for fast and efficient mining operations. If this option is selected, the original PDF report is also stored for separate retrieval.
- **Store Original Report:** When reports are read and indexed for storage, their format is changed to enable fast and efficient retrieval and mining. Selecting this option will also store the original report, as read, to the storage system.
- **Pages / Storage Unit:** In storing reports, there are trade-offs between the compression ratio (disk space requirements) and speed of retrieval. A higher number of **Pages / Storage Unit** can provide dramatically increased storage compression but at a possible cost of reduced retrieval efficiency and performance.

Other Processing Options

- **Automatically start task when a new file appears:** If you select this option, a filing process definition is not required for the filing tasks. New files will be automatically queued and processed.
- **Task priority:** If there are several tasks in queue, the system will first handle those with higher priority. Priority is set by numeric values in inverse relation, meaning the higher the priority — the smaller the number, top priority being "1". By default, if this field is left blank, the system will consider it a top-priority task. (when Auto selected).
- **Log performance statistics:** Select this option to gather the following indexing performance statistics: keywords quantity, documents and pages quantities, time for each indexing stage, total time for task and task status. This information is collected in [Instance_Name][Filing_Task_Name][Date][Time].log files.
- **Block Reports:** Select the check box to block reports, so that reports cannot be searched for or viewed by non-admin users in MSCClient.

NOTE: You can also [block reports](#) via the **Report Instances** tab.

Redaction

Redaction settings are available only if a redaction license is enabled in MS.

- **Store reports redacted:** Select this option to allow storage reports to be stored with redaction. In this case reports are stored in the redacted format in storage volume.
- **Store mining data redacted:** Select this option to allow pre-mined data to be stored with redaction.
- **Save:** Saves a new or existing filing task.
- **Clear:** Clears all the boxes.
- **Cancel:** Cancels the operation.


NOTE: Identical reports may only be filed once. Reports with the same attributes (file name, file date, and file size) as a previous report will not be filed for the same Document Type.

Assigning Filing Tasks to Filing Processes

To execute a [filing task](#), you need to assign it to a [filing process](#). The filing process runs and executes the filing task at a certain time, according to the scheduled execution frequency.

NOTE: You can [configure a new filing process](#) and add the filing task to it, or you can add the task to an already existing process.

To assign a filing task to a filing process

1. On the Navigation List, click Report Warehouse, then click Filing Processes. The Filing Processes page appears.
2. Do one of the following:
 - Click the name of the filing process you want to add a filing task to.
 - Select the filing process by clicking anywhere on the row, and then click .

The Filing Process page displays.


3. Drag the task you want to assign to the process, from the **Available Tasks** pane to the **Assigned Tasks** pane.
4. Check the process execution frequency and make any adjustments to it, if necessary.
5. Click **Save**.

The process will execute the filing task according to the scheduled execution frequency.

NOTE: If you prefer, you can execute the process immediately by clicking the **Run Now** button.

Editing a Filing Task

To edit a filing task

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Filing Tasks**.
2. Do one of the following:
 - Click the name of the filing task you want to edit.
 - Select the filing task, by clicking anywhere on the row, and then click .

The Filing Task page appears. For details about how to change its items refer to [Adding a Filing Task](#).



3. Make the necessary changes.

The following tabs become available when you edit an existing filing task:

- **Pre Processing** tab: Allows you to define the list of applications with appropriate parameters, which will be launched before carrying out the current task. For details, see [Extra Processing page](#).
 - **Index Defaults** tab: Allows you to edit index default values for a filing task. For details, see [Edit Index Defaults](#).
 - **Post Processing** tab: Allows you to define the list of applications with appropriate parameters, which will be launched after carrying out the current task. For details, see [Extra Processing page](#).
 - **Filing Results** tab: Allows you to display the filing results, which are generated for the task where these results are available. For details, see [Filing Results page](#).
4. Click **Save**. The system saves the modified filing task to the database and displays the updated Filing Task page, if the operation is completed successfully.

Deleting a Filing Task

To delete a filing task from the list

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Filing Tasks**.
2. Do one of the following:
 - Select the filing task you want to delete, by clicking anywhere on the row, and then click .
 - Click  at the end of the row with the filing task you want to delete.

A dialog box appears.

3. Click **Delete** to delete the filing task from the list.

Extra Processing Page

The Extra Processing page allows you to define and edit pre-processing and post-processing actions for [filing tasks](#). These actions will be launched before or after carrying out a filing task.

To access the Extra Processing window

1. Click **Report Warehouse**, then click **Document Management** and select **Filing Tasks**.
2. Click the name of a task you want to specify pre-processing or post-processing actions for.
3. Select the **Pre Processing** or **Post Processing** tab at the top of the Filing Task page.

The Extra Processing page contains:

- **Extra Processing** pane: Displays the path to the specified executable file, the specified **Ignore Fail** setting (that is, **Yes** or **No**), and the specified command line parameters.

NOTE: Pre- and post-processing actions are executed in the order in which they are listed in the **Extra Processing** pane. To change the order, drag an item up or down.

- The **Add** button: Click to add an extra processing action to the list. The **Add Extra Process** dialog box appears, containing the following items:
 - **Executable File:** Enter the path to an executable file to be used for pre- or post-processing.
 - **Command Line Parameters:** Enter a command statement and any necessary parameters of a process, which you want to launch before or after carrying out the current task.
 - **Ignore Fail:** Specify the desired **Ignore Fail** setting by either selecting this check box (to specify a **Yes** setting) or leaving it unselected (to specify a **No** setting). The **Ignore Fail** setting specifies whether or not the filing task should still be run if a pre- or post-processing action fails. Select **Yes** to have the filing task run if the pre- or post-processing action fails, or **No** to prevent the filing task from running if it fails.
- The **Save** button: Saves the new extra process.
- The **Clear** button: Clears all boxes.
- The **Cancel** button: Cancels the operation.

Edit Index Defaults Page


You can specify [index defaults](#) for a document type. Whenever documents of that type are [archived in the system](#) via a [filing task](#), the default index values are applied to them. Monarch Server users can then retrieve these documents by using the default index values in their search criteria.

To access the Edit Index Defaults page

1. Click **Report Warehouse**, then click **Document Management** and select **Filing Tasks**.
2. Click the name of a task you want to edit index defaults for.
3. Select the **Index Defaults** tab at the top of the page.

The Edit Index Defaults page contains:

- **Default Values** pane: Displays the paired index fields and values you have specified.

NOTE: Click  to delete an index field and value selected in the **Default Values** pane.

- The **Index** list: Select the index field, for which you want to specify a default value.

Note: The list includes index fields assigned to the document type specified in the **Document Type** field on the [Filing Task page](#).

- The **Value** field: Enter a default value for the selected index field.

You can build default values from file-name elements:

- a. Click the **Select** button. The **Index Value** dialog box appears.
 - b. Type any optional text in the **Index-Value String** field.
 - c. Specify the element number and delimiter.
 - d. Click **Apply**. The file name macro ([FNE <element number>/<delimiter>]) will be added to the string. For example, if you specify the element number as **1** and the delimiter as a period (.), then the first element of the file name before the period will be included in the index-value string.
 - e. Click **Save**.
- The **Add** button: Click to add the paired index field and value to the Default Values field.
 - The **Save** button: Saves any changes you have made to the settings.
 - The **Clear** button: Clears all boxes.
 - The **Cancel** button: Closes the window without saving any changes to the settings.

Filing Results Page

The system collects the following data about all filing task executions:

- Files and documents created by a particular filing task execution
- Filing task start time and date
- Filing task finish time and date


You can view the list of all filing task executions on the Filing Results page.


To access the Filing Results page

1. Click **Report Warehouse**, then click **Document Management** and select **Filing Tasks**.
2. Click the name of the task you want to view filing results for.
3. Select the **Filing Results** tab at the top of the page.

The Filing Results page shows the number of summary documents being processed by all filing tasks during the period indicated in the **From** and **To** columns. The number of summary documents is shown in the **Number of Documents** column. To display the **Start Time** and **Finish Time** of each filing task, click a plus sign in the first column.

Using the drop-down list at the top of the table, you can display filing task executions grouped by the following periods: **None** (all executions are shown), **Daily**, **Weekly**, and **Monthly**.

Click  to edit filing task results (change the report date range or block all reports).

An administrator can delete any particular filing task result or a group of filing task results by clicking . When deleting particular groups of filing task results, all selected filing task results will be deleted. When deleting filing tasks results, all files and documents created by the filing task execution will be deleted (similar to maintenance task deletions).

NOTE:

Deletion of a filing task result will delete all reports that were filed by the original filing task.

The number of items shown per page is limited by the value of the **Count of items per page** item in system preference (settings). For more information refer to [System Settings](#).

Filing Processes

Filing processes are used to schedule and run [filing tasks](#). When a filing process [runs](#), it executes all filing tasks that are assigned to it.

All filing processes used in the system are listed on the Filing Processes page. To display the Filing Processes page, click **Report Warehouse** on the Navigation Tree, then click **Document Management** and select **Filing Processes**.



The Filing Processes page lists the existing filing processes.

The list shows

- Process name
- Run Now (click  to run the process immediately)
- Suspend status
- Last started date and time
- Last finished date and time
- Next execution date and time of the current process


Use the Filing Processes page to [add](#), [edit](#) or [delete](#) a filing process.

You can also:

- Suspend all processes, by clicking the **Suspend** button below the list.
- Resume all processes, by clicking the **Resume** button below the list.
- Run a process immediately, by clicking the  icon next to its name.
- Update the status of filing processes by clicking the  icon, below the list.

Adding a Filing Process

To add a filing process

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Filing Processes**.
2. Click  to display the **Filing Process** page.
3. **Name:** Enter a unique name of a new process.
4. **Number of concurrent tasks:** Enter the number of the concurrent tasks. Enter **1**, if you want several tasks to be executed sequentially. Enter the actual number of tasks, if you want them to be executed simultaneously.
5. **Suspended:** Select this check box, if you want to suspend the current process.
6. **Available Tasks:** Displays all available tasks, from which you can select the tasks to assign to the current process. To add a task, drag it from the left pane to the right pane.


NOTE: You can search for a particular task by typing (part of) its name in the **Filter by** field and clicking **Apply**.

7. **Assigned Tasks:** The tasks in this pane will be assigned to the current process. The tasks are carried out in the order they appear on the list. To change the order, drag an item up or down. To remove a task, drag it to the left pane.
8. **Execution Frequency:** These options allow you to set periodicity of launching the current process. For more information, see [Defining Execution Frequency](#).

9. To save the new process, click the **Save button**.
The system saves the new process to the database and displays the updated **Filing Processes** page, if the operation is completed successfully.
10. To allow an administrator to launch the process immediately and save the schedule in the database with the **Run Once** scheduling type and the current date as a date to run, click **Run Now**.
11. To reset the values, click the **Clear** button.
12. To close the **Filing Process** page without saving, click **Cancel**. Keep in mind that no changes will be saved.



Editing a Filing Process

To edit a filing process

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Filing Processes**.
2. On the Filing Processes page, do one of the following:
 - Click the name of the filing process you want to edit.
 - Select the filing process, by clicking anywhere on the row, and then click .
3. The Filing Process page appears. For details about how to change its items refer to [Adding a Filing Process](#).
4. Make the necessary changes and click **Save**. The system saves the modified process to the database and displays the updated Filing Processes page.

Deleting a Filing Process

To delete a filing process

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Filing Processes**.

 - Select the filing process by clicking anywhere on the row, and then click .
 - Click  at the end of the row with the filing task you want to delete.

A dialog box will appear.


3. Click **Delete** to delete the filing process from the list.

Assigning Filing Tasks to Filing Processes

To execute a [filing task](#), you need to assign it to a [filing process](#). The filing process runs and executes the filing task at a certain time, according to the scheduled execution frequency.

NOTE: You can [configure a new filing process](#) and add the filing task to it, or you can add the task to an already existing process.

To assign a filing task to a filing process

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Management** and select **Filing Processes**.
2. Do one of the following:
 - Click the name of the filing process you want to add a filing task to.
 - Select the filing process, by clicking anywhere on the row, and then click .
3. Drag the task you want to assign to the process, from the **Available Tasks** pane to the **Assigned Tasks** pane.
4. Check the process [execution frequency](#) and make any adjustments to it, if necessary.
5. Click **Save**.

The process will execute the filing task according to the scheduled execution frequency.

NOTE: If you prefer, you can execute the process immediately by clicking the **Run Now** button.

Running a Filing Process

When a [filing process](#) runs, it executes all [filing tasks](#) assigned to it. A filing process can be run in two ways:

- **Manually** — To run a filing process manually, click the **Run Now** button on the [Filing Process page](#). You can do this immediately after you've finished [configuring a new process](#). (**Note:** When you click the **Run Now** button, there may be a brief delay before the process actually runs. This is due to a time discrepancy between the server's clock and the clock on the local machine. Processes are run according to the time of the server's clock.)
- **Scheduled** — To execute a filing process at a scheduled runtime, [specify the execution frequency](#) for it on the [Filing Process page](#), then click the **Save** button. The process will be executed at the specified time.

Search Groups


Search groups provide a convenient way of grouping similar or related [searches](#) together.

All search groups used in the system are listed on the Search Groups page. To display the Search Groups page, click **Report Warehouse** on the Navigation Tree, then click **Document Retrieval** and select **Search Groups**.

Use this page to [add](#), [edit](#) or [delete](#) a search group.

Adding a Search Group

To add a search group

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Search Groups**.
2. Click  on the **Search Groups** page.
3. **Search Group Name:** Enter a unique name of a new search group.
4. **Description:** Optionally, enter any text defining the search group.
5. **Available Searches:** The searches from this pane may be assigned to the current search group. To add a search, drag it from the left pane to the right pane.


NOTE: You can search for a particular query by typing (part of) its name in the **Filter by** field and clicking **Apply**.

6. **Assigned Searches:** Displays the searches selected by an administrator for the current search group. To remove a search, drag it to the left pane.
7. To save a search group, click the **Save button**.
The system saves the new search group to the database and displays the updated **Search Groups** page, if the operation is completed successfully.
8. To reset the values, click the **Clear** button.
9. To close the **Search Groups** page without saving, click **Cancel**. Keep in mind that no changes will be saved.

NOTE: If you assign a search to the current search group, the system automatically excludes it from the search group, which had contained it before. If you exclude a search from the search group, it will not appear in MSCClient.


Editing a Search Group

To edit a search group

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Search Groups**.
2. Click the name of the search group you want to edit or click anywhere on its row, and then click . The **Search Group** page appears. For details about how to change its items refer to [Adding a Search Group](#).
3. Make the necessary changes and click **Save**.
The system saves a modified search group to the database and displays the updated **Search Groups** page, if the operation is completed successfully.

Deleting a Search Group

To delete a search group from the list

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Search Groups**.
2. Click  at the end of the row with the search group you want to delete. A dialog box appears.
3. Click **Delete** to delete the search group from the list.

Searches


[Searches](#) allow Monarch Server users to query the report warehouse and retrieve documents that match the search criteria. You can add pre-configured searches to the system and then assign them to users (see [Adding a Search](#)). You can also [grant users the Document Search privilege](#), which allows them to configure their own searches.

All searches used in the system are listed on the Searches page. To display this page, double-click **Report Warehouse** on the Navigation Tree, then click **Document Retrieval** and select **Searches**.

Use this page to [add](#), [edit](#) or [delete](#) a search.

Adding a Search

To add a search to the list


1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Searches**.
2. Click  on the **Searches** page.
3. **Search Type**: Select either **Document Search** or **Report Search**.
4. **Search Name**: Enter a unique name of a new search.

5. **Search Group:** Select a search group, to which the current search will be assigned.
6. **Document Groups:** Select a document group, where the search is to be made.
7. **Available Document Types:** This pane displays available document types, which depends on the selected document group. To add a document type, drag it from the left pane to the right pane.
8. **Assigned Document Types:** This pane displays the assigned document types.
9. **Document Date:** [Using the calendar](#), define the time interval to be covered by the current search.
10. **Annotation Criteria:** Define whether the search should include annotated reports, non-annotated reports or all reports.
11. **Search Criteria:** To specify additional search criteria, including several conditions that involve multiple keyword types and keyword values, click the **Add condition** button.
12. Select a Boolean operator (**AND** or **OR**). While the **AND** operator can be used to link search criteria of different keyword types, the **OR** operator can only be used to link search criteria of the same keyword type.
13. Select a keyword type. The list contains keyword types that are used in the selected document types.
14. Select a relational operator (equal to (=), not equal to (<>), less than (<), greater than (>), less than or equal to (<=), greater than or equal to (>=)).
15. Enter a keyword value. To look up available keyword values, click the **Lookup** button.
16. To add another condition, click the **Add condition** button and repeat steps 2-5. To remove a condition, click the **Remove** button.
17. To save a new or existing search, click the **Save button**.
The system saves the new search to the database and displays the updated **Searches** page, if the operation is completed successfully.
18. To reset the values, click the **Clear** button.
19. To close the **Search** page without saving, click **Cancel**. Keep in mind that no changes will be saved.

Assigning Searches

After you [configure](#) a [search](#), you can assign it to [roles](#), [user groups](#) and [users](#), so that they can use it.


To assign a search to roles, user groups and users

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Searches**.
2. Select the search you want to assign to roles, user groups, or users:
 - Click the name of the search you want to assign to roles, user groups, or users; or
 - Clicking anywhere on the row, and then click .
3. Click the **Rights** tab at the top of the page. The **Rights** tab is available only for existing objects (in the **Edit** mode).

4. To make a search available to all users, select **Global** check box and click the **Save** button.
Otherwise proceed to the next steps.
5. Click **User Groups** to expand the section enabling you to select user groups that you want to have access to the search.
To select a user group, drag it from the left pane to the right pane.
6. Click **Roles** to expand the section enabling you to select roles that you want to have access to the search.
To select a role, drag it from the left pane to the right pane.
7. In the **Users** section, select users that you want to have access to the search.
To select a user, drag it from the left pane to the right pane.
8. Click the **Save** button.

Editing a Search

To edit a search

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Searches**.
2. Select the search you want to edit on the **Searches** page:
 - Click the name of the search you want to edit, or
 - Clicking anywhere on the row, and then click .The **Search** page appears. For information on how to change search options, see [Adding a Search](#).
3. To [assign the search](#) to roles, user groups and users, select the **Rights** tab at the top of the page.
4. Make the necessary changes and click **Save**. The system saves the modified search in the database and displays the updated Search page, if the operation is completed successfully.


Deleting a Search

You can delete a [search](#) from the system at any time. Keep in mind, however, that if you delete the search, users will no longer be able to use it.

NOTE: In some cases it makes more sense to [edit the search](#) (deny everyone's access rights to it) rather than to delete it outright. If you delete it, in the future if you find that you need the same search (or a similar one), you will have to configure and save it all over again. If, instead of deleting it, however, you remove everyone's access to it, you could easily "activate" it in the future should you need to do so.

To delete a search from the list

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Searches**.
2. Select the search you want to delete on the **Searches** page:

- Click the name of the search you want to delete, or
 - Clicking anywhere on the row, and then click . A dialog box appears

Search Notifications

Search notifications are an automated way of notifying Monarch Server users via e-mail that a scheduled search has been run. Only authorized users of the Monarch Server system may receive search notifications.

A scheduled search runs at a certain time according to its specified execution frequency. Search notifications automatically trigger an e-mail to specified users, notifying them that the search has occurred and providing a link to the resulting document list. Users may subscribe to permitted notifications from MSCient.

Unlike [system notifications](#), search notifications are not predefined.

NOTE:


- You can only create, edit and delete notifications if you have been granted **Create Notification** rights by your system administrator. If you have not been granted notification rights, however, and another Monarch Server user with notification rights assigns a notification to you, you can still select it (that is, turn it on) and be notified, when a search occurs.
- The creator of the notification automatically receives the rights to the notification.

Search notifications are listed on the Search Notifications page, which you can use to [add](#), [edit](#), or [remove](#) search notifications.

To display the Search Notifications page, click **Report Warehouse** on the Navigation Tree, then click **Document Retrieval** and select **Search Notifications**.

Adding a Search Notification

To add a search notification

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Search Notifications**.
2. Click  on the Search Notifications page. The **Search Notification** page appears.
3. **Search Notification Name** box: Enter a unique name for a notification.
4. **Search Groups** drop-down list: Select the search group that contains the search you want to apply a notification to.
5. **Searches** box: Select the search that you want to apply a notification to. (**Note:** Available searches are determined by the search group you specified earlier.)

NOTE: You can search for a particular query by typing (part of) its name in the **Filter by** field and clicking **Apply**.

6. **Execution Frequency:** To [set the periodicity](#) of launching the notification, select an appropriate option and fill in additional fields that appear.
7. To save the new notification, click the **Save** button.
The system saves the new notification to the database and displays the updated Notifications page, if the operation is completed successfully.
8. To reset the values, click the **Clear** button.
9. To close the **Search Notification** page without saving, click **Cancel**. Keep in mind that no changes will be saved.

NOTE:


You can assign a notification to a role, user group or user via the **Rights** tab, which is available only for existing search notifications. For more details see [Editing a Search Notification](#).

At a specified time the search runs, and all users, who turned on the notification, receive an e-mail notification.

Editing a Search Notification

You can edit a [search notification](#) that you have added. You cannot edit search notifications added by other Monarch Server users. If these notifications have been assigned to you, however, you can turn them on or off (that is, specify whether you want them applied to you or not).

To edit a search notification

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Search Notifications**.
2. Select the search notification you want to edit on the Search Notifications page:
 - Click the name of the search notification, or
 - Select the search notification, by clicking anywhere on the row, and then click .The **Search Notification** page appears. For details about how to change its items refer to [Adding a Search Notification](#).
3. To assign a search to a role, user group or user, click the **Rights** tab at the top of the page.

NOTE: The **Rights** tab is available only for existing objects (in the **Edit** mode).

4. To make a search notification available to all users, select **Global** check box and click the **Save** button.
Otherwise proceed to the next steps.

3. Click **Delete** to delete the search notification from the list.

System Notifications

System notifications are an automated way of notifying Monarch Server users via e-mail that a particular system event has occurred. Only authorized users of the Monarch Server system may receive notifications.

The events that trigger system notification are pre-defined and cannot be edited or deleted. Typically, these types of notifications are sent to system administrators who are monitoring the system. Users may select which of the notifications are sent to them. Notifications may be sent to more than one user.

System notifications are listed on the System Notifications page. They are pre-defined and can not be edited or deleted.

To display the System Notifications page, click **Report Warehouse** on the Navigation Tree, then click **Document Retrieval** and select **System Notifications**.

To assign rights to receive a system notification

1. Click the name of a system notification.
2. To make a system notification available to all users, select **Global** check box and click the **Save** button. Otherwise proceed to the next steps.
3. Expand hidden sections by clicking the **User Groups**, or **Roles** heading. To specify the roles, groups or users that you want to have rights to the system notification, drag their names from the left pane to the right pane (in an appropriate section).
4. Click **Save**.

NOTE: Assigning rights to a system notification does not mean that the notification will be sent. It only allows users to receive the notification, if they request it. Each user must specifically request each notification they want to receive.

You can also assign rights to receive system notifications in the following way:

1. In MSAdmin, click **Rights and Privileges**, and select either **Roles**, **User Groups**, or **Users**.
2. Click the name of a role, user group or user, to whom you want to assign rights.
3. Select the **System Notifications** tab at the top of the page.
4. Drag appropriate items from the **Available System Notifications** pane to the **Assigned System Notifications** pane.
5. Click **Save**.

Users may receive notifications for the following event types:

- **FILING - Filing process completion events:** Sends an e-mail to the user whenever any filing process completes.
- **FILING - Filing process - Database error events:** Sends an e-mail to the user whenever a database error occurs during a filing process.
- **FILING - Filing process - Generic error events:** Sends an e-mail to the user whenever a non-specific error occurs during a filing process.
- **FILING - Filing process - Disk off-line error events:** Sends an e-mail to the user whenever a disk offline error occurs during a filing process.
- **FILING - Filing process - Not enough space error events:** Sends an e-mail to the user whenever insufficient space error is encountered during a filing process.
- **FILING - Filing process - File system error events:** Sends an e-mail to the user whenever a file system error is encountered during a filing process.
- **FILING - Filing process - No sub volume error events:** Sends an e-mail to the user whenever no sub-volume error is encountered during a filing process.
- **MAINTENANCE - Maintenance process completion events:** Sends an e-mail to the user whenever any maintenance process completes.
- **DISK_OFFLINE - Offline disk request events:** Sends an e-mail to the user whenever any offline disk request is issued.
- **VOLUME_FULL - Volume full events:** Sends an e-mail to the user whenever a volume becomes full.
- **VOLUME_ALMOST_FULL - Volume almost full events:** Sends an e-mail to the user whenever the sum of the used volume size and twice the amount of the maximum size of the subvolume is greater than or equal to the maximum size of the volume, i.e., **used volume size + (max subvolume size) × 2 >= max volume size**. This condition is checked before subvolumes rollover in volume (the first subvolume is created automatically).

- **LAST_VOLUME - Last volume usage events:** Sends an e-mail to the user whenever documents begin to be archived in the last volume in a storage group.
- **ONLY_ARCHIVE_REPORT - Working report request events:** Sends an e-mail to the user whenever a request is submitted to restore an archived report to a working state.
- **FILE_OFFLINE - Offline file request events:** Sends an e-mail to the user whenever an offline file request is made.
- **ERROR - All error events:** Sends an e-mail to the user whenever any process results in an error condition.
- **WARNING - All warning events:** Sends an e-mail to the user whenever any process receives a warning.
- **SEARCH - New search creation events:** Sends an e-mail to the user whenever a new search is created.

Filing Notifications

Filing notifications are an automated way of notifying Monarch Server users via e-mail that a filing event has occurred. Only authorized users of the Monarch Server system may receive filing notifications.


Filing notifications are listed on the Filing Notifications page, which you can use to [add](#), [edit](#), or [remove](#) notifications.

To display the Filing Notifications page, click **Report Warehouse** on the Navigation Tree, then click **Document Retrieval** and select **Filing Notifications**.

NOTE: Users may subscribe to or unsubscribe from filing notifications via the MSClient application.

Adding a Filing Notification

To add a filing notification

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Filing Notifications**.
2. Click  on the Filing Notifications page. The **Filing Notification** page appears.
3. **Filing Notification Name:** Enter a unique name of a new notification.
4. **Filing Description:** Optionally, enter any text defining the filing notification
5. **Document Groups:** Select a document group that contains the document type you want to apply the notification to.
6. **Document Types:** Select the document types to be included in the filing notification definition.
7. **Run immediate:** Select this check box to execute the filing notification immediately upon the filing completion event. Each filing notification will be sent as an individual e-mail.
8. **Execution Frequency:** These options become available if you have not selected the **Run immediate** check box. You can [set the frequency](#) of executing filing notifications.
9. To save a new or existing filing notification definition, click the **Save** button.


10. To reset the values, click the **Clear** button.
11. **Save**: Saves a new or existing filing notification definition.
12. To close the **Filing Notification** page without saving, click **Cancel**. Keep in mind that no changes will be saved.

NOTE: You can assign a notification to a role, user group or user via the **Rights** tab, which is available only for existing search notifications. For more details see [Editing a Filing Notification](#).

Editing a Filing Notification

You can edit any filing notification that you have added. You cannot edit filing notifications added by other Monarch Server users. If these filing notifications have been assigned to you, however, you can turn them on or off (that is, specify whether or not you want them applied to you) in MSCClient.

To edit a filing notification

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Filing Notifications**.
2. Select the filing notification you want to edit on the **Filing Notifications** page:

2. Click **X** at the end of the row with the filing notification you want to delete. A dialog box appears.
3. Click **Delete** to delete the filing notification from the list.

Offline Tasks

Offline processing provides the ability to process large datasets in the offline mode on a scheduled basis. If a user requests some operation (view report, table, summary, and so on) for a dataset of a size exceeding the system limit, Altair offers to process such requests in the offline mode. Schedule information for this task includes the start and stop time, which allows executing the task at the specified time only.

All offline tasks used in the system are listed on the Offline Tasks page. To display the page, click **Report Warehouse** on the Navigation Tree, then click **Document Retrieval** and select **Offline Tasks**.

The **Offline Tasks** page displays the following information:

- **User Name:** Displays the user name for an offline task.
- **Task Name:** Displays the name of an offline task.
- **View Type:** Displays one of the following view types: **Table**, **Summary**, **Excel**, or **PRF**.
- **Creation Date:** Displays the creation date and time of an offline task.
- **State:** Displays the state of the offline task. It can be one of the following: **Ready**, **Processing** or **Pending**.

To delete an offline task from the list


1. Click **X** at the end of the row with the offline task you want to delete. A dialog box appears.
2. Click **Delete** to delete the offline task from the list.

Offline Processes

Offline processes are used to schedule and run offline tasks. When an offline process [runs](#), it executes all [offline tasks](#) that are assigned to it.


All [offline processes](#) used in the system are listed on the Offline Processes page. To display the Offline Processes page, click **Report Warehouse** on the Navigation Tree, then click **Document Retrieval** and select **Offline Processes**.

The list shows

- Process name
- Run Now (click  to run the process immediately)
- Suspend status
- Last started date and time
- Last finished date and time
- Next execution date and time of the current process


Use the **Offline Processes** page to [add](#), [edit](#), or [remove](#) an offline process from the list.

You can also:

- Suspend all processes, by clicking the **Suspend** button below the list.
- Resume all processes, by clicking the **Resume** button below the list.
- Run a process immediately, by clicking the  icon next to its name.

Adding an Offline Process

To add a process

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Offline Processes**.
2. Click  on the Offline Processes page. The Offline Process page appears.
3. Fill in the boxes of the page and click **Save**. The system saves the new process in the database and displays the updated Offline Processes page, if the operation is completed successfully.

This page contains the following items:

- **Name:** Enter a unique name of a new process.
Note: All tasks with the **Pending** status will be automatically assigned to the current process.
- **Processing Length:** Specify the value between 1 and 60 for the field processing length.
- **Suspended:** Select this check box to suspend the current process.
- **Execution Frequency:** These options allow you to set periodicity of launching the current process. For more information, see [Execution Frequency](#).
- **Save:** Saves a new process.
- **Run Now:** Allows an administrator to launch the process immediately and saves the schedule in the database with the **Run Once** scheduling type and the current date as a **Date to run**.
- **Clear:** Clears all the boxes.
- **Cancel:** Cancels the operation.

Running an Offline Process

When an [offline process](#) runs, it executes all offline tasks assigned to it. A offline process can be run in two ways:


- **Manually** — To run an offline process manually, click the **Run Now** button on the [Offline Process page](#). You can do this immediately after you've finished configuring a new process, or you can manually run a previously configured process by going to the Offline Processes page, selecting the process you want to run, and then clicking the **Run Now** button.

NOTE: When you click the **Run Now** button, there may be a brief delay before the process actually runs. This is due to a time discrepancy between the server's clock and the clock on the local machine. Processes are run according to the time of the server's clock.

- **Scheduled** — To execute an offline process via a scheduled runtime, specify the execution frequency for it on the Offline Process page, then click **Save**. At the specified time, the process will be executed.

Editing an Offline Process

To edit a offline process



1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Offline Processes**.
2. Do one of the following:
 - Click the name of the offline process you want to edit.
 - Select the offline process, by clicking anywhere on the row, and then click .

The Offline Process page appears. For details about how to change its items refer to [Adding an Offline Process](#).

3. Make the necessary changes and click **Save**. The system saves the modified offline process to the database and displays the updated Offline Processes page, if the operation is completed successfully.

Deleting an Offline Process

To delete an offline process

1. On the Navigation Tree, click **Report Warehouse**, then click **Document Retrieval** and select **Offline Processes**.
2. Do one of the following:
 - Select the offline process you want to delete, by clicking anywhere on the row, and then click .
 - Click  at the end of the row with the offline process you want to delete.

A dialog box appears.

3. Click **Delete** to remove the offline process from the list.



4. Under each document type you can specify items for export. The following items are imported by default: Index Model, Document Type Group, Index Fields, PDF Settings, Digital Signatures, and Available Views.
5. Under **Storage Group**, select the target storage group from the list. If you select the *[inherit]* value then the imported document type(s) will be placed to the storage group specified in the **Storage Group** field at the bottom of the page.

6. In the **Name Template** field, specify the name(s) for the imported file(s). For this either type in the name you want to assign to the imported document type(s) or insert the following values: name, date, time or space, by clicking the appropriate buttons. The name specified in the **Name Template** field will be used for all imported document types. You can also specify names for each item in the editable fields.
7. Click the **Import** button to import document type(s).

Automator

Automator is a data conversion solution that uses existing ASCII or ANSI reports, PDF files, XPS files, ISAM files (e.g. XLS, MDB, ACCDB, DBF, Open XML Spreadsheets (XLSX/XLSM), html files, and OLEDB/ODBC sources as a source for data. You can input report files (e.g., TXT, DAT, PRN, LOG, .etc.) into Automator and then export their data to a variety of formats (e.g., PDF, XLS, XLSX/XLSM, MDB, ACCDB, HTML, DBF, etc.) or to an OLE DB or ODBC destination. Automator also allows you to export files to a Microsoft Office SharePoint Server, FTP/SFTP site, email destination, or distribution list. In short, Automator lets you extract, transform, move and load data faster and more easily than previously possible.

Features and Functions

Automator has the following capabilities:

- Automated conversion of data from TXT, PDF, ISAM, XPS, and OLE DB/ODBC sources to an ISAM, or OLE DB/ODBC (e.g. SQL Server, Oracle) target by scheduled or event-driven execution via monitored folders.
- Email distribution of PDF, ISAM, and Open XML Spreadsheets
- File system and SharePoint distribution of input and export files
- RSS publication
- Visual Process Designer tool
- Creating logs and alerts resulting from operations
- Allowing user creation of pre-processes and post-processes using VB.NET Scripting
- Scheduled administration of job logs and database entries









Server Status

The **Server Status** page displays information detailing the current status of Automator.

To view the **Server Status** page, click **Automator** and select **Server Status**.

The **Server Status** page includes the following information:

- **Refresh Status**
 - **Interval (in seconds)**: Specify the refresh status interval in seconds.

- **Refresh Now:** Click the button to refresh status now.
- **Automatic:** Select this check box to refresh status at the specified interval automatically.
- **Server Status**
 - **Info from database**
 - **Standard Processes**
 - **Custodian Status:** Shows whether the custodian schedule is running.
 - **Jobs/Processes Currently Executing:** Shows the number of jobs in "Running" status. Hover over the  icon to view the names of the jobs.
 - **Process Queue Entries:** Shows the number of Standard Processes in the queue that have not been picked up by the dispatcher. Click the Delete button  to clear the current queue of Standard Processes. Hover over the  icon to view the names of the processes in queue.
 - **Active Jobs/Processes:** Shows the number of all jobs with the following status: "Process ready to run," "Process awaiting retry after a failed run attempt," "Process ready to run," "Job running," "Export failed and will be retried," "Process resolving Web addresses in a manifest," "Dispatcher host is not responding," and "Process is running PreProcess script." Hover over the  icon to view the names of active jobs.
 - **Process Count:** Shows the total number of processes in the system.
 - **Jobs/Logs Count:** Shows the total number of jobs in the system.
 - **Visual Processes**
 - **Jobs/Processes Currently Executing:** Shows the number of Visual Processes without completed dates and all other Visual Processes except those with the following status: "Process awaiting retry after a failed run attempt," "Orphan Job," and "Dispatcher host is not responding." Hover over the  icon to view the names of the processes being executed.
 - **Process Queue Entries:** Shows the number of Visual Processes in the queue that have not been picked up by the dispatcher. Click the Delete button  to clear the current queue of Visual Processes. Hover over the  icon to view the names of the processes in queue.
 - **Active Jobs/Processes:** Shows the number of Visual Processes without completed dates. Hover over the  icon to view the names of the active processes.
 - **Process Count:** Shows the total number of processes in the system.
 - **Jobs/Logs Count:** Shows the total number of logs in the system.
 - **Info from runtime**
 - **Standard Processes**
 - **Jobs/Processes Currently Executing:** Shows the number of jobs currently being executed.
 - **Active Jobs/Processes:** Shows the number of active jobs.
 - **Visual Processes**

- **Jobs/Processes Current Executing:** Shows the number of Visual Processes currently being executed.
- **Active Jobs/Processes:** Shows the number of active Visual Processes.

NOTE:

The database and runtime values should be ideally equal. However, in some cases, the database values may not be updated immediately once a job or process is executed. In this scenario, the database and runtime values will not be the same.

- **The number of processes in the system:** Shows the number of processes that have been reached but have NOT exceeded the number allowed by the license.

NOTE: If the number of processes in the system exceeds the number allowed by your license, the following message appears instead: "The maximum number of allowed processes per your license (XX) is exceeded." The number of processes is the total count of Visual and Standard Processes.

- **CPU Cores Usage:** Shows the number of CPU cores available for the system.

NOTE: When the number of CPU cores allowed by your license is exceeded, the following message appears: "The maximum number of allowed CPU cores per your license (XX) is exceeded." Here, "XX" is the number of CPU cores allowed by your license.

- **Dispatcher Status:** Displays a summary of the server status, including the server name, number of running jobs/ Visual Processes, and number of jobs/Visual Processes in queue.

- **Operations**

- **Orphan Automator Jobs:** Shows the number of jobs that are stuck in the running state and belong to hosts that do not exist in the current configuration.
 - **Reset:** Clicking this button executes the orphan Automator jobs on existing hosts
 - **Cancel:** Clicking this button cancels the orphan Automator jobs and sets them in canceled state (**NOTE:** For orphan Automator jobs with schedules, they will be executed accordingly on the basis of the schedules specified and will not be placed in canceled state)
- **Stuck Automator Jobs:** Shows the number of jobs that are stuck in the execution state because the host that performed these jobs is not responding.
 - **Reset:** Clicking this button executes the stuck Automator jobs on available hosts
 - **Cancel:** Clicking this button cancels the stuck Automator jobs and set in canceled state (**NOTE:** For stuck Automator jobs with schedules, they will be executed accordingly on the basis of the schedules specified and will not be placed in canceled state)
- **Job Processing Status:** Shows the current job processing status.

- **Start:** Click this button starts the Automator Dispatcher Service Host. Starting the dispatcher enables the running of new jobs.
- **Stop:** Click this button stops the Automator Dispatcher Service Host. Stopping the dispatcher disables the running of new jobs.

NOTE: When the **Job Processing Status** is disabled, a notification in the Admin interface and the logs would indicate the disabled status of the Automator Dispatcher Service Host.

Processes

A process contains a set of one or more XML project files (for example, XPRJ or DPRJ files) that are to be executed to perform a desired Automator operation. Processes utilize Monarch models and project files to extract data from text or database sources, and export it to various file types, such as, XLS, MDB, TXT, HTML, and XML.

Processes are configured on the **Processes** page of the Automator Standard Processes section. When adding a process, you name it, assign a project file or files to it, and set a schedule for when it is to be run.

All existing system processes are displayed on the **Processes** page. To view the **Processes** page, on the **Navigation Tree**, click **Automator > Standard Processes** and select **Processes**.


On this page you can view the following information:

- Process name

- Jobs column linked to the Jobs page
- Process description
- Process priority
- Usage column showing the current status of the process:
 - Monitored enabled
 - Monitored disabled
 - Scheduled enabled
 - Scheduled disabled
 - Ad hoc (i.e., no monitoring or schedule defined)

Use this page to:

To re-run a process, click the **Run Now** icon  .

Adding a Process

With Automator, you can configure processes to extract data from text or database sources and to export it to various file types (for example, XLS, MDB, TXT, HTML, XML).

To add a Process

1. On the **Navigation Tree**, click **Automator** and select **Standard Processes**.
2. On the **Processes** page, click the **Add** icon . The page with general process settings will be displayed.

NOTE: If you exceed the number of processes allowed by your license, the following message appears:

"The license for Monarch Server is used improperly. The maximum number of processes per your license (XX) is exceeded as you have NN processes currently defined and no more processes can be defined. You may delete unused processes or contact your Altair sales representative for extended options."

3. In the **Name** field, enter the name you want to assign to the process.
4. In the **Description** field, enter an appropriate description of the process.
5. Specify the number of projects per job:
 - **One project per job:** Select this option, to specify one project per job.
 - **Multiple projects per job:** Select this option, to specify several projects per job.

NOTE: If you select the **One project per job** option, each project assigned to the process will spawn its own job. If you select the **Multiple projects per job** option, all projects will be executed as one job. See [Process Handling Scenarios](#) for more information.

6. In the **Location** field, select the location type from the drop-down list.

NOTE: If the required server is not on the list, refer to [Locations Management](#) topic to add a new location. In case of a single server configuration, refer to Configurator Guide in the [Monarch Server Installation Guide](#) to change location settings.

If a process cannot be executed on the specified location (e.g., the server is unavailable, the server has high utilization, or the Automator Dispatcher module is not installed), then it will be executed on any available location with the least utilization.

7. In the **Project File Paths** box, specify at least one project file in the .xprj or .dprj format. For this click the **Add** button and the **Add Project File Path** window appears.

In the displayed window do one of the following:

- In the **Project File Path** field, type the path to the project file. Click **Save** to add the project file.
- From the the **Source Type** list, select the appropriate data source type and depending on the data source type specify other parameters:
 - If **Named Paths** selected, specify the [named paths](#) and choose the project file path from the list of displayed in the **Named Path Content** box. Click **Save** to add the project file.
 - If **Server Library** selected, specify the **Server Library** types and choose the **Server Library** from the list of displayed in the **Available Server Library** box. Click **Save** to add the project file.


NOTE: If you assign more than one project to the process, specify the order in which you want them to be processed. Projects in the list are processed from top to bottom.

8. Click the **Save** button to save the project or **Run Now** to run the project immediately. The system saves the new process to the database and displays the updated Process page, if the operation is completed successfully.

Editing a Standard Process

Once you have configured and saved a Standard Process, you can edit it at any time.

To edit a process

1. On the **Navigation Tree**, click **Automator** and select **Standard Processes**.
2. Click the name of the process you want to change or clicking anywhere on its row, and then click .
3. When you open a saved process for editing, the following additional tabs become available on the **Process Properties** page:
 - **General** tab: Allows you to [specify general settings](#).
 - **Advanced** tab: Use this tab to [specify advanced settings](#).
 - **Job Disposition** tab: Use this tab to [specify job log disposition settings](#).
 - **Monitoring** tab: Allows you to [specify input file monitoring settings](#).
 - **Script** tab: Allows you to add, view, or edit a [process-specific script](#).
 - **Schedule** tab: Allows you to [specify process schedule settings](#).
 - **Rights** tab: Allows you to assign process access rights to other users, roles or groups.

- **Alerts** tab: Allows you to define process alerts that will only act for the current process. Process alerts act in addition to global alerts. Adding and use of process alerts is identical to global alerts adding. Refer to [Alerts](#) section for details.

Specifying General Settings


For details about how to change general settings please refer to [Adding a Process](#).

After specifying general settings for the process, you can click the **Advanced** tab to specify [advanced settings](#) or you may click the **Save** button to save the general settings and close the page.

Specifying Advanced Settings

After you have created a process you can specify its priority, whether to allow parallel jobs, and whether to enable process retries.

To specify advanced settings for a process

1. On the **Navigation Tree**, click **Automator** and select **Standard Processes**.
2. Click the name of the process you want to change or click anywhere on its row, and then click .
3. On the displayed page, select the **Advanced** tab.
4. In the **Job Priority** field, specify the priority for the job.
When multiple processes are launched at the same time, the priority settings primarily determine the order they run. Other factors may affect the priority of a process. Select the priority from the following options:
 - Lowest
 - Below Normal
 - Normal
 - Above Normal
 - Highest
5. Select the **Allow Parallel Jobs** check box, if you want to allow parallel jobs.
When parallel jobs are enabled, Automator creates a job for each of the input files assigned to a process. This setting only applies to processes that contain multiple input files when the One Project Per Job option is selected on the General tab. Enabling parallel jobs should be used in conjunction with an output [naming macro](#) that ensures the creation of unique file names throughout the duration of the process, for example, the Job Number macro.

NOTE: The order of the projects in the process will not be observed, as all jobs will execute at the same time.

6. The **Process Priority** option is used for monitoring. If a number of processes have monitoring enabled and they are launched simultaneously, then processes with the highest priority run first. Any number from 1 to 255 is a valid process priority setting. Processes run in ascending numerical order according to their priority settings (for example, a process with the priority of 1 runs before a process with the priority of 2 or higher).
7. Set the behavior of the process when exporting to .accdb, .dbf, and .mdb in the **Export Behavior for accdb/dbf/mdb** option. The following options are available:
 - **Default** - Use this option for all new processes.

NOTE: The default behavior can be defined in the config.xml file as follows:

- **ACE DAO** - Use this option for better performance for large datasets. All exports in the system with this behavior will be executed concurrently. ACE OleDb will be used as fallback when output tables exist option is "Update existing rows" or "Update existing rows and append new."
- **ACE OleDb** - Use this option for better reliability. This behavior is slower than ACE DAO, but it allows to handle exports in parallel.

NOTE: The values for the **Export Behavior for accdb/dbf/mdb** option can be edited in [Bulk Edits](#) for several processes at the same time.

Take for example two jobs from different processes in a queue that exports to a different mdb.

- If the export behavior is set to ACE DAO, then the second job will wait for the first job. The second job just wastes a free slot in the ThreadPool.
- If the export behavior is set to ACE OleDb, then the two jobs will run in parallel.

- In summary, two jobs in parallel will be completed in ~10 min with ACE DAO and ~20 min with ACE OleDb.
- In case of five jobs in parallel, then they will be completed in ~25 min with ACE DAO and ~20 min with ACE OleDb.

8. Select the **Bulk Behavior for OleDb** check box to enhance performance of table-based exports only (not summary).

NOTE: This option is applicable for Oracle Database and Microsoft SQL Server OLEDB providers only.

9. Select the **Use Transaction** check box to revert the export via rollback if an error occurs during the export.

NOTE:

- The **Use Transaction** check box is only available when the **Bulk Behavior** check box is selected.
- Selecting this option will affect the performance of the table export and may require a large amount of system resources, especially for the target destination. Therefore, make sure to test this option first and then make the necessary adjustments.
- The transaction is valid for the export operation only and not for the overall process.

10. Select the **Retry automatically if process prerequisites are not satisfied** check box, if you want to enable process retries.

When configuring a process, one of the settings you can specify is a process retries setting. This setting allows a process to be retried if it fails for some reason, such as due to a process prerequisite not being met. When specifying a process retries setting, you may specify the interval for the retry in hours and minutes, as well as the number of retries to attempt.

The retry functionality can be useful in performing a type of polling, as well as dealing with delays in the arrival of files necessary for a process. For example, if you wish to poll for the existence of a file, you could set up a schedule that operates every 5 minutes and then set a retry that has an interval of 1 minute which retries 4 times.

11. Specify the desired retry interval in hours or minutes in the **Retry every n hours n minutes** field.

12. Select one of the following options:

- **Continue retrying for:** Select this option to specify the desired retry duration in minutes, hours and/or days.
- **Continue retrying indefinitely:** Select this option to continue retrying the process indefinitely until it successfully runs.
- **Retry at most n times:** Select this option to enter the maximum number of times you want Automator to retry the process.

13. Select the **Once found check n times for consistent file size** check box to specify that a file size check be carried out once the prerequisite is found. Also enter the number of times the check is to be carried out.

This allows the system to cope with file inputs from slow, unreliable or multi-stage write sources. Automator will test the input file, ensuring the file size has not changed for a specified period to ensure that the file is fully ready to be processed.

14. Specify a retry interval for checking the file size in the **Retry every n minutes**.


15. Select the **Retry automatically if job export failed** check box, if you want to enable failed export retries. This option allows to restart the process export provided it is blocked. When specifying an export retries setting, you can specify the interval for the retry in minutes and seconds, as well as the number of retries to attempt.
16. Specify the desired retry interval in minutes or seconds in the **Retry every n minutes n seconds** field.
17. Select one of the following options:
 - **Continue retrying indefinitely:** Select this option to continue retrying the failed export indefinitely until it successfully runs..
 - **Retry at most n times:** Select this option to enter the maximum number of times you want Automator to retry the failed export.
18. Click the **Save** button to save the current settings. The system saves the changes and displays the updated Process page, if the operation is completed successfully.

Specifying Job Log Disposition Settings for a Process

Job log disposition settings specify what to do with the job log after the job is finished, and under what circumstances the specified disposition will occur. Job log disposition settings can be specified on a process basis or you can specify default job log disposition settings, which will apply to all job logs.


NOTE: After you specify job log disposition settings for a [process](#), be sure to specify a schedule for the [Custodian](#) and enable it, as the Custodian is responsible for implementing the disposition settings. If you do not specify a schedule for the Custodian, the disposition settings will not be implemented.

To specify job log disposition settings for a process

1. On the **Navigation Tree**, click **Automator** and select **Standard Processes**.
2. Click the name of the process you want to change or click anywhere on the row, and then click .
3. On the displayed page, select the **Job Disposition** tab.
4. Select one of the following Job Log Disposition actions:
 - **Leave:** Leaves the job log in its current location and with its current name.
 - **Remove:** Removes the job log.
 - **Move:** Moves the job log to the location you specify.

You can either enter the destination folder path in the text box or select the folder by clicking the **Browse** button. The **Named Paths** dialog box will appear.

- From the **Named Paths** list, select the appropriate [named path](#).
- Select the folder from the list of displayed in the **Named Path Content** box.
- Click **Save** to add the folder.

NOTE: You can also use a [naming macro](#) to assign a new name to the job log by selecting one from the drop-down list. To do so, click the **Insert Macro** icon  and select the desired macro.


5. Select one of the following Apply Disposition By Job Status settings:
 - **Completed:** Select this check box, if you want the specified disposition to occur when a job is successfully completed. Use the adjacent fields to specify the number of days and/or hours after the job is completed that you want the disposition to occur.
 - **Failed:** Select this check box, if you want the specified disposition to occur when a job fails to run successfully. Use the adjacent fields to specify the number of days and/or hours after the job fails that you want the disposition to occur.
 - **Cancelled:** Select this check box, if you want the specified disposition to occur when a job is cancelled. Use the adjacent fields to specify the number of days and/or hours after the job is cancelled that you want the disposition to occur.
6. Click the **Save** button to save the current settings and close the dialog.

Specifying Input File Monitoring Settings for a Process

When you specify input file monitoring settings for a process, you specify input files that you want Automator to monitor a particular location for. When the file arrives in the specified location, Automator will trigger running of the associated process.

You can specify the input file monitoring settings on the **Monitoring** tab of the Process page.

To specify input file monitoring settings

1. On the **Navigation Tree**, click **Automator** and select **Standard Processes**.
2. Click the name of the process you want to change or click anywhere on its row, and then click .
3. On the displayed page, select the **Monitoring** tab.
4. Select the **Enable** check box, to enable monitoring.

NOTE: Changes in monitoring settings, including enabling and disabling monitoring or changing paths for monitored folders, take effect after approximately 1 minute.


5. Select the monitoring type.
 - Choose **Inputs** if the file to be monitored is an input file. Proceed to **Step 6**.
 - Choose **Manifests** if the file to be monitored is an XML file. Proceed to **Step 7**.
6. Click the **Load File Specifications from Project** button to specify the way specifications will be added from the following:

- Append to the end of the list, or
 - Replace the list
7. Click the **Add** button to select the folder you want Automator to monitor for reports. The **Add File Specification** dialog box will appear.
 8. Select one of two options in Manifest PostProcessing:
 - **Delete** (selected by default): Removes the XML file after processing
 - **Move** (and set the folder path): Moves the XML file after processing
 9. In the **Add File Specification** dialog box, specify the following parameters:
 - **Source Type**: Choose a **local** source and enter the file path with the name of the file you want Automator to monitor for at the end or select the file from the [Named Paths](#) list.

Note: If you're unsure of the file's exact name or if you want Automator to monitor for any file of a particular file type, you can use a wildcard character, either an asterisk (*) or a question mark (?), so that the arrival of any file of the specified type will trigger the running of the process. An asterisk may replace multiple characters while a question mark may replace any single character.) For example, adding *.prn to the end of the folder path instructs Automator to trigger the running of the associated process when any report file with a .prn extension arrives in the specified location.

 - **Location**: Select the location type from the drop-down list.

NOTE: If the required server is not on the list, refer to [Locations Management](#) topic to add a new location.

- From the **Named Paths** list, select the appropriate [named path](#) and select the project file from the list of displayed in the **Named Path Content** box.
 - **Path (for Local Source Type)/File Path (for Named Paths)**: You may use the naming macros to specify the file path. Click the Insert Macro icon  and select the [naming macros](#) from the drop-down list.
 - Click **Save** to add the file.
10. Back in the **Monitoring** tab, specify the monitoring behavior:
 - **Disable monitoring if trigger file is not removed** – The input mask (e.g., myfile.txt or *xyz.pdf) from the monitored folder can sometimes cause a process job to fail with an error and remain in its original folder. By selecting **Disable monitoring if trigger file is not removed**, Automator stops monitoring the corresponding folder(s) for the process and its input mask(s) only. When this option is not selected, the monitoring is left enabled; when new files appear in the monitoring folder, the process running is triggered again. You would, for example, enable this option if a problem requires intervention to determine why the inputs caused the process to fail and prevent the process from running until the issue is addressed.
 - **All files must exist** – Monitoring based on multiple files starts as soon as one of the files is found. By selecting the *All files must exist* option, the monitoring process will not start unless all the associated files are found.
 11. Choose to download a manifest file that is based on the settings of the standard process. In **Download Manifest**, choose between the following:

- **XML** – creates a manifest XML file
- **JSON** – creates a manifest JSON file

NOTE: Before starting a process with a manifest containing some passwords, make sure to specify all required passwords and uncomment the “TODO:Specify Password” row in the manifest. If the process has no passwords, the manifest file generated automatically could be retained as it is.

12. Click the **Download** button, and rename and save the manifest file as usual. Click the **Save** button to save the input file monitoring settings and proceed to the [Processes page](#).

NOTE: When you specify manifests monitoring settings for a process, you specify the manifest XML files that you want Automator to monitor a particular location for. When the file arrives in the specified location, Automator will trigger running of the associated process.

Specifying Scripts for a Process

On the **Script** tab you can create and edit the [global environment](#) and [process scripts](#).

The following scripts are displayed on the page:

- [PreProcess tab](#): Specifies process-specific, pre-process declarations.
- [PostProcess tab](#): Specifies process-specific, post-process declarations.
- [Global Declarations tab](#): Specifies Dim statements or other statements that must be global to the entire script module.
- [References and Imports tab](#): Specifies additional .NET assembly references and namespaces required by the PostExport, PreExport, and Global Declarations tabs.
- [Passwords tab](#): Specifies passwords for use in password macros.


NOTE: Automator users can only edit these scripts if they are granted editing privileges by the Admin.

Scheduling a Process

After adding a process, you can create a process schedule to specify when, and at what interval the process will run. All schedules used in the system are listed on the [Schedules](#) page. You can [add](#), [edit](#) or [delete](#) the schedule on the **Schedule** tab of the process page.

To open the Schedule tab

1. On the **Navigation Tree**, click **Automator** and select **Standard Processes**.

2. Click the name of the process you want to change or clicking anywhere on its row, and then click .
3. On the displayed page, select the **Schedule** tab.

To suspend the selected process

1. Click the **Suspend Selected** button.

To resume the selected process

1. Click the **Resume Selected** button.

To suspend all processes

1. Click the **Suspend All** button.

To resume all processes


1. Click the **Resume All** button.

NOTE: If the process fails to run, see [When a Job Fails to Run](#) for possible explanations.

Adding a Schedule

A schedule is used to specify when, and at what interval the process will run.

To add a new schedule for a process

1. On the **Schedule** tab, click .
2. Select the **Suspended** check box if you want to suspend the task.
3. Select the task [execution frequency](#) from the following options: **One Time**, **Hourly**, **Daily**, **Weekly**, **Monthly**.
4. Set the time you want the process to run.
5. Set the start date of the process.
6. Select the appropriate timezone from the drop-down list.
7. Click the **Save** button, to save the schedule or **Run Now** to start the task immediately.



Editing a Schedule

For details about how to change the schedule settings please refer to [Adding a Schedule](#).

Deleting a Schedule

You can delete any schedule on the Schedule page.

To delete a schedule



1. On the Navigation Tree, click **Automator** and select **Standard Processes**.
2. Click the name of the process you want to change or click anywhere on its row, and then click .
3. On the displayed page, select the **Schedule** tab.
4. Click  at the end of the row with the schedule you want to delete. A dialog box appears.
5. Click **Delete** to remove the schedule from the list.

Assigning Process Access Rights



The creator of a process automatically receives the rights to view and edit the project.

You can assign process access rights to other users. Authorized users can view and edit processes, assigned to them, in MSAdmin.



To assign process access rights

1. On the Navigation Tree, click **Automator** and select **Standard Processes**.
2. Click the name of a process you want to assign access rights for.
3. On the displayed page, select the **Rights** tab.
4. To make a process available to all users, select **Global** check box and click the **Save** button. Otherwise proceed to the next steps.
5. Click **User Groups** to expand a hidden section. Select user groups that you want to have an access to the process.
 - a. To add a user group drag it from the left pane to the right pane or click  icon next to its name.
 - b. To remove a user group drag it from the right pane to the left pane or click  icon next to its name.

NOTE: You may also use **Add All** and **Remove All** controls.

6. Click **Roles** to expand a hidden section. Select roles that you want to have an access to the process.
 - a. To add a role drag it from the left pane to the right pane or click  icon next to its name
 - b. To remove a role drag it from the right pane to the left pane or click  icon next to its name.

NOTE: You may also use **Add All** and **Remove All** controls.

7. In the **Users** section, select users that you want to have an access to the process.
 - a. To add a user drag it from the left pane to the right pane or click  icon next to its name
 - b. To remove a user drag it from the right pane to the left pane or click  icon next to its name.

NOTE: You may also use **Add All** and **Remove All** controls.


8. To apply the changes, click **Save**.

Deleting a Process

You can delete any process on the **Processes** page.

NOTE: When you delete a process, all of its associated jobs on the Jobs page are also deleted.

To delete a process

1. On the Navigation Tree, click **Automator** and select **Standard Processes**.
2. Click  at the end of the row with the process you want to delete. A dialog box appears.
3. Click **Delete** to remove the process from the list.

The process is removed from the [Processes](#) page, and its associated jobs are removed from the [Jobs](#) page.


NOTE: When deleting a standard process that uses a model or a project in the Server Library, a dialog box appears and gives the option to **Delete dependencies**. Clicking the **Delete dependencies** button removes the associated model or project from the Server Library. Clicking **Cancel** deletes the process only and not the associated model or project. The **Delete dependencies** option is not available when the model or project is used by more than one process.

Enabling/Disabling Monitoring of Standard Processes

You can enable or disable the monitoring of multiple Standard Processes simultaneously.

To enable/disable process monitoring

1. On the Navigation Tree, click **Automator**, and select **Standard Processes**.
2. Select the Standard Processes you want to enable/disable the monitoring for by clicking their corresponding checkboxes.


3. Click the drop-down arrow , and choose **Disable Monitoring** or **Enable Monitoring**.
4. In the **Monitoring** dialog box, click **Ok** to proceed.

NOTE: When enabling/disabling monitoring, the changes take effect after approximately 1 minute.

Enabling/Disabling Scheduled Standard Processes

You can enable or disable one or more scheduled Standard Processes.

To enable/disable scheduled Standard Processes


1. On the Navigation Tree, click **Automator**, and select **Standard Processes**.
2. Select the Standard Processes whose schedule you want to enable/disable by clicking their corresponding checkboxes.
3. Click the **Additional schedule actions** icon , and choose **Disable Schedules** or **Enable Schedules**.

NOTE: When enabling schedules, the corresponding **Suspend** checkbox in [Schedules](#) is unchecked (i.e., the schedule is active). When disabling schedules, the corresponding **Suspend** checkbox is checked (i.e., the schedule is suspended).

Running a Process

Automator provides several methods by which you can run a process.

Process can be run:

- **Manually:** You can run a process manually by clicking the **Run Now** icon  in the corresponding row. Automator will then generate and execute a job (or jobs) for the process.

NOTE: If the Config service is not available and you are using Altair licensing, Automator processes will be switched to "Limp Mode." In this mode, you can run only one process (i.e., one Standard Process and one Visual Process) every hour. Moreover, you cannot run a Visual Process that involves other Standard or Visual Processes. Limp Mode is deactivated once the Config service becomes available.

- **Via a [process schedule](#):** When you configure a process schedule, you specify a day and time for the process to run.

Note: You can specify multiple schedules for a process if desired.

- **Via an [input file specification](#):** An input file specification instructs Automator to monitor a particular location for a certain input file (or for any file of a specified file type), and to trigger the running of the associated process when the input file arrives there.

NOTE: If a corresponding job for a process fails to run, refer to [When a Job Fails to Run](#). You should also view the [job's log](#) file, as they may indicate why the job failed.

Importing a Standard Process

You can import a process from the **Processes** page.

You can only import a process by selecting the output (in XML format) of a previous export process operation.

To import a process

1. On the **Navigation Tree**, click **Automator** and select **Standard Processes**.
2. On the displayed page, select the **Import Processes** tab.
3. In the **Location** field select the location type from the drop-down list.

NOTE: If the required server is not on the list, refer to [Locations Management](#) topic to add a new location.

4. Click the **Add Files...** button and choose the file(s) to import in the **Open** dialog box. You can select several files at once. Alternatively, you can drag your files to the **Drop files here** area.
5. Enable the **Include process dependencies** check box to import projects and project models connected with the processes (if any) to Server Library. If a project/model is unavailable in the file system, you can opt to upload the new one instead.
6. Click **Save** to save the process. A message box will inform you that the import operation is complete and the [Processes page](#) will be displayed.


NOTE:




You cannot specify a location for processes exported with defined locations.

If you exceed the number of processes allowed by your license, the following message appears: "The maximum number of processes per your license (XX) will be exceeded with this import and it cannot be completed. You can select at most (NN) processes for import, or you may delete unused processes or contact your Altair sales representative for extended options."

Named Path Mapping

During import of an exported Standard Process that includes named paths, the **Named Path Mapping** window displays. In this window, the named paths in the Standard Process being imported are mapped to the existing named paths in the destination environment. The following options are available:

-  Auto Map Named Path button – Click to automatically map all imported named paths by ID or by Name (depending on the radio button selected). By default, the imported named paths are mapped by Name.

-  Edit Mapping button – Click to manually perform mapping or modify existing mapping.
-  Delete Mapping button – Click to delete currently selected mapping.
-  Delete All Mappings button – Click to delete all listed mappings.

Exporting a Process

You can export a process on the **Processes** page.

The output of the export operation will be an XML file (or files) that can then be imported into some other Automator Installation.

To export a process

1. On the **Navigation Tree**, click **Automator** and select **Standard Processes**.
2. On the displayed page, select the **Export Processes** tab.
3. Select the process you want to export. Multiple selection is available.
4. Enable the **Include process dependencies** check box to export projects and project models from Server Library.
5. Specify the number of processes per file by selecting one of the following options:
 - **One process per file** if you want each Process to be exported to it's own XML file.
 - **All processes in one file** if you want the exported Processes to be exported into one XML file.
6. Click the **Export** button.
7. In the displayed dialog box, enter the name of the output archived file.

NOTE: If you selected the **One process per file**, the outputs will be named `_process.xml`, located in the folder you have specified. If you selected **All processes in one file**, the output will use the name you specified, located in the folder you selected.

8. Click the **OK** button to export the process or **Cancel** to cancel exporting. A message box will inform you when the export operation has completed.

Process Handling Scenarios

When specifying general settings for a process, you must specify whether there will be one project per job or multiple projects per job for the process.

If you select the **One Project per Job** option, each project assigned to the process will spawn its own job or more than one job if that project contains multiple input files that are to be handled each in its own job. If the **Allow Parallel Jobs** option is

not selected, then the job(s) from the first project will be processed before the job(s) from the second project, and so on. If allow parallel jobs is selected, however, then one cannot assume that the spawned jobs will run in any particular sequence.

If you select the multiple projects per job option on the General tab, then each job spawned will process the inputs for all the projects in their given order. Often there will be only one such job spawned, but there will be more than one job spawned if any of the projects specifies multiple input files that are to be handled each in its own job.

NOTE: In the case where more than one project specifies multiple input files that are to be handled each in its own job, then the process will generate an error if the multiplicities implied by these multiple projects actually exist, and/or are not compatible with each other. See Scenario 8 further for an example of this.

Below is an analysis of the scenarios that can arise from a process containing two projects, ProjectA and ProjectB. ProjectA has input Class*.prn that expands to ClassJan.prn, ClassFeb.prn, and ClassMar.prn. ProjectB has input Employ*.prn that expands to Employ1.prn and Employ2.prn.

Scenario 1

- ProjectA set for handling multiple files "all in a single job"
- ProjectB set for handling multiple files "all in a single job"
- Processing "one project per job"

Spawns 2 jobs:

1. Job1: ProjectA with inputs ClassJan.prn, ClassFeb.prn, ClassMar.prn
2. Job2: ProjectB with inputs Employ1.prn, Employ2.prn

Scenario 2

- ProjectA set for handling multiple files "all in a single job"
- ProjectB set for handling multiple files "all in a single job"
- Processing "multiple projects per job"

Spawns 1 job:

1. Job1: ProjectA with inputs ClassJan.prn, ClassFeb.prn, ClassMar.prn AND ProjectB with inputs Employ1.prn, Employ2.prn

Scenario 3

- ProjectA set for handling multiple files "all in a single job"
- ProjectB set for handling multiple files "each in its own job"
- Processing "one project per job"

Spawns 3 jobs:

1. Job1: ProjectA with inputs ClassJan.prn, ClassFeb.prn, ClassMar.prn
2. Job2: ProjectB with input Employ1.prn
3. Job3: ProjectB with input Employ2.prn

Scenario 4

- ProjectA set for handling multiple files "all in a single job"
- ProjectB set for handling multiple files "each in its own job"
- Processing "multiple projects per job"

Spawns 2 jobs:

1. Job1: ProjectA with inputs ClassJan.prn, ClassFeb.prn, ClassMar.prn AND ProjectB with input Employ1.prn
2. Job2: ProjectA with inputs ClassJan.prn, ClassFeb.prn, ClassMar.prn AND ProjectB with input Employ2.prn

Scenario 5

- ProjectA set for handling multiple files "each in its own job"
- ProjectB set for handling multiple files "all in a single job"
- Processing "one project per job"

Spawns 4 jobs:

1. Job1: ProjectA with input ClassJan.prn
2. Job2: ProjectA with input ClassFeb.prn
3. Job3: ProjectA with input ClassMar.prn
4. Job4: ProjectB with inputs Employ1.prn, Employ2.prn

Scenario 6

- ProjectA set for handling multiple files "each in its own job"
- ProjectB set for handling multiple files "all in a single job"
- Processing "multiple projects per job"

Spawns 3 jobs:

1. Job1: ProjectA with input ClassJan.prn AND ProjectB with inputs Employ1.prn, Employ2.prn
2. Job2: ProjectA with input ClassFeb.prn AND ProjectB with inputs Employ1.prn, Employ2.prn

3. Job3: ProjectA with input ClassMar.prn AND ProjectB with inputs Employ1.prn, Employ2.prn

Scenario 7

- ProjectA set for handling multiple files "each in its own job"
- ProjectB set for handling multiple files "each in its own job"
- Processing "one project per job"

Spawns 5 jobs:

1. Job1: ProjectA with input ClassJan.prn
2. Job2: ProjectA with input ClassFeb.prn
3. Job3: ProjectA with input ClassMar.prn
4. Job4: ProjectB with input Employ1.prn
5. Job5: ProjectB with input Employ2.prn

Scenario 8.1

NOTE: Scenario 8.1 is executed if the key "PumpTaskLegacyBehavior" is set to "true" in the config.xml file.

- ProjectA set for handling multiple files "each in its own job"
- ProjectB set for handling multiple files "each in its own job"
- Processing "multiple projects per job"
- Error: IncompatibleProjectInputsException

Scenario 8.2

NOTE: Scenario 8.2 is executed if the key "PumpTaskLegacyBehavior" is set to "false" in the config.xml file.

- ProjectA set for handling multiple files "each in its own job"
- ProjectB set for handling multiple files "each in its own job"
- Processing "multiple projects per job"

Spawns 3 jobs:


1. Job1: ProjectA with input ClassFeb.prn AND ProjectB with input Employ1.prn
2. Job2: ProjectA with input ClassJan.prn AND ProjectB with input Employ2.prn

3. Job3: ProjectA with input ClassMar.prn

Schedules


All schedules for Standard Processes are listed on the **Schedules** page. You can use this page to [add](#), [edit](#) or [delete](#) schedules.

To add a new schedule for a Standard Process

1. On the **Schedules** page under Standard Processes, click . The Schedule page will be displayed.
2. Select the **Suspended** check box if you want to suspend the task.
3. Specify the process to which the schedule will be assigned.
4. Select the task [execution frequency](#) from the following options: **One Time**, **Hourly**, **Daily**, **Weekly**, **Monthly**.
5. Set the time you want the process to run.
6. Set the start date of the schedule.
7. Select the appropriate timezone from the drop-down list.
8. Click the **Save** button to save the schedule or **Run Now** to start the task immediately.


NOTE: If the Config service is not available and you are using Altair licensing, Automator processes will be switched to "Limp Mode." In this mode, you can run only one process (i.e., one Standard Process and one Visual Process) every hour. Moreover, you cannot run a Visual Process that involves other Standard or Visual Processes. Limp Mode is deactivated once the Config service becomes available.

To edit a schedule for a Standard Process

1. Click the name of the schedule you want to change or select the schedule by clicking anywhere on the row, and then click .
2. On the displayed page, make the necessary changes and save the schedule.

For details about how to change the schedule settings please refer to [Adding a Schedule](#).

To delete a schedule for a Standard Process

1. Click  at the end of the row of the schedule you want to delete. A dialog box appears.
2. Click **Delete** to remove the schedule from the list.

Execution Frequency

Execution frequency (or run time) specifies both how often a process will run (for example, once, hourly, daily, etc.) and at what time it will run. You specify execution frequency when configuring a [schedule](#) or a [custodian schedule](#).

The options in the **Execution Frequency** pane allow you to set periodicity of launching the current process. An administrator can set the following options:

- **One Time:** Select this option if you want to launch the current process only once.
 - **At:** Set the time when the current process will be launched following the **HH:MM** format.
 - **on (mm/dd/yyyy):** Set the date when the current process will be launched. Upon clicking the field, the [calendar](#) appears.
- **Hourly:** Select this option if you want to launch the current process at the specified hour or hours.
 - **At... minute(s) of Every hour:** Set the time when the current process will be launched following the **MM** format.
- **Daily:** Select this option if you want to launch the current process in a specified number of days.
 - **Every ... day(s):** Set the number of days after which the current process will recur.
 - **At:** Set the time when the current process will be launched following the **HH:MM** format.
- **Weekly:** Select this option if you want to launch the current process weekly.
 - **Recur every:** Set the number of weeks after which the current process will recur.
 - Select corresponding days of the week.
 - **At:** Set the time when the current process will be launched following the **HH:MM** format.
- **Monthly:** Select this option if you want to launch the current process monthly.
 - Select the day when to perform the process.
 - If you select **Day**, set the number of days in the box.
 - If you select **Business Day**, set the business day(s) on which the current process will be launched. Business days are weekdays (i.e., Monday-Friday), unless an exception date is defined. The definition of [Exception Dates](#) can be used for holidays. When an exception day is found, the count skips to the next working day.

The process will be executed immediately after exception date/time is over. Otherwise, the process will only run on the set schedule, with the exception of the Business Day schedule, wherein an "All day" Exception Date will be excluded in the day count.

Examples:

To run the process on the 6th business day of the month, enter "6" in the field.

To run the process on the 1st business day of the month, then again on the 16th to the 20th business day of the month, enter "1, 16-20" in the field.

NOTE:

It is possible to schedule the process on a range of working days at a given time, e.g., "5"; "1,2,22,23"; "1-3, 21-23"; "-1"; "-3--1"; and "-2-3, 5, 10."

A negative number denotes the number of days prior to the month selected, e.g., “business day –1” of October 2019 would be September 30, 2019 (provided it is a working day). Exception Dates must skip count to the next previous working day.

- If you select **The...**, select First, Second, Third, Fourth or Last from the first drop-down list and the day of the week from the second drop-down list.
- Select the month on which to perform the action.
 - If you select the **of every n Month** option, set the number of month in the box.
 - If you select the **of selected months** option, select the appropriate check box referring to the desired month.
- In the **At** check box set the time when the current process will be launched following the **HH:MM** format.

Jobs

A job is the resulting task of one or more projects that comprise the associated [process](#). When a process runs, it ultimately spawns one or more jobs, with each job appearing as a row on the Automator Standard Processes **Jobs** page.

The number of jobs a process creates is determined by the following:

- Whether the one project per job or the multiple projects per job setting is selected on the [General tab](#) of the Process Properties page
- The number of input files assigned to the project on the [Monitoring tab](#).
- Whether all in a single job or each in its own job is selected in the project file.




The **Jobs** page displays the following information:

- The job's unique ID number
- The name of its associated process
- The status of the job
 - Registered
 - Process resolving Web addresses in a manifest
 - Process is running PreProcess script
 - Process ready to run
 - Process awaiting entry after a failed run attempt
 - Process failed and not scheduled for retry
 - Process canceled before jobs were launched
 - Job ready to be dispatched
 - Job deferred while a parallel job was running

- Job running
 - Export failed and will be retried
 - Job completed without errors
 - Job failed
 - Job canceled before completion
 - Dispatcher host is not responding (a job has been executed on a host that is currently not responding)
 - Orphan job (a job has been executed on a host that does not exist in the current configuration)
- The name of the server on which the job was processed
 - The date and time when the job was registered
 - The date and time when the job was last processed.
 - The duration of job execution.

To view this page, on the **Navigation Tree**, click **Automator > Standard Processes** and select **Jobs**.

You can [delete](#), [cancel](#) and re-run jobs that have failed (due to process prerequisites that haven't been met, for example).

- To view the jobs log, click the **View Job Log** icon . In the **Logs** page, you can view the progress of an export (shown as a percentage) under **Project Outputs**.
- To re-run a job, click the **Re-run** icon .
- To reload the jobs list, click the **Reload Grid** icon .

NOTE: You can filter the jobs by job ID, process name, status, location, date/time registered, and date/time last processed by using the corresponding fields in the column headings.




Cancelling a Job

Jobs may be cancelled at a number of stages prior to their completion. For example, you may want to cancel a job that has failed to run due to a missing process prerequisite if retries are enabled for the process and you are sure that the prerequisite will not be met in the near future.

To cancel a job



1. On the **Navigation Tree**, click **Automator > Standard Processes** and select **Jobs**.
2. On the **Jobs** page do one of the following:
 - Select the job you want to cancel, by clicking anywhere on the row, and then click , or
 - Click  at the end of the row with the job you want to cancel.

Deleting a Job

You can remove jobs from the Jobs page by deleting them. You may find it necessary to do this during testing or to simply purge old data.

NOTE: Once a job has been deleted it cannot be recovered. Specifically, jobs deleted from the UI are subsequently deleted from the database. Delete a job only if you are sure you no longer need it.

To delete a job

1. On the **Navigation Tree**, click **Automator > Standard Processes** and select **Jobs**.
2. On the **Jobs** page do one of the following:
 - Select the job you want to delete, by clicking anywhere on the row, and then click , or
 - Click  at the end of the row with the job you want to delete. A dialog box appears.

NOTE: Multiple jobs selection is possible.

3. Click **Delete** to remove the process from the list.

Distributions

Distributions specify actions, called distribution actions, that distribute or handle files and information outside of Automator. Distributions can be specified for input files, export files, and portable reports, and can be configured with the Distribution Editor and the Script Editor. Distributions can be used for:

- Sending [emails](#) (with or without attachments)

- [RSS](#) feeds
- [Moving](#), [copying](#), and [deleting](#) files (to both the file system and to FTP/SFTP-compliant and WebDAV-compliant servers using http)
- Writing to the Windows Event [Log](#)

There are two types of distributions that can be specified:

- **Project Distributions:** These distributions apply only to the input, export and portable report files of the specified project.
- **Global Distributions:** These distributions can apply to any input files used in all processes, and to any export files and portable reports that are produced by all processed in the specified folders.


Global distributions are useful if you have fairly narrow rules on distribution of files and information, or you want to try and structure distribution in a more transparent way, rather than having multiple discrete distribution rules in many different projects.

A typical use for this might be to set up "inboxes" and "outboxes", where files that come into the specific inboxes are renamed and copied to an archive folder and then deleted, and the projects are set up to export to a particular person's (or group's) outbox so that they receive emails or RSS feeds targeted to them.

To view the Distributions page, on the **Navigation Tree**, click **Automator > Standard Processes** and select **Distributions**.

Adding a Distribution

To create a Global Distribution

1. On the **Navigation Tree**, click **Automator > Standard Processes** and select **Distributions**.
2. Click the **Add** icon  to display the Distribution page.
3. In the **Location** box select the location type from the drop-down list.


NOTE: If the required server is not on the list, refer to [Locations Management](#) topic to add a new location. In case of a single server configuration refer to the Configurator Guide in the [Monarch Server Installation Guide](#) to change location settings.

4. In the **Path** box enter the path to a file or click the **Browse** button, to select a file. The **Named Paths** window will appear.
In the displayed window do one of the following:
 - From the **Named Paths** list, select the appropriate [named path](#) and select the file from the list of displayed in the **Named Path Content** box. Click **Save** to add the file.
 - In the **Path** field, type the path to the file. Click **Save** to add the file.
5. Click **Add Actions** to [add actions](#) to the distribution.

Editing a Distribution

Once you have configured and saved a distribution, you can edit it at any time.

To edit a distribution

1. On the **Navigation Tree**, click **Automator > Standard Processes** and select **Distributions**.
2. Click the name of the distribution you want to edit or click anywhere on its row, and then click .


When you open a saved distribution for editing, the list of actions for the distribution becomes available. You can [add](#), [edit](#) or [delete](#) actions.

For details about how to change distribution parameters please refer to [Adding a Distribution](#).

Adding a Distribution Action

The specified action will be applied to any input files that are used in a process, as well as to any export files and portable reports that are produced by a process, in the folders specified.

To add an action for a distribution

1. On the Distribution Properties page click the Add icon . The Action page will display.
2. Select one of the following actions for distribution:
 - [Translate](#): This distribution provides a way to translate folder names to Internet addresses. This is necessary for RSS distributions and web service actions. The Translate distribution is only available as a global distribution defined in Automator, it cannot be defined in a project.
 - [Move](#): This allows files to be moved to another location, either to the file system using drive letter or UNC naming, or to FTP/SFTP and HTTP locations.
 - [RSS](#): RSS (Really Simple Syndication) is a widely used format for publishing information. This is a way of allowing users to "pull" information as opposed to the "push" model of email. The RSS file must reside on a web server and be accessible to users who can read the RSS feed using one of the many free and commercial RSS news readers available on the market, for example, RSSBandit.
 - [Log](#): This allows the creation of an event written to the WindowsApplication Event Log. This can be useful when using system management systems such as BMC Patrol, Tivoli, or Openview to tie in Automator operations with your overall systems management strategy. This is especially useful when combining Alerts with a log distribution.
 - [Copy](#): This distribution allows files to be copied to another location, either to the file system using drive letter or UNC naming, or to FTP/SFTP and HTTP locations.
 - [Email](#): To create an email distribution, you need to specify the folder (location) which will be used to detect the input and/or export files for distribution. Once specified, you can then select the sender's mail address and the "To" and "CC" addresses for the email.
 - [Delete](#): This deletes all files specified by the distribution.

Translate Distribution Action

To add a translate action

1. Select the **Translate** option on the Action page.
2. In the **Url** box specify the folder for translation and the base URL. For example, you may be exporting files to a folder named z:\iispublic\automatorrss, which is accessible to the intranet at the URL <http://internal.yourcompany.com/reports/rss>.


NOTE: You may also have the scenario where you are copying the files to a different web server via a copy distribution using FTP/SFTP, and so require the RSS items to point to the files on the target web server. The translate distribution allows you to do this.

3. Click **Save** to save the action.

Move Distribution Action

To add a move action

1. Select the **Move** option on the Action page.
2. In the **Move File to Folder** box, specify the destination folder. You can either enter the destination folder path in the box or select the folder by clicking the **Browse** button. The **Named Paths** dialog box will appear.
 - a. From the **Named Paths** list, select the appropriate [named path](#).
 - b. Select the folder from the list of displayed in the **Named Path Content** box.
 - c. Click **Save** to add the folder.
3. In the **Rename file as** box, specify a new file name, if you want to change the file name.

NOTE: You may use the naming macros to name the moved files and destination folder. To do this, click the **Insert Macro** icon  and select the [naming macros](#) from the drop-down list.

4. Select the **Change extension to** check box to change file's extension. Specify new extension in the enabled text box below.
5. Select the **Zip** check box, if you want to archive the file. The **Zip Options** drop-down arrow will appear.

NOTE: The **Zip** check box is disabled if **Change extension to** check box selected.

6. Under **Zip Options** provide the following information:
 - Select the compression type from the following: **None, Medium, Maximum**.
 - Select the **Store directory path** check box, if you want to store directory path.

- Select the **Password** check box to set the password.
7. Select the **Overwrite** check box to overwrite the existing file.
 8. Click the **Authentication Credentials** drop-down arrow to specify the authentication credentials.

NOTE: The **Authentication Credentials** link appears only if you enter "ftp://" or "sftp://" or "http://" in the folder path in the **Move File to Folder** box.

9. Under **Authentication Credentials** do the following:
 - Specify **username**.
 - Specify **password**.
 - Specify **domain** name.
 - Select the **Ascii** check box to specify an ASCII mode transfer for your FTP/SFTP distribution rather than binary mode, which is the default.


NOTE: ASCII Mode should only be used for text-only files such as TXT, ASP, HTML, while binary mode can be used for anything else, for example, DOC, ZIP, XLS. If in doubt as to which transfer mode to use, go with the default mode of binary (to do so, do not select this check box).

10. Click the **Save** button to save the action.

RSS Distribution Action

To add an RSS action

1. Select the **RSS** option on the Action page.
2. In the **File** box, specify the file. You can either enter the path to a file in the box or select a file by clicking the **Browse** button. The **Named Paths** dialog box will appear.
 - a. From the **Named Paths** list, select the appropriate [named path](#).
 - b. Select the file from the list of displayed in the **Named Path Content** box.
 - c. Click **Save** to add the file.
3. Select the **Create if not found** check box, if you want to create the file if the specified not found.
4. In the **Title** box, enter the item title.
5. In the **Item description** box, enter the item description.

NOTE: You may use the naming macros to provide a title and description for an RSS distribution. To do this, click the **Insert Macro** icon  and select the [naming macros](#) from the drop-down list.

6. In the **Link** box, enter the name of link to the file.

NOTE: Displays the URL of the RSS item. This field is usually left blank so that Automator can automatically assign a URL (based on a translate distribution) from the input or export file that is being processed.

7. Click the **Channel** title to provide the channel parameters:

- **Title:** Enter channel title.
- **Channel Description:** Provide channel description.
- **Link:** Enter the name of link to the file. (**NOTE:** If you leave the **Title**, **Channel Description**, and **Link** fields blank the default values will be automatically assigned.)
- **Max Items:** Specify the maximum number of items.
- **Unlimited:** Select this check box if you want to set the unlimited number of items.

8. Click **Save** to save the action.


In order to use an RSS feed, you must define a global [Translate](#) distribution action. When creating an RSS feed, the location must be specified, as well as the path to the RSS file to be created or updated.

NOTE: Automator uses the RSS 2.0 format when generating an RSS feed.

Log Distribution Action

To add a log action

1. Select the **Log** option on the Action page.
2. Specify the necessary information in the following fields:
 - **Type:** Select the type from the drop-down list.
 - **Event ID:** Enter the event ID.
 - **Message:** Type the message in the text field.
3. Click **Save** to save the action.

NOTE: You may use the naming macros to provide a message for the log distribution. To do this, click the **Insert Macro** icon  and select the naming macros from the drop-down list.


Copy Distribution Action

To add a copy action

1. Select the **Copy** option on the Action page.
2. In the **Copy File to Folder** box, specify the destination folder. You can either enter the destination folder in the box or select the folder by clicking the **Browse** button. The **Named Paths** dialog box will appear.
 - a. From the **Named Paths** list, select the appropriate [named path](#).
 - b. Select the folder from the list of displayed in the **Named Path Content** box.
 - c. Click **Save** to add the folder.

NOTE: You can also specify an FTP/SFTP site or http WebDAV repository here, for example, ftp://ftp.yourcompany.com/excelexports.

3. In the **Rename file as** box, specify a new file name, if you want to change the file name.

NOTE: You may use the naming macros to name the moved files and destination folder. To do this, click the **Insert Macro** icon  and select the [naming macros](#) from the drop-down list.

4. Select the **Change extension to** check box to change file's extension. Specify new extension in the enabled text box below.
5. Select the **Zip** check box, if you want to archive the file. The **Zip Options** drop-down arrow will appear.

NOTE: The **Zip** check box is disabled if **Change extension to** check box selected.

6. Under **Zip Options** provide the following information:
 - Select the compression type from the following: **None, Medium, Maximum**.
 - Select the **Store directory path** check box, if you want to store directory path.
 - Select the **Password** check box to set the password.
7. Select the **Overwrite** check box to overwrite the existing file.
8. Click the **Authentication Credentials** drop-down arrow to specify the authentication credentials.

NOTE: The **Authentication Credentials** link appears only if you enter "ftp://" or "sftp://" or "http://" in the folder path in the **Copy File to Folder** box.

9. Under **Authentication Credentials** do the following:


- Specify **username**.
- Specify **password**.
- Specify **domain** name.
- Select the **Ascii** check box to specify an ASCII mode transfer for your FTP/SFTP distribution rather than binary mode, which is the default.


NOTE: ASCII Mode should only be used for text-only files such as TXT, ASP, HTML, while binary mode can be used for anything else, for example, DOC, ZIP, XLS. If in doubt as to which transfer mode to use, go with the default mode of binary (to do so, do not select this check box).

10. Click the **Save** button to save the action.

Email Distribution Action

To add an email action

1. Select the **Email** option on the Action page.
 2. Specify the recipients' email addresses in the corresponding boxes: **From**, **To**, **Cc**, **Bcc**. To select recipients from the [contacts list](#), click the **Contacts** icon . The **Find Contacts** window will appear. In the **Find Contacts** window:
 - a. Select the **Look In** criteria from the following:
 - **Internal:** Select from contacts specified in the [Automator Contacts](#).
 - **Active Directory:** Selects from contacts specified in the active directory.
 - **Domino Notes:** Select from contacts specified in [Domino notes](#).
 - b. Select the **Search Criteria** from the following options: **Name**, **Email**, **Contains**, **Is**, **Starts with**, **Ends with**.
 - c. Click the **Find Now** button, to display all the available contacts according to the specified criteria.
 - d. Select the necessary contacts from the **Available Contacts** list.
 - e. Click **Save** to insert specified recipients.
3. Type the message subject in the **Subject** box.

NOTE: You may use the naming macros to provide a subject line for an email distribution. To do this, click the **Insert Macro** icon  and select the naming macros from the drop-down list.

4. Type the message in the text box.
5. Select the **Attach files** check box to attach a file for the distribution.
6. Select the **Zip** check box to archive the attached files. The **Zip Options** drop-down arrow will appear.
7. Under **Zip Options** provide the following information:
 - Specify the compression type from the following: **None, Medium, Maximum**.
 - Select the **Store directory path** check box if necessary.
 - Select the **Password** check box to set the password.
8. Select the **Attach links** check box to attach a link to file.

NOTE: Please specify the **Admin Host and Port** and **Client Host and Port** information in the [System Settings](#).

9. Select the **One file per mail** check box to attach only one file per mail.
10. Select the email priority from the following: **Low, Normal, High**.
11. Click **Save** to save the action.

Delete Distribution Action





Alerts

Automator provides an alerting mechanism whereby users can be automatically notified of certain conditions. For example, you can define an alert that will notify you whenever a process fails to run.

Automator includes five predefined alerts that you can use, and any number of additional alerts can be defined using scripting.

All the existing in the system alerts are displayed on the **Alerts** page. To view the **Alerts** page, click **Automator > Standard Processes** and select **Alerts**.

Use this page to [add](#), [edit](#), or [delete](#) alerts.

Using a Script to Define an Alert

Scripts can be used to define alerts. For example, suppose the PostExport code examines the outputs listed in the job log and determines that something is amiss. It could then raise an alert as follows:

```
Log.AddEvent ("The record count for the balance is outside specified bounds", "BalanceProcessAlert")
```

This would raise an alert named "BalanceProcessAlert".

This alert could then be assigned an email distribution action to notify a technician of the problem via an email message.

Adding an Alert

Automator provides an alerting mechanism whereby you can be notified based upon certain conditions. You can, for example, be notified via email if a process fails to run. These notifications are called alerts. Some alerts are pre-defined within Automator itself, such as the process failure (SystemAlertProcessFailed) and job failure (SystemAlertJobFailed) alerts, while others can be defined by users in global, pre-export or post-export scripts, using the AddEvent method from the JobLog object.

To add an alert

1. On the **Navigation Tree**, click **Automator > Standard Processes** and select **Alerts**. The Alerts page displays.
2. On the Alerts page, click the **Add** icon  to create a new alert.
3. In the **Code** box specify the alert type.

You may type a new alert name or select one of the following predefined alert types:

- SystemAlertProcessFailed: Indicates that a [process](#) has failed.
- SystemAlertJobFailed: Indicates that a [job](#) has failed.
- SystemAlertNoInputToExporter: Indicates that there was no input to the Exporter (which means, that no [input file](#) exists).
- SystemAlertDistributionError: Indicates that a [distribution](#) has failed.
- SystemAlertVerifyFailed: Indicates a project verification failure.

NOTE: If a predefined alert (for example, the SystemAlertJobFailed) has already been selected, it will no longer be listed in the Code drop-down list, as you cannot specify two predefined alerts of the same type.

4. In the **Description** field enter alert description.
5. Click the **Ignore Global Alert** check box to ignore global alerts.

NOTE: This option is available only when the **Allow ignore Global alerts** setting is enabled. See the [General Settings](#) in [Automator Settings](#) for details.


6. Click **Add Actions** to add actions to the alert.

NOTE: When you add an alert, you must specify a distribution action for it. The distribution action you assign to the alert determines how you are notified of the problem. See [Alert Distribution Actions](#) below for more information.

Editing an Alert

Once you have configured and saved an alert, you can edit it at any time.

To edit an alert

1. On the **Navigation Tree**, click **Automator > Standard Processes** and select **Alerts**.
2. Click the name of the alert you want to change or click anywhere on its row, and then click .


When you open a saved alert for editing, the list of actions for the alert becomes available. You can [add](#), [edit](#) or [delete](#) actions.

For details about how to change alert settings please refer to [Adding an Alert](#).

Adding an Alert Action

When adding an alert, you must specify a distribution action for it. The distribution action you assign to the alert determines how you are notified of the problem. The Alert Properties page displays the list of actions that can be specified for the alert.

To add an action for an alert


1. On the **Alert Properties** page click the **Add** icon . The Action page will display.

 - **Email:** Select to send an email notification. Note that if the email connection is down at the time the alert is invoked, the alert will also be written to the Windows Application Event Log.

- **Log**: Select to specify an Application Event Log notification. This can be useful if you use network management software such as BMC Patrol, IBM Tivoli, HP Openview or other software, to provide tighter integration into your systems management.

NOTE: If an alert already has an action set, you must add another action if one is required, rather than creating a new alert.

1. Select the **Email** option on the **Action** page.
2. Specify the recipients' email addresses in the corresponding boxes: **From**, **To**, **Cc**, **Bcc**. To select recipients from the [contacts list](#), click the **Contacts** icon . The **Find Contacts** window will appear. In the **Find Contacts** window:
 - a. Select the **Look In** criteria from the following:
 - **Internal**: Select from contacts specified in the [Automator Contacts](#).
 - **Active Directory**: Selects from contacts specified in the active directory.
 - **Domino Notes**: Select from contacts specified in [Domino notes](#).
 - b. Select the **Search Criteria** from the following options: **Name**, **Email**, **Contains**, **Is**, **Starts with**, **Ends with**.
 - c. Click the **Find Now** button, to display all the available contacts according to the specified criteria.
 - d. Select the necessary contacts from the **Available Contacts** list.
 - e. Click **Save** to insert specified recipients.

 - Select the **Store directory path** check box if necessary.

- Select the **Password** check box to set the password.
8. Select the **Attach links** check box to attach a link to file.

9. Select the **One file per mail** check box to attach only one file per mail.

NOTE: If you leave the **Title**, **Channel Description**, and **Link** fields blank the default values will be automatically assigned.



Global Environment Scripts

Global environment scripts allow you to enter functions, classes, variables, etc, that are available for, or will execute over, all processes. They also allow the setting of global assembly imports and references, which are valid over Automator process boundaries. Global environment scripts are split into three sections:

- [Global Declarations](#): Used for variables, classes, functions, subroutines, etc., that need to be available across all Automator processes.
- [References and Imports](#): Used for importing .NET namespaces and .NET assemblies for global use.
- [Passwords](#): Used to specify passwords for use in password macros.

For global environment scripting, access the Script Editor by clicking **Automator > Standard Processes** on the **Navigation Tree** and then selecting **Scripts** from menu.

Project Editor

Project files are special files created with Project Editor (or with Monarch) that have a .xprj or .dprj extension and which contain all of the information necessary to execute one or more Automator operations. Projects utilize text or database input, extract data from the input via Monarch model files, and export the extracted data to various file types (for e, XLS, PDF, MDB, TXT, HTML, XML, etc.).

Project files may contain:

- Information about the project's data source (e.g., either one or more report files or an external database)
- The path and filename of the model to be applied to the data source
- Data extraction templates and field properties
- Filters, sort orders, and summary information
- Calculated field definitions
- Information about project exports, portable report settings, and process prerequisites

Projects are a key component of processes as when you [create a process in Automator](#), one of the key steps you perform is to assign a project (or projects) to it.

With Automator you can use an existing project file created with Monarch or you can create a new project file via the Project Editor. For details refer to topic [Creating Project Files](#).

Creating Project Files

When creating a new project file via the Project Editor, you may perform the following steps:

- [Specify general settings](#) — General settings specify an author for the project file, its name and provide a description of it.
- [Specify a model setting](#) — When you specify a model setting, you assign a model to the project, and specify the desired verification settings, if any.
- [Specify input settings](#) — Input settings specify the input file type (i.e., text or database), the input file(s) you want to assign to the project, how multiple input files should be grouped, etc.

- [Specify export settings](#) — When you specify project export settings, you specify an export (or exports) of export files and specify any distribution actions you want to apply to them.
- [Specify prerequisite settings](#) — When you specify prerequisite settings, you add a file prerequisite or a command line prerequisite to the project. Any prerequisites you add must first be met if the associated process is to run.
- [Specify script settings](#) — Script settings allow you to, among other things, specify pre-export and post-export scripts to modify the input and export files.

NOTE: Depending on your needs, not all of these steps may have to be performed. Specifying [general](#) and [model](#) settings is enough to create a project.

Specifying General Settings for a Project File

When you specify general settings for a project, you specify an author for the project file, its name and provide a description of it.

To specify general settings for a project

1. On the **Navigation Tree**, click **Automator > Standard Processes** and select **Project Editor**. The **Home** tab is displayed.
2. In the **Author** field, enter the desired author's name.
3. In the **Name** field, enter project name.
4. In the **Description** field, enter a description of the project.
5. Proceed to the **Model and Verifications** tab to specify model settings for the project.

Viewing Project Information

Under **Project Information** heading you can view, copy, and print the information contained in the current project. It also provides access to the Audit Trail.

NOTE: The contents of the Project window vary, as they are determined by the contents of the current project.

The Project Information section displays information such as:

- **Author:** Displays the author of the current project.
- **Description:** Displays the current description of the project file.
- **Current State:** Displays the currently active view, and the current summary, filter or sort (if any).
- **Model:** Displays the path of the project's model file.

- **Report:** Displays the path of the project's report file.
- **Project Exports:** Displays information about the project's export(s), such as the name and export location of the export file, whether a filter is assigned to the table, etc.
- **Audit Trail:** Displays the audit trail for the current project.

To print the information contained in the current project, use the **Print** icon in the upper-right corner of the Project Information section.

Specifying Model Settings for a Project File

When you specify model settings for a project, you select the model you want to assign to it, and specify any desired verification settings.

To specify model settings for a project

1. On the **Navigation Tree**, click **Automator > Standard Processes** and select **Project Editor**.
2. On the **Model and Verifications** tab, click the **Browse** button next to the **Location** field, to select the desired model.
3. In the displayed window, select the data source type from the following: Local, Named Paths, Web, or Server Library.
4. Depending on the data source type specify other parameters:
 - **Local:** Specify project location and path to it.
 - **Named Paths:** Select the appropriate [named_path](#) and select the project file path from the list of displayed in the **Named Path Content** box.
 - **Web:** Specify project location.
 - **Server Library:** Select server library type and select the server library from the list of displayed in the **Available Server Library** box.

NOTE: Model files in compressed archive format (e.g., zip and gzip) can be used and specified in the Project Editor.

5. If you want to specify verification settings for report inputs, select the desired options under the **Model Verifications** heading.

NOTE: Verification is not available for database inputs. See [Verifying Projects](#) for additional information.

6. To save or download created project file, click the corresponding button or continue specifying other project settings if necessary.

NOTE: When saving a project file provide a comment in the displayed window and click **Commit**. The Server Library [Project page](#) is displayed, where you can edit project file name, revision and access rights if necessary.

The next step in creating a project is to [specify input settings](#) for it.

Verifying Project Reports

Automator supports verification of report inputs on a project-by-project basis.

NOTE: Verification is not available for database inputs. If a project calls for database inputs, the verification options are simply ignored.

Verification settings allow you to specify the kind of verifications you want it to perform when processing the project's associated job. When project verification is enabled, Automator may verify field boundaries, data types and filter results.

NOTE: Automator performs verifications after running the PreExport script (if any), and before performing any exports.

Specify the desired verification settings by selecting the appropriate check boxes on the **Model and Verifications** tab. The following types of verification are available:

- **Following filter produces at least one row** — Checks that when the specified filter is applied to the data, the resulting table contains at least one row.
- **Following filter produces no rows** — Checks that when the specified filter is applied to the table, no rows are produced. For example, you may have created a filter that performs checks on your data to ensure that it is valid, and if any bad rows are returned by this filter, you wish to abort the procedure.
- **Field boundaries and data types for text inputs** — Checks that all fields are in the correct location, are the correct length, and are of the correct data type. This is equivalent to using the verify feature in Monarch. Note that any verification settings recorded in the Monarch model will be honored. These can be found in the Field List of Monarch. (**Note:** This feature is not available for database and PDF inputs.)
- **Unfiltered table has at least one row** — Checks that the unfiltered table contains at least one row of data.
- **Text field lengths** — Checks that all text fields have valid field lengths.
- **Numeric field decimals** — Checks that all numeric fields have valid decimals.
- **Numeric field lengths** - Checks that all numeric fields have valid field lengths.
- **Database fields** — Checks that all database fields have been defined correctly.
- **Calculated fields** — Checks that all calculated fields have been defined correctly.
- **Date/time format precisions** — Checks that all date/time fields have the correct format precision.

When you select a verification option, project verification is activated. Note that the default **If verification fails** setting is **Continue**. This means Automator will continue processing the associated job even if a verification failure of the specified kind is encountered. If you prefer to have Automator stop the job when a verification failure occurs, select the **Stop** option instead. If you want to stop the job without sending an email alert, select the **Stop without error notifications** option.

The **If verification fails** option applies to the entire set of verifications. If this option is **Stop**, then the first failed verification causes the job to immediately fail, thereby skipping any subsequent verifications. If this option is **Continue**, then all the verifications are performed regardless of their success or failure. In either case, the verification results are noted in the **<verification>** section of the job log.

If verification fails, a "SystemAlertVerifyFailed" alert is raised in the job log, then the job either continues or fails, according to the specified continue/stop option.

Whenever Automator performs verification, it writes a **<verification>** section to the job log, regardless of whether verification is successful or not. The verification section of the job log looks similar to this when successful:

If a verification failure occurs, the **<verification>** section of the job log will contain some details about the type of failure and its specific location within the input report(s).

Viewing Model Information

Model Information section provides detailed information about the Monarch model assigned to the current project. Here you can view, copy and print the information contained in the current model. It also provides access to the Audit Trail.

NOTE: The contents of the Model window vary, as they are determined by the contents of the current model.

The **Model Information** section displays information such as:

- **Author:** Displays the author of the current model.
- **Description:** Displays the description of the current model.
- **Input Settings:** Displays information about the current input settings, such as whether to ignore leading control characters and form feeds, whether to interpret input as ASCII, when to force a page break (i.e., after n lines), etc.
- **Templates:** Lists the templates within the model, provides information about them (e.g., their names, whether they are floating traps or multi-column traps, their trap characters, etc), and displays sample lines of the data they trap.
- **Fields:** Lists the fields within the model and provides information about them, e.g., their names, their type (character or numeric), their data and display lengths, their alignment, etc.

- **Filters:** Lists filters defined for the model. Each entry on the list shows the name of the filter, the filter type, and the filter expression.
- **Sorts:** Lists sorts defined for the model. Each entry on the list shows the sort name, sort fields used, and sort order (ascending or descending).
- **Summaries:** Lists summaries defined for the model. Each entry on the list shows the summary name, filter used, custom page setup, number of keys, and number of measures.
- **Summaries: Key Fields and Measures:** Enumerates key fields and measures for each summary in the Summaries list. For each Key Field, the field names, titles, display lengths, and sort directions are displayed. For each Measure, the measure title, display length, and expression are displayed.
- **Audit Trail:** Displays the audit trail for the current model.

Specifying Input Settings for a Project File

You can specify the following the input settings for a project file:

- The input file type: either text or database
- The input file(s) to be assigned to the project
- How multiple input files should be grouped
- The desired file existence criteria
- The order in which multiple input files will be processed
- An input file distribution, with which you can email, copy, move, etc, the input file(s).

To specify input settings for a project

1. On the **Navigation Tree**, click **Automator > Standard Processes** and select **Project Editor**.
2. On the **Input** tab specify the input file type by selecting either the **Text** or **Database** radio button. If you select **Database**, perform the following steps, then skip down to [Step 5](#):
 - Under the Select a data source heading, specify the data source or click the Browse For... button to select the data source type (Local or Web File, Data Link Wizard, Data Link File or Connection Definitions) and the desired file via the dialog that displays.

NOTE: In addition to Excel file types .xls and .xlsx, .xlsb and .xlsm file types may be used as database file input.

- If the file is password protected, select the Include password check box and enter the required password in the adjacent field.
- If you want to select a specific table within the input file to export data to, click the Table drop-down arrow and select the desired table.
- If you want to replace nulls in the table, select the Replace nulls with default values (empty strings, zeros, and default dates (1/1/1970)) check box.

- To apply a filter (or filters) to the table during the export select the Apply filter check box and click the Change button under it to specify necessary filters.

NOTE: When Automator exports the table data, the filter(s) you selected will be applied to it. Only the data that matches the filter's specifications will be exported.

- To include column names in the table with the exported data, select the First row contains column names check box.
- To choose an Excel engine, click on the Excel Engine drop-down list, and choose Legacy or Modern.

NOTE: For the Modern Excel engine, password-protected Excel files can be used.

3. If you select **Text**, click the **Add** button to add an input file to the project via the displayed dialog. Repeat this step to add any additional input files to the project.

NOTE: Input files in compressed archive format (e.g., zip and gzip) can be used and specified in the Project Editor.

4. If you added more than one input file to the project, specify how you want to group the multiple files by selecting the **All in a single job** or the **Each in its own job** radio button.

NOTE: This provides a fundamental choice as to how jobs are spawned when the process is assigned more than one project file. The option makes no difference if the process specifies only a single project. For more information, see [Process Handling Scenarios](#).

5. Specify a **File Existence Criteria** setting by selecting one of the following options:
 - **All specified files must exist:** Specifies that all of the input files must exist for the process to start.
 - **At least one must exist:** Specifies that at least one of the input files must exist for the process to start.
 - **Not required:** Specifies that none of the input files must exist for the process to start.
6. Specify an **Order in which to process multiple files** setting by selecting one of the following options:
 - **Natural:** Select to process the input files in the order in which they are listed (i.e., from top to bottom of the input file list).
 - **Alphabetical:** Select to process the input files alphabetically according to their names.
 - **Oldest first:** Select to process the input files in chronological order, i.e., from oldest to newest.
 - **Newest first:** Select to process the input files in reverse chronological order, i.e., from newest to oldest.
7. To save or download created project, click the corresponding button or continue specifying other project settings if necessary.

NOTE: When saving a project file provide a comment in the displayed window and click **Commit**. The Server Library [Project page](#) is displayed, where you can edit project file name, revision and access rights if necessary.

You may now perform the next step in configuring a project file, [specifying export settings](#).

If you want to add an input distribution to the project, navigate to the **Input Distribution** tab and follow the instructions provided in the [Distributions](#) section.

If in Monarch Server License the **Enterprise Server** component enabled, you can define document types from the Report Warehouse as input for a project.

To specify Report Warehouse as input settings for a project


1. On the **Navigation Tree**, click **Automator > Standard Processes** and select **Project Editor**.
2. On the **Input** tab, select the **Text** radio button to specify the input file type and click the **Add** button to add the input file to the project via the displayed **Set Report File** dialog.
3. In the **Set Report File** dialog, select **Report Warehouse** from the drop-down list in the **Source Type** field.
4. Specify document type of the reports to be considered as input. Click **Select** and in the displayed **Select document type** dialog select the appropriate item in the list of existing document types.
5. Specify time for launching the process. You can select the following options:
 - **When the specified number of files appear:** specify number of new reports appeared after which the process will be launched.
 - **By date:** a range of new reports (based on **filing** or **document date**) for which the process will be launched. Use calendar to specify the date.
 - **For newest reports:** the process will be launched as soon as any new report appears.

Specifying Export Settings for a Project File

Using Automator Export Wizard, you can configure project exports to export table or summary data to a file or database. When the project's associated process is run, the export(s) will be performed. When you specify export settings for a project, you specify an export (or exports) of files as well as any [distribution actions](#) you want to apply to it.

NOTE: You can also specify default export file types at this time.

To specify export settings for a project

1. On the **Navigation Tree**, click **Automator > Standard Processes** and select **Project Editor**.
2. On the **Exports** tab click the **Add** icon  to display the Export Wizard.

3. Step through the screens of the Export Wizard, specifying the desired settings as you go. The Export Wizard is comprised of the following screens:

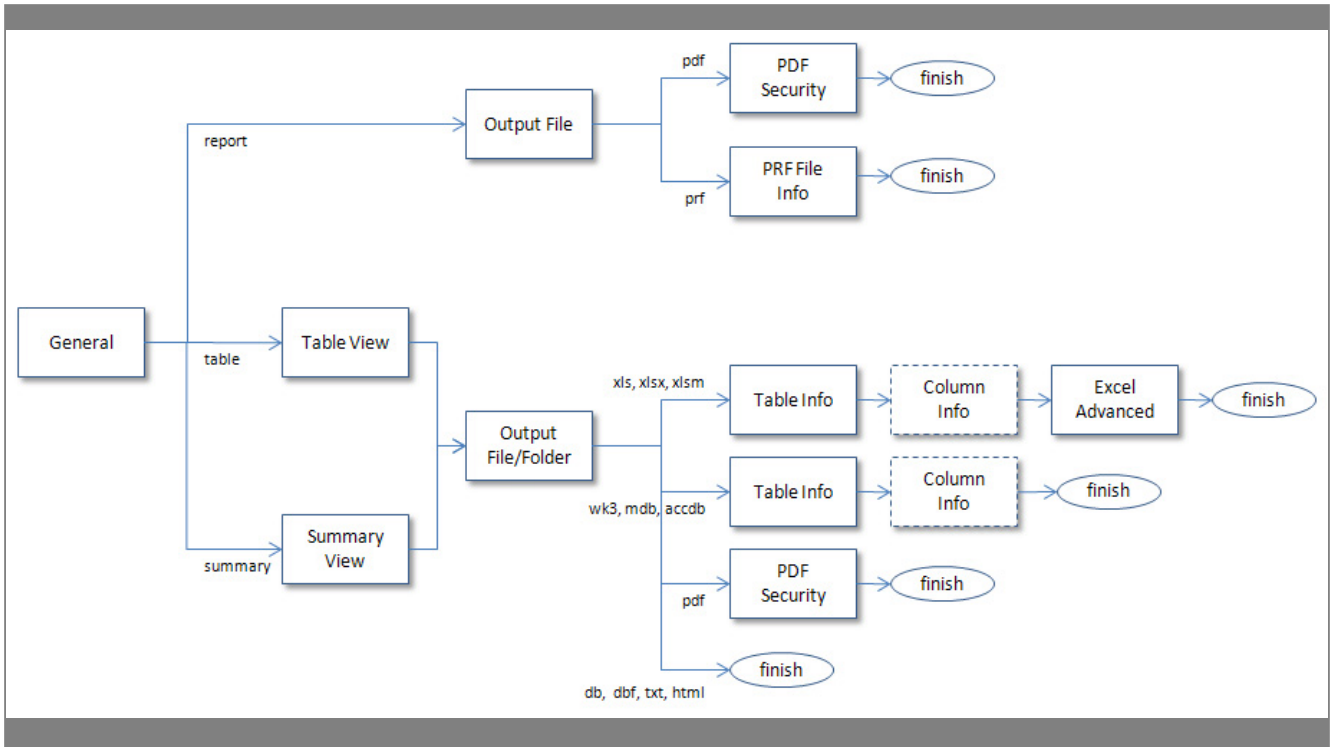

NOTE: A set of screens you will traverse depends on your settings. Refer to the export wizard workflow below.

4. On the final screen of the wizard, click the **Finish button to save the export settings and close the wizard.**
5. To [specify the default version](#) for each supported export file type when exporting table or summary data for the current project, click the **Types... button.**
6. To save or download created project, click the corresponding button or continue specifying other project settings if necessary.

NOTE: When saving a project file provide a comment in the displayed window and click **Commit**. The Server Library [Project page](#) is displayed, where you can edit project file name, revision and access rights if necessary.

You may now perform the next step in configuring a project file, [specifying export settings](#).



General Screen

The General Screen is part of the Export Wizard. Use this screen to:

- Name the export
- Specify whether you are exporting the report, table or summary

The **General** screen includes the following settings:

- **Name:** Names the export.
- **Report:** Exports to a report (text, PRF, or PDF).
- **Table:** Exports table data.
- **Summary:** Exports summary data.
- **Comment:** Displays the comments about the export. These comments may help to remind you of important facts about the export.
- **Next:** Displays the [Output File](#), [Table View](#) or [Summary View](#) screen depending on your settings (for details, see [Export Wizard workflow](#)).
- **Cancel:** Cancels the export operation and closes the Export Wizard.

Table View Screen

The **Table View** screen is part of the Export Wizard. When configuring a table export, use this screen to select a filter and/or sort order to be applied to the table data. This screen is displayed when you click the **Next** button on the [General screen](#) of the Export wizard.

Dialog box options:

- **Description:** Displays a description of the current export (e.g., "Export the table data").
- **Filtering:** Select the filter you want to apply to the table or summary or select the "All filters" option to apply all of the available filters or the "No filter" option to apply none of them. If you choose the **All filters** option, you also need to specify an **Automatic Naming** option:
 - **By files** produces a file for each filter (this is the default)
 - **By tables** produces a table for each filter
- **Sorting:** To apply a sort order to the data you are exporting, select the desired sort order from the drop-down list.
- **Output using:** Select how the output will be produced:
 - File System
 - Oledb provider
- **Back:** Displays the General screen of the Export Wizard.
- **Next:** Displays the [Output File](#) screen (the Output Folder screen when exporting all filters and an Automatic Naming setting of "by files" is selected) or the [OleDb Info](#) screen (if OleDb provider is selected).
- **Cancel:** Cancels any changes you have made and closes the Export Wizard.

To view the Export Wizard workflow, go to [Specifying Project Export Settings](#).

Output File Screen


The **Output File** screen is part of the Export Wizard. When configuring a table or summary export, use this screen to specify the folder you want to export files to.

Dialog box options:

- **Save as:** Enter the path to the desired export file or click the **Browse** button and use the dialog that displays to select the export location. This option is available when exporting all filters and an **Automatic Naming** setting of "by tables" is selected.

NOTE: Specifying a .PRF or .PDF extension will generate the corresponding file type accordingly. Specifying .TXT or any other extension will generate a file with text-based content only.

- **Save to:** Enter the path to the desired export folder or click the **Browse** button and use the dialog that displays to select the export location.
- **File Naming:** Enter the name of the exported file.

NOTE: You may also use the naming macros to name the exported files and destination folder. To do this, click the **Insert Macro** icon  and select the [naming macros](#) from the drop-down list.

- **Extension:** Select the file extension of the desired export file format.

NOTE: The **Save to**, **File Naming** and **Extension** options are available when exporting all filters and an **Automatic Naming** setting of "by files" is selected.

- **When output files exist:** If a file of the specified name and type already exists in the export location, select one of the following options:
 - **Overwrite file:** Overwrites the data of the existing output file with the data in the current export file.
 - **Add data to file:** Adds the export file data to the end of the specified file.
 - **Skip file:** Used for Automator project exports, this allows you to create a project export which will skip the export operation if a file of the same name already exists. This is useful for automated operations, where you may not want to overwrite a file that already exists.
- **Format for Text File(s):** Allows you to specify the export format for text files. The format you select will be saved in the project file:
 - **Fixed-length:** Select to specify "fixed-length" as the export format for text files.
 - **Delimited:** Select to specify "delimited" as the export format for text files.

NOTE: When creating a new export job or modifying a non-text export job, the default text export format is fixed-length for ".txt" extensions and delimited for other extensions. This assures backward compatibility with old projects.

- **Cancel:** Cancels any changes to the settings and closes the Export Wizard.
- **Back:** Displays the [Table View](#) or [Summary View](#) screen.
- **Next:** Displays the [Table Info](#), [Tableau Server](#) or the [PDF Security](#) (if .pdf format is selected) screen.
- **Finish:** Performs the table or summary export and closes the Export Wizard (if .db, .dbf, .txt, .qvx, .html format is selected).

Summary View Screen

The **Summary View** screen is part of Export Wizard, which you can use to export report, table or summary data to a file, multiple tables within a file, or multiple files in a folder. The Summary View screen displays when, on the Export Wizard's General screen, you select the **Summary** option and then click the **Next** button.

Dialog box options:

- **Summary:** Select the summary that you want to export or select the "All summaries" option to export all of the available summaries.
- **Automatic Naming:** Select one of the following options to specify how you want Automator to name the export:
 - By files: Specifies that, when exporting multiple summaries, a file is exported for each summary, and the files are named according to the summary names.
 - By tables: Specifies that, when exporting multiple summaries, a table is produced in the export file for each summary.
- **Drill State:** Select one of the following options to specify the desired drill state:
 - Most detailed: Select to export the summary in the most detailed (i.e., drilled down) drill state.
 - Current: Select to export the summary in the current drill state.
- **Measure:** When exporting an across summary that contains multiple measures, select one of the following options:
 - Active measure or measure grouping: Select to export only the current measure or measure grouping.
 - All measures as separate exports: Select to export all of the measures as separate exports. Note: If you choose this option, specify the desired Automatic Naming setting, either "by files" or "by tables".
- **Split:** Select the **Each distinct value of the first key makes a separate file or table** check box to have Automator split the summary export according to each value change in the first key (i.e., the leftmost one).

NOTE: If you choose this option, specify the desired Automatic Naming setting, either "by files" to have each distinct value of the first key make a separate file, or "by tables" to have each change of it make a separate table.

- **Filtering :** Select the filter you want to apply to the table or summary or select the "All filters" option to apply all of the available filters or the "No filter" option to apply none of them.

NOTE: If you choose the "All filters" option, specify the desired Automatic Naming setting, either "by files" or "by tables".

- **Sorting :** Select the sort you want to apply to the table or summary or select the "No Sort" option to apply none of them.
- **Output Using:** Select how the output will be produced:
 - File System

- Oledb provider
- **Next:** Displays the [Output File](#) (the Output Folder screen when exporting all filters and an Automatic Naming setting of "by files" is selected) or the [OleDb Info](#) screen (if OleDb provider is selected).
- **Cancel:** Cancels the export operation and closes the Export wizard.

To view the Export Wizard workflow, go to [Specifying Project Export Settings](#).

PDF Security Screen

This screen displays when, during the configuration of a project export, you select PDF from the **Extension** drop-down list on the [Output File](#) screen of the Export Wizard, then click the **Next** button. Use this screen to specify security and encryption permissions when exporting to a PDF file.

The **PDF Security** screen includes the following options:

- **Description:** Displays a description of what the export will do when run.
- **Open Password** options:
 - **Apply:** Password-protects the PDF file.
 - **Change Open Password:** Displays the Change PDF Export Open Password dialog. Use this dialog to specify the password that must be supplied to open the PDF file.
- **Permissions** options:

These options let you restrict the permissions available to users of the PDF file.

 - **Apply:** Specifies permission options for the PDF file.
 - **Change Permissions Password:** Displays the Change PDF Export Permission Password dialog, with which you can specify a password for the exported PDF file(s).
 - **Printing allowed:** Allows the PDF file to be printed.
 - **Content extraction allowed:** Allows copying (e.g., cut and paste) of the PDF file's content.
 - **Editing allowed:** Allows editing of the PDF file.
 - **Annotation (comments) allowed:** Allows comments to be added to the PDF file.

NOTE: If you do not specify PDF file permissions, users will have full access to it.

- **Encryption** options:

Select one of the following encryption options.

NOTE: One (or both) of the passwords must be applied to enable encryption.

- **RC4 (128-bit)** : Encrypts the PDF file with RC4 encryption. WARNING: This option is not recommended for extremely confidential data. Use the AES option instead.
- **AES**: Encrypts the PDF file with the Advanced Encryption Standard. Note: If you choose this encryption method, Adobe Acrobat 7 or higher must be used to open the PDF file, as earlier versions of Acrobat do not support AES encryption.
- **Back**: Displays the File Info screen.
- **Finish**: Saves the export settings and closes the Export Wizard.
- **Cancel**: Cancels any changes to the export's settings and closes the Export Wizard.

PRF Info Screen

Use this dialog to specify settings for a portable report. To access this dialog, select the Portable Report (PRF) as the file type when you set the folder and file name in the Output File dialog and then select Next.

The **Portable Report Settings** dialog includes the following options:

- **Description**: Displays a description of Portable Report File: file name, file location, and behavior when output files exist (overwrite, add, or skip).
- **PRF options**:
 - **Include Tree View Index**: Includes the Tree view index in the portable report. Typically, the tree view index will contain the values from fields at each sort level in the report. When a portable report is viewed in Monarch Report Explorer, the tree view index is displayed in the same manner that Windows Explorer displays a directory tree. Each report represents a root of the tree, with branches for each field selected as part of the tree view index.
 - **Include Model**: Includes the model file in the portable report.
 - **Encrypt PRF**: Password-protects the portable report.
- **Change PRF Password**: Specifies a password for the PRF via the Change PRF Password dialog.
- **Compression options**: Select one of the following compression options:
 - **None**: Specifies no compression of the portable report contents.
 - **Medium (Fast)**: Compresses and decompresses slightly faster than the Maximum compression option, and yields a compression ratio of approximately 5:1. This compression ratio may vary depending upon the density of information in your reports.
 - **Maximum**: Compresses and decompresses slightly slower than the Medium compression option but typically yields a compression ratio of 10:1. This compression ratio may vary depending upon the density of information in your reports.

NOTE: If you plan to distribute the portable report you should compress it by selecting the Medium or the Maximum option.

- **Back** : Displays the [Output File](#) screen.
- **Finish**: Saves the current export settings and closes the Export Wizard.
- **Cancel**: Cancels the export operation and closes the Export Wizard.

Tableau Server screen

This screen displays when, during the configuration of a project export, you select **TDE** from the **Extension** drop-down list on the **Output File** screen of the **Export Wizard**, then click the **Next** button. Use this screen to specify settings of the **Tableau Server** for publishing Tableau export to the **Tableau Server**.

The **Tableau Server** screen includes the following options:

- **Publish to Tableau Server**: Select this option to display Tableau Server settings.
- **Data Source Name**: The name of the Data Source on the Tableau Server.
- **Path to TABCMD**: The route to the executable file of the TableauServerTabcmd application.
- **Server Address**: The address of the Tableau Server.
- **Username**: The login name to the Tableau Server.
- **Use Password File**: Allows to use the .txt file with the password.
- **Password**: The password to the Tableau Server (if the option Use Password File enabled, it allows to specify the path to the Password File).
- **Proxy Address**: The address of the proxy server (Note: you must use HOST:PORT format).
- **Publish Type**: Allows to specify an action for the Data Source:
 - **overwrite data source**: overwrites data in Data Source by data from the export table (note: date modified is changed);
 - **replace data**: replaces data in Data Source with data from the export table (note: date modified is not changed);
 - **append data**: adds data from the export table to the end of the Data Source table.
- **Back**: Displays the [Output File screen](#).
- **Finish**: Saves the current export settings and closes the Export Wizard.
- **Cancel**: Cancels the export operation and closes the Export Wizard.

OleDb Info Screen

The **OleDb Info** screen is part of the Export Wizard, and displays when you select OleDb provider from Table View. Use this screen to specify the OLE DB or ODBC data source you want to connect to.

The **OleDB Info** screen includes the following settings:

- Displays a description of what the current export will do.
- **Connection String:**
 - Enter the connection string manually, or
 - click the **Browse for ...** button and select Data Link Wizard to open **Data Link Wizard** window. For more information see [Connection Type Wizard](#), or
 - click the **Browse for ...** button and select Connection Definitions to open **Connection Definitions** window and select from existing connection definitions. For more information, see [Connection Definitions](#)

After you made your choice the **Connection string** field displays the connection string for the data you want to connect to.

- Select **Include Password** check box if your connection requires password. For security reasons, the password is displayed here. (**NOTE:** Passwords are saved in an encrypted format using 1024-bit encryption strength.)
 - **Test Connection:** Tests whether or not the data link was successful (i.e., to test whether you can connect to the specified OLE DB or ODBC provider). If the connection is successful, a Test Connection Succeeded message is displayed.
- **Back:** Displays the [Table View](#) or [Summary View](#) screen.
- **Next:** Displays the [Table Info](#) screen.
- **Cancel:** Cancels the export operation and closes the Export Wizard.

Table Info Screen

The **Table Info** screen is part of the Export Wizard. When configuring an export, use this screen to specify the table to which you want to export data, and to select a When output tables exist option, which tells Automator how to handle an already existing table of the same name.

The **Table Info** screen displays when you click the Next button on either the Output File/Folder screen or the OleDb Info screen when exporting to a database table (xls or mdb).

The **Table Info** screen includes the following settings:

- **Description:** Displays information about the export, such as whether filters are applied to the table or summary data, the filename and path of the output file, etc.
- **Table Name:** Displays the current name of the table. You can assign a new table name by entering it here.
- **Existing Tables:** Displays the names of the tables in that file when exporting to a file that already exists.
- **When output tables exist options:**
 - **Overwrite existing table:** Overwrites the data in the existing table with the data in the export table.
 - **Append data to existing table:** Adds the export table data to the end of the selected existing table.
 - **Update existing rows (OLE DB direct exports of table data only):** Updates existing rows in a table.

- **Update existing rows and append new** (OLE DB direct exports of table data only): Updates existing rows in a table and append new rows to it.
- **Skip** (no output): Skips the export operation if a table of the same name already exists. This is useful for automated operations, where you may not want to overwrite a table that already exists.

NOTE: Some of these options apply only to OLE DB direct exports. In addition, if you are performing a file system output, some of these options are only accessible if you selected the Add data to file option on the File Info screen.

- **When update match not found:** Select the Export to delimited text file check box to export the unmatched record(s) to a delimited text file when updating existing rows in a table, if a matching row is not found in the destination table. The path of this file will be written to the job log under an Exceptions heading (below the Outputs section).
- **Back:** Displays the File Info screen or the OleDb Info screen.
- **Next:** Displays the [Column Info](#) screen, if you selected an existing table to export to under the Existing Tables heading (see above).
- **Finish:** Saves the current export settings and closes the Export Wizard, if you are exporting to a new table.
- **Cancel:** Cancels the export operation and closes the Export Wizard.

Column Info Screen

The **Column Info** screen displays when you click the **Next** button on the Export Wizard's [Table Info](#) screen.

NOTE: If you are updating existing rows in a table, you must map at least one key field and one data field. To designate a key field, right-click on a mapping and select **Enable** as key field. A key icon will appear to the left of the field name.

The **Column Info** screen includes the following settings:

- **Export all:** Exports all the columns in the export table.

Note: When appending data to an existing table, appends will only occur for columns that exist in both the export table and the destination table.
- **Allow unrestricted mapping so that any Export column may be mapped to any Destination column:** Relaxes Automator's type checking and relies on the OLE DB Provider to perform type conversions. For example, if you need to export a numeric value that is so large that it cannot be stored in Monarch as a number, you can export it as a character field. The character field can then be mapped to a numeric field in DB2, for example, and the OLE DB provider will perform the type conversion, if that functionality is available.
- **Export Column:** Lists the columns in the export table that have been mapped to columns in the destination table.
- **Destination Column:** Lists the columns in the destination table that have been mapped to columns in the export table.

- **Auto Map:** Instructs Automator to automatically map columns in the export table to columns in the destination table that have the same names. Note: Columns that don't occur in both tables will not be mapped.
- **Add:** Displays the Select Columns to Map dialog, with which you can map an export column to a destination column.
- **Edit:** Edits the selected mapping via the Select Columns to Map dialog.
- **Remove:** Removes the selected mapping from the list.
- **Remove All:** Clears all mappings from the list.
- **Cancel:** Cancels any changes you have made and closes the Export wizard.
- **Back:** Displays the [Table Info](#) screen of the Export Wizard.
- **Next:** Displays the [Excel Advanced Features](#) screen when exporting to Microsoft Excel.
- **Finish:** Saves the current export settings and closes the Export Wizard.

Excel Advanced Features Screen

Use this dialog to use Excel Advanced Features when exporting to Microsoft Excel.

The **Excel Advanced Features** dialog box includes the following settings:

- **Description:** Displays information about the export, as entered in previous screens. For instance, if you are exporting a Summary, the description displays the summary being exported, the output file or folder to export to, and table that will be used.
- **Document Properties:** Displays the Document Properties dialog box. Here, you can set the property values of the Excel file, such as its Category, Creator, Description, Keywords, Subject, and Title.
- **Digital Signature:** Allows you to embed the currently selected digital signature to the exported Excel file (XLSX/XLSM). This option is available for Table and Summary exports. By adding a digital signature, you establish the authenticity, integrity, and non repudiation of the export output.
- **Certificate...:** Displays a Select Certificate dialog. Options will allow you to digitally sign with a valid X.509 Certificate (an existing Certificate selected from the Current User's Certificate Store or from a Certificate file).
- **Add AutoFilter drop down lists to column labels in the Table:** Enables the Excel AutoFilter feature, ready and active when you open the exported Excel file. This option is available for Table exports.
- **Include Report view text in XLSX file:** Allows you to include source data with the exported Excel file (XLSX/XLSM). This option is available for Table exports. Readers of the exported file can work with the Monarch Context add-in to reference the source data, or the even view the source report.
- **Include Pivot Table sheet:** This option is available for Table exports to Excel 2007 (xlsx) files.
 - **Fields:** Use this tab to select the desired pivot field filters, columns, rows and values.
 - **Options:** Use this tab to specify the Pivot Table name, action (if the Pivot Table exists), style, and grand total parameters.

- **Back:** Displays the [Column Info](#) screen.
- **Finish:** Saves the current export settings and closes the Export Wizard.
- **Cancel:** Cancels the export operation and closes the Export Wizard.

Specifying Default Export File Types

When configuring an export for a project, you have the option to specify default export file types. If you don't specify default export file types, the defaults stored in the Registry will be used.

NOTE: The export file types you specify are stored in the project file. They are applied only to exports that utilize the current project file.

To specify the default version for each supported export file type when exporting table or summary data for the current project, click the **Types...** button on the Project Editor's Exports tab.

NOTE: This dialog does not include options for XML-SS, HTML, Fixed Text (TXT), and Delimited Text (typically CSV), as only a single version of each file type is supported by MDP.

The **Export File Types** dialog box includes the following settings:

- **Override registry settings:** Overrides the default export file types currently specified in the Registry.
- **DBF Files:** Displays the file format and version to be used when exporting dBASE DBF files. The drop-down list includes all versions of the dBASE DBF file format supported by the Jet 4.0 database engine. Note: The drop-down list also includes a dBASE III (Monarch V3) entry. This option is available for users who have upgraded from Monarch version 3 and who have a need to create dBASE III export files with the exact same structure as those created by Monarch version 3. However, this option should not be required in most cases, as the Jet dBASE III format is only slightly different in structure from the Monarch V3 dBASE III format.
- **MDB Files:** Displays the file format and version to be used when exporting MDB (MS-Access) files. The drop-down list includes all versions of the MS-Access MDB file format supported by the Jet 4.0 database engine.
- **OK:** Saves the current settings to the Registry (if the Override Registry Settings option is checked) and closes the dialog.
- **Cancel:** Cancels any changes you have made to the settings and closes the dialog.

Specifying Prerequisite Settings for a Project File

When configuring a process, you have the option to specify prerequisites for the associated project file(s), which must be met if the process is to run.

To specify process prerequisites

1. On the **Navigation Tree**, click **Automator > Standard Processes** and select **Project Editor**.
2. On the **Prerequisites** tab, specify the type of prerequisite you want to add, either **File** or **Command line**, by clicking the corresponding button. The Add Prerequisite dialog box is displayed.
3. In the **Add Prerequisite** dialog box do one of the following:
 - To specify a file prerequisite, specify a file name in the corresponding field or click the **Browse** button to select it via the dialog that displays, and then click the **OK** button. The path and filename of the file prerequisite appear under the **Prerequisite** heading.
 - To specify a command line prerequisite, specify a command line or click the **Browse** button to select it via the dialog that displays and enter an integer success code in the corresponding fields, and then click the **OK** button. The command line and success code appear under the **Prerequisite** and **Success Code** headings on the **Prerequisites** tab.
4. Perform Steps 2 and 3 again to add any additional prerequisites, then click the **OK** button to save the prerequisite(s).
5. To test added prerequisites do one of the following:
 - If machine location is specified in the prerequisite path, click the **Test** button adjacent to the path field.
 - If machine location is not specified in the prerequisite path, then select it from the **Location for Testing** drop-down list and click the **Test** button adjacent to the prerequisite path field.
6. To save or download created project, click the corresponding button or continue specifying other project settings if necessary.

NOTE: When saving a project file provide a comment in the displayed window and click **Commit**. The Server Library [Project page](#) is displayed, where you can edit project file name, revision and access rights if necessary.

When the scheduled run time arrives, Automator will check the specified prerequisites to see that they have been met, and if they have been, the process will run. If they haven't, the process won't run.

Specifying Script Settings for a Project File

When you specify script settings for a project, you add a project-specific script to it.

NOTE: This step is optional. If you have no need to utilize scripts in your project, you may skip this step. Automator users can only edit these scripts if they are granted editing privileges by the Admin.

To specify script settings for a project

1. On the **Navigation Tree**, click **Automator > Standard Processes**, select **Project Editor** and navigate to the **Script Editor** tab.
2. Step through the Script Editor's tabs to specify the desired script settings:

- [PreExport tab](#): Specifies project-specific, pre-export declarations, e.g., to apply a pre-export script to the input file.
 - [PostExport tab](#): Specifies project-specific, post-export declarations, e.g., to add steps to further process the export file(s).
 - [Global Declarations tab](#): Specifies Dim statements or other statements that must be global to the entire script module.
 - [References and Imports tab](#): Specifies additional .NET assembly references and namespaces required by the PostExport, PreExport, and Global Declarations tabs.
 - [Passwords tab](#): Specifies passwords for use in password macros.
3. In the **Locations for testing** field, select location from the drop-down list.
 4. To save or download created project, click the corresponding button or continue specifying other project settings if necessary.

NOTE: When saving a project file provide a comment in the displayed window and click **Commit**. The Server Library [Project page](#) is displayed, where you can edit project file name, revision and access rights if necessary.

Once you have finished configuring the project file, you may [assign it to a process](#).

Specifying Login Credentials

The Login Credentials tab is part of the Project Editor. Use this tab to specify the HTTP, FTP/SFTP, and Amazon S3 login credentials to be written into the project file when using input files from an FTP/SFTP site, a SharePoint repository, or Amazon S3 storage.

NOTE: Input files located on FTP/SFTP sites, SharePoint repositories, or Amazon S3 storage cannot be used if monitoring is enabled. In addition, there can only be one set of credentials per project, so you should not specify input files that reside on different locations which require different login credentials.

To specify login credentials

1. On the Navigation Tree, click **Automator > Standard Processes** and select **Project Editor**.
2. On the Login Credentials tab, do one of the following:
 - To specify HTTP login credentials, specify a name in the Login field and password by clicking the Password button.

NOTE: To use the current windows login select the corresponding check box.

- To specify FTP/SFTP login credentials, specify a name in the Login field and password by clicking the Password button.

- To specify Amazon S3 login credentials, specify an ID in the Access key ID field and an access key by clicking the Secret access key button.
3. To save or download created project, click the appropriate button or continue specifying other project settings if necessary.

NOTE: When saving a project file provide a comment in the displayed window and click **Commit**. The Server Library [Project page](#) is displayed, where you can edit project file name, revision and access rights if necessary.

Visual Processes

Automator has a Visual Process Designer tool that allows you to create the process and define its work flow in a fast and convenient way. The Visual Process Designer visualizes mechanism of process components assembling by providing you with the library of various graphic elements and connectors and a workspace within which you can arrange them. Besides, the Process Designer can intuitively arrange the elements on the workspace.

Information on starting and finishing processes when executing processes are stored in process logs.

Processes

All the existing Visual Processes are displayed on the **Processes** page. To view the **Processes** page, on the **Navigation Tree**, click **Automator > Visual Processes** and select **Processes**.

The **Processes** page shows the following:

- Process name
- Logs column linked to the Process Logs page
- Process description
- Process current status displayed in the Usage column:
 - Monitored enabled
 - Monitored disabled
 - Scheduled enabled
 - Scheduled disabled
 - Ad hoc (i.e., no monitoring or schedule defined)

- Date and time the process was created
- Name of the author who created the process
- Date and time the process was updated
- Date and time the process was last run
- Most recent status of the process

NOTE: When deleting a visual process that uses a model, workspace, or change list in the Server Library, a dialog box appears and gives the option to **Delete dependencies**. Clicking the **Delete dependencies** button removes the associated model, workspace, or change list from the Server Library. Clicking **Cancel** deletes the process only and not the associated model, workspace, or change list. The **Delete dependencies** option is not available when the model, workspace, or change list is used by more than one process.

Adding a Visual Process


To add a Process

1. On the **Navigation Tree**, click **Automator** and select **Visual Processes**.
2. On the **Processes** page, click the **Add** icon . The [Visual Process Designer](#) interface will be displayed.
3. Choose **Blank Process** to work on a Visual Process from scratch. To use a template, you may choose from the following:
 - Data Prep
 - Distribute export result
 - Groups
 - Model verify
 - Parallel export
 - Script
 - Sequential export

Editing a Visual Process

Once you have configured and saved a Visual Process, you can edit it at any time.

To edit a process

1. On the **Navigation Tree**, click **Automator** and select **Visual Processes**.
2. Click the name of the process you want to change or clicking anywhere on its row, and then click . You can then modify the process from the Visual Process Designer interface.


NOTE: When loading a Visual Process containing a workspace element, workspace validation is initiated and is terminated automatically after a certain number of seconds. The duration of workspace validation can be modified in Automator's [General Settings](#).

You may terminate the workspace validation manually by clicking **Cancel** in the loading screen.

Deleting a Visual Process

You can delete any process on the **Processes** page.

To delete a process


1. On the Navigation Tree, click **Automator** and select **Visual Processes**.
2. Click  at the end of the row with the process you want to delete. A dialog box appears.
3. Click **Delete** to remove the process from the list.
The process is removed from the [Processes](#) page, and its associated logs are removed from the [Logs](#) page.

NOTE: When deleting a visual process that uses a model, workspace, or change list in the Server Library, a dialog box appears and gives the option to **Delete dependencies**. Clicking the **Delete dependencies** button removes the associated model, workspace, or change list from the Server Library. Clicking **Cancel** deletes the process only and not the associated model, workspace, or change list. The **Delete dependencies** option is not available when the model, workspace, or change list is used by more than one process.

Enabling/Disabling Monitoring of Visual Processes

You can enable or disable the monitoring of multiple Visual Processes simultaneously.

To enable/disable process monitoring


1. On the Navigation Tree, click **Automator**, and select **Visual Processes**.
2. Select the Visual Processes you want to enable/disable the monitoring for by clicking their corresponding checkboxes.
3. Click the drop-down arrow , and choose **Disable Monitoring** or **Enable Monitoring**.
4. In the **Monitoring** dialog box, click **Ok** to proceed.

NOTE: When enabling/disabling monitoring, the changes take effect after approximately 1 minute.

Enabling/Disabling Scheduled Visual Processes

You can enable or disable one or more scheduled Visual Processes.

To enable/disable scheduled Visual Processes

1. On the Navigation Tree, click **Automator**, and select **Visual Processes**.
2. Select the Visual Processes whose schedule you want to enable/disable by clicking their corresponding checkboxes.
3. Click the **Additional schedule actions** icon , and choose **Disable Schedules** or **Enable Schedules**.

NOTE: When enabling/disabling schedules, the schedule status (i.e., active/suspended) of the selected processes is automatically saved.

Visual Process Designer

The Visual Process Designer tool allows you to create processes in easier and more convenient way than to apply the standard approach. You have full set of tools for process creation that is used in standard processes but you have greater capabilities to apply these tools and therefore set up more sophisticated scenarios.

Data acquisition, conversion and distribution is visualized in the Process Designer through use of graphic elements and connectors arranged by threads.

By using library of graphic elements and a workspace, you can quickly assemble different process components to set the required process. The created process can be represented as a graph in the Process Designer window.

Visual Process Designer interface

The Visual Process Designer interface consists of the upper line, Process Designer Library, Workspace panel, and Properties panel.

The upper line of the Process Designer contains name of the process (on the left) and the Designer Toolbar. You are allowed to change name of the process if needed.

The table below specifies buttons of the Visual Process Designer toolbar.

Button Name	Description
New	Click to open new workspace for creation new process. The workspace with the previous process will not be saved automatically.
Save	Click to save the specified work flow as a process.

Save as ...	<p>You can choose the following options:</p> <ul style="list-style-type: none"> • Save new process: Save the specified work flow as a new process. • Save as template: Save the specified work flow as a template. Elements settings are not saved. • Save as template (retain data): Save the specified work flow as a template. Elements settings are saved.
Insert Template	<p>Click to open the list of existing templates. You can select the required template and add it to the workspace.</p>
Insert Process as Group	<p>Click to open the list of existing processes. You can select the required process and add it to the workspace as a group element.</p>

On the Process triggers dialog, select the Schedule radio button. 3. Click the Add schedule button.

4. Select the task execution frequency from the following options: **One Time, Hourly, Daily, Weekly, Monthly**.
5. Set the time you want the process to run.
6. Set the start date of the process.
7. Select the appropriate time zone from the drop-down list.
8. Click the **Ok** button to save the schedule.

To delete a schedule:

1. Click the **Triggers** icon.
2. Click the **Delete** icon near the schedule you want to delete.
3. Click the **Ok** button to save process schedules.

Select the **Suspend** check box to temporarily hold up the trigger.

Inputs Monitoring Trigger

When you specify inputs monitoring settings for a process, you specify files that you want Automator to monitor a particular location for. When the file arrives in the specified location, Automator will trigger running of the associated process.


NOTE: Changes in monitoring settings, including enabling and disabling monitoring or changing paths for monitored folders, take effect after approximately 1 minute.

To specify an inputs monitoring file

1. Click the **Triggers** icon.
2. On the **Process** triggers dialog, select the **Inputs Monitoring** radio button.
3. To add a file not from the process, expand the **Browse** section, set the file path, and click the **Add** button.

NOTE: If you're unsure of the file's exact name or if you want Automator to monitor for any file of a particular file type, you can use a wildcard character, either an asterisk (*) or a question mark (?), so that the arrival of any file of the specified type will trigger the running of the process. An asterisk may replace multiple characters while a question mark may replace any single character.) For example, adding *.prn to the end of the folder path instructs Automator to trigger the running of the associated process when any report file with a .prn extension arrives in the specified location.

You may also use the naming macros to specify the file path (for local and named paths).

Click the Insert Macro icon  and select the [naming macros](#) from the drop-down list.

4. To add a file from the process, expand the **Process inputs** sections and press the **Add** icon near the input path, which you want to add to the **Monitoring Paths** list.
5. Expand **Options** to specify monitoring behavior:
 - **Disable monitoring if trigger file is not removed** – The input mask (e.g., myfile.txt or *xyz.pdf) from the monitored folder can sometimes cause a process job to fail with an error and remain in its original folder. By selecting **Disable monitoring if trigger file is not removed**, Automator stops monitoring the corresponding folder(s) for the process and its input mask(s) only. When this option is not selected, the monitoring is left enabled; when new files appear in the monitoring folder, the process running is triggered again. You would, for example, enable this option if a problem requires intervention to determine why the inputs caused the process to fail and prevent the process from running until the issue is addressed.
 - **All files must exist** – Monitoring based on multiple files starts as soon as one of the files is found. By selecting the *All files must exist* option, the monitoring process will not start unless all the associated files are found.
6. Click the **Ok** button to save the process monitoring.

To delete an inputs monitoring file

1. Click the **Triggers** icon.
2. Select the **Inputs Monitoring** radio button.
3. Click **Delete** icon near the file path you want to delete.
4. Click the **Ok** button to save process monitoring.

Manifests Monitoring Trigger


When you specify manifests monitoring settings for a process, you specify the manifest XML files that you want Automator to monitor a particular location for. When the file arrives in the specified location, Automator will trigger running of the associated process.

To specify a manifests monitoring file

1. Click the **Triggers** icon.
2. On the Process triggers dialog, select the **Manifests Monitoring** radio button.
3. To add a file, expand the **Browse** section, set the file path, and click the **Add** button.

NOTE: If you're unsure of the file's exact name or if you want Automator to monitor for any file of a particular file type, you can use a wildcard character, either an asterisk (*) or a question mark (?), so that the arrival of any XML file will trigger the running of the process. An asterisk may replace multiple characters while a question mark may replace any single character.)

You may also use the naming macros to specify the file path (for local and named paths).

Click the Insert Macro icon  and select the [naming macros](#) from the drop-down list.

4. Click the **Ok** button to save the process monitoring.

To delete a manifests monitoring file

1. Click the **Triggers** icon.
2. Select the **Manifests Monitoring** radio button.
3. Click **Delete** icon near the file path you want to delete.
4. Click the **Ok** button to save process monitoring.

Report Warehouse Trigger

This trigger is available only if in the Monarch Server License the Enterprise Server component is enabled.

It enables you to specify certain document types so, when the system receives a report with the corresponding document type, the trigger runs a process.

To assign Report Warehouse document types

1. Click the **Triggers** icon.
2. Select **Report Warehouse**.
3. Add document types by clicking the plus icons or by drag and dropping them into the **Assigned Document Types** field.
4. Click **Ok**.

You can also add document types from the **Report Warehouse Input** of the current process by clicking the **Assign from process** button.



Select the **Disable Triggers** check box to temporarily turn off all triggers.


Scripts

Click to apply scripts to the current process.

In the **Process Declarations** tab, the following settings are available.

- **Script field:** Displays the existing process declarations.
- **Insert Script:** Allows you to quickly generate VB.NET script for frequently used tasks. For complete options, refer to [Inserting a Script](#) section.
- **User Scripting Help:** Opens the User Scripting API Help, which is a collection of script fragments that can be copied and pasted as useful starting points in the Script Editor.

	<p>In the References and Imports tab, specify additional assembly references and namespaces that are required by PostExport, PreExport, and Global Declarations sections. Major part of toolbar controls can be called using the context menu. The Process Designer context menu is called on the right click on the workspace area. You can use the following commands from the Process Designer context menu:

- Insert Template
- Insert Process as Group
- Auto Arrange
- Zoom In
- Zoom Out
- Show/Hide Grid
- Enable Auto Connect
- Show advanced connectors
- Clear

The context menu is also available for all graphic elements. You can use the following commands from the element context menu:

- **Duplicate** — to duplicate the selected element.
- **Group** — to combine several selected elements into a single element group (available for multiple selected elements only).
- **Ungroup** — to revert elements grouping (available for selected group elements only).
- **Drill in** — to open the group element (available for group elements only).

- **Rename** — to rename the selected element.
- **Delete** — to delete the selected element.
- **Properties** — to open properties of the selected element.

On the left panel, there is a Process Designer Library with graphic elements to denote different types of inputs, models, exporting jobs, prerequisites, etc. All items from this library can be used to assemble the required process.

To the left of the Process Designer Library, the Workspace panel is adjusted to where you can drag and drop graphic elements from the Library panel.

Single or double click on a particular graphic element opens panel with its properties. When displayed, the Property panel is located on the right part of the Process Designer window. Mandatory buttons of the Properties panel are as follows:

- **Ok** — to save the changes made on the Properties panel and close the panel.
- **Apply** — to save the changes made on the Properties panel and leave the panel to be expanded.
- **Cancel** — to cancel the changes made on the Properties panel.

NOTE: When you do not click **Ok** or **Apply** in the Property panel and you click on another graphic element in the Workspace panel, a dialog box appears to warn you about losing unsaved changes. In the dialog box, you can choose to save or not save the changes you have made in the Property panel. Clicking **Cancel** will close the dialog box, and the Property panel will remain open.

The Process Designer Library contains the following groups of the graphic elements:

- [Input](#)
- [Model](#)
- [DataPrep](#)
- [Export](#)
- [Prerequisites](#)
- [Misc](#)
- [Output](#)

Some library elements define the process work flow, and some not. For example, library elements from the **Input** and **Model** groups represent data, but not work flow.


Process work flow is defined by graphic elements in the following library groups:

- **Exports**
- **Prerequisites**
- **Misc** (with the exception of the **Credential** element)

- **Output**

Elements from the **Input** and **Model** groups do not define process work flow. Belonging to work flow is a benchmark why two types of connectors are used, namely:

- **Solid line connectors** — for connecting work flow items
- **Dashed line connectors** — for connecting non-work-flow items.

One more work flow (not data) indicator for a graphic element is availability of input and output pins of gray color on the element's icon ().

Connectors differ by color:

- **Gray connector** — implementation of work flow stage is successful
- **Red connector** — implementation of work flow stage leads to failure

Quick adding the connected elements

Quick connectors are available upon mouse over an element — two plus signs (+) appear on top of it.

- **Left plus connector** — allows to promptly select and add another input element connected to the current one.
- **Right plus connector** — allows to select and add an output connected element.

NOTE: Quick connector buttons for workspaces with selected settings of load plans and input files allows to select and add a connected input file element (unpinned input files only).

Group element

You can open the group element by right-clicking and choosing Drill In, or by double-clicking the element. After opening, the breadcrumbs line displays the group name.

If you want to exit the group, click the previous element in the breadcrumbs line.

You can add new elements to the group element by dragging and dropping.

You can connect the group element with the required element by dragging the connector icon from the group element to the required element. Also, you can connect the required element with an element of the group. After that, you can open the group element and proceed with connecting it to the necessary element in the group (the icon of that connection is selected and the name of the connecting element is displayed in the tool tip).

Instructions for process work flow building

- There are no mandatory graphical elements that must be used for work flow building.
- Starting work flow item is defined by absence of input connector. Process execution starts with the starting work flow item.
- Final work flow item is defined by absence of output connector. Process execution finishes on processing final work flow item.
- If there two or more starting items, execution starts synchronously and is divided in two parallel threads.
- You can fork work flow using connectors if you need to branch one thread of process execution into two or more parallel threads.
- Successful execution of work flow stage is defined by gray connector, unsuccessful execution of work flow stage is defined by red connector.
- By pop-up colorful arrows, the Process Designer gives prompts that some work flow items are available for connecting with the particular item and some work flow items cannot be connected with the given item.
- By pop-up single/double arrows, the Process Designer gives prompts that a particular work flow item can be connected with the single item only or with multiple items.
- For export operations, output work flow item can be an input item for subsequent work flow item.

NOTE: A Visual Process can be run in parallel with itself. This feature is useful in specific cases, e.g., those initiated by a manifest file with different inputs and outputs for each process run or when a macro output is used according to different input file names.

However, running the same Visual Process in parallel could lead to resource contention. This feature does not include any mechanism for locking inputs or outputs if they simultaneously appear in more than one instance.

Every time you run a process, process log item is created. Refer to the [Process Logs](#) section for details.



If you save some process as a template, it will be saved in the list of templates and could not be found in the list of processes. In this case, settings for all data flow items will not be saved.


Input Elements

Input elements in the Process Designer tool are data sources which are used for exporting.

The table below specifies functionality of the **Input** group elements.

- To apply filtering to the table during the export, select the **Apply Filter** check box and click the **Change** button to specify necessary filters.
- Filters are not applicable when applied directly to a Workspace-based dataset. To implement a filter for a Workspace-derived export, apply a change list to the preceding Workspace object as part of the load plan selection.
- When Automator exports the table data, the filter(s) you selected will be applied to it. Only the data that matches the filter's specifications will be exported.
- To include column names in the table with the exported data, select the **First row contains column names** check box.
- To choose an Excel engine, click on the **Excel Engine** drop-down list, and choose **Legacy** or **Modern**. For the Modern Excel engine, password-protected Excel files can be used.
- **Delimiter character** — specifies the delimiter (i.e., comma, tab, semicolon, pipe, space, other) used in the file to separate values.

NOTES:

If the source file has PDF format, the **PDF Password** field appears on the **Properties** panel. You need to enter password if the source file is protected with the password and click **Check**. The specified password for PDF file will be checked. If the password is wrong or you ignore password check, you cannot use the given input.

It is recommended to use wildcards in the **Input Path** field to enable using multiple input files or any input file of a particular file type. Use asterisk (*) to replace multiple characters and question mark (?) to replace some single character. For web input files, wildcards can be used only if it is an FTP/SFTP connection, not HTTP.

Model Elements

Model elements in the Process Designer tool are sets of instructions how input files are parsed by Automator.

A model file, created within Monarch, is a file with the *.dmod* or *.xmod* extension that may contain field, filter, summary and chart definitions as well as other settings. This information can be viewed by clicking the information icon  below the **Model Path** field.

The table below specifies the functionality of each **Model** element.

DataPrep Elements

DataPrep elements in the Process Designer tool are used for executing data preparation operations upon process inputs. These elements consist of Workspace and DataPrep Export.

NOTE: A **Hub** element can be added between a **Workspace** element and a **DataPrep Export** element to process multiple input files individually or by group on a workspace.

The table below specifies functionality of the **DataPrep** group elements.

NOTE: Workspace validation is sensitive to data volume and connection speed and is thus disabled by default. For web/cloud-based load plans, you may select the **Disable validation optimization** checkbox to disable the automatic downloading/parsing of files from the web.

- **Load Plans** — the list of available export load plans, including:
 - **Provider type.** This shows the type of provider.
 - **File Name.** If your Workspace input is a file of a certain format, you can substitute it with the file from the process input. Do the following. For the PDF Report, Text Report and Delimited Text file formats add a **File input** item to your visual process design form. For Microsoft Access and Microsoft Excel formats add a **Database input** item. Connect this item with your Workspace element. Set up the **Input path** for your File input or Database input. Then in the File Name drop-down list for your load plan select a File input or a Database input option.

NOTES:

When the Database Input option is selected, the table name automatically changes to the table name from the database input. The table name may be changed manually.

Database Input is required for Excel formats and must include the extension even with wildcards.

Additional options are available for Excel Worksheet Design. They are detailed [here](#).

- **Source** — If the workspace input is a database, then this field displays the database name. If the source type is SQL Server, ODBC, or OLE DB, there is the possibility to rewrite/edit the Database Data Source. To do so, click the **Edit Table Info** button, and then edit the Connection String, Table, etc. If the plugin is Google Analytics, the settings can be changed by clicking the **Edit Table Info** button. In the Google Analytics window, edit the Service Account Email, Profile ID, Start Date, End Date, etc. If the plugin is Oracle, edit the settings by clicking the Edit Table Info button. In the Oracle window, edit the connection type and settings (including host name, port,

		<p>service name, user ID, password, etc.). Tables and views, as well as queries, can also be edited from this window.</p> <p>NOTE: Additional options for SQL Server, OLE DB, and Oracle source types are provided below.</p> <ul style="list-style-type: none"> ◦ Change History — additional operations to be executed with the input. Click the Add Change List button and select a change list from the Server Library to add to the workspace. You can also add new item to Server Library via the Add Change List dialog box. Click OK to proceed. The settings of the selected export are then applied to the DataPrep Export item settings.


NOTE: The advanced settings for a predefined Excel export from the selected export definition will also be fetched and applied to the DataPrep Export item settings. A label of **Excel Advanced Options: Default** indicates that the selected export definition to be imported has no advanced Excel export settings. A label of **Excel Advanced Options: Custom** indicates that the selected export definition has at least one advanced Excel export setting.

However, if the **Enable Advanced Excel features** for existing exports of the current workspace is disabled, the advanced Excel export settings of the selected export definition are not applied to the DataPrep export item at all. Note that the same does not apply to new exports created in Monarch Server.


- **Export File System** — the file system to which your table will be exported. This setting is available for the following export types:
 - CSV
 - Microsoft Excel
 - Microsoft Access
 - Qlik
 - Tableau
 - SAS Transport File Format V5
 - JSON
 - XML

The following file systems are available:

- Local or mounted disk
 - Amazon S3
 - Azure Data Lake Storage Gen2
 - Azure Blob Storage
 - Oracle Cloud Infrastructure
 - Google Cloud Storage
- **Export Type** — the type of export file. Further settings depend on the type of file and are described as advanced options [below](#).

- **Export Destination** — path to required export file. Click the Browse button  to modify the destination path for the *local or mounted disk* file system or to open the **Browse For File** window from which you can view the containers of your selected export file system and set the file to be used as the export destination. Then, click **Ok** to proceed.

NOTES:

You may also use the naming macros to name the exported files and destination folder. To do this, click the **Insert Macro** icon () and select the naming macros from the drop-down list.

The **Input File Name** macro is available to specify one or more input file names. If there are several inputs in a Load Plan (Join/Union), the names of the export files will contain a combination of these input files. When the Input files are processed by group, the **Input File Name** macro will only hold the first file name.

- **Export Options** — allows you to specify the filter, summary, and sort settings for the export

Filtering:

- **Select filter:** From the dropdown list, choose the filter you want to apply to the export. When **All filters** is selected, you will be asked to specify the **Automatic Naming** setting:
 - **By Files:** produces a file for each filter
 - **By Tables:** produces a table for each filter

Select a summary:

NOTE: This option is available for the following file types: CSV, Microsoft Excel, Microsoft Access, XML, JSON, Tableau, SAS Transport Format, and Qlik.

- **Summary:** From the dropdown list, choose the summary to apply to the export. Selecting **All summaries** will let you specify the **Automatic Naming** setting:
 - **By files** — when exporting multiple summaries, a file is exported for each summary, and the files are named according to the summary names.

- **By tables** — when exporting multiple summaries, a table is produced in the export file for each summary.
- **Measure:** Allows you to specify the measure to apply to the summary selected. This is activated when the summary has a defined column key. From the dropdown list, you can also choose **All, by key** to include all measures grouped by key or **All, by measure** to include all measures grouped by measure.
- **Split:** Check **Each distinct value of the first key makes a separate file or table** to split the summary export according to each value change in the first key (i.e., the leftmost one). The **Automatic Naming** setting can then be modified:
 - **By Files:** produces a file for each distinct first key
 - **By Tables:** produces a table for each distinct first
- **Drill level:** Set the drill level to apply to the summary being exported. Drilling up and drilling down is to collapse and expand a summary data set, respectively. A lower drill level (e.g., Level 1) results in fewer columns in the exported table.

Sorting

- **Select Order:** From the dropdown list, choose the sort to apply to the export.

NOTE: When the selected table has a row limit applied, you can proceed with the export by exporting either all rows or limited rows. Specifically, the following options are available:

- **Export all rows** : the export file will contain all the rows from the workspace
- **Export limited rows (Limit: X number of rows):** the export file will contain only a limited number of rows, as set in Data Prep Studio.

The option to export either all rows or limited rows is only available when one load plan is selected. It cannot be modified when multiple load plans are selected for export.

Additional options for Excel Worksheet Design

Export Elements

Export elements in the Process Designer tool are sets of instructions how the parsed data is exported by Automator.



The table below specifies functionality of the **Export** group elements.

Element Name	Description	Properties and Comments
Hub	Defines in what way multiple input files should be grouped	<ul style="list-style-type: none"> • Name — name of the graphic element.

- **File inputs processing:**


- **Group** — all input files are processed in a group
- **Individually (Export Only)** — each input file is processed separately by the following element types: Report Export, Table Export, Summary Export, DataPrep Export, Verify Model, and Verify Workspace
- **Individually** – each input file is processed by all elements after the Hub separately


NOTES: When the **Individually** option is selected, the **Process individual inputs in parallel** check box is shown. Once this check box

is selected, the icon of the Hub element changes from  to 

. This is because all actions after the Hub element are performed in parallel, meaning all actions are started consecutively and completed consecutively.

The same change can be seen for the export elements when the

Individually (Export Only) option is selected. For example, 

becomes .


As for the **Individually** option, the same change in the appearance of icons is observed not only in the export elements but also in the distribution and script elements.

Note that only 10 inputs can be processed in parallel under the **Individually** setting because the default Max Threads setting in the Automator Dispatcher Service Host is 10. This value can be changed in Configurator. For more details about the Max Threads setting, refer to the Configurator Guide ("Configuring Servers") in the [Monarch Server Installation Guide](#).

- Order in which to process multiple files:

- **No order** — input files are processed in random order
- **Alphabetical** — input files are processed alphabetically according to their names
- **Old First** — input files are processed in chronological order, i.e., from oldest files to newest ones

 - click the **Browse for ...** button and select **Connection Definitions** to open the **Connection Definitions** window and select from the existing connection definitions. For more information, see **Connection Definitions**.

After you made your choice, the **Connection string** field displays the connection string for the data you want to connect to.

- Select the **Include Password** check box if your connection requires password. For security reasons, the password is displayed here. (**NOTE:** Passwords are saved in an encrypted format using 1024-bit encryption strength.)
- Select the **Bulk Behavior** check box to enhance table export performance. (**NOTE:** This option is applicable for Oracle Database and Microsoft SQL Server OLEDB providers only.)
- Select the Use Transaction check box to revert the export via rollback if an error occurs during the export.

NOTE: The Use Transaction check box is only available when the Bulk Behavior check box is selected.

Selecting this option will affect the performance of the table export and may require a large amount of system resources, especially for the target destination. Therefore, make sure to test this option first and then make the necessary adjustments.

The transaction is valid for the export operation only and not for the overall process.

- **Test Connection String:** Tests whether or not the data link was successful (i.e., to test whether you can connect to the specified OLE DB or ODBC provider). If the connection is successful, the **Test Connection Succeeded** message is displayed.

NOTE:


When the dBase, Microsoft Access ACCDB, or Microsoft Access MDB export file type is selected, the **Export Behavior** drop-down menu becomes available. The available options are:

- **Default** - Use this option for all new processes.
- **ACE DAO** - Use this option for better performance for large datasets. All exports in the system with this behavior will be executed concurrently. ACE OleDb will be used as fallback when output tables exist option is "Update existing rows" or "Update existing rows and append new."
- **ACE OleDb** - Use this option for better reliability. This behavior is slower than ACE DAO, but it allows to handle exports in parallel.

From Monarch Server 2022.0, the Panopticon Designer export format (.dwx) has been deprecated, and processes with this file type from previous versions of Monarch Server are no longer supported. Running such processes will lead to a failed export error. Choose an alternative file type in this case.

- **When output file exists:** If a file of the specified name and type already exists in the export location, select one of the following options:
 - **Overwrite:** Overwrites the data of the existing output file with the data in the current export file.
 - **Add data:** Adds the export file data to the end of the specified file.
 - **Skip:** Used for Automator project exports, this allows you to create a project export which will skip the export operation if a file of the same name already exists. This is useful for automated operations, where you may not want to overwrite a file that already exists.

Table options

- **Table auto-name by:**
 - **None:** Select if you want export produces only one table;
 - **Summary:** Select if you want export produces a table for each summary (this option available only if **All Summaries** filter is selected);
 - **Measure titles:** Select if you want export produces a table for each measure title (this option available only if the **All measures as separate exports** filter is selected);

- **Skip:** Skips the export operation if a table of the same name already exists. This is useful for automated operations, where you may not want to overwrite a table that already exists.

PDF options (displayed if export file is PDF)

- **Apply open password:** Password-protects the PDF file.
- **Change...:** Displays the **Change PDF Export Open Password** dialog. Use this dialog to specify the password that must be supplied to open the PDF file.

These options let you restrict the permissions available to users of the PDF file.

- **Apply permissions:** Specifies permission options for the PDF file.
- **Change...:** Displays the **Change PDF Export Permission Password** dialog, with which you can specify a password for the exported PDF file(s).
- **Printing allowed:** Allows the PDF file to be printed.
- **Content extraction allowed:** Allows copying (e.g., cut and paste) of the PDF file's content.
- **Editing allowed:** Allows editing of the PDF file.
- **Annotation (comments) allowed:** Allows comments to be added to the PDF file.

NOTE: If you do not specify PDF file permissions, users will have full access to it.

Select one of the following encryption options. (**NOTE:** One (or both) of the passwords must be applied to enable encryption.)

- **RC4 (128-bit):** Encrypts the PDF file with RC4 encryption. WARNING: This option is not recommended for extremely confidential data. Use the AES option instead.

- **Include Formulas to Facilitate Editing in Excel:** Click this option if you want Automator to attempt to translate subtotal and grand total calculations into Excel formulas in the exported Excel file.
- **Use conditional formatting if required conditions are fewer than (?):** This option implements Conditional Formatting Rules in the exported Excel file, as long as the number of rules would not exceed the specified amount. The Conditional Formatting feature in Excel provides a mechanism to modify the display attributes of a cell based upon the value of that cell. Automator leverages this feature by creating conditional formats from the rules specified on the Coloring and Limits dialog of a measure's properties. Depending upon the rules defined for each measure, up to 3 conditional formatting rules can be generated for each value of an exported measure.

Move

Advanced options

- **Store Original Report:** When reports are read and indexed for storage, their format is changed to enable fast and efficient retrieval and mining. Selecting this option will also store the original report, as read, in the storage system.
- **Pages / Storage Unit:** In storing reports, there are trade-offs between the compression ratio (disk space requirements) and speed of retrieval. A higher number of Pages / Storage Units can provide dramatically increased storage compression but at a cost of reduced retrieval efficiency and performance.
- **Pre-mine all processed reports for interactive data analysis:** Select this option, if you want table data to be extracted from the reports during the filing process and put into the Monarch Server database. Then the data can be used to build Dynamic View data views. This option requires licensing.

Redaction settings are available only if a redaction license is enabled in Monarch Server.

- **Store reports redacted:** Select this option to allow storage reports to be stored with redaction. In this case reports are stored in the redacted format in storage volume.
- **Store mining data redacted:** Select this option to allow pre-mined data to be stored with redaction.

Limitation: For this output type, you can use data from text input or report export.

Process Designer Scripting API

We have provided a short collection of script fragments to take a look at and copy and paste to serve as starting points or fragments of your own scripts.

The Visual Process Designer Scripting API expose the following members:

- **AddEvent:** Adds any text to the log (for informational or auditing purposes).

- **AddInput:** Adds an input item to the process.
- **AddOutput:** Adds an output item to the items for the specified export.
- **AddPassword:** Adds a script password.
- **AddRuntimeFieldValue:** Sets the value for a runtime field. This value will be used, if called for, by subsequent exports.
- **AddVariable:** Adds a variable to the script.
- **ClearPasswords:** Clears all script passwords.
- **ClearRuntimeFieldValues:** Clears values for runtime fields.
- **ExpandMacros:** Expands macros in a given string, in the context of the entire log.
- **GetEvents:** Gets the list of events for the log item specified by name.
- **GetExports:** Gets the list of process export names.
- **GetInputs:** Gets the list of input items.
- **GetOutputRowCount:** Gets the row count of Report, Table, Summary, or DataPrep export by export element name; by export element name and location; or by export element name, location, and table name.
- **GetOutputs:** Gets the list of output items for a process.
- **GetOutputs (string):** Gets the list of output items for a specified process export.
- **GetOutputTableNames:** Gets the table names of Report, Table, Summary, or DataPrep export by location.
- **GetPassword:** Gets the list of script passwords.
- **GetProcessName:** Returns the name of the process.
- **GetRuntimeFieldValue:** Returns the current value, if any, for a given runtime field name.
- **GetTrackingId:** Gets the tracking ID of the current log.
- **GetVariable:** Gets the list of script variables.
- **HasPassword:** Returns “true” if the password as added using the AddPassword method
- **HasRuntimeFieldValue:** Returns true if a value has already been set for a given runtime field name.
- **RiseAlert:** Rise process or global alert by name with a specified message.

Importing a Visual Process

You can import visual processes from the **Processes** page.

You can import a process by selecting the output (in the JSON format) of a previous export process operation.

To import a process

1. On the **Navigation Tree**, click **Automator** and select **Visual Processes**.
2. On the displayed page, select the **Import Processes** tab.
3. Click the **Upload** button and choose the file to import in the **Open** dialog box. You can select only one file at once.

NOTE: You can also import a standard process as a visual process. For this, export the standard processes with the *"Include process dependencies"* option enabled, and then upload them to Visual Processes.





4. Enable the **Change locations on import** check box to substitute all locations values to the selected new location.
5. Enable the **Include process dependencies** check box to import models, workspaces, change lists, and Visual Processes/Standard Processes connected to the processes (if any) to the Server Library.
6. Click the **Import** button to import the processes. A message box informs you that the import operation is complete.

NOTE: If you exceed the number of processes allowed by your license, the following message appears.

"The maximum number of processes per your license (XX) will be exceeded with this import and it cannot be completed. You can select at most (NN) processes for import, or you may delete unused processes or contact your Altair sales representative for extended options."

Named Path Mapping

During import of an exported Visual Process that includes named paths, the **Named Path Mapping** window displays. In this window, the named paths in the Visual Process being imported are mapped to the existing named paths in the destination environment. The following options are available:

-  **Auto Map Named Path** – Click to automatically map all imported named paths by ID or by Name (depending on the radio button selected). By default, the imported named paths are mapped by Name.
-  **Edit Mapping** – Click to manually perform mapping or modify existing mapping.
-  **Delete Mapping** – Click to delete currently selected mapping.
-  **Delete All Mappings** – Click to delete all listed mappings.

Exporting a Visual Process

You can export visual processes on the **Processes** page.

The output of the export operation is a JSON file (or files) that can then be imported into another Automator Installation.

To export a process

1. On the **Navigation Tree**, click **Automator** and select **Visual Processes**.
2. On the displayed page, select the **Export Processes** tab.
3. Select the process you want to export. Multiple selection is available.
4. Specify the number of processes per file by selecting one of the following options:

NOTE: One process per file if you want each process to be exported to its own JSON file. All processes in one file if you want the exported processes to be exported into one JSON file.

5. Enable the **Include process dependencies** check box to export model, workspace, change list content, and Visual Processes/Standard Processes.
6. Click **Export**.
7. In the displayed dialog box, enter the name of the archived output file.

NOTE: If you select *"One process per file"*, the outputs are named .json, located in the folder you specify. If you select *"All processes in one file"*, the output uses the name you specify, located in the folder you select.

8. Click **OK** to export the process or **Cancel** to cancel exporting. A message box informs you when the export operation is complete.

Migrating a Visual Process

You can migrate existing standard processes into visual processes.

To migrate a process

1. On the **Navigation Tree**, click **Automator** and select **Visual Processes**.
2. On the displayed page, select the **Migrate Standard Processes** tab.
3. Select the process you want to export. Multiple selection is available.
4. Enable the **Change locations on import** check box to substitute all locations values to the selected new location.
5. Click the **Migrate** button. A message box will inform you that the migrate operation is complete.

NOTE:

You can migrate only the processes with projects from the **Server Library** location.


If you exceed the number of processes allowed by your license, the following message appears:

"The maximum number of processes per your license (XX) will be exceeded with this migration and it cannot be completed. You can select at most (NN) processes for migration, or you may delete unused processes or contact your Altair sales representative for extended options."

Schedules


All schedules for Visual Processes are listed on the **Schedules** page. You can use this page to [add](#), [edit](#) or [delete](#) schedules.

To add a new schedule for a Visual Process

1. On the **Schedules** page under Visual Processes, click . The Schedule page will be displayed.
2. Select the **Suspended** check box if you want to suspend the task.
3. Specify the process to which the schedule will be assigned.
4. Select the task [execution frequency](#) from the following options: **One Time**, **Hourly**, **Daily**, **Weekly**, **Monthly**.
5. Set the time you want the process to run.
6. Set the start date of the schedule.
7. Select the appropriate timezone from the drop-down list.
8. Click the **Save** button to save the schedule or **Run Now** to start the task immediately.


NOTE: If the Config service is not available and you are using Altair licensing, Automator processes will be switched to "Limp Mode." In this mode, you can run only one process (i.e., one Standard Process and one Visual Process) every hour. Moreover, you cannot run a Visual Process that involves other Standard or Visual Processes. Limp Mode is deactivated once the Config service becomes available.

To edit a schedule for a Visual Process

1. Click the name of the schedule you want to change or select the schedule by clicking anywhere on the row, and then click .
2. On the displayed page, make the necessary changes and save the schedule.

For details about how to change the schedule settings please refer to [Adding a Schedule](#).

To delete a schedule for a Visual Process

1. Click  at the end of the row of the schedule you want to delete. A dialog box appears.
2. Click **Delete** to remove the schedule from the list.

Process Templates

Templates can be used for processes creation if the template is expected to be used in other projects for many times.

Interface, logic and instructions for templates creation and configuring using the Process Designer is the same as for processes. Refer to [Processes section](#).

Each template should have its specific name. The template name should be unique not only within templates namespace, but within the process namespace as well.

A newly created template can be saved as:

- template — graphic elements of this templates and connections between them will be saved
- template (retain data) — all element settings will be saved as well

Templates can be marked as favourite. The favourite templates are displayed in the Processes window on startup.

Process Logs

Process logs are used to view information about executed processes, including their start and end dates and times, duration, and the results of the execution.

User can view the Logs on the **Logs** list. The records in the log grid are editable, and the unnecessary log records can be deleted.

Currently running processes can be canceled by clicking the **Cancel** button.

To open the **Logs** list, on the Navigation Tree, double-click **Automator**, click **Visual Processes**, and select **Logs**.

The **Logs** page displays the following information:

- The log's unique ID number
- The name of the process
- The date and time when the process was started
- The date and time when the process was completed
- The duration of the process execution
- The state of the process
 - Building executing plan
 - Ready to run
 - Running
 - Completed
 - Some items completed with errors
 - Some prerequisites completed with errors
 - Some exports completed with errors
 - Canceled
 - Cancelling
 - Process awaiting retry after a failed run attempt
 - Dispatcher host is not responding (a process has been executed on a host that is currently not responding)
 - Orphan job (a process has been executed on a host that does not exist in the current configuration)
 - Cancelled automatically (a process log is stuck because the host became unavailable and another log was created after the host became available)
- The name of the server on which the process is run

NOTE: You can filter the processes by log ID, process name, date started, date completed, state, and location by using the corresponding fields in the column headings.

The following filter settings are available:

Symbol	Description
~	contains
==	equal

<	less
>	greater
X	Reset search value

Open a log item to view it.

The **Text** tab displays a summary of the process execution. The **Visual** tab displays the visual process of the selected process as well as the summary of the process execution. You can also view the progress of an export in the export element (shown as a percentage).

Process Events displays general information about the recently run process, including the start and end times.

Process Items allows you to filter the process information by selecting and clearing the following check boxes:


- All — displays all file sources.
- Warning — displays the file sources with warnings.
- Error — displays the files sources with errors.

Click the *n Events* link below each file source to expand the relevant information, including the start and end times.

The items may be sorted according to duration (ascending and descending), start time (ascending and descending), and type.

Click the **Export Log**  button to export the log to an XML file.

Click the **Back to list** button  to navigate to the Logs list.

Click the **Go to Process** button  to navigate to the Process details page (i.e., the process that was run and created in the current log).

Click the **Previous/Next** button   to navigate to the previous/next log from the Logs list.

Alerts

In the latest version of Automator, you can now define an alert for Visual Processes. Three predefined alerts can be used, and any number of additional alerts can be defined using scripting.

All existing system alerts are displayed on the **Alerts** page. To view the **Alerts** page, click **Automator > Visual Processes** and select **Alerts**.

Use this page to [add](#), [edit](#), or [delete](#) alerts.

Adding an Alert

Alerts allow users to be notified based upon certain conditions. You can, for example, be notified via email if a process fails to run. These notifications are called alerts. Some alerts are pre-defined within Automator itself, such as the process failure (SystemAlertProcessFailed) and process element failure (SystemAlertProcessElementFailed) alerts. Others can be defined by users in scripts.

To add an alert


1. On the **Navigation Tree**, click **Automator > Visual Processes** and select **Alerts**. The Alerts page displays.
2. On the Alerts page, click the **Add** icon to create a new alert.
3. In the **Code** box specify the alert type.

You may type a new alert name or select one of the following predefined alert types:

- **SystemAlertProcessFailed**: Indicates that a process has failed.
- **SystemAlertNoInputToExporter**: Indicates that there was no input to the Exporter (which means, that no input file exists).
- **SystemAlertProcessElementFailed**: Indicates the failure of a project element.

If a predefined alert (for example, the SystemAlertProcessFailed) has already been selected, it will no longer be listed in the Code drop-down list, as you cannot specify two predefined alerts of the same type (except for the SystemAlertProcessElementFailed).


4. In the **Description** field enter alert description.

NOTE: If you use the SystemAlertProcessElementFailed alert, you can choose one or more element types by clicking .


5. If the alert should be immediate, check the **Rise Alert Immediate** checkbox.

NOTE: The **Rise Alert Immediate** checkbox is available only for the SystemAlertNoInputToExporter alert and the SystemAlertProcessElementFailed alert.


6. Under **Actions**, choose which action to add to the alert.
 - **Log**: Select to specify an Application Event Log notification. This can be useful if you use network management software such as BMC Patrol, IBM Tivoli, HP Openview or other software, to provide tighter integration into your systems management.
 - In the **Event level** drop-down menu, set the event as Information, Warning, or Error.
 - In the **Event ID** box, enter the event ID.
 - In the **Message** text field, type the message.

NOTE: You may use the [naming macros](#) to provide a message for the log alert. To do this, click the **Insert Macro** icon  and select the naming macros from the drop-down list.

- **Email:** Select to send an email notification. Note that if the email connection is down at the time the alert is invoked, the alert will also be written to the Windows Application Event Log.
 - Specify the recipients' email addresses in the corresponding boxes: **From**, **To**, **Cc**, and **Bcc**. To select recipients from the [contacts list](#), click the **Contacts** icon .
 - Type the message subject in the **Subject** box.

NOTE: You may use the [naming macros](#) to provide a subject line for an email alert. To do this, click the **Insert Macro** icon  and select the naming macros from the drop-down list.

- Type the message in the Message box.
- Select the **Attach files** check box to attach a file for the alert.
- Select the **Zip** check box to archive the attached files. The Zip Options drop-down arrow will appear. Under Zip Options provide the following information:
 - Specify the compression level from the following: **None**, **Medium**, **Maximum**.
 - Select the **Store directory path** check box if necessary.
 - Select the Set **Password** check box to set the password.
- Select the **One file per mail** check box to attach only one file per mail.
- Select the **Attach links** check box to attach a link to file.
- Select the email priority from the following: **Low**, **Normal**, **High**.
- **RSS:** Select this to specify an RSS notification.
 - In the **Feed** box, specify the file. You can either enter the path to a file in the box or select a folder by clicking the **Browse** button. The **Select Folder** dialog box will appear.
 - From the **Named Paths** list, select the appropriate [named path](#).
 - Select the folder from the list of displayed in the **Named Paths** box.
 - Click **Ok** to add the folder.
 - Select the **Create if not found** checkbox in order to create the file if the specified one is not found.
 - In the **Title** box, enter the item title.
 - In the **Item description** box, enter item description.

NOTE: You may use the [naming macros](#) to provide a title and description for an RSS alert. To do this, click the **Insert Macro** icon  and select the naming macros from the drop-down list.

- In the **Link** box, enter the link name.

NOTE: Displays the URL of the RSS item. This field is usually left blank so that Automator can automatically assign a URL (based on a [translate distribution](#)) from the input or export file that is being processed.

- Click the **Channel** section to specify the channel parameters:
 - **Title:** Enter channel title.
 - **Channel Description:** Provide channel description.
 - **Link:** Enter link name.

NOTE: If you leave the **Title**, **Channel Description**, and **Link** fields blank the default values will be automatically assigned.

- **Max Items:** Specify the maximum number of items.
- **Unlimited:** Select this check box if you want to set the unlimited number of items.

7. Click **OK** to save the action.


8. Click **Save** to save the alert.



Editing an Alert

Once you have configured and saved an alert, you can edit it at any time.

To edit an alert

1. On the Navigation Tree, click **Automator > Visual Processes** and select **Alerts**.
2. Click the name of the alert you want to change or click anywhere on its row, and then click .

When you open a saved alert for editing, the list of actions for the alert becomes available. You can add, edit or delete actions.

For details about how to change alert settings, please refer to [Adding an Alert](#).

Deleting an Alert

You can delete any alert on the **Alerts** page.

NOTE: When you delete an alert, all of its associated actions are also deleted.

To delete an alert

1. On the Navigation Tree, click **Automator > Visual Processes** and select **Alerts**.
2. Click at the end of the row with the alert you want to delete. A dialog box appears.
3. Click **Delete** to remove the alert from the list.

Global Environment Scripts

Global environment scripts allow you to enter functions, classes, variables, etc., that are available for, or will execute over, all Visual Processes. They also allow the setting of global assembly imports and references, which are valid over Automator process boundaries. Global environment scripts are split into two sections:

- [Global Declarations](#): Used for variables, classes, functions, subroutines, etc., that need to be available across all Visual Processes.
- [References and Imports](#): Used for importing .NET namespaces and .NET assemblies for global use.

For global environment scripting, access the Script Editor by clicking **Automator > Visual Processes** on the **Navigation Tree** and then selecting **Scripts** from the menu.

Script Editor

Automator supports the use of Visual Basic.NET script in three main areas:

- [Global Environment Scripts](#): Global scripts allow users to view functions, classes, and variables, that are available or will execute over all processes. It also allows the setting of global assembly imports and references, which are valid over Automator process boundaries.
- [Project Scripts](#): Project scripts are used for project-specific scripting.
- [Process Scripts](#): Process scripts are used for process-specific scripting, enabling you to specify pre-process and post-process operations that execute before or after any operations in the process itself.

NOTE: Automator users can only edit these scripts if they are granted editing privileges by the Admin.

Accessing Script Editor

As the Script Editor can be accessed from several places within Automator, its contents can vary:

- [PreExport tab](#): Specifies project-specific, pre-export declarations, e.g., to apply a pre-export script to the input file. **Note:** This tab is displayed only for project-specific scripting.
- [PostExport tab](#): Specifies project-specific, post-export declarations, e.g., to add steps to further process the export file(s). **Note:** This tab is displayed only for project-specific scripting.
- [PreProcess tab](#): Specifies process-specific, pre-process declarations. **Note:** This tab is displayed only for process-specific scripting.
- [PostProcess tab](#): Specifies process-specific, post-process declarations. **Note:** This tab is displayed only for process-specific scripting.
- [Global Declarations tab](#): Specifies Dim statements or other statements that must be global to the entire script module.
- [References and Imports tab](#): Specifies additional .NET assembly references and namespaces required by the PostExport, PreExport, and Global Declarations tabs.
- [Passwords tab](#): Specifies passwords for use in password macros.

You can open Help on user scripting by clicking on the **User Scripting Help** button. The button is available on the following tabs:

- **PreExport** tab
- **PostExport** tab
- **PreProcess** tab
- **PostProcess** tab
- **Global Declarations** tab

PreExport Script

The **PreExport** tab is part of the Script Editor. Use this tab to apply a pre-export script to the input file(s). Any script specified here will execute before any export actions take place.

The **PreExport** tab includes the following settings:

- **Script field**: Displays the current pre-export script.
- **Compile/Run**: Compiles the pre-export script and if the script is compiled without errors runs it on the specified for testing location.
- **Insert Script**: Allows you to quickly generate VB.NET script for frequently used tasks. Click to select the necessary options. For details, refer to [Inserting a Script](#) section.
- **Clear**: Removes the scripts from the script field.
- **Locations for testing**: Displays the location used for testing the script before deploying it.

PostExport Script

The **PostExport** tab is part of the Script Editor. Use this tab to add steps to further process the export file(s). Any script specified here will execute after any export actions take place and before any distributions occur.

The **PostExport** tab includes the following settings:

- **Script field:** Displays the current post-export script.
- **Compile/Run:** Compiles the script and if the script is compiled without errors runs it on the specified for testing location.
- **Insert Script:** Allows you to quickly generate VB.NET script for frequently used tasks. Click to select the necessary options. For details, refer to [Inserting a Script](#) section.
- **Clear:** Removes the scripts from the script field.
- **Locations for testing:** Displays the location used for testing the script before deploying it.

PreProcess Script

The **PreProcess** tab is part of the Script Editor. Use this tab to specify any initialization or setup operations that are required before the process' jobs run.

The **PreProcess** tab includes the following settings:

- **Script field:** Displays the existing pre-process declarations.
- **Compile/Run:** Compiles/runs the script and if the script is compiled without errors runs it on the specified for testing location.
- **Insert Script:** Allows you to quickly generate VB.NET script for frequently used tasks. Click to select the necessary options. For details, refer to [Inserting a Script](#) section.
- **Clear:** Removes the scripts from the script field.
- **Locations for testing:** Displays the location used for testing the script before deploying it.

PostProcess Script

The **PostProcess** tab is part of the Script Editor. Use this tab to specify any cleanup or shutdown operations to be performed after the last job of a process completes.

The **PostProcess** tab includes the following settings:

- **Script field:** Displays the existing post-process declarations.
- **Compile/Run:** Compiles/runs the script and if the script is compiled without errors runs it on the specified for testing location.

- **Insert Script:** Allows you to quickly generate VB.NET script for frequently used tasks. Click to select the necessary options. For details, refer to [Inserting a Script](#) section.
- **Clear:** Removes the scripts from the script field.
- **Locations for testing:** Displays the location used for testing the script before deploying it.

Global Declarations Script for Standard Processes

The **Global Declarations** tab is part of the Script Editor. Use this tab to specify Dim statements or other statements that must be global to the entire script module.

The **Global Declarations** tab in the Script Editor for Standard Processes includes the following settings:

- **Script field:** Displays the existing global declarations.
- **Compile:** Compiles the global declarations script. If the script is compiled without errors, it is run on the specified testing location.
- **Insert Script:** Allows you to quickly generate VB.NET script for frequently used tasks. Click to select the necessary options. For details, refer to [Inserting a Script](#) section.
- **Clear:** Removes the scripts from the script field.
- **User Scripting Help:** Opens the User Scripting API Help, which is a collection of script fragments that can be copied and pasted as useful starting points in the Script Editor.
- **Locations for testing:** Displays the location used for testing the script before deploying it.

Global Declarations Script for Visual Processes



The **Global Declarations** tab in the Script Editor for Visual Processes includes the following settings:

- **Script field:** Displays the existing global declarations.
- **Insert Script:** Allows you to quickly generate VB.NET script for frequently used tasks. Click to select the necessary options. For details, refer to [Inserting a Script](#) section.
- **User Scripting Help:** Opens the User Scripting API Help, which is a collection of script fragments that can be copied and pasted as useful starting points in the Script Editor.

References and Imports

The **References and Imports** tab is part of the Script Editor. Use this tab to specify additional assembly references and namespaces that are required by PostExport, PreExport, and Global Declarations sections.

The **References and Imports** tab includes the following settings:

- **Namespace:** Lists the namespaces you have specified. You can add a namespace by clicking the **Add** button.
- **Name:** Lists the names of any additional assembly references you have specified. To add a name, click the **Add** button.
- **Assembly:** Lists the paths of any assemblies you have selected. To add a namespace, click the **Add** button.
- **Add:** Use this button to add an assembly and name it.
- **Add Named:** Displays the **Add Reference** dialog, with which you can name and select an assembly.
- **Clear:** Removes the scripts from the script field.
- **Locations for testing:** Displays the location used for testing the script before deploying it.

Passwords

This tab is part of the Script Editor. Use this tab to specify passwords for use in password macros. Specified passwords can then be utilized in pre-export or post-export scripts via the macro drop-down list, which can be accessed by clicking the Macros button on the Execute an External Command Line dialog.

The **Passwords** tab includes the following options:

- **Name: Displays the names of any specified passwords.**
- **Description:** Displays descriptions of any specified passwords.
- **Add:** Adds a new password via the Script Password dialog.
- **Edit:** Edits the selected password via the **Edit Script Password** dialog.
- **Clear:** Removes the scripts from the script field.
- **Locations for testing:** Displays the location used for testing the script before deploying it.

Inserting a Script for Standard Processes

To quickly generate VB.NET script for frequently used tasks, click the **Insert Script** button on the **Script Editor** page. The following options are available:

- **Add an event to the log:** Select to add an event to the Job Log.
- Specify the text to be added to the Job Log in the **Event Text** field and click **Insert**.

Here you can view an example of generated script.

For example, you may wish to specify the exact nature of the export within the log, which cannot be inferred by the file name. Here is some sample code generated by the Insert Script feature to do this:

```
Log.AddEvent("Monthly General Ledger Export")
```

- **Raise an Alert:** Select to raise an alert for use with the alerts in the Automator. Specify the following settings:
 - a. In the **Name** field, select the desired alert from those listed or enter of a new alert name.
 Note: The available alerts are the user-defined alerts listed on the Automator [Alerts page](#).
 - b. In the **Text** field enter the text you want displayed for the alert.
 - c. Click **Insert** to add the script.
- **Execute an external command line:** Select to execute a command line application. This function allows you to specify the command line, the parameters, including Automator [macros](#), and a timeout value for the command line. Specify the following settings:
 - a. In the **Command** field, enter the command line text.
 - b. In the **Parameters** field, specify the parameters to be passed to the program or batch file (you can also use the [naming macros](#)).
 - c. Select one of the options:
 - **No time limit:** Specifies that a time limit for the command line to complete is not necessary. **Note:** If the command line does not complete, Automator will wait indefinitely until it completes or is terminated.
 - **Timeout after n second(s):** Sets the delay before Automator terminates the command line.
 - d. Click **Insert** to add the script.

Here is some sample code generated by the Insert Script.

```
If Shell("""c:\test.bat""",AppWinstyle.Hide,True,10000) <>0 Then
  'TODO: Handle command timeout here.
End If
```

NOTE: Command lines are executed by the .NET service, which for security reasons does not allow the application to show a user interface. Please ensure that any command lines or applications you run do not require a user interface and shut themselves down after completion. In addition, be sure to specify a timeout value after which Automator will kill the offending process if you do not want Automator to hold up processing altogether. If no timeout is specified, Automator will wait forever until the command line returns. If you specify a timeout that is exceeded, then you can deal with that condition in your script.

- **Iterate through a list of input or output items** (available only for project-scripting) - Select to run the script through a list of input or output items and specify whether you want to do it for data exceptions in the current project or in all projects. Specify the following settings:

- a. Type: input items (iterates through a list of input items) and output items (iterates through a list of output items).
 - b. Scope: current project (iterates through items in only the current project) and all projects (iterates through items in all projects).
 - c. Click **Insert** to add the script.
- **Iterate through the list of events:** Select to iterate the script through the list of events in the job log. Simply click **Insert** to add the script.
 - **Test for data exceptions** (available only for project-scripting): Select to specify whether you want to test for data exceptions in the current project or in all projects and click **Insert** to add the script.

Here is some sample code generated by the Insert Script.

In the following example, the feature has been combined with the raise alert feature to raise an alert called *Summary Exception* if any of the projects contained a summary exception as defined by the model's summary exception coloring rules.

First, the Test for Data Exceptions was chosen with an option of "All Projects" to give a script of :

```
If Log.HasExceptions() Then
  TODO: Perform desired operation if exceptions were found.
End If
```

Second, the whole line containing the TODO: was highlighted and the Insert Script To Raise an Alert was chosen with the Alert Name of "Summary Exception" and the Alert text of "A summary exception has occurred". This produces the final script of:

```
If Log.HasExceptions() Then
  Log.AddEvent("A summary exception has occurred", "Summary Exception")
End If
```

Now you can define the [actions for this alert](#) on the Alerts page of the Automator.

Note: You must have already defined summary exception coloring rules in your Monarch model in order for this feature to work.

- **Set the value of a runtime field:** Select to specify a value for a runtime field. Specify the following settings:
 - a. In the **Field Name** field, enter the name of the runtime field.
 - b. In the **Field Value** field, specify the desired value for the runtime field.
 - c. Select one of the following:
 - **Set this value unconditionally:** Sets the value unconditionally, resulting in a simple call to `SetRuntimeFieldValue`.
 - **Set this value only if a value for this field has not already been set:** Sets the value conditionally, resulting in a call to `SetRuntimeFieldValue` that is contingent on a return of **False** from `HasRuntimeFieldValue`.
 - d. Click **Insert** to add the script.

- **Export to MapR Hive table:** Select to export data to MapR Hive table. Specify the following settings:
 - a. Specify the target server information: **Host Name or IP Address**, **Cluster Name** and path to the **HDFS Directory** (if necessary).
 - b. Specify the export information: **Project ID** and **Export Name**.
 - c. To overwrite data in the existing table, select the **Overwrite Table** check box.
 - d. Click **Insert** to add the script.
- **Export to HD Insight Hive table:** Select to export data to HD Insight Hive table. Specify the following settings:
 - a. Specify the target server information: **Host Name or IP Address** and path to the **HDFS Directory** (if necessary).
 - b. Specify the export information: **Project ID** and **Export Name**.
 - c. To overwrite data in the existing table, select the **Overwrite Table** check box.
 - d. Click **Insert** to add the script.
- **Copy to HDFS MapR:** Select to copy data to HDFS MapR.
 - a. Specify the target server information: **Host Name or IP Address**, **Cluster Name**, **Target Directory Path** and **Target File Name**.
 - b. Specify the export information: **Project ID** and **Export Name**.
 - c. Click **Insert** to add the script.
- **Copy to HDFS HD Insight:** Select to copy data to HDFS HD Insight. Specify the following settings:
 - a. Specify the target server information: **Host Name or IP Address**, **Target Directory Path** and **Target File Name**.
 - b. Specify the export information: **Project ID** and **Export Name**.
 - c. Click **Insert** to add the script.
- **Insert:** Inserts the current pre-export script into the script field.
- **Cancel:** Cancels any changes you have made.

Inserting a Script for Visual Processes

To quickly generate VB.NET script for frequently used tasks, click the **Insert Script** button. The following options are available:

- **Add an event to the log:** Select to add an event to the log. Enter the event text in the field provided.
- **Raise an alert:** Select to prompt an alert to the process.
 - a. In the **Code** field, enter the name of the alert code.

- b. In the **Message** field, provide an alert message.
- **Execute an external command line:** Select to execute a command line application. This function allows you to specify the command line, the parameters, including Automator [macros](#), and a timeout value for the command line. Specify the following settings:
 - a. In the **Command** field, enter the command line text.
 - b. In the **Parameters** field, specify the parameters to be passed to the program or batch file (you can also use the [naming macros](#)).
 - c. Select one of the options:
 - **No time limit:** Specifies that a time limit for the command line to complete is not necessary.

Note: If the command line does not complete, Automator will wait indefinitely until it completes or is terminated.
 - **Timeout after n second(s):** Sets the delay before Automator terminates the command line.
 - d. Click **Insert** to add the script.

Here is some sample code generated by the Insert Script.

```
If Shell("""c:\test.bat""",AppWinstyle.Hide,True,10000) <>0 Then
'TODO: Handle command timeout here.
End If
```

NOTE: Command lines are executed by the .NET service, which for security reasons does not allow the application to show a user interface. Please ensure that any command lines or applications you run do not require a user interface and shut themselves down after completion. In addition, be sure to specify a timeout value after which Automator will kill the offending process if you do not want Automator to hold up processing altogether. If no timeout is specified, Automator will wait forever until the command line returns. If you specify a timeout that is exceeded, then you can deal with that condition in your script.

- **Iterate through a list of input or output items** — Select to run the script through a list of input or output items and specify whether you want to do it for data exceptions. Specify the following settings:
 - a. Iterate through input items.
 - b. Iterate through output items.
 - c. **Export Name** — type the export element name.
- **Set the value of a runtime field:** Select to specify a value for a runtime field. Specify the following settings:
 - a. In the **Field Name** field, enter the name of the runtime field.
 - b. In the **Field Value** field, specify the desired value for the runtime field.

c. Select one of the following:

- **Set this value unconditionally:** Sets the value unconditionally, resulting in a simple call to `SetRuntimeFieldValue`.
- **Set this value only if a value for this field has not already been set:** Sets the value conditionally, resulting in a call to `SetRuntimeFieldValue` that is contingent on a return of **False** from `HasRuntimeFieldValue`.

d. Click **Insert** to add the script.

- **Insert Script:** Inserts the current script into the script field.
- **Cancel:** Cancels any changes you have made.

Testing a Script

You can test your PreProcess/PostProcess or PreExport/PostExport script before deploying it. This allows you to run the script based on a Job Log file you specify.

After entering a script in the Script Editor's PreExport or PostExport tab, or the PreProcess or PostProcess tab, click the **Compile/Run** button and, if your script is compiled without any errors, click the **OK** button in the Run Script dialog box that appears.

The **Run Script** dialog box includes the following settings:

Entry Point

- **PreExport(Log as JobLog, Project ID as Integer):** Specifies that you want to run the PreExport function.
- **PreExport(Log as JobLog, Project ID as Integer):** Specifies that you want to run the PreExport function.
- **PostExport(Log as JobLog, Project ID as Integer, ExportCompleted as Boolean):** Specifies that you want to run the PostExport function.
- **PreProcess(Log as JobLog):** Specifies that you want to run the PreProcess function.
- **PostProcess(Log as JobLog):** Specifies that you want to run the PostProcess function.

Parameters

- **Job ID:** Displays the Job ID of the job log to which the script will be applied. **Note:** To select a job ID, click its name in the table or select from the **Select Job ID** drop-down list.
- **Project ID:** Specifies the Project ID to pass to the PreExport or PostExport Function. **Note:** This only needs to be changed if you are using the **Multiple Projects per Job** option in the [Process settings](#). Otherwise leave the value at 1.
- **Export Completed:** Allows you to specify that the ExportCompleted variable is forced to true, if checked, and false, if unchecked, so any code checking the contents of the variable can be fully tested, even if an export fails.


- **Run:** Runs the selected function.
- **Show Log:** Displays the contents of the selected log file. **Note:** After the function runs, you may wish to click this button to view the log file to make sure that the function modified the log file in the desired way.
- **Cancel** - Closes the dialog box and returns to the Script Editor page.

Connection Definitions

The **Connections Definitions** tab is part of the Project Editor. Use this tab to add predefined/saved connection definitions that can be reused in multiple projects.


Important: Connection definition parameters are taken from the server at a project creation time. Any changes in initial connection strings on source machines will not be tracked.

To add connection definition

1. On the **Navigation Tree**, click **Automator** and select **Connection Definitions**.
2. On the displayed page, click the **Add** icon . The **Connection Definition** page appears.
3. Enter the connection definition name in the **Name** field.
4. Enter connection definition description in the **Description** field.
5. Enter connection string in the **Connection String** field:
 - Manually and then proceed to step 6, or
 - Click the **Browse** button to open **Connection Type Wizard** window:
 - a. Select provider type from the following choices: OleDb for Native MsSql Provider, OleDb Provider or Odbc Provider
 - b. Provide parameters according to provider type chosen
 - c. Click the **Test Connection** button to test whether or not the data link was successful (i.e., to test whether you can connect to the specified OLE DB or ODBC provider). If the connection is successful, a Test Connection Succeeded message is displayed.
 - d. To use connection string, click **OK**.
6. Select **Include Password** check box if your connection requires password.
7. Enter matching passwords in the **Password** and **Confirm Password** fields.
8. Click the **Test Connection** button to make sure that your DB connection is successful.
9. To save connection definition, click **Save**.

To duplicate connection definition

1. On the **Navigation Tree**, click **Automator** and select **Connection Definitions**.

2. On the displayed page, select the name of the connection definition that you want to duplicate.
3. Click the **Duplicate** icon . The **Connection Definition** page appears.
4. Enter connection definition name in the **Name** field. The name must not coincide with the original definition name. All other settings of this definition will be duplicated.
5. To save connection definition, click **Save**.


To manage security rights for a connection definition

1. On the **Navigation Tree**, click **Automator** and select **Connection Definitions**.
2. On the displayed page, select the connection definition whose security settings you want to modify.
3. On the **Connection Definition** page, click the **Rights** tab.
4. If you want to make the connection definition available to all users, click the **Global** checkbox.

If you want to make the connection definition available to specific user groups, roles, or users, click the corresponding tabs to select the user groups, roles, and users you want to grant access to the connection definition.
5. Click **Save** to save the settings, **Clear** to reject all changes made, and **Cancel** to stop the operation and return to the **Connection Definition** page.

Using the Naming Macros

Automator offers a number of naming macros that can be used to name files and tables that are being exported, moved, copied and so on. They can also be used to add information when performing distributions or even when using scripting. The macros can be used individually or in combination with one another.

NOTE: Some of the naming macros may not be valid under certain conditions (for example, some macros are only available when using scripts), so until you are well acquainted with the product, use the **Insert Macro** icon  to ensure that you select macros that are valid for the situation.

The following naming macros are available:

Macro	Symbol	Result
Year (4 digit)	&[yyyy]	4-digit year (for example, 2007)
Year (2 digit)	&[yy]	2-digit year (for example, 07)

Month	&[mm]	Month
Day	&[dd]	Adds the day to the file name as a two digit numeral, for example, 09 for the ninth Day
Hour	&[hh]	Hour
Minute	&[mi]	Minutes
Second	&[ss]	Seconds
Quarter	&[qtr]	1-digit quarter of the calendar year: 1 for dates in January: March, 2 for dates in April: June, 3 for dates in July: September, 4 for dates in October: December.
Day of Year	&[dayofyear]	3-digit day of the year in range 001-366.
Previous Day	&[dd.-1d]	2-digit value in the range of 01-31.
Previous Month	&[mm.-1m]	2-digit value in the range of 01-12.
Previous Year	&[yyyy.-1y]	4-digit year (referring to previous year).
ISO Year	&[isoyear]	4-digit year corresponding to the ISO-8601 week in which the date falls.

The naming macros are available in the following locations:

- [Job Disposition Settings](#) : Use the naming macros here to name job logs that have been moved.
- [Copy Distribution Action](#): Use the naming macros here to name copies of files generated by a distribution.
- [Move Distribution Action](#): Use the naming macros here to name files that have been moved via a distribution.
- Email Action: Use the naming macros here to provide a subject line for an email [distribution](#) or [alert](#).
- RSS action: Use the naming macros here to provide a title and description for an RSS [distribution](#) or [alert](#).

- [Default Job Log Disposition](#): Use the naming macros here to assign new names to the job logs when moving them.

NOTE: The naming macros can also be used when scripting, for example, when using the `Item.ExpandMacros` method. See the UserScripting Help file for additional information. To use the naming macros in email body fields and NT Event Log Message fields, right-click and choose Insert.

Utilizing naming macros

1. When viewing a field for which you can select a naming macro, click the adjacent **Insert Macro** icon  to view the naming macro drop-down list.
2. Select the desired naming macro from the list.

Syntax checking of macros

In the Export Wizard and the Portable Report Settings dialog, if the file name contains a macro (or macros), Automator performs a series of tests to be sure that the macros are well-formed. For example, the following conditions are detected and reported as errors:

- Unknown macro names, for example, `&[fred]`. Such macros will not expand at runtime.
- Parameterized macros having ill-formed parameters, for example, `&[yyyy.+1q]`. Such macros will expand to empty at runtime.
- Macro names that are not appropriate in the context of the export in question. For instance, `&[filter]` makes no sense when publishing a PRF file.
- Ill-formed macros. For example, a macro prefix (`&[`) without its matching suffix (`]`), or a macro embedded within a macro for example, `&[fil&[dd]ter]`.

Offset Expressions in Macros

The date/time macros (yyyy, mm, etc.) have been extended by defining "offset expressions" that may be tacked onto the macro name to compute an offset from today's date.

NOTE: Offset expressions are available for file naming only; they are not available for distributions, etc.

The syntax is as follows:

```
&[macro{.sign{count}units}]
```

- The braces (`{ }`) enclose optional portions of the syntax.

- *macro* is a macro name (e.g., *yyyy*).
- *sign* is + (plus) to add to the current date or - (minus) to subtract from the current date.
- *count* is an optional integer count.
- *units* specifies the units to be added or subtracted: **d** for days, **m** for months or **y** for years.

NOTE: The offset expression, if present, must be separated from the macro name by a period (.).

Syntax for Offset Expressions

The following table provides examples of syntax for offset expressions:

Example	Meaning
&[dd.+1d]	The day portion of tomorrow's date.
&[dd.+d]	Synonymous with &[dd.+1d]. The count defaults to 1.
&[mm.+1d]	The month portion of tomorrow's date.
&[yyyy.+1d]	The 4-digit year portion of tomorrow's date.
&[dd.-1d]	The day portion of yesterday's date
&[mm.+7d]	The month portion of the date one week from today
&[mm.+1m]	The month portion of the date one month from today.
&[yyyy.+1y]	The year portion of the date one year from today.
&[yyyy.+2m+15d]	The year portion of the date 2 months plus 15 days from today. More than one offset expression may be concatenated as shown to affect sums of different units.

NOTE: The offset expression may be used with any of the date/time macros, including the time macros (hh, mi, and ss), although they have no effect on the latter, since **&[hh.+1d]** would give the same result as **&[hh]**. Likewise, one may make a macro like **&[mm.+4y]**, but it is equivalent to **&[mm]** because adding or subtracting an integral number of years to a date can never affect the month.

When a Job Fails to Run

A [job](#) may fail to run for a number of reasons, including the following:

- **The Automator Service is not running:** Check the Server Status page and make sure that the service is running.
- **No input files are in the input folder:** When you create a process, you specify a folder where the input file you want to use is located (or will be located). If the File Existence Criteria you specified for the project is that at least one input file must exist or that all files must exist, the job will not run until an input file of the specified type appears in the input folder.
- **Associated report file is no longer available:** If the report file associated with the job's project is no longer present, the job will be halted.
- **Project file is no longer available:** If you attempt to run a process for which the project file no longer exists or has been moved, the associated job will fail to run.
- **Process prerequisites have not been met:** If you specified a process prerequisite, the associated job will not run until that prerequisite has been met, regardless of when you scheduled the process to run.

NOTE: For each job that is spawned a log file is created. If a job fails to run, you should examine the job's log, as it should provide information as to why the job failed.

Runtime Fields

Runtime fields are a special type of calculated field whose value can be easily set at runtime, thereby providing a way to parameterize a model in some fashion. When Monarch is running in interactive mode it prompts the user via a dialog box for the values of any runtime fields at the time a model is loaded. Runtime fields may also be used with Monarch in "lights-out" mode by specifying the desired values on the command line or via an automation method.

With Automator, runtime field values may be specified via script, or a manifest file when using the Web Service or API. Regardless of the source, the runtime field values are written to a special section of the job log where they are then read at the time the project is loaded.

Specifying Runtime Values via a Manifest

To specify values for runtime fields using a manifest, construct the manifest XML as usual, but add a <runtime fields> section structured as in the following example:

The name attribute of each runtime_field tag is the field name exactly as it appears in the model, and the text is the desired value. One may specify as many runtime field values as desired. The values specified in a manifest apply across all projects/models in the specified process because Automator automatically copies these values to the job logs of any and all jobs spawned by the process instance. Once a suitable manifest has been constructed it may be passed into Automator in a call to StartProcessUsingManifest, which method already exists both in Automator's .Net API and in its Web Service.

Specifying Runtime Values via Script

One may also specify runtime values in PreExport, PreProcess, or PostExport script. In the most likely scenario, one would set the desired values in the PreExport script of the project to which they apply. However, in a multiple-project-per-job scenario it might be convenient to set the values in the PreProcess script, in which case the values would apply across all projects/models in the process. In rare cases, it may even be useful to set values in PostExport script, in which case the values would apply to any projects/models that are "downstream" of that project in the same job.

The following methods are included in the JobLog class to support getting/setting of runtime field values:

Method	Description
SetRuntimeFieldValue(string strFieldName, string strFieldValue)	Sets the value of a specified runtime field, superseding the old value, if any, which may have been set for that field.
HasRuntimeFieldValue(string strFieldName)	Returns true if a value has already been set for the specified runtime field.
GetRuntimeFieldValue(string strFieldName)	Returns the value of the specified runtime field as a string. Returns an empty string if no value has yet been set for the field.
SetRuntimeFieldValues(string[] FieldNames, string[] FieldValues)	Sets the values for a whole set of runtime fields in one call. This is used internally by Automator but might also be useful to a sophisticated script programmer.
GetRuntimeFieldValues(out string[] FieldNames, out string[] FieldValues)	Gets the runtime field names and their corresponding values for all fields whose values have already been set.

To make the setting of runtime field values easily accessible, Automator includes a **Set the value of a runtime field...** option in the Script Editor's **Insert script to...** menu. If you select this option, the **Set the Value of a Runtime Field** dialog appears, in which you may enter the name of the field and its desired value. In addition, you may choose whether the value is set unconditionally (resulting in a simple call to `SetRuntimeFieldValue`) or conditionally (resulting in a call to `SetRuntimeFieldValue` which is contingent on a return of false from `HasRuntimeFieldValue`).

NOTE: The **Set the Value of a Runtime Field** dialog makes no attempt to enumerate the possible runtime fields, nor does it check that the given field name actually corresponds to a runtime field in the model(s) in question.

Runtime Fields in the Job Log

Whenever runtime field values are used in Automator, they are recorded in the job log. This serves two purposes:

- It is the mechanism by which the values are communicated to Exporter
- It provides documentation for what values were actually in effect during the export(s)

The runtime field values appear in the job log in a `<runtime fields>` section structured exactly the same as the corresponding section of a manifest (see earlier in this section). The job log's `<runtime_fields>` section records the last value set for each runtime field. In addition, whenever a runtime field value is set, either indirectly via a manifest or directly in script, an event is automatically added to the `<events>` section of the log. This event documents the field name and the value set for it at that point in the execution, thereby making it possible to accurately determine at a later time what value a particular runtime field had at the time of a particular export.

Project Inputs via Manifest

To specify values for Text Inputs using a manifest, construct the manifest XML as in the following example:

Content Recognition Rules

Content recognition rules allow to automatically load models based on the content of the reports uploaded by the user. This relieves the user of some routine operations.

When a report is uploaded, it is searched for key words, and, in case of a match, a corresponding model is loaded.

Creating or Editing Content Recognition Rules


The **Content Recognition Rule** dialog provides a convenient and easy way of creating a new or editing an existing **Content Recognition Rule**.

All the Content Recognition Rules are listed on the [Content Recognition Rules](#) page.

To display it, click **RMS** on the Navigation Tree, then click **Content Recognition Rules**.

To add a new content recognition rule, click **Add New Content Recognition Rule** icon  above or below the list of content recognition rules.

To delete a content recognition rule, select it, and click the **Delete** icon . You can also click the  icon next to a rule to delete it.

To edit a content recognition rule, select it, and click the Edit icon .

The following fields should be filled to create a **Content Recognition Rule**:

- **Name:** The name of your rule.
- **Description:** The description of your rule, this field is hidden, to show it click **Show advanced options**. This field is not mandatory.
- **Max Pages to Scan:** The maximum number of page that will be searched for a pattern specified in the **Criteria** field.
- **Criteria:** Enter the word or phrase that you want the program to recognize. You can use wildcard characters * (to substitute for any zero or more characters) and ? (to substitute for a single character), in case you do, activate the **Use wildcard** check box under the **Criteria** field. To make the search case sensitive, activate the **Case sensitive** check box.
- **Models:** Lists the models that will be loaded in case of **Criteria** match. Clicking **Add Model** opens a model selection dialog.

Clicking **Save** closes the dialog and creates the rule. Clicking **Clear** clears the fields. **Cancel** closes the dialog without saving the changes.

Portlets

A portlet contains one or more visual elements used for presentation of data. The Portlets module allows the integration of portlets — Panopticon Workbooks — with Monarch Server. Users of MSCClient and RMSClient can view Panopticon Workbooks in the application according to their access rights and privileges.

Portlets are created and managed in MSAdmin. For more information, see [Portlets](#).

For convenience, portlets are organized into [portlet groups](#).


Portlets

You can [add](#), [edit](#), and [delete](#) portlets. To make portlets available to users, you assign the appropriate portlet access rights to users, user groups, or roles.

All available portlets are listed on the Portlets page. To display it, on the Navigation Tree, click **Portlets**, and then select **Portlets**.

Adding a Portlet

To add a portlet

1. On the Navigation Tree, click **Portlets**, and then select **Portlets**.
2. Click  on the Portlets page. The **Portlet** page appears.
3. Enter a unique name of the new portlet in the **Name** field.
4. Enter any text defining the portlet in the **Description** field. This step is optional.
5. Enter the full URL to the portlet item on the Panopticon Workbooks in the **Url** field.

Note: This URL is made by combining the base URL of the portlet group to which the portlet is added and the URL of the portlet itself (i.e. the name of the workbook). Therefore, you can also specify only a unique name that identifies the workbook.


6. To save the new portlet and close the page, click **Save**.

7. The system saves the new portlet to the database and displays the updated **Portlets** page.
8. To save the new portlet and open it immediately in the editing mode for assigning portlet access rights, click the **Save/Edit** button. For more information on how to assign portlet access rights, see Steps 4-8 in "[Editing a Portlet](#)".
9. To clear all the fields, click **Clear**.
10. To close the **Portlet** page without saving, click **Cancel**. Keep in mind that no changes will be saved



NOTE: After you have added the portlet, you have to assign access rights for it (see [Editing a Portlet](#), steps 4-8), as well as [assign it to a portlet group](#).

Editing a Portlet



To edit a portlet

1. On the Navigation Tree, click **Portlets**, and select **Portlets**.
2. Click the name of the portlet you want to edit or click anywhere on the row, and then click .
3. Make the necessary changes on the **Portlet** tab if required. For details about how to change portlet properties, refer to [Adding a Portlet](#).
4. Click the **Rights** tab to assign portlet access rights to users, user groups, or roles.

NOTE: When **Global** check box is selected the portlet is available to all users. The access rights to specific portlet can also be granted on the corresponding **User**, **User Group**, or **Role** page. For more information, see [Assigning Access Rights](#).



5. Click **User Groups** to expand a hidden section. Select user groups that you want to view the portlet.
 - a. To add a user group drag it from the left pane to the right pane or click  icon next to its name
 - b. To remove a user group drag it from the right pane to the left pane or click  icon next to its name.

NOTE: You may also use **Add All** and **Remove All** controls.

6. Click **Roles** to expand a hidden section. Select roles that you want to view the portlet.
 - a. To add a role drag it from the left pane to the right pane or click  icon next to its name
 - b. To remove a role drag it from the right pane to the left pane or click  icon next to its name.

NOTE: You may also use **Add All** and **Remove All** controls.

7. In the **Users** section, select users that you want to view the dashboard.

- a. To add a user drag it from the left pane to the right pane or click  icon next to its name
- b. To remove a user drag it from the right pane to the left pane or click  icon next to its name.


NOTE: You may also use **Add All** and **Remove All** controls.

8. To save the changes, click **Save**.

NOTE: For the portlet to be visible in MSCClient/RMSClient to a user with the portlet access rights, the user must also have the Portlets [privilege](#) enabled at the user, user group, or role level.

Deleting a Portlet

To delete a portlet

1. On the Navigation Tree, click **Portlets**, and then select **Portlets**.
2. Click  at the end of the row with the portlet you want to delete. A dialog box appears.
3. Click **Delete** to delete the portlet from the list.

Portlet Groups


Users of MSCClient and RMSClient see portlets organized into logical groupings — portlet groups — and arranged according to a particular layout.

Portlet groups are managed in MSAdmin. All available portlet groups are listed on the Portlet Groups page. To display it, on the Navigation Tree, click **Portlets**, and then select **Portlet Groups**.

Use this page to [add](#) portlet groups, assign portlets to them, and set their layouts. You can also [edit](#) and [delete](#) existing portlet groups.

Adding a Portlet Group

To add a portlet group

1. On the Navigation Tree, click **Portlets**, and then select **Portlet Groups**.
2. Click  on the **Portlet Groups** page. The **Portlet Group** page appears.
3. **Name:** Enter a unique name of the new portlet.

4. **Description:** Optionally, enter any text defining the portlet.
5. **Base Url:** Provide the base URL of the portlets belonging to the current group.

NOTE: If you have already provided the full URLs for the portlets of the group, you can leave the **Base Url** field empty.


6. **Layout size:** Select a layout in which the portlets will be displayed for the user in the Server client application. Possible layouts range from 1x1 (1 item arranged horizontally x 1 item vertically) to 4x4 (4 items arranged horizontally x 4 items vertically).
7. **Available Portlets:** Contains the list of portlets from which you select those to be assigned to the current portlet group. To assign a portlet to the group, drag it from the left pane to the right pane or click the plus sign next to the portlet name.
8. **Assigned Portlets:** Contains the portlets that you assign to the current group. To remove a portlet from the group, drag it from the right pane to the left pane or click the minus sign next to the portlet name.

NOTE: The maximum number of portlets that can be assigned to a group is 16, which is limited by the maximum layout size 4x4.

9. **Add All:** Click to assign all available portlets to the current group.



Projects

Projects utilize text or database input, extract data from the input via Monarch model files, and export the extracted data to various file types (for e, XLS, PDF, MDB, TXT, HTML, XML, etc.).

Projects are a key component of processes as when you [create a process in Automator](#), one of the key steps you perform is to assign a project (or projects) to it.

With Automator you can use an existing project file created with Monarch or you can [create a new project file](#) via the Project Editor.

All project files used in the system are displayed on the **Projects** page. To view this page, on the Navigation Tree, click **Server Library** and select **Projects**.



Models

A model file, created within Monarch, is a file with a .dmod or .xmod extension that may contain field, filter, summary and chart definitions as well as other settings. Typically, all Monarch models are created by a system administrator.

Creating a model file is one of the first steps you need to perform, as you cannot define a document type or archive documents into the system without specifying a model file. (Refer to the Altair documentation for detailed information on the model creation process.)

All models used in the Monarch Server system are listed on the Models page. Each model is defined by a Monarch model file.

1. On the Navigation Tree, click **Server Library** and select **Templates**.

Changing Template State

Workspaces

Workspace is the collective term for the objects and actions that are involved in a data preparation operation. Your workspace includes:

- the prep data operations you have carried out.


To display the **Workspaces** page, on the Navigation Tree, click **Server Library** and select **Workspaces**.

Adding a Workspace

7. Assign the workspace to a new or existing folder in the **Assign to Folders** field. To add the workspace to a new folder, click **Create New Folder**.
8. To save a workspace, click **Save**.
The system saves the new workspace to the database and displays the updated **Workspaces** page, if the operation is completed successfully.
9. To reset the recent changes, click the **Clear** button.
10. To cancel the operation and return to the **Workspaces** page, click the **Cancel** button.

To upload a workspace

1. On the Navigation Tree, click **Server Library** and select **Workspaces**.
2. Click **Upload Workspaces** on the **Workspaces** page.
3. Click **Add Files** to browse to a workspace file or drag and drop workspace file in the **Drop files here** area.
4. To save a workspace, click **Save**.
The system saves the new workspace to the database and displays the updated **Workspaces** page, if the operation is completed successfully.
5. To reset the recent changes, click the **Clear** button.
6. To cancel the operation and return to the **Workspaces** page, click the **Cancel** button.

To replace workspace file paths

1. Expand the **Replace Paths** section. You will see a list of workspace input files, along with the names of the load plans. Those files that could not be found are marked with a warning sign.
2. Click the **Browse Server** button for the file, select the file path, then click **OK**. The file can also be dragged and dropped into the rectangular area to overwrite the input file.

When the workspace being added is based on a database (e.g., SQL Server, OLEDB, ODBC, Google Analytics, or Oracle), the connector settings for the workspace can be modified as follows:

- a. In the expanded **Replace Paths** section, click **Edit Table Info**.
- b. An interface appears. Edit the necessary parameters.
 - For workspaces based on SQL server, e.g., Host Name, Port, Authentication, User ID, Password.
(NOTE: Click **Validate** to test the connection based on the SQL plugin settings provided.)
 - For workspaces based on OLEDB, e.g., Connection Name, SQL Dialect, Timeout.

- For workspaces based on ODBC, e.g., ODBC DSN, User ID, and Password.
- For workspaces based on Google Analytics, e.g., Service Account Email, Profile ID, Start Date, End Date.
- For workspaces based on Oracle, e.g., Connection Type, Host Name, Port, Service Name, User ID, Password, Other Connection Options, Edition Name, Tables and Views, Query, etc.

c. Click **Ok**.

NOTE: When the workspace being added contains Excel load plans (but not Excel Trapping load plans), the Excel Engine (i.e., Legacy or Modern) to use can be selected from the drop-down menu in the **Additional Settings** column.

NOTE: The **Replace** checkbox corresponding to the file whose path was updated is automatically selected.

3. Click the **Save** button.


NOTE: After you upload new file for input, that is linked with the current workspace, it is marked as pinned. Pinned files are displayed for each workspace. If several load plans within a workspace contain an unpinned file, it will appear in the list only once. All pinned files are displayed separately.





- undo changes;
- apply changes to other columns in other tables within the Prep Data Window. You can even export the Change History and apply to other tables in a different workspace.
- create a library of changes that you can import and reuse.





Bulk Edits

The **Bulk Edits** feature of the Monarch Server administrator allows you to apply text content bulk editing to models, alerts, distributions, and project objects. Input and manifest files within monitored Standard and Visual Processes can also be bulk edited.

To use bulk editing

1. On the **Navigation Tree**, click **Server Library**, and select **Bulk Edits**.
2. On the displayed page, enter the text fragment you want to edit in the **Find** text box. You can combine your text fragments with "*" and "?" wildcards in the **Find** text box to leverage your search query. If you select the **Ignore Wildcards** check box, the wildcards will not be applied during the search.
3. Enter the text fragment with which you want to replace the original fragment in the **Replace** text box.
4. Define the appropriate Server Library (**Alerts [global alerts for standard processes]**, **Distributions [global distributions for standard processes]**, **Models**, **Projects**, **Templates**, **Workspaces**, **Change lists**, **Visual Processes**, and **Standard Processes**) where you want to perform bulk editing by selecting the corresponding check boxes in the **Find in** line. You can assign bulk editing to the whole definition object or to its particular settings, for example, to channel links and titles of the alerts log only. Consider the following options:
 - In the **Find in** line, select the check boxes corresponding to the objects to which bulk editing will be applied.
 - If you want to apply bulk editing to all models, for example, select the **Models** checkbox.
 - If you want to apply bulk editing to the **descriptions** of models only, click **Models** to display the context menu. From the menu that displays, select the **Description** check box.

NOTE: Some of the options available for bulk editing are as follows:

- You can apply bulk editing to the entire Server Library by selecting all check boxes.
- To replace ACE DAO/ACE OleDb/Default values for Visual Processes, bulk editing can be applied to **Export behavior for accdb/dbf/mdb**. Under Visual Processes, select Table or Summary Export, and then choose **Export Behavior for accdb/dbf/mdb**.
- The following properties of distribution items in Visual Processes can also be modified via Bulk Edits: Copy, Move, Rss, Email, Email by key, Log, and Export to Amazon S3.
- Scripts for Standard and Visual Processes can be edited via Bulk Edits. The following options are available:

For Standard Processes

- Script namespaces
- Script references
- Script global declaration
- Script pre export
- Script post export

For Visual Processes

- Script namespaces
- Script references
- Script global declaration

5. Click **Find** if you want just view the results of your search query. The results are displayed in the **Search Results** table that contains the detailed definition object information, namely, the object name, its settings and values. In the table, you can mark out all or some required object items for further replacement.
6. Click **Replace** if you want to apply the assigned bulk editing for the specified Server Library. Executed changes are irreversible.

NOTE: When searching values using a wildcard (*) and then proceeding with the replace operation without specifying a new search criterion, the following alert displays:

"Warning: You are about to use the "Replace" option using a "wildcard" search pattern. Doing so will replace different types with the replace value specified. Do you want to continue?" Click **OK** to proceed with the replace operation; alternatively, click **Cancel**.

Rights and Privileges

Monarch Server users should be given privileges to carry out such tasks as defining searches, creating notifications, etc.

The Monarch Server administrator should also provide users with the rights to access objects.

Assigning Privileges


When you grant privileges to [roles](#), [user groups](#) or [users](#), you specify which actions the role members, group members or users can perform within Monarch Server.

The following privileges can be granted:

- **Common Privileges**
 - **Administrator:** Allows users to log on to MSAdmin.
 - **SubAdmin:** Allows users [limited administration](#).
 - **Portlets:** Allows users to view portlets — Panopticon Workbooks — in Client.
 - **SaaS Administrator:** Allows users [limited administration](#).
- **Report Warehouse Privileges**

- **Document search:** Allows users to configure searches.
 - **Save search:** Allows users to save [searches](#) that they created.
 - **Report search:** Allows users to search and view original reports.
 - **Delete document:** Allows users to delete documents from the report warehouse.
 - **Download Original Report:** Allows users to download the archive copy of reports.
 - **Concatenate Original Reports:** Allows users to download a number of original PDF reports as a single file.
 - **Create annotation:** Allows users to create [annotations](#).
 - **Create notification:** Allows users to create [search notifications](#) and [filing notifications](#).
 - **See trustee list on save Annotation:** Allows the user to view the list of trustees in the saved annotation report.
 - **See trustee list on save Search:** Allows the user to view the list of trustees in the saved search.
 - **Add attachments on Annotations:** Allows the user to add attachments to the annotation report.
 - **Create Annotations for all users:** Allows the user to create an annotation report accessible to all users.
 - **Edit and delete Annotations:** Allows the user to modify and remove annotations.
 - **See Annotations:** Allows the user to view the existing annotations.
- **Automator Privileges**
 - **Automator Administrator:** Allows the user full administration.
 - **Automator User:** Allows the user to manage processes and jobs.
 - **Can Edit Scripts:** Allows the user to edit process scripts and script items for Visual Processes and Standard Processes, as well as project scripts (i.e., PreProcess, PostProcess, and Global). If unselected, the user cannot edit the properties of script items for existing processes; the user can only run the script and check the results.
 - **Automator Light User:** Allows the user to partially manage processes and jobs.
 - **Can Edit Schedules:** Allows the user to add, edit, and delete schedules for Visual Processes and Standard Processes. Note that only the schedules whose processes are assigned to the user can be modified.
- **RMS Privileges**
 - **RMS User:** Allows the user to connect to RMS Client.
 - **RMS Administrator:** Provides the user with full administration rights to Monarch Server Report Mining Edition.

To grant privileges

1. On the Navigation Tree, click **Rights and Privileges**, and select **Roles**, **User Groups** or **Users** (depending on who you want to assign privileges to).
2. Click the name of a role, user group or user by clicking anywhere on the row, and then click .
3. In the **Privileges** section, select the necessary check boxes to specify the privileges for the role, user group, or user.
4. Click **Save** to save the current settings.

Sub Administrator

Only the following components are available to the **SubAdmin** user:

- Home
- Maintenance Tasks: Delete, Purge, Re-Index, Pre-Mined Data, Block
- Maintenance Processes
- Index Fields
- Document Groups
- Document Types (only rights and edit actions are available, and Copy Profile)
- All Document Retrieval options are available except Offline Processes.
- Portlets
- Server Library
- All System Reports except Removed Reports are available.
- All News are available except Global News
- Help

SaaS Administrator

SaaS admin: administrator at the remote customer site without knowledge of paths and physical system structure.

The **SaaSAdmin** user cannot:

- Change configured physical attributes in MES.
- Create or manage **Storage Volumes** or **Storage Groups**.
- Define or view post-processing delete/moves/errors.
- Establish Physical and Location resources in **System Preferences/System Defaults**.
- Create admins, sub admins, or group admins.

- Have visibility to Trustees of type (Full) Admin.
- Use the full **SQL Syntax** (only SELECTs are available.)

Automator Administrator

The Automator Administrator user has the right for full administration of all the Automator components.

Automator User

The Automator User has the right to manage the following components.

- **Automator**
 - **Standard Processes**
 - **Processes:** The user can add a new Standard Process and edit, delete, and run Standard Processes that are assigned to him.
 - **Schedules:** The user can edit, delete, and run schedules whose Standard Processes are assigned to him.
 - **Jobs:** The user can edit, delete, and run the jobs whose Standard Processes are assigned to him.
 - **Project Editor:** The user can create project files and edit, lock, or delete the project files assigned to him.
 - **Visual Processes**
 - **Processes:** The user can add a new Visual Process and edit, delete, and run Visual Processes that are assigned to him.
 - **Schedules:** The user can edit, delete, and run schedules whose Visual Processes are assigned to him.
 - **Templates:** The user can add, edit, and delete templates assigned to him.
 - **Logs:** The user can edit, delete, and run the logs whose Visual Processes are assigned to him.
 - **Connection Definition:** The user can add, edit and delete connection definitions.
- **Server Library:** The user can add folders, projects, models, workspaces, and change lists to the system and edit, lock, or delete those that are assigned to him. The user can also perform bulk edits on the text content of models, projects, workspaces, change lists, Visual Processes, and Standard Processes that are available to him.

Automator Light User

The Automator Light User has the right to manage the following components:

- **Standard Processes**

- **Processes:** The user can view and run the Standard Processes that are assigned to him.
- **Schedules:** The user can add, edit, and delete schedules whose Standard Processes are assigned to him.
- **Jobs:** The user can view, run, delete, and cancel the jobs whose Standard Processes are assigned to him.

- **Visual Processes**

- **Processes:** The user can view and run the Visual Processes that are assigned to him.
- **Schedules:** The user can add, edit, and delete schedules whose Visual Processes are assigned to him.
- **Logs:** The user can view, run, delete, and cancel the logs whose Visual Processes are assigned to him.


NOTE: Schedules are only available when the Automator Light User is granted the “Can Edit Schedules” privilege.

Assigning Access Rights

When you assign access rights to a [role](#), [user group](#) or [user](#), you grant them access to a particular part of the MS system. For example, if you assign document type rights to a user group, all members of that user group will be able to retrieve documents of the specified document type.

NOTE: Keep in mind that access rights in MS are cumulative (for example, access rights of a role are added to those of any user or user group assigned to it).

To assign access rights

1. On the Navigation Tree, click **Rights and Privileges**, and select **Roles**, **User Groups** or **Users**, depending on who you want to assign rights to.
2. Select a role, user group, or a user. Click its name or click anywhere on the row, and then click .
3. Select a tab at the top of the page to specify appropriate rights. The following tabs are available:
 - **Group Administrator:** Assign limited administration rights to [group administrators](#).
 - **Views:** Grant access to [views](#) for the role, user group, or user in the document search results page or RMS view.
 - **Security Keywords:** Specify which [security keywords](#) apply to the role, user group, or user.
 - **Global Security Keywords:** Specify which [global security keywords](#) apply to the role, user group, or user.

- **Report Security:** Grant access to [report security rules](#) for the role, user group, or user.
- **Document Types:** Grant access to [document types](#) for the role, user group, or user.
- **Unredacted Document Types:** Select a document group and assign its document types for the role, user group, or user.

NOTE: The **Unredacted Document Types** tab becomes available only if a redaction license is enabled in MS.

- **Portlets:** Grant access to specific portlets for the role, user group, or user.
- **Searches:** Grant access to [searches](#) for the role, user group, or user.
- **Templates:** Grant access to [templates](#) templates for the role, user group, or user.
- **Models:** Assign [models](#) to the current user.
- **Search Notifications:** Grant access to [search notifications](#) for the role, user group, or user.
- **System Notifications:** Grant access to [system notifications](#) for the role, user group, or user.
- **Filing Notifications:** Grant access to [filing notifications](#) for the role, user group, or user.
- **Document States Security:** Assign rights for [managing document states](#) to the role, user group, or user.
- **Automator Processes:** Grant access to [Automator processes](#) for the role, user group, or user.
- **Visual Processes:** Grant access to [Visual Processes](#) for the role, user group, or user.
- **Automator Projects:** Grant access to [Projects](#) for the role, user group, or user.
- **Workspaces:** Grant access to [Workspaces](#) for the role, user group, or user.
- **Change Lists:** Grant access to [Change Lists](#) for the role, user group, or user.
- **Named Paths:** Assign [named paths](#) to the current role, user group, or user.
- **Folders:** Assign [folders](#) to the current role, user group, or user.
- **Connection Definition:** Assign available [connection definitions](#) to the current role, user group, or user.

4. Assign the appropriate rights.

5. To save changes, click **Save**.

6. Repeat steps 3-5 until you have assigned all desired rights to a role, user group or user.

Group Administrator

An administrator can assign limited administration rights to group administrators (users who can perform a limited set of operations in Web Admin). Limited administration rights can be assigned to a user, group, or role. In case of a group or role, all explicit and implicit members of that group or role will have the specified limited rights.

Group administrators can view only those objects, to which they have corresponding rights. For example, when defining a new filing task, they can work only with document types assigned to them.

To display the **Group Administrator** page, when [assigning access rights](#), click the **Group Administrator** tab at the top of the page.

The **Group Administrator** page contains the following items:

- **Privileges:** Select check boxes to assign the following privileges to a group administrator:
 - **Manage Filing Task:** This privilege enables a group administrator to:
 - Create a new filing task. When creating a filing task, group administrators can view only those document types, for which they have rights.
 - Edit existing filing tasks for document types, for which a group administrator has rights.
 - Delete existing filing tasks for document types, for which a group administrator has rights.

Note: The group administrator can not add a new location.
 - **Manage Searches:** This privilege enables a group administrator to:
 - Create a new search using document types, for which a group administrator has rights.
 - Edit existing searches, for which a group administrator has rights. The Search Definition page shall contain only document types, for which a group administrator has rights.
 - Delete existing searches, for which a group administrator has rights.
 - Assign rights to any user, group, or role for existing searches, for which a group administrator has rights.
 - **Manage Maintenance Process:** This privilege enables a group administrator to:
 - Create a new maintenance process.
 - Edit any existing maintenance processes (including schedule type, periodicity, and suspension flag).
 - Delete any existing maintenance processes.
 - Include to or remove from a maintenance process any maintenance tasks.
 - **Manage News:** This privilege enables a group administrator to:
 - Create global and group specific news.
 - Edit global and group specific news.
 - Delete global and group specific news.

- Delete expired news.
- Assign rights to any user, group, or role for existing group specific news.
- **Manage Maintenance Task:** This privilege enables a group administrator to:
 - Create a new maintenance task. When creating a maintenance task, group administrators can view only those document types, for which they have rights.
 - Edit existing maintenance tasks for document types, for which a group administrator has rights.
 - Delete existing filing tasks for document types, for which a group administrator has rights.
- **Manage Notifications:** This privilege enables a group administrator to:
 - Create a new notification using searches, for which a group administrator has rights.
 - Edit existing notifications, for which a group administrator has rights. The Notification Definition page shall contain only searches, for which a group administrator has rights.
 - Delete existing notifications, for which a group administrator has rights.
 - Assign rights to any user, group, or role for existing notifications, for which a group administrator has rights.
- **Manage Document Groups:** This privilege enables a group administrator to:
 - Create a new document group.
 - Edit existing document groups.
 - Delete existing document groups.
 - Include or remove from existing document groups any document types, for which a group administrator has rights.
- **Manage Document Types:** This privilege enables a group administrator to:
 - Create a new index field.
 - Edit existing index fields.
 - Delete existing index fields.
 - Upload a new model.
 - Edit existing models.
 - Delete existing models.
 - Create a new document type.
 - Edit existing document types the group administrator has rights for.
 - Delete existing document types the group administrator has rights for.
 - Assign rights to any user, group, or role for existing document types the group administrator has rights for.

- Manage templates of existing document types the group administrator has rights for:
 - Upload a new template.
 - Edit existing templates the group administrator has rights for.
 - Delete existing templates the group administrator has rights for.
 - Assign rights to any user, group, or role for existing templates the group administrator has rights for.
- **Manage Filing Process:** This privilege enables a group administrator to:
 - Create a new filing process.
 - Edit any existing filing processes (including schedule type, periodicity, and suspension flag).
 - Delete any existing filing processes.
 - Include or remove from a filing process any filing tasks.
- **Manage Search Groups:** This privilege enables a group administrator to:
 - Create a new search group.
 - Edit existing search groups.
 - Delete existing search groups.
 - Include or remove from existing search groups any searches, for which the group administrator has rights.
- **Manage Filters:** After you select this check box, the **Manage Filters** button becomes visible. Click it to expand a hidden section, allowing you to assign roles and groups, which a group administrator can manage. To assign a role or group, drag it from the left pane to the right pane. This privilege enables a group administrator to:
 - Manage filters of the following trustees:
 - Assigned roles and groups.
 - Any implicit or explicit members of assigned roles and groups.
 - Assign any filters based on their filters. If they are restricted from seeing a particular keyword, then any filters in the set shall also include that restriction.
- **Manage Users:** After you select this check box, the **Manage Users** button becomes visible. Click it to expand a hidden section, allowing you to assign roles and groups, which a group administrator can manage. To assign a role or group, drag it from the left pane to the right pane. This privilege enables a group administrator to manage the assigned roles and groups.
- **Save:** Saves the settings.
- **Clear:** Clears all the boxes.
- **Cancel:** Cancels the operation.

- **Copy Profile:** Opens a dialog box, where you can select a role, user or group. All its settings will be copied. You can make the necessary changes.

Setting Security Provider

A security provider provides the system with security information about user groups and users, as well as checks user passwords for validity.

To select the security provider of the system, on the Navigation Tree, click **Rights and Privileges**, and select **Security Provider**.

You can select one of the following options:

- **Active Directory.** The system is supported by Active Directory Authentication, which is based on (and integrated with) the security system of Windows NT.
- **Default.** The default provider presents an ordinary security model dealing with roles, groups and users, which are kept in the MS database. The default provider does not interact with security systems.
- **Strong password provider.** The Strong Password Provider supports the same security model as the default provider, but applies stricter rules to passwords. In particular it supports password history, length limitation and expiration period. If you select this option, you can specify the following settings:
 - **Number of passwords stored in the history:** The valid values are integers in the range 0 - 100. This value specifies the number of last used passwords that the system remembers for each user. The system does not allow assigning a new password, if it is in the password history. Zero value disables this functionality. The default value is 15.
 - **Minimum password length:** The valid values are integers in the range 0 - 128. The value specifies the minimum password length. Zero value disables this functionality. The default value is equal to 7.
 - **Password age in days:** The valid values are integers in the range 0 - 365. The value specifies the number of days after which the password will expire. Zero value disables this functionality. The default value is 30 days.
 - **Password must meet complexity requirements:** This check box enables validation of complexity requirements for the password. These requirements include the following rules: within the password string user must use at least three characters out of the four types of characters: digits (0-9), upper case alpha characters (A-Z), lower case alpha characters (a-z), and special characters which are pretty much the rest of the keyboard.
 - **Force a new user to change the password at first logon:** If you select this check box, a user must change the password at the first logon, in case an administrator does not set a password for the user.

NOTE: All the settings of the Strong Password Provider are global and have effect for all users.

- **Show SSO:** Select this check box and the **Active Directory** option, to enable the user to sign in to the system by clicking the **SSO** link on the Login page, without having to type the name and password each time.

- **Enable Active Directory Group Lookup:** to allow searching and importing user groups on the [Importing a User Group](#) page.

About Security Keywords

Security keywords provide a way of limiting the documents within a [document type](#) that a user can retrieve.

NOTE: If you don't want a user to retrieve any documents of a particular document type, you can [remove that document type from the user](#). Secured keywords can be [assigned to roles, user groups and users](#). When you assign a security keyword to a role, user group or user, the specified users can only retrieve documents that meet the criteria of the security keyword. No other documents of the specified document type can be retrieved by them.

For example, you have a **Homes for Sale** document type and you specify **Home Location = Lowell** as a security keyword (**Home Location** being an [index field](#), and **Lowell** being an [index value](#)) for a particular user. As a result, the user can only retrieve documents of the **Homes for Sale** document type, in which **Lowell** occurs in the **Home Location** index field. Documents with **Home Location** other than **Lowell** (for example, **Leominster** or **Fitchburg**) are not available to the user.

Global Security Keywords

Global security keywords are similar to [security keywords](#), except that global security keywords are automatically assigned to a document type if the document type uses the keyword as an index field. This capability is automatically applied to newly created document types that use the index field.

To assign a global security keyword to a role, user group or user

1. On the Navigation Tree, click **Rights and Privileges**, and select **Roles, User Groups or Users**.
2. Click the name of the role, user group or user you want to assign global security keywords to.
3. Select the **Global Security Keywords** tab at the top of the page.
4. Click the **Add condition** button. A row of fields will appear.

9. To add another condition, click the **Add condition** button and repeat steps 5-8. To remove a condition, click the **Remove** button.
10. Click **Save** to save the global security keyword configuration, then click **Save** on the Role (User Group or User) page to assign the global security keyword to the role (user group or user).

To get a list of documents that correspond to the saved global security keywords

1. Click the **Preview** button.
2. In the dialog box that appears, choose the document group and document type from the lists.

The system will display a list of documents that correspond to the defined global security keywords. The list contains the following information:

- Document name
- Document type
- Document data

Assigning Security Keywords to Roles, User Groups or Users

When you assign [security keywords](#) to a [role](#), [user group](#) or [user](#), they can retrieve only those documents that meet the criteria of the security keyword. No other documents of the specified document type can be retrieved by them.


For example, you have a **Homes for Sale** document type and you specify **Home Location = Lowell** as a security keyword (**Home Location** being an [index field](#), and **Lowell** being an [index value](#)) for a particular user. As a result, the user can only retrieve documents of the **Homes for Sale** document type, in which **Lowell** occurs in the **Home Location** index field. Documents with **Home Location** other than **Lowell** (for example, **Leominster** or **Fitchburg**) are not available to the user.

To assign a security keyword to a role, user group or user

1. On the Navigation Tree, click **Rights and Privileges**, and select **Roles, User Groups** or **Users**.
2. Click the name of the role, user group or user you want to assign security keywords to.
3. Select the **Security Keywords** tab at the top of the page.
4. From the **Document Groups** drop-down list, select the appropriate document group. The document types assigned to the selected document group will appear in the **Document Types** box.

Note: You can search for a document type by entering (part of) its name in the **Filter by** box and clicking the **Apply** button.

5. Click the **Add condition** button. A row of fields will appear.



6. Select a Boolean operator (**AND** or **OR**). While the **AND** operator can be used to link conditions for different keyword types, the **OR** operator can only be used to link conditions of the same keyword type.
7. Select a keyword type. The list contains keyword types that are used in the selected document types.
8. Select a relational operator (equal to (=), not equal to (<>), less than (<), greater than (>), less than or equal to (<=), greater than or equal to (>=).)
9. Enter a keyword value. To look up available keyword values, click the **Lookup** button.
10. To add another condition, click the **Add condition** button and repeat steps 6-9. To remove a condition, click the **Remove** button.
11. Click **Save** to save the security keyword configuration, then click **Save** on the Role Role (User Group or User) page to assign the security keyword to the role (user group or user).

To get a list of documents that correspond to the saved security keywords

1. Click the **Preview** button.
2. In the dialog box that appears, choose the document group and document type from the lists.

The system will display a list of documents that correspond to the defined security keywords. The list contains the following information:

- Document name.
- Document type.
- Document data.

Document States Security

To assign rights of managing document state

1. On the Navigation Tree, click **Rights and Privileges**, and select **Roles**, **User Groups** or **Users**.
2. Click the name of the role, user group or user you want to assign rights to change document state to.
3. Select the **Document States Security** tab at the top of the page.
4. From the **Document State Group** drop-down list, select the appropriate document state group. The list of document states assigned to the selected document state group appears.

5. Select the appropriate check boxes for each state:
 - View: allows to view the document state
 - Set to this state: allows to set to this document state
 - Edit from this state: allows to switch from this document state
6. Click **Save**.

Roles

Roles are used to set rights and privileges for users and user group. A role can include both [user groups](#) and [users](#), but cannot include other roles. A role is kept in the database and has no tie with other security systems. An administrator can define rights via roles (Role Based Security) or assign them to user groups and users individually.


All roles used in the system are listed on the Roles page. To display the Roles page, on the Navigation Tree, click **Rights and Privileges** and select **Roles**.

Use this page to set rights and privileges for roles, as well as to [add](#), [edit](#), or [remove](#) roles from the list.

Adding a Role

Roles allow you to quickly assign specific [access rights](#) and [privileges](#) to a [user](#) or [user group](#). Because access rights and privileges in Monarch Server are cumulative, when you add a user or user group to a role, the user or user group members are granted the role's access rights and privileges in addition to their own.

To add a role

1. On the Navigation Tree, click **Rights and Privileges**, and select **Roles**.
2. Click  on the **Roles** page. The **Role** page containing the following items appears:
 - **Role Name:** Enter a unique name of a new role.

- **Description:** Optionally, enter any text defining the role.
- **Privileges:** By selecting check boxes, an administrator can grant the following privileges:
 - **Administrator:** Allows the user to log on to MSAdmin.
 - **SubAdmin:** Allows the user limited administration.
 - **SaaS Administrator:** Allows the user limited administration.
 - **Portlets:** Allows the user to view Panopticon Workbooks in MSClient.
 - **Document Search:** Allows the user to configure searches.
 - **Save Search:** Allows users to save searches that they created to the database.
 - **Report search:** Allows the user to search and view original reports.
 - **Delete document:** Allows the user to delete documents from the report warehouse.
 - **Download Original Report:** Allows the user to download the archive copy of reports.
 - **Concatenate Original Reports:** Allows users to download a number of original PDF reports as a single file.
 - **Create annotation:** Allows the user to annotate documents.
 - **Create notification:** Allows the user to create notifications.
 - **See trustee list on save Annotation:** Allows the user to view the list of trustees in the saved annotation report.
 - **See trustee list on save Search:** Allows the user to view the list of trustees in the saved search.
 - **Add attachments on Annotations:** Allows the user to add attachments to the annotation report.
 - **Create Annotations for all users:** Allows the user to create an annotation report accessible to all users.
 - **Edit and delete Annotations:** Allows the user to modify and remove annotations.
 - **See Annotations:** Allows the user to view the existing annotations.
 - **Automator Administrator:** Allows the user full administration.
 - **Automator User:** Allows the user to manage processes and jobs.
 - **Can Edit Scripts:** Allows the user to edit process scripts and script items for Visual Processes and Standard Processes, as well as project scripts (i.e., PreProcess, PostProcess,


and Global). If unselected, the user cannot edit the properties of script items for existing processes; the user can only run the script and check the results.

- **Automator Light User:** Allows the user to partially manage processes and jobs.
 - **Can Edit Schedules:** Allows the user to add, edit, and delete schedules for Visual Processes and Standard Processes. Note that only the schedules whose processes are assigned to the user can be modified.
 - **RMS User:** Allows the user to connect to RMS Client.
 - **RMS Administrator:** Allows the user to log on to RMSAdmin.
 - **Members:** Click this heading to expand hidden sections.
 - **Available User Groups:** Displays all available user groups from which you can select ones to assign to the current role. To add a user group, drag it from the left pane to the right pane.
 - **Selected User Groups:** The user groups in this pane will be assigned to the current role. To remove a user group, drag it from the right pane to the left pane.
 - **Available Users:** Displays all available users from which you can select ones to assign to the current role. To add a user, drag it from the left pane to the right pane.
 - **Selected Users:** The users in this pane will be assigned to the current role. To remove a user, drag it from the right pane to the left pane.
 - **Save:** Click to save a new role and close the page.
 - **Clear:** Click to clear all the boxes.
 - **Save/Edit:** Click to save a new role and display additional tabs.
 - **Cancel:** Click to cancel the operation.
 - **Copy Profile:** Opens a dialog box, where you can select a role. All its settings will be copied. You can make the necessary changes.
3. Fill in the boxes of the page and click **Save**. The system saves the new role to the database and displays the updated Roles page, if the operation is completed successfully.

NOTE: After you have created a role, you can assign access rights to it. For details, see [Assigning Access Rights](#).

Editing a Role

To edit a role

1. On the Navigation Tree, click **Rights and Privileges**, and select **Roles**.
2. Click the name of the role you want to edit or click anywhere on the row, and then click . The **Role** page appears.

3. Make the necessary changes. For more information on how to change its items, see [Adding a Role](#).
4. To grant access rights, select an appropriate tab at the top of the page. The following tabs are available in the **Edit** mode:
 - **Role** tab allows you to modify the role name and description and grant common and specific privileges to the selected role.
 - **Group Administrator** tab allows you to grant privileges to [group administrators](#). To do this, select appropriate check boxes, and click **Save**.
 - **Views** tab allows you to specify what [views](#) of the document search results page or RMS views page will be available for the current role. To do this, select or clear appropriate check boxes, and click **Save**.
 - **Settings** tab allows you to modify the [notification settings](#), particularly the number of days when an alert about license expiration will be shown.

NOTE: The Defined check box is disabled by default. If the setting is not “Defined,” then the global setting under System Preferences applies.

- **Security Keywords** tab allows you to [assign security keywords](#) to the current role.
- **Global Security Keywords** tab allows you to [assign global security keywords](#) to the current role.
- **Report Security** tab allows you to grant access to [report security rules](#) for the current role. To do this, select a document group and a document type, then drag appropriate items from the left pane to the right pane, and click **Save**.
- **Document Types** tab allows you to grant access to [document types](#) for the current role. To do this, select a document group from the list, then drag appropriate items from the left pane to the right pane, and click **Save**.
- **Unredacted Document Types** tab allows you to select document group and assign its document types for the role. To do this, select a document group from the list, then drag appropriate items from the left pane to the right pane, and click **Save**. Document types from the **Assigned Document Types** pane will be assigned.

When assigned, on the **Report** view, **Data** view, and **Summary** view data will be displayed in the unredacted format.

For unassigned document types, data will be displayed in the redacted format.

NOTE: The **Unredacted Document Types** tab becomes available only if a redaction license is enabled in MS.

- **Portlets** tab allows you to [assign portlet access rights](#) to the current user role.
- **Searches** tab allows you to set the accessible [searches](#) for the current role. To do this, select a search group from the list, then drag appropriate items from the left pane to the right pane, and click **Save**.
- **Templates** tab allows you to assign document [templates](#) to the current role. To do this, select a document type from the list, then drag appropriate items from the left pane to the right pane, and click **Save**.

- **Models** tab allows you to assign [models](#) to the current user. To do this, drag appropriate items from the left pane to the right pane, and click **Save**.
- **Search Notifications** tab allows you to assign [search notifications](#) to the current role. To do this, select a search from the list, then drag appropriate items from the left pane to the right pane, and click **Save**.
- **System Notifications** tab allows you to assign [system notifications](#) to the current role. To do this, drag appropriate items from the left pane to the right pane, and click **Save**.
- **Filing Notifications** tab allows you to assign [filing notifications](#) to the current role. To do this, drag appropriate items from the left pane to the right pane, and click **Save**.

Note: You can copy rights of a role, by clicking the **Copy Profile** button, available on the above mentioned tabs (except **Views** and **Report Security** tabs).

- **Automator Processes** tab allows you to assign automator processes to the current role. To do this, select a search from the list, then drag appropriate items from the left pane to the right pane, and click **Save**.
- **Visual Processes** tab allows you to assign visual processes to the current role. To do this, select a search from the list, then drag appropriate items from the left pane to the right pane, and click **Save**.

NOTE: Processes created in older versions of Monarch Server (e.g., v13.2) are assigned to all users.

- **Automator Projects** tab allows you to assign projects to the current role. To do this, drag appropriate items from the left pane to the right pane, and click **Save**.
- **Workspaces** tab allows you to assign workspaces to the current role. To do this, drag appropriate items from the left pane to the right pane, and click **Save**.
- **Change Lists** tab allows you to assign change lists to the current role. To do this, drag appropriate items from the left pane to the right pane, and click **Save**.
- **Folders** tab allows you to assign folders to the current role. To do this, drag appropriate items from the left pane to the right pane, and click **Save**.
- **Named Paths** tab allows you to assign named paths to the current role. To do this, drag appropriate items from the left pane to the right pane, and click **Save**.


NOTE: You can copy rights of a role by clicking the **Copy Profile** button available on the aforementioned tabs, except the **Views** and **Report Security** tabs.

5. Make the necessary changes and click **Save**.

The system saves the modified role to the database and displays the updated **Roles** page, if the operation is completed successfully.

Deleting a Role

To delete a role

1. On the Navigation Tree, click **Rights and Privileges**, and select **Roles**.
2. Click  at the end of the row with the role you want to delete. A dialog box appears.
3. Click **Delete** to delete the role from the list.

User Groups

User groups allow you to quickly assign specific [access rights](#) and [privileges](#) to [users](#).

A user group can include both user groups and users. A user group is kept in the database and has no tie with other security systems. An administrator can define rights via user groups or assign them to users individually.


Access rights and privileges in Monarch Server are cumulative. It means that when you add a user to a user group, the user is granted the group's access rights and privileges.

All user groups used in the system are listed on the User Groups page. To display the User Groups page, on the Navigation Tree, click **Rights and Privileges** and select **User Groups**.

Use this page to [set access rights](#) and [privileges](#) for user groups, as well as to [add](#), [import](#), [edit](#), or [remove](#) user groups from the list.

Adding a User Group

To add a user group

1. On the Navigation Tree, click **Rights and Privileges**, and select **User Groups**.
2. Click  on the **User Groups** page. The **User Group** page containing the following items appears:
 - **User Group Name**: Enter a unique name of a new user group.
 - **Description**: Optionally, enter any text defining the user group.
 - **Alias**: Active Directory group name. This field is filled out automatically if you apply user group importing.

NOTE: **Alias** is only available when the **Enable Active Directory Group Lookup** checkbox in **Active Directory** is selected.

- **Privileges**: By selecting check boxes, an administrator can grant the following privileges:
 - **Administrator**: Allows the user to log on to MSAdmin.
 - **SubAdmin**: Allows the user limited administration.

- **SaaS Administrator:** Allows the user limited administration.
- **Portlets:** Allows the user to view Panopticon Workbooks in MSCClient.
- **Document Search:** Allows the user to configure searches.
- **Save Search:** Allows users to save searches that they created to the database.
- **Report search:** Allows the user to search and view original reports.
- **Delete document:** Allows the user to delete documents from the report warehouse.

If unselected, the user cannot edit the properties of script items for existing processes; the user can only run the script and check the results.
- **Automator Light User:** Allows the user to partially manage processes and jobs.
 - **Can Edit Schedules:** Allows the user to add, edit, and delete schedules for Visual Processes and Standard Processes. Note that only the schedules whose processes are assigned to the user can be modified.
- **RMS User:** Allows the user to connect to RMS Client.

- **RMS Administrator:** Allows the user to log on to RMSAdmin.
 - **Members:** Click this heading to expand hidden sections.
 - **Available User Groups:** Displays all available user groups from which you can select ones to assign to the current role. To add a user group, drag it from the left pane to the right pane.
 - **Selected User Groups:** The user groups in this pane will be assigned to the current role. To remove a user group, drag it from the right pane to the left pane.
 - **Available Users:** Displays all available users from which you can select ones to assign to the current role. To add a user, drag it from the left pane to the right pane.
 - **Selected Users:** The users in this pane will be assigned to the current role. To remove a user, drag it from the right pane to the left pane.
 - **Members of:** Click this heading to expand the hidden sections.
 - **Available User Groups:** Displays all available user groups from which you can select ones to assign the current user to. To add a user group, drag it from the left pane to the right pane.
 - **Selected User Groups:** The current user will be assigned to the user groups in this pane. To remove a user group, drag it from the right pane to the left pane.
 - **Available Roles:** Displays all available roles from which you can select ones to assign the current user to. To add a role, drag it from the left pane to the right pane.
 - **Selected Roles:** The current user will be assigned to the roles in this pane. To remove a role, drag it from the right pane to the left pane.

NOTE: The default user groups and roles available in the list of available user groups and roles for the new user are those specified in the **New User Defaults** settings in **System Preferences** under **System Settings**. See [Groups and Roles](#).
 - **Save:** Click to save a new user group and close the page.
 - **Clear:** Click to clear all the boxes.
 - **Save/Edit:** Click to save a new user group and display additional tabs.
 - **Cancel:** Click to cancel the operation.
 - **Copy Profile:** Opens a dialog box, where you can select a user group. All its settings will be copied. You can make the necessary changes.
3. Fill in the boxes of the page and click **Save**. The system saves the new user group to the database and displays the updated User Groups page, if the operation is completed successfully.

NOTE: After you have created a user group, you can assign access rights to it. For details refer to [Assigning Access Rights](#).

Importing a User Group


You can import user groups from Active Directory of the user under which Monarch Server Agent Service is running. Use the **Import Groups** button for importing user groups.

The **Import Groups** button is available if Security Provider is selected from Active Directory and the Monarch Server Agent Service runs as user in Active Directory.

When a user from Active Directory logs in Monarch Server Admin or Client, the system starts checking all groups in the Active Directory in which the given user has membership. The checking is executed by the **sAMAccountName** parameter. The system checks whether the **sAMAccountName** parameter matches the **Alias** parameter of Monarch Server groups. In case of matches, privileges of all Monarch Server groups are granted to the given user during the current session only.

Editing a User Group

- **Global Security Keywords** tab allows you to [assign global security keywords](#) to the current user group.
- **Report Security** tab allows you to grant access to [report security rules](#) for the current user group. To do this, select a document group and a document type, then drag appropriate items from the left pane to the right pane, and click **Save**.

- **Document Types** tab allows you to grant access to [document types](#) for the current user group. To do this, select a document group from the list, then drag appropriate items from the left pane to the right pane, and click **Save**.
- **Unredacted Document Types** tab allows you to select document group and assign its document types for the user group. To do this, select a document group from the list, then drag appropriate items from the left pane to the right pane, and click **Save**. When assigned, on the **Report** view, **Data** view, and **Summary** view data will be displayed in the unredacted format.

Users

All users working in the system are listed on the Users page. A user is kept in the Monarch Server database and has no tie with other security systems.

To display the Users page, on the Navigation Tree, click **Rights and Privileges**, and select **Users**.

Use this page to set rights and privileges for users, as well as to [add](#), [edit](#), or [remove](#) users from the list.

An administrator can assign rights to users individually.

Adding a User

Document States

All document states of the particular document state group are listed on the Document State Group page. To display this page, on the Navigation Tree, click **Rights and Privileges**, then click **Document State Groups** and select necessary document state group from the list.

On the **System Preferences** tab you can specify the following settings:

System Preferences

- **Maximum transaction report size**: Define the maximum number of rows to read from the MS Transaction database.
- **Allow empty date range in documents/reports search**: Select this check box to permit empty date range in documents/reports search results list.
- **Dynamic search on lists**: Select this check box to enable the auto-suggest feature in MSClient, when the user types an index value on the **Simple Search** page, or a report name on the Reports List or search criteria in all object lists in MSAdmin application.
- **Display "data" items in the Administrator navigation tree**: The check box allows an administrator to show/hide "data" items on the Navigation Tree. As the amount of data may total up to hundreds of document groups, types, index fields, filing tasks and so on, it can be useful to hide all these items for easier navigation.
- **Display "data" items in the Client navigation tree**: Select this check box, if you want individual items to be displayed on the MSClient Navigation Tree upon double-clicking. For example, if this option is selected, and you click **Saved Views**, the **Saved View** groups will appear on the Navigation Tree, allowing direct navigation to the **Saved View** group you select.
- **Expand Administrator Tree**: Select this check box, if you want the MSAdmin Navigation Tree to be expanded to second-level navigation options by default.
- **Expand Client Tree**: Select this check box, if you want the MSClient Navigation Tree to be expanded to second-level navigation options by default. This action is available to users, only if they have selected **Tree-based** navigation on the **Site Style** tab under **Preferences** in MSClient.
- **Enable text download in Report View**: Enables users to download text copies of a selected report.
- **Enable PDF download in Report View**: Enables users to download PDF copies of a selected report.
- **Wrap text in PDF Export on Dynamic View**: Select this check box, if you want the text to wrap to a new line, when the edge of a page is reached.
- **Allow using Latest Reports on search**: If you select this check box, MSAdmin and MSClient users will be able to include in their searches only those reports that were added to the system during the last filing.

- **Display dynamic users entitlement report:** Select this check box to add Dynamic User Entitlements Report to [Transaction Reports](#).
- **Allow Mail sending on Client:** Select this check box to allow using Mail sending on client app.
- **Hide advanced content:** Select this check box to hide some advanced options in the Navigation Tree and object settings.

NOTE: No matter whether the **Hide advanced content** check box is selected or deselected, you can hide non-mandatory items by clicking the **Hide advanced options** heading inside the given section. To display them, click the **Show advanced options** heading.

- **Implementation Name:** This optional name will be displayed on the Login page and on the **Welcome** line of the user interface.

PDF Security

- **Enable secure PDF output:** Select this check box to disable editing and printing of the exported PDF document by client. By default this check box is cleared.

Job log disposition settings specify what is to be done with the job log after a job is run, and under what circumstances the specified disposition will occur. Job log disposition settings can be specified on a [process basis](#) or you can specify default job log disposition settings, which will apply to all job logs.

NOTE: After you specify job log disposition settings for a process, be sure to specify a schedule for the [Custodian](#) and enable it, as the Custodian is responsible for implementing the disposition settings. If you do not specify a schedule for the Custodian, the disposition settings will not be implemented.

To specify a default job log disposition

1. On the **Navigation Tree**, click **System Settings**, and then select **System Preferences**.
2. At the top of the page under **Automator Settings**, select the **Default Job Log Disposition** tab
3. Select one of the following Job Log Disposition actions:
 - **Leave:** Leaves the job log in its current location and with its current name.
 - **Remove:** Removes the job log.
 - **Move:** Moves the job log to the location you specify.
 - You can either enter the destination folder path in the text box or select the folder by clicking the **Browse** button. The **Named Paths** dialog box will appear.
 - From the Named Paths list, select the appropriate [named path](#).
 - Select the folder from the list of displayed in the Named Path Content box.
 - Click Save to add the folder.

NOTE: You can also use a naming macro to assign a new name to the job log by selecting one from the drop-down list. To do this, click the **Insert Macro** icon  and select the desired macro.

4. Select one of the following Apply Disposition By Job Status settings:
 - **Completed:** Select this check box, if you want the specified disposition to occur when a job is successfully completed. Use the adjacent fields to specify the number of days and/or hours after the job is completed that you want the disposition to occur.
 - **Failed:** Select this check box, if you want the specified disposition to occur when a job fails to run successfully. Use the adjacent fields to specify the number of days and/or hours after the job fails that you want the disposition to occur.
 - **Cancelled:** Select this check box, if you want the specified disposition to occur when a job is cancelled. Use the adjacent fields to specify the number of days and/or hours after the job is cancelled that you want the disposition to occur.
5. Click the **Save** button to save current settings and close the dialog.

A locale is a group of settings that determine the language, time format, date format, currency symbol, and so on. The existing locales are listed on the Locale Management page.

To access the Locale Management page, click **System Settings** on the Navigation Tree, and select **Locale Management**.

Use this page to edit locales.

The Locale Management page contains the following items:

- **Locale group:** Select from the list of options.
 - Select **Admin** if you need to edit labels appearing only in MSAdmin.
 - Select **Client** if you need to edit labels appearing only in MSCClient.
 - Select **Common** if you need to edit labels appearing both in MSAdmin and MSCClient.
 - Select **Services** if you need to edit labels appearing in System Reports.
 - Select **Database** if you need to edit labels appearing in the database.
- **Locale Language:** Select a language from the list. This list includes languages that were selected during the installation.

- **Search:** You can search for a label, by typing its name in this box.
- **Constant name:** The list displays names of fields as they appear in code, to facilitate tracking their location.
- **Original name:** The list displays all labels appearing on the user interface.
- **New Name:** The list displays all labels appearing on the user interface after localization.
- **Reload icon** : Click this icon to reload the grid.
- **Edit icon** : To edit a label, click anywhere on the row and click this icon. The **Edit Record** dialog box appears. Type the new name into a box and click **Submit**.

NOTE: You can open the **Edit Record** dialog box by clicking anywhere on a row.

You can edit labels in one of the following ways:

- One by one:
 - Click the name of a label.
 - Type a new name in the **Edit Record** dialog box.
- All at once:
 - Select the **Import Resources** tab.
 - After editing, click the **Upload** button to browse for an .xml file containing the list of all localized labels. Labels from the selected file will be uploaded and displayed on the Locale Management page.

NOTE: When necessary, company logos can be changed in Locale Management. Different logos can also be added for different locations (English, Deutsch, Français).

To do so, modify the following constants under the **Common Locale Group**.

- **Theme_LoginPageLogoUri:** To change the logo in the login page
- **Theme_HeaderLogoUri:** To change the header logo
- **Theme_ShortcutIconUri:** To change the shortcut icon

To download the edited labels, click the **Export Resources** tab.

The Export Resource page contains the following items:

- **Locale Language:** Select a language from the list. This list includes languages that were selected during the installation.
- **Export Resources:** Click this button to open or download an .xml file, containing the list of all labels.


- **Export only overridden resources:** Select this check box, to export only overridden resources.

Preprocess Converters



Third party utilities are used by the system for processing files with foreign, non-standard formats.

These utilities are installed separately by the deployment team.

To add a third-party utility

1. Click **System Settings** on the Navigation Tree, and select **Preprocess Converters**.
2. Click  on the **Preprocess Converters** page.
3. Enter the converter name in the **Name** field.
4. Enter the path to the utility executable file or click the **Browse** button to locate it.
5. Enter command parameters in the **Command Parameters** field.

To delete a third-party preprocess converter

1. Select the converter you want to delete, by clicking anywhere on the row, and then click .
2. Click  button to confirm deletion.

NOTE: Utilities can be removed from the system only when they are not being used in any Filing Tasks.

Bulk Schedules Edits

The **Bulk Schedules Edits** feature allows you to apply bulk editing of schedules to Automator Standard Processes, Visual Processes, Pump Custodian Processes, Filing Processes, and Maintenance Processes, Offline Processes, Filing Notifications, and Search Notifications.

To use bulk schedule editing

1. On the **Navigation Tree**, click **System Settings**, and then select **Bulk Schedules Edits**.
2. On the displayed page, select the **Find a Schedule** tab.
3. In the **Select Process Type** field, select the process you want to edit from the drop-down list. The available options are:
 - Automator Standard Processes

- Visual Processes
 - Pump Custodian Processes
 - Filing Processes
 - Maintenance Processes
 - Offline Processes
 - Filing Notifications
 - Search Notifications
4. Select the **Include Suspended** check box, if you need the suspended schedules to be displayed.
 5. In the **Search Criteria** section, specify the time parameters of the schedule you want to change.

You can get onscreen all schedules of the selected type by clicking the **All** button. You can also get onscreen the schedules with a certain value by selecting **Schedule** or **Next Execution Time**.

NOTE: In the Search and Next Execution Time criteria, you can leave the fields empty to display all corresponding schedules.

Click **Find**.

The list of corresponding processes is displayed.

6. Select the **Replace a Schedule** tab.
7. In the **Execution Frequency** section, specify the time parameters of the schedule you want to change.
8. Specify the processes you want to re-schedule by enabling corresponding check boxes.
9. Click **Replace** to apply your changes.

If you need to suspend or resume any schedule, you can select it in the list and click the **Suspend/Resume selected Schedules** icon.

You can also create a new schedule for Automator Standard Process and Visual Process.

To create a new schedule

1. Select the **Create a Schedule** tab.
2. In the **Select Process Type** field, from the drop-down list select the process type for which you want to create a schedule.
3. Select the **Suspended** check box, if a new schedule must be suspended.
4. In the **Execution Frequency** section, specify the time parameters of the schedule you want to create.
5. Select the necessary schedules in the list, and click the **Save** button to create a new schedule.

News

MSAdmin provides the News Message feature as a way to easily share information with other Monarch Server users. You can post news messages on the [All News](#) and [Global News](#) pages. After posting a message, you specify which Monarch Server users you want the message to be visible to. The users you specify will be able to view the message on the News page within Client.

There are three types of news:

- **All News:** These are all the news used in the system. They are available to user groups or users having the appropriate rights. For more information refer to [All News](#).
- **Expired News:** These are news that have expired. For details, see [Expired News](#).
- **Global News:** Include both all news and expired news. They are available to all users. For more information refer to [Global News](#).



All News

All news messages can be viewed by Monarch Server users or user groups having the appropriate rights.








System Reports

Monarch Server Administrator provides an easy means of generating system reports. The following types of system reports can be generated:

- [Configuration reports](#) provide information about the current configuration of various parts of the Monarch Server system, such as the existing roles, users, and so on.
- [Transaction reports](#) provide information about any actions that have occurred in the system, such as security, audit, and so on.
- [Annotation reports](#) provide information about annotations to reports.
- [Removed Reports](#) provide information about reports that were removed from **Read-Only** volumes.

Configuration Reports

Configuration reports provide information about the current configuration of various parts of the Monarch Server system, such as the existing roles, users, and so on. You can generate the following types of configuration reports:

- [Product License](#): Displays the product licensee, the product expiration date (if any), etc.
- [Storage Groups](#): Lists the existing storage groups, their assigned volumes, their location, etc.
- [Document Groups](#): Lists the existing document groups, their assigned document type(s), their encoding, their index and report models, etc.
- [Index Fields](#): Lists the existing index fields, and provides their ID numbers, type and length limit.
- [Roles](#): Lists the existing roles and their assigned user groups and users.
- [User Groups](#): Lists the existing user groups, their assigned users, and their privileges.
- [Users](#): Lists the existing users, their e-mail addresses, and their locked privileges.
- [Maintenance Tasks](#): Lists the existing maintenance tasks, their last start and finish dates, etc.
- [Filing Tasks](#): Lists the existing filing tasks, their last start and finish dates, etc.
- [Security](#): Lists user's security attributes.
- [Model Indexes](#): Reports on problems where mapping of Monarch model fields does not correspond to index fields due to model changes subsequent to document type configuration.

- [Document Type Security](#): Lists all existing users, groups and roles the document type is available for.
- [Automator Process Dependencies](#): Lists which projects are used by which Standard Processes, which models are used by which projects, and which models and workspaces are used by which Visual Processes.

To generate configuration reports


1. On the Navigation Tree, click **System Reports**, and select **Configuration**. The **Configuration Reports** page appears.

Product License Report

A Product License report is one of the configuration reports provided by Monarch Server. This report includes the following licensing information:

- Name of the product
- Product vendor
- Product copyright information
- License expiration date
- Customer name
- Customer address
- Product Components (for example, Report View, Chart, and so on)
- Product options (for example, maximum allowed connections, machine names, and so on)

To view and print a Product License configuration report

1. On the Navigation Tree, click **System Reports** and select **Configuration**.
2. Click the **Product License** link. The Product License configuration report is displayed.
3. To print the report, click the  icon at the top of the page, then click **OK** in the **Print** dialog box.

NOTE: If you do not provide a date or time period, all document actions for the specified user(s) will be displayed.

4. From the **User** list, select a user, whose actions you want to include in the report. (To view document actions for all users, select **All Users**.)



Annotations

An annotation is a portion of a document to which a text message has been attached. When a document that contains an annotation is viewed on the Report View page within MSCClient, the annotated portion of the document is highlighted in yellow.

When MSCClient users add an annotation to a document, they specify the role members, group members and users, to whom they want the annotation to be visible. Any user who subsequently views that document, and to whom the annotation has been assigned, will be able to view the text message.

NOTE: MSCClient users can only add annotations to documents if an administrator has [granted](#) them the **Create Annotation** privilege.



Removed Reports

 - **Last 24 Hours** (to show processes that occurred during the last 24 hours)
 - **Nearest** (to show processes that will occur in the near future)

The list displays the following information:

- **Name of a process**
- **Start time**
- **End time**
- **Information** (click a plus sign to display additional information about a process)
- **Status** (Not Started, In Progress or Completed)

NOTE: The list auto-refreshes every 60 seconds. You can refresh it manually by clicking **Refresh**.


Active Users

Monarch Server provides the possibility to monitor active users in the system.

To access the Active Users Report, on the **Navigation Tree**, click **System Reports**, and select **Active Users**. The list displays the following information:

- User name
- Privileges
- Creation time

- Module name
- Terminate

Click the  icon in the **Terminate** column to close the current session for the selected active user. The **Terminate User Session** dialog box will pop up with the the following question: *Terminate selected User Session?*

Click **Delete** to confirm your choice or **Cancel** to remain the session.

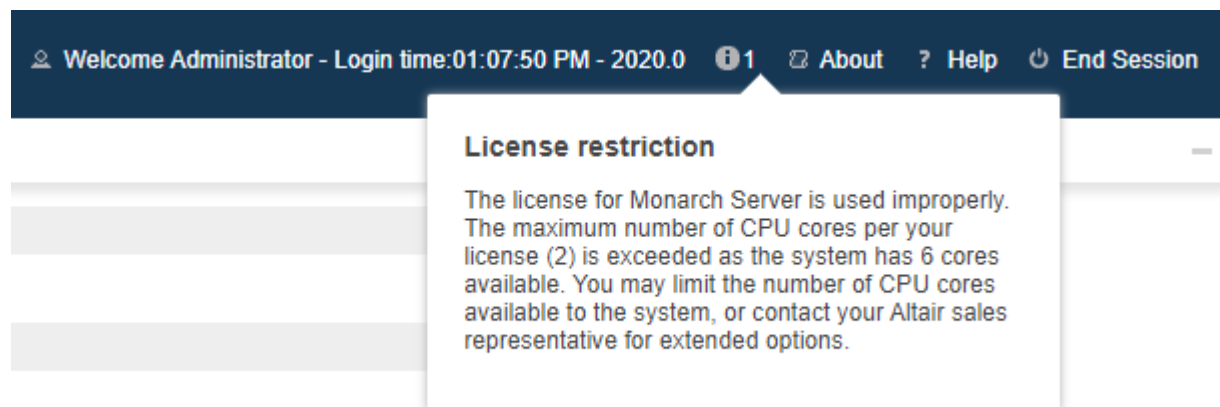

Glossary

Administrator: Any individual performing system administration, database administration, network administration, or warehouse administration duties.

Analytical Data: Data that has been evaluated, summarized or in some way analyzed.

Connection: A set of parameters necessary to connect to a data warehouse.

Copy: In Monarch Server Web, a storage location that will receive data files when documents are added to a storage group. A first copy (Copy 1) must reside on a mass storage device. Subsequent copies (Copies 2 and greater) may reside on any form of media.

Default Keyword: As opposed to a standard keyword, which is a value taken from a report, a default keyword is a single keyword that is automatically associated with every document created during a specific archive process or process job. It is used to mark or identify documents with a value that is not contained within the documents themselves. Use of default keywords is optional.

Document: A section of a report that is logically independent from other sections. Documents are the units that a report is divided into when it is stored in the report warehouse.

Document Break Field: An index field that is used to mark the beginning of a new document within a report. For example, a change in Purchase Order Number would be used to detect the start of a new document. The system administrator identifies the document break fields for a report for use during the archiving process.

Document Search: A database search for all documents that match the specified document type, document date range, and keywords. These criteria are specified in MSAdmin, while the document search itself is performed in Server.

Document Group: A document group is a classification of document types according to some common characteristic or subject. You could, for example, decide to group different kinds of financial reports into a single document group. Each document group contains one or more document types.

Document Template: A pre-designed document that contains formatting and, in many cases, generic text.

Document Type: A generic class of documents that have the same physical layout and function. Document types are assigned names and are classified into document groups by the system administrator.

Execution Frequency: Execution frequency (or run time) specifies both how often a process will run (e.g. once, hourly, daily, etc.) and at what time it will run. When scheduling a filing or maintenance process, you specify the execution frequency on the Filing Process page or the Maintenance Process page.

Filing: The process of indexing, paginating, and archiving incoming reports.

Filing Process: A process that executes all the filing tasks assigned to it.

Filing Task: A task that launches operations of indexing, paginating, and archiving incoming reports.

Global Security Keyword: A keyword associated with a role, user group or user that is logically added (the **AND** operation) to any retrieval requests. The purpose of a security keyword is to restrict user access to only those documents that contain this specific keyword.

Index Field: This is an internal pointer that associates a specific keyword with a specific document. It points to the start of a document, with which the given keyword is to be associated. Monarch Server uses indexes to locate and retrieve documents according to keywords. For example, when you type in the keyword **001-01-0001** for **Social Security Number**, the index is used to locate documents for the individual with that social security number.

Keyword: A specific value of a keyword type. **John Q. Public** is a keyword for the **Employee Name** keyword type.

Keyword type: A keyword type is the term, which is defined when you create a Monarch model (when creating a Monarch model, one or several keyword types are defined). This is a field within a model that identifies the document. For example, a keyword type for purchase orders might be **Purchase Order Number**. A keyword type for an employee report would be **Social Security Number**. A document type may have several keyword types associated with it. These keyword types are set up by a system administrator and are made available to users automatically.

Keyword value: This is the specific value of a keyword type. For example, **Q197-4112** could be a keyword for the **Purchase Order** keyword type.

Log Clearance Task: The process of clearing log-records from the Monarch Server database.

Locale: Defines one of the regional options. A locale affects the way some programs display and sort dates, times, currency and numbers.

Maintenance process: A process that executes all maintenance tasks assigned to it.

Maintenance Task: The process of copying, moving, and deleting files to maintain document storage.

Monarch Index Model File: A special form of Monarch Model File that contains only those fields that are used as keyword types for a given document type. A system administrator creates and controls this model file. It is used only during the archive process.

Monarch Model File: A file with the .dmod or .xmod extension, which contains field, filter, summary and chart definitions as well as other settings used by Monarch. A Monarch Model file is associated with each document type and is automatically opened when documents are viewed. A system administrator creates the default model file. End users can also create their own Monarch Model Files with their personal analysis settings and preferences.

Offline task: Offline processing provides the ability to process large datasets in the offline mode on a scheduled basis. If a user requests some operation (view report, table, summary, and so on) for a dataset, whose size exceeds the system limit, Monarch offers to process such requests in the offline mode. Schedule information for this task includes the start and stop time, which allows executing the task at the specified time only.

Online Mass Storage Device: Any storage device that provides immediate access to data.

Privileges: Permission to perform certain tasks within Monarch Server.

Process: An ordered sequence of tasks, scheduled by an administrator to perform once or periodically. It guarantees that tasks are performed sequentially, in proper order.

Removable Storage Device: Any storage device that requires human intervention to mount and unmount media when reading and writing data. A request for mounting a given storage group (or volume) must be issued before data can be retrieved or stored.

Report: A formal record containing information in a printed or electronic format. Reports have a consistent, structured layout and are generally stored in a single file on a storage volume.

Report Mining: The process of accessing and analyzing report data, usually across numerous reports contained in a report warehouse.

Report Premining: Pre-extracting table data from reports during a filing process (as part of archiving report data), and putting it into the MS database. The data will be used to build data views. No access to original report data is needed.

Report Warehouse: A repository containing reports that have been indexed for retrieval.

Rights: Permission to access any of the Monarch Server components, basic functions, as well as documents and custom queries.

Role: A role defines rights for users and user groups. It cannot include other roles. A role is kept in the Monarch Server database and has no tie with other security systems. An administrator can define rights via roles (Role Based Security) or assign them to user groups and individual users.

Search group: A set of logically related searches.

Search: Document retrieval criteria saved in the database under a particular name.

Security Keyword: A keyword associated with a role, user group or user that is logically added (the **AND** operation) to any retrieval requests. The purpose of the security keyword is to restrict user access to only those documents that contain this specific keyword.

Source: A set of parameters determining what data should be retrieved from a data warehouse.

Storage Group: The logical storage bins (referred to as storage groups) in which reports put into the Monarch Server system are stored. All the data in a storage group is stored together. Each storage group may be composed of several storage volumes.

Storage Volume: Volumes are used to segment the continually growing amount of data in a storage group. Each volume can have one or more copies, which may reside in separate storage locations. Several storage volumes comprise a storage group, each volume having a specific, user-defined size.

Task: Appropriate processing of a group of files from one incoming directory, described by task properties. Tasks have a name, description, and can be reused and assigned to multiple processes.

Text Search: A search through the text of documents for a given string of text. Documents must also meet the specified selections for document type, document date range, and index fields.

User: A user is an individual who has been granted product rights and privileges to Monarch Server by a system administrator.

User Group: A classification of users created to manage individual user's rights to the system.

User Name: A name or word defined by an administrator that lets Monarch Server recognize and identify authorized users. A user must supply a user name to log on to Monarch Server. Unique user names can be created for either each user, or for each type of user (for example, data entry clerk).
